Saunders Family in Virginia Has Well Known Descendants, W&M President

The following is from pages 145-148 of the *William and Mary Quarterly Magazine*, Vol. 14, Issue 3, Jan. 1906.

SAUNDERS FAMILY

1 JOHN SAUNDERS lived in York Co., Virginia, and his will was proved Feb. 24, 1700. It disposes of a large estate in money, slaves, and land. Issue named in the will: 2 Christtabel, wife of Samuel Waddow; 3 *John*; 4 Edward; 5 *Robert*; 6 George; 7 Hargrave; 8 Peter; 9 Sarah; 10 Susannah. There is a deed recorded in Yorktown from John and Edward Saunders, in 1707, disposing of land to William Barber, "inherited from their mother, Mary Risle, daughter of John Risle," but reserving "the burial place of their mother and father, forty feet square." It is probable that the other children were by a second wife, a daughter of Peter Hargrave.

3 JOHN² SAUNDERS (John,¹) married ___ Hyde, daughter of Robert Hyde (Note 1 [not included in this excerpt]) removed to Goochland County where his will, dated October 2, 1736, is recorded. He had issue: 11 Mary, who married Daniel Johnson, and had issue: John and Daniel, Jr., 12 *John Hyde*.

12 JOHN HYDE³ SAUNDERS (John,² John¹) lived in Cumberland County, and probably married ___ Fleming. In a deed recorded in York Co. from John Hyde Saunders to Samuel Hyde, for land in Goochland County, patented 1690, the former is described "as son and heir of John Saunders who was son and heir to John Saunders." His will dated Feb. 2, 1768, was proved March 29, 1768, and makes his friends William Fleming, Archibald Buchanan and son John Hyde Saunders executors. He names issue: 13 Samuel Hyde; 14 *Robert* (Hyde); 15 Chancellor; 16 *Jesse*; 17 *John Hyde*; 18 *Peter* to whom he gave 195 acres in the county of Pittsylvania; 19 Rebecca; 20 Patty; 21 Mariana. In "Early Settlers of Alabama" by Mrs. Elizabeth Saunders Blair Stubbs, the parents of these chil-

dren are represented as Samuel and Phyllis (Dudley) Saunders, while another tradition makes Jesse Saunders the father. But there can be no doubt that the text is correct.

14 ROBERT HYDE⁴ SAUNDERS (John Hyde,³ John,² John¹), was ensign in the State line in 1777 and first lieutenant in 1778. (For reputed descendants see "Early Settlers in Alabama" p. 461.)

16 JESSE HYDE⁴ SAUNDERS (John Hyde,³ John,² John¹), resided in King William Parish, Cumberland Co., and married Mary, daughter of Anthony Lavillion, a French Huguenot. (See deed in Cumberland, dated 22 Oct., 1764.) For issue, See "Early Settlers in Alabama," p. 462.

17 JOHN HYDE⁴ SAUNDERS, (John Hyde,³ John,² John¹) was a student at William and Mary in 1762, from which he was dismissed for insubordination, went to Europe, was ordained as a minister, and returned in 1772. He was minister of St. James Parish Southam, Cumberland County; and in 1775 he was a member of the county committee, espousing the American side in the Revolution. (For descendants see "Early Settlers in Alabama" p. 461.)

18 PETER SAUNDERS, (born Sept. 20, 1748, died August 4, 1813), lived in Pittsylvania County, where in 1775 he was one of the County Committee of Safety. He married Oct. 31, 1767, Mary Sparrell, ward of Governor Giles. Issue: 22 Judith, (b. 1768); 23 Lettie (b. 1770); 24 Elizabeth, (b. 1772); 25 Peter, (b. 1776); 26 Fleming, (b. 1778); 27 Robert (b. 1781); 28 Samuel, (b. 1783); 29 Polly.

26 (Judge) FLEMING⁵ SAUNDERS (Peter,⁴ John Hyde,³ John,² John¹), of Franklin County, married May 14, 1814, Alice, daughter of William and Mary (Scott) Watts, of Flat Creek, Campbell County, and had issue: 30 Mary; 31 Sarah; 32 William; 33 Edward (all died

Will of Nahum Sanders in Rawleigh Archives Yields Much Valuable Genealogical Information

Mary Lu Sanders, 5203 Fieldbrook Drive, Greensboro, NC 27455-1119, <marylus@earthlink.net> sent in the following will of Nahum Sanders of Stokes County, N.C. Mary Lu's husband is a direct descendant of Nahum Sanders through son Arden. Mary Lu transcribed this will from the original in the North Carolina State Archives in Rawleigh.

LAST WILL AND TESTAMENT OF NAHUM SANDERS

In the name of God Amen. I, Nahum Sanders, of Stokes County State of North Carolina being weak in body but of sound and perfect mind and memory (blessed be God) do this thirty first day of March in this year of our Lord one thousand seven hundred ninety four make and publish this my last Will & testament in manner & form following that is to say-

First I give & bequeath unto my beloved wife Susanna during the term of her Widowhood all the plantation whereon I now dwell.

Secondly I will that all of my just debts and funeral expenses be paid out of my personal accounts or moveable estate.

3rdly I will & bequeath unto my eldest son Arden Sanders one hundred acres of land adjoining the lands of John Findal Carr, Michael Faire)— Entry of William Dobson esqr. and Benjamin Watsons being the north end of the tract of land whereon I now dwell, to him the said Arden his heirs and assigns forever; With this reserve that the said Arden is not to be put in possession thereof untill he shall arrive at the age of Twenty one years.

4thly I will & bequeath unto Merry Arthur Sanders my second son one hundred fifty acres of land being the South end of my plantation I now dwell on; to be put in possession upon my wife's death or Marriage provided he the said Merry Arthur shall then be of age if not to remain under the management of my Executors untill that period—but if so be that at any time before my wife's death or marriage after he the said Merry Arthur is of age he should incline to live on said land he shall be at liberty to settle and improve the uncultivated part of said land but shall not interfere or meddle with any part of the improvement untill my wife's Marriage or death as aforesaid.

5thly I will that my two eldest sons Arden & Merry Arthur shall and do pay

jointly unto my three youngest sons viz. Jesse Sanders, Richard Sanders and Benjamin Sanders the just sum of thirty pounds good and lawful money of this state that is to say the sum of ten pounds each to be paid unto them as they shall severally become of age as their part or quota of the aforesaid plantation & to be paid by the said Arden and Merry Arthur equally that is to say the sum of Fifteen pounds each

6thly I will & bequeath unto my beloved Wife Susannah all my moveable estate during her life or Widowhood after all my just debts funeral charges and legacies hereafter bequeathed in this my last Will & Testament are discharged—& at my Wife's Marriage or death I will that my moveable Estate be equally divided among my five sons viz. Arden, Merry Arthur, Jesse, Richard & Benjamin

7th I will that my wife be at liberty to give to any of my sons after they shall come of age any part or the whole of their quota of my moveable Estate or she may conceive they stand in need thereof, but shall not be compelled to make such distribution untill her marriage or death aforesaid.

8thly I will & bequeath unto my three sons-in laws John Sapp, James King, and Thomas Medieress the sums of five shillings each to be raised and levied out of my moveable Estate by my Executors & paid unto them as their wife's legacies.

And I do hereby make and ordain my beloved Wife Susanna Exectrix and my friend William Howell Executor of this my last will and testament and I do hereby revoke & disavow all former Wills & Testaments by me made ratifying and confirming this and no other to be my last Will and testament. In witness thereof I the said Nahum Sanders have to this my last Will and Testament set my hand and seal the day and year above written

Signed sealed published and declared by the said Nahum Sanders the Testator as his last Will and Testament in the presence of us who were present at the time of signing and sealing thereof. (Mark of Nahum Sanders is shown.)

Any Robert Sa(u)nders From Early 1600s in New England Would Interest Ted

From Ted Chadborne, 50 Stockholm Drive, Cumberland Center, ME 04021-3514, <tedchad@maine.rr.com>. We join others who've advocated *both location + time frame* [with names] in their queries.

We're also interested in any Robert Sa(u)nders who in the early 1600s migrated or journeyed between Massachusetts and (Virginia, Maryland, North Carolina), whether "coasting" or in a triangular trade route including points east: Europe or faraway islands.

This may have included one Robert Sa(u)nders left by Mr. Weston in charge of a fledgling colony at Wessagusset (Weymouth, Mass.) during an early harsh winter—a man not proved to have stayed in or returned to New England, nor to have married or had children, so far as we can ascertain.

We'd value by U.S. mail or by private e-mail evidence, *with sources*, tying the man above to others of that surname in U.S. Atlantic mid-coast. Submitters with good source data may expect a summary of our merged finding within six months.

Leading sources of information on these early John Sanders include:

The Great Migration Begins p. 1625, by Robert Charles Anderson.

* John of Thomas Weston's colony at Wessagusset Colony (Weymouth, Mass.) 1622 who may have died by 1637. Anderson concludes it unlikely that this man was seen later in New England.

Founders of Early American Families - Emigrants from Europe 1607-1657 Revised Edition, by Meredith B. Colket, 1985, p.272, which distinguished between these three men:

* John of Salem 1630 and Marblehead 1639, d. after 28 Oct 1643.

young); 34 Peter, (b. 1823), member of the Legislature, married Betty Dabney, (parents of Judge E. W. Saunders, of Franklin Co.); 35 Ann Maria, (b. Oct. 19, 1825), married Col. Thomas L. Preston, and is living in Charlottesville; 36 Robert Chancellor, b. May 26, 1827, of Campbell Co.; 37 Capt. Fleming, (b. 1829, living in 1905); 38 Louisa Morris, b. 1833, m. Richard T. Davis.

5 ROBERT² SAUNDERS, (John¹), lived in Williamsburg, and probably married Miss Spratley, for in his will dated April 28, 1728, John Spratley, of Surry refers to "his granddaughter Mary Saunders, daughter of Mr. Robert Saunders, of Williamisburg." He had issue: 39 *John Saunders*.

39 JOHN³ SAUNDERS, (Robert² John¹), lived in Williamsburg where he was a contractor. He had issue: 40 *Robert Saunders*; 41 *John Saunders*.

40 ROBERT⁴ SAUNDERS, (John³ Robert² John¹), was born Nov. 9, 1761, attended the grammar school of the College in 1776, was in the American army, practiced law, and was a member of the State Senate in 1799. He married Nov. 6, 1799, Mariana Barbara Hunter, daughter of John Hunter (Note 2 [not included in this excerpt]) and Susannah Jones, and had issue: 42 *Robert*; 43 *Mary Hunter Saunders*, died aged 16 years.

42 ROBERT⁵ SAUNDERS (Robert⁴ John³ Robert² John¹) was born January 25, 1805, and graduated A.B. at William and Mary College in 1823. He married June 17, 1828, Lucy, youngest daughter of Governor John Page, of Rosewell. He was elected professor of Mathematics in 1833, and became President in 1849. Issue: 44 Mariana Barbara, who married Rev. George T. Wilmer; 45 Margaret; 46 Lelia, died unmarried; 47 Robert Page now of Baltimore; 48 Lucy Page, died unmarried. Robert Saunders, the father, died in 1869.

43 JOHN⁵ SAUNDERS (Robert⁴ John³ Robert² John¹), married Lucy Galt, removed to Norfolk, where he was an officer of the customs. Issue: 49 Mary, d. s. p.; 50 (Rev.) *William Turner*, b. in Norfolk, 1817, an Episcopal clergyman, for twenty years rector at Appalachicola.

50 Rev. WILLIAM TURNER⁶ SAUNDERS (John⁵ Robert⁴ John³ Robert² John¹) married and had issue: 51 Robert; 52

Benjamin Holly Sanders Has A Story That Anyone Would Like In Their Family Lore

The following first-hand account of Benjamin Holly Sanders was sent in by Clara Stringfellow, 1693 Garden Road, Durham, CA 95938-9608. B. H. Sanders is the brother of her great grandmother.

"I was born February 10, 1874, near Marshall, Arkansas. I went to California in 1897. Three of my brothers were already living there. We settled in the Owens valley near Big Pine. In 1898, I and Brother Charlie decided to go to Los Angeles on horseback a distance of 300 miles across the desert. Not realizing our mistake, we took our horses fresh from green pasture and started out. We had to make some long rides in order to reach water. The weather was hot and by the second day our horses were almost give out. On the third day we reached Little Lake. After dark, we bought feed, but our horses were too tired to eat much. The man at the station told us it was 21 miles to the next water, a place called Indian Wells, and told us to watch for a left hand road that went to a mining town, Randsburg. We started before daylight to get the benefit of the cool of the morning. When we got to the forks of the road, we took the right road all right, but long before we reached water, our canteens were empty and we were thirsty and our horses about give out. We began to fear that we had took the wrong road, and by the time we could go back to the other road, we would be unable to reach water. We were uncertain which was best, but decided to keep going on the same road. We finally made it to the top of Anup Grade. Our horses couldn't have went much further when we looked ahead and seen green trees where the station was, and I think that was about the happiest moment of my life. The horses drank plenty of water but didn't eat much. We decide to turn them loose and take the stage to Mojave, then the train to Los Angles. We tied tags to the horses

manes and wrote on the tags, "These horses belong at Big Pine. Please drive them North," hoping that they would make it back home the next day. We started them back on the road toward Little Lake and got on the stage. Ordinarily it wouldn't have been done exactly that way.

"Now here is the part that I have thought of all these years. At the time we turned the horses loose, tagged for Big Pine, there were some Salvation Army people leaving Bakersfield, California, headed for Big Pine, with wagon and team. Somewhere on the road, one of the horses died. They were left on the desert with the wagon and one horse and their families. The men took time about by the side of the horse, pulling the wagon and praying to the Lord for help. I don't suppose they were praying for horses, but for help, and when they got to Little Lake, the horses were there, tagged for Big Pine, California, just where they were headed for. One of the horses was a work horse, the other just a saddle pony. They took them both and turned them loose when they got to Big Pine, and when I got home a few weeks later, the horses were there.

"I didn't know of the unusual circumstances until three weeks later, when the County Fair was held at the Big Pine and I met a man there that was on the stage and seen us turn the horse loose. He told me about the Salvation Army people finding the horses at Little Lake and working the work horse through to Big Pine and turning them loose. But at Independence, California, 28 miles before they got to Big Pine, they preached on the street, and told how their prayers were answered, and some people were making fun of it and this man told me it was the truth and when he seen me he asked me to go with him, and tell the people about it, which I did, and they seemed satisfied God answers prayers according to His own way, and I firmly believe it was in answer to their prayers that caused us to turn the horses loose the way we did, but the way we done it caused them to get help across the desert. Also, caused our horses to get home in good shape.

Sanders Name Appears Many Times In *Cherokee Roots*, Vol. 1

The following "SANDERS" names are taken from *Cherokee Roots Vol I: Eastern Cherokee Rolls*, by Bob Blankenship, copyright 1992. If only a person's Native American name was used, then those are not copied here. Also, there are some first names only, which, of course, have not been copied.

Volume I: Members of the Cherokee Tribe residing east of the Mississippi River during the period 1817-1924. Though it is not commonly known, western migration of the Cherokee Nation commenced well before the removal in 1838, known as "The Trail of Tears." By the time the Eastern Cherokee arrived in northeastern Oklahoma in 1839, approximately 1/3 of the Cherokee Nation was already residing in Oklahoma.

Records of how many people, and when, moved west are limited. It is known for a fact that as early as the 1790s some Cherokee moved into southeastern Missouri. It is probable that there were already Cherokee settled in the Missouri area. Due to earthquakes and flooding in Missouri around 1812, most of the Cherokee moved into northwestern Arkansas.

Because of mounting political pressure, the United States entered treaties with the Cherokee in 1817 and 1819, for the purpose of acquiring Cherokee land in the east. Out of these treaties, the Cherokee had a choice of two alternatives. They could either enroll to move to the traded for land in northwestern Arkansas or they could file for a reservation of 640 acres in the east which would revert to the state upon their death or abandonment of the property.

By treaty in 1828, the Cherokee ceded their lands in Arkansas for lands in Oklahoma. There was also some incentive for those east of the Mississippi to join the Cherokee in Oklahoma.

I. RESERVATION ROLL - 1817. A listing of those desiring a 640 acre tract of land in the east, in lieu of removing to Arkansas. Upon the death of the reservee, or the abandonment of the property, title was to revert to the state. *No Sanders listed.*

II. EMIGRATION ROLLS 1817-1835. Those who filed to emigrate to Arkansas country, and after treaties in 1828, on to

Oklahoma. These Cherokee became known as the Old Settlers after the Eastern Cherokee joined them in 1839.

The Baker Roll "Revised" is the current membership roll of the Eastern Band of Cherokee Indians of North Carolina.

My ancestor Cornelius Sanders, born 9 Oct 1828 Ala., would fit in the above outline that was taken from an undocumented web site. Cornelius Sanders m. Matilda "Jane" McIntosh c 1846 in Greene Co., Ark.; later lived Texas, St. Francois, and Wright Counties in Mo. Jane McIntosh had a son Peter Sanders (b. 1841), traditionally by a first marriage to an older brother of Cornelius Sanders. The father is believed to be the Lewis Sanders in the 1840 Greene Co., Ark. census living next door to Solomon McIntosh, the father of Jane. She and Cornelius named their first-born Lewis (b. 1847). Another child could fit in the 1824 time slot of the Union Co., Ill. family above. I am trying to document the source of these birth dates - hopefully from a Bible record. Although I previously had no clue that my Sanders family was in Illinois, some uncles of Jane McIntosh from Logan/Christian/ Todd Counties in Ky. and Weakley Co., Tenn. did settle in Union Co., Ill. so there is a connection, and it isn't far north of Arkansas. In Texas Co., Mo., Cornelius Sanders lived two farms away from and was buried adjacent to Andrew Jackson Sanders (1814-1858; wife Sabrina) who was believed to be a son of Peter and Michel (Tarbutton) Sanders. William Sanders (b. c 1829 in Miss.) married Sarah Elaine Coward (born 1830). William Sanders was the son of John, b. 1790, and Mary (b. 1800) Sanders. Sarah Elaine Coward Sanders was the d/o of Richard Addison Coward and Eleanor Henderson. Richard and Eleanor were married in 1826 in Opelousas, La. Calcasieu Parish was formed from St. Landry Parish where Opelousas is. It is #79 in the marriage book in the courthouse. This is found in Rev. D. Hebert's genealogy records for southwest Louisiana. William and Sarah Elaine died after 1860. They disappear from the Calcasieu Parish, La. census after 1860. They are both buried in Indian Village

Area in La. near Kinder, La. William and Mary had the following children: 1.) Thomas J., b. 1850, buried Big Woods Cemetery, Edgerly, La. He m. Elizabeth Shoemaker; 2.) William Benjamin, b. 1852, d. 1942; he m. Mary Jane; 3.) Allen, b. 1854, d. 1922, buried Big Woods Cemetery. He m. Margaret Rebecca Lyons; 4.) Martha, b. 1856; 5.) Mary Jane, b. 1858, d. 4 Apr 1927 in DeQuincy, La. She m. John Shoemaker; they are buried in the Big Woods Cemetery; 6.) Joseph E., b. 1860, d. 5 Jan 1927, buried Merryville Cemetery in Merryville, La. He m. Martha Jane Meadows; 7.) Carrol Murdock, b. 1862, d. 1934, buried Sugartown Cemetery, Sugartown, La.
