

Descendants of Daniel Embody

Generation One

1. **DANIEL' EMBODY** was born circa 1788 Minden, Montgomery Co., New York.¹ Another source says he was born circa 1777.² He married **Bautje** (____) before 1814.³ He possibly died before 1820 as evidence of Daniel has not been found in a census search of the New York counties of Montgomery, Herkimer or Jefferson, and as he has only two known children, the eldest born in 1816.

He would be one of four males under 16, enumerated with his father on the 1790 Federal Census. He is probably one of the two males age 10-16 who appear in his father's household on the 1800 Federal census. He witnessed the baptism of **Maria Knauts**, daughter of **John Knauts** and **Catharina Embody**, on 2 Feb 1806 Lutheran St. Paul's (Geisenberg Church), Minden, Montgomery Co., New York, (sponsors Daniel Embody und Magdalena Knauts).⁴ He witnessed the baptism of **Elisabeth Kraemer**, daughter of **Jost Kraemer** and **Magdalena** (____), on 31 Aug 1806 Lutheran St. Paul's (Geisenberg Church), Minden, Montgomery Co., New York, (sponsors Daniel Embody und Elisabeth Walts).⁵ He witnessed the baptism of **Daniel Embody**, son of **Jacob Embody** and **Catherine Cramer**, on 16 Aug 1812 Lutheran St. Paul's (Geisenberg Church), Minden, Montgomery Co., New York, (sponsors Daniel Embody und Delia Craemer).⁶ A descendant of Daniel Embody has participated in the Brewer DNA Project (Kit no. 11677).⁷ A Daniel Embody, and a Mrs. Daniel Embody are buried at Oneida Castle Cemetery, Oneida Co., New York. No dates are available. Location: 98 B.⁸ **John Brewer** and **Daniel Embody** each have descendants that appear to be closely related. DNA testing of direct male descendants, carried out through the Brewer DNA Project, has demonstrated that direct descendants of Daniel Embody and John Brewer share a common ancestor within a meaningful genealogical time period. It is apparent that the descendants, through their respective earliest known ancestors, are descended from Jan Brouwer of Flatlands. (See the DNA Analysis page of the Brouwer Genealogy Database website).⁹ **Daniel Embody** and **John Rose** each have descendants that appear to be closely related. DNA testing of direct male descendants, carried out through the Brewer DNA Project, has demonstrated that direct descendants of John Rose and Daniel Embody share a common ancestor within a meaningful genealogical time period. It is apparent that the descendants, through their respective earliest known ancestors, are descended from Jan Brouwer of Flatlands. (See the DNA Analysis page of the Brouwer Genealogy Database website).¹⁰

- + 2 i. Isaac² was born on 18 Mar 1814. He married **Phebe J. Van Vorst**, daughter of (____) **Van Vorst** and **Betsey** (____), circa 1840. He died on 20 Mar 1900.
- 3 ii. Belinda was born on 4 Jun 1816.¹¹ She was baptized on 21 Jul 1816 Lutheran St. Paul's (Geisenberg Church), Minden, Montgomery Co., New York; (no sponsors recorded).¹²
Belinda's baptism on 21 Jul 1816, is last recording of a member of the Embody family in the records of the Lutheran St. Paul's Church at Minden, New York.

Generation Two

2. **ISAAC² EMBODY** (Daniel') was born on 18 Mar 1814 Minden, Montgomery Co., New York.¹³ He was baptized on 30 Mar 1814 Lutheran St. Paul's (Geisenberg Church), Minden, Montgomery Co., New York; sponsors Jacob Embody, frau Catharina.¹⁴ He married **Phebe J. Van Vorst**, daughter of (____) **Van Vorst** and **Betsey** (____), circa 1840.¹⁵ He died on 20 Mar 1900 Auburn, Cayuga Co., New York; at 78 Seymour St., his son Daniel A. Embody's residence.^{16,17} He was buried Soule Cemetery, Auburn, Cayuga Co., New York.¹⁸

He appeared on the census on 22 Aug 1850 Norway, Herkimer Co., New York, as Isaac Embody, age 36, a farmer with real estate valued at \$2000. With him are his wife Phebe, children Daniel, Helen, and William, and Betsey Van Vorst (age 56), Daniel Van Vorst (17), Martha Van Vorst (12).¹⁹ He appeared on the census on 10 Jul 1860 Sennett, Cayuga Co., New York, as Isaac Embody, age 45, a farmer, no real estate, personal estate valued at \$400. With him are his wife Phebe, and children Daniel, Helen and William.²⁰ He appeared on the census on 20 Jun 1870 Auburn, Cayuga Co., New York, as Isaac Emboddy, age 54, born in New York, a laborer, with wife Phebe.²¹ He and **Phebe J. Van Vorst** were members of First United Methodist Church, Auburn, New York, between 1872 and 1885 residing at 14 Miller St., Auburn,

N.Y.²² He appeared on the census on 10 Jun 1880 Auburn, Cayuga Co., New York, as Isaac Embody, age 66, born in New York, a laborer, with wife Phebe, daughter Helen Wayne, and grandson William Wayne.²³

Children of **Isaac² Embody** and **Phebe J. Van Vorst** all born Herkimer Co., New York, were as follows:

- + 4 i. Daniel A.³ was born in Jun 1841. He married **Emma Washburn**, daughter of (____) **Washburn** and **Rachel** (____), before Jun 1870. He died circa 2 May 1907. He was buried on 4 May 1907.
- + 5 ii. Helen E. was born in Oct 1845. She married **Robert Wayne** before 1871.
- + 6 iii. William H. was born in Jul 1849. He married **Ella Hoff** circa 1868. He died in 1906.

Generation Three

4. DANIEL A.³ EMBODY (Isaac², Daniel¹) was born in Jun 1841 Herkimer Co., New York.²⁴ He married **Emma Washburn**, daughter of (____) **Washburn** and **Rachel** (____), before Jun 1870.²⁵ He died circa 2 May 1907.²⁶ He was buried on 4 May 1907 Fort Hill Cemetery, Auburn, Cayuga Co., New York; age 65.²⁷

He appeared on the census on 22 Aug 1850 Norway, Herkimer Co., New York, age 9.²⁸ He appeared on the census on 10 Jul 1860 Sennett, Cayuga Co., New York, as Daniel Embody, age 19, a farmer, enumerated in his parents household.²⁹ He appeared on the census on 26 Jul 1860 Skaneateles, Onondaga Co., New York, as Daniel Embody, age 20, a laborer, living in the household of (and probably employed by) Anthony Austin.³⁰ He served during the Civil War. Mustered in 15 June 1861 at Albany, for a term of two years, Capt. Thomas Corcoran's Co. C, 34th Regt. of New York (Foot) Volunteers commanded by Col. William La Dew. The roll describes Daniel Embody, private, as age 20.^{31,32} He appeared on the census on 12 Jul 1870 3rd Ward, Auburn, Cayuga Co., New York, as Daniel Embody, age given as 39, a blacksmith, with wife Emma.³³ He appeared on the census on 7 Jun 1880 6th Ward, Auburn, Cayuga Co., New York, as Daniel Embody, age 39, a blacksmith, with wife Annie, son George, and boarders Eunice and Alice Washburn.³⁴ He appeared on the census on 5 Jun 1900 6th Ward, Auburn, Cayuga Co., New York, living at 78 Seymour Street, Daniel A. Embody is age 58, born June 1841, married for 35 years, born in New York as were his parents, employed as a blacksmith. His wife Emma, and mother-in-law Rachel Washburn make up the household.³⁵

Children of **Daniel A.³ Embody** and **Emma Washburn** were:

- + 7 i. George Charles⁴ was born in 1876 Auburn, Cayuga Co., New York. He married **Mary M. Riceman**, daughter of **Robert Riceman**, before Apr 1910. He died circa 27 May 1939. He was buried on 29 May 1939 Fort Hill Cemetery, Auburn, Cayuga Co., New York.

5. HELEN E.³ EMBODY (Isaac², Daniel¹) was born in Oct 1845 Herkimer Co., New York.³⁶ She married **Robert Wayne** before 1871.

She appeared on the census on 22 Aug 1850 Norway, Herkimer Co., New York, age 4.³⁷ She appeared on the census on 10 Jul 1860 Sennett, Cayuga Co., New York, age 14, living with her parents.³⁸ She appeared on the census on 10 Jun 1880 Auburn, Cayuga Co., New York, as Helen Wayne, age 34, born in New York, a widow, employed as a hair dresser. Helen and her son William are living in the household of her parents.³⁹ She appeared on the census on 2 Jun 1900 Ward 6, Auburn, Cayuga Co., New York, as Helen E. Wayne, age 54, born Oct 1845 in New York. Both parents born in New York. Widow. She has had 3 children (1 living). Head of household which includes Minnie Griffin, age 45, widow, boarder.⁴⁰

Children of **Helen E.³ Embody** and **Robert Wayne** were:

- 8 i. William⁴ was born circa 1871 New York.⁴¹
He appeared on the census on 10 Jun 1880 Auburn, Cayuga Co., New York, age 9, living with his mother in the home of his grandparents, Isaac and Phebe Embody.⁴²

6. WILLIAM H.³ EMBODY (Isaac², Daniel¹) was born in Jul 1849 Herkimer Co., New York.⁴³ He married **Ella Hoff** circa 1868.⁴⁴ He died in 1906.⁴⁵ He was buried Soule Cemetery, Sennett, Cayuga Co., New York.⁴⁶

He appeared on the census on 22 Aug 1850 Norway, Herkimer Co., New York, age 1.⁴⁷ He appeared on the census on 10 Jul 1860 Sennett, Cayuga Co., New York, age 11.⁴⁸ He appeared on the census on 17 Jun 1870 1st Ward, Auburn, Cayuga Co., New York, as William Embody, age 21, born in New York, a plane maker, with wife Ella, and daughter Mimmie.⁴⁹ He appeared on the census on 3 Jun 1880 Auburn, Cayuga Co., New York, as William Embody, age 30, born in New York, a plane maker. His parents were both born in New York. With him are his wife Ella, and children Minnie, Jennie, Clarence and Charles.⁵⁰ He appeared on the census on 28 Jun 1900 Aurelius, Cayuga Co., New York, as William Emboddy, age 50, born July 1849 in New York, both parents born in New York, married for 32 years, employed as a pattern maker. With him are his wife, Ella, son Charles, and mother-in-law, Amelia Hoff.⁵¹

Children of **William H.³ Embody** and **Ella Hoff** all born Auburn, Cayuga Co., New York, were as follows:

- + 9 i. Minnie⁴ was born circa Sep 1869. She married **William Drury Ridley** circa 1889. She died in 1903.
- 10 ii. Jennie was born on 29 Sep 1872 (calculated form age at death). She died on 15 Feb 1883; age 10y 4m 17d.⁵² She was buried Soule Cemetery, Sennett, Cayuga Co., New York.⁵³
She appeared on the census on 3 Jun 1880 Auburn, Cayuga Co., New York, age 8, attending school.⁵⁴
- + 11 iii. Clarence was born circa 1876. He married **Alice A. Gilling** circa 1896. He died in 1929.
- + 12 iv. Charles was born on 14 Feb 1880. He married **Flora M. Roe** circa 1904. He died in 1937.

Generation Four

7. GEORGE CHARLES⁴ EMBODY (Daniel³, Isaac², Daniel¹) was born in 1876 Auburn, Cayuga Co., New York.⁵⁵ He married **Mary M. Riceman**, daughter of **Robert Riceman**, before Apr 1910.^{56,57} He died circa 27 May 1939. He was buried on 29 May 1939 Fort Hill Cemetery, Auburn, Cayuga Co., New York; (age 62).⁵⁸

He appeared on the census on 7 Jun 1880 6th Ward, Auburn, Cayuga Co., New York, age 3.⁵⁹ He appeared on the census on 15 Apr 1910 4th Ward, Ithaca, Tompkins Co., New York, as George C. Embody, age 33, born in New York, employed by the college (exact occupation is difficult to interpret). With him his his wife, Mary, age 21. They are living next to Robert Pratty, and his partner Harry Brower (age 24).⁶⁰ **Harry Brower** and **George Charles Embody** live next to each other in Ithaca, New York in 1910 (as per the Federal Census).⁶¹ He appeared on the census on 10 Jan 1920 4th Ward, Ithaca, Tompkins Co., New York, residing at 143 Ithaca Rd., as George C. Embody, age 43, born in New York, with his wife Madeline M., and son Dalie R. (age 5).⁶² He appeared on the census on 3 Apr 1930 Ithaca, Tompkins Co., New York, as George C. Embody, age 53, born in New York, married at age 33, a teacher at the college. With him are his wife Mary M., son Daniel R., and father-in-law Robert Riceman.⁶³

Children of **George Charles⁴ Embody** and **Mary M. Riceman** are:

- + 13 i. Daniel R.⁵ was born on 10 Jul 1914 Ithaca, Tompkins Co., New York. He married **Margaret Gran**. He died on 31 Jan 2007.

9. MINNIE⁴ EMBODY (William³, Isaac², Daniel¹) was born circa Sep 1869 Auburn, Cayuga Co., New York.^{64,65} She married **William Drury Ridley** circa 1889.⁶⁶ She died in 1903.⁶⁷ She was buried Soule Cemetery, Sennett, Cayuga Co., New York.⁶⁸

She appeared on the census on 17 Jun 1870 1st Ward, Auburn, Cayuga Co., New York, as Minnie Embody, age 8 months.⁶⁹ She appeared on the census on 3 Jun 1880 Auburn, Cayuga Co., New York, age 10, attending school.⁷⁰ She appeared on the census in Jun 1900 Ward 4, Marinette, Marinette Co., Wisconsin, as Minnie Ridley, age 29, March 1871 in New York. Both parents born in New York. Married for 11 years. She has had 2 children (2 living).⁷¹

Children of **Minnie⁴ Embody** and **William Drury Ridley** both born New York were as follows:

- 14 i. Bertha⁵ was born on 8 Jan 1891.^{72,73} She married George A. Coon circa 1919.^{74,75} She died in Jul 1976.^{76,77} She was buried Soule Cemetery, Sennett, Cayuga Co., New York.⁷⁸
She appeared on the census in Jun 1900 Ward 4, Marinette, Marinette Co., Wisconsin, Bertha Ridley, age 9, born in New York.⁷⁹ She appeared on the census on 5 Feb 1920 Aurelius, Cayuga Co., New York, as Bertha Coon, age 29, born in New York. Both parents born in New York.⁸⁰ She appeared on the census on 9 Apr 1930 Auburn, Cayuga Co., New York, as Bertha Coon, age 39, born in New York. Both parents born in New York. Married at age 28.⁸¹ Her last residence was Auburn, Cayuga Co., New York.⁸²
- 15 ii. Ernest was born in Aug 1893.⁸³ He died in 1919.⁸⁴ He was buried Soule Cemetery, Sennett, Cayuga Co., New York.⁸⁵

Also known as **WILLIAM E. RIDLEY**.⁸⁶ He appeared on the census in Jun 1900 Ward 4, Marinette, Marinette Co., Wisconsin, Ernest Ridley, age 6, born Aug 1893 in New York.⁸⁷

11. CLARENCE⁴ EMBODY (William³, Isaac², Daniel¹) was born circa 1876 Auburn, Cayuga Co., New York.⁸⁸ He married **Alice A. Gilling** circa 1896.⁸⁹ He died in 1929.⁹⁰ He was buried Soule Cemetery, Sennett, Cayuga Co., New York.⁹¹

Also known as **Calvin Embody**.⁹² He appeared on the census on 3 Jun 1880 Auburn, Cayuga Co., New York, age 4.⁹³ He appeared on the census on 28 Apr 1910 Aurelius, Cayuga Co., New York, as Calvin Embody, age 34, born in New York, married for 14 years, employed as a carpenter for a plane maker. With him are his wife Alace M., and children Robert W. and Louis C. They are residing next door to his mother, Ella Embody, on Canoga Road.⁹⁴ He appeared on the

census on 30 Jan 1920 Aurelius, Cayuga Co., New York, as Clarence Embody, age 43, born in New York, both parents born in New York. Working as a gardener on his own farm. With him are his wife Alice, and children Robert, Louis, and Margery.⁹⁵

Children of **Clarence^d Embody** and **Alice A. Gilling** were as follows:

- 16 i. Robert W.⁵ was born on 14 Jan 1897 Cayuga Co., New York.^{96,97} He married Elizabeth (____) in 1929.⁹⁸ He married Olive St. John.⁹⁹ He died on 23 Jun 1962; age 65 years.¹⁰⁰ He was buried Lakeview Cemetery, Cayuga, Cayuga Co., New York.¹⁰¹

He appeared on the census on 28 Apr 1910 Aurelius, Cayuga Co., New York, age 13.¹⁰² He appeared on the census on 30 Jan 1920 Aurelius, Cayuga Co., New York, age 23, single, living with his parents, employed as a bookkeeper.¹⁰³ He appeared on the census in 1930 Aurelius, Cayuga Co., New York, as Robert W. Embody, age 33, married at age 32, living with his wife in his mother's household. He is a gardner for "Luck Farm."¹⁰⁴ Robert W. Embody's obituary appeared on 23 Jun 1962 in the *Citizen Advertiser*, Auburn, N. Y. "R. Embody, Former Veterans Officer, Dead at 65." Survived by his widow, Mrs. Olive St. John Embody; a brother Louis C. Embody of Aurelius; a sister Mrs. Richard W. Pearce of Aurelius; three aunts; and several nieces and nephews.¹⁰⁵
- 17 ii. Louis C was born on 2 Nov 1900 New York.¹⁰⁶ He died on 21 Oct 1987 Aurelius, Cayuga Co., New York.^{107,108}

He appeared on the census on 28 Apr 1910 Aurelius, Cayuga Co., New York, age 9.¹⁰⁹ He appeared on the census on 30 Jan 1920 Aurelius, Cayuga Co., New York, age 19, living with his parents.¹¹⁰ He appeared on the census in 1930 Aurelius, Cayuga Co., New York, as Louis C. Embody, age 29, single, living in his widowed mother's household. Employed as a shoe cutter for a shoe manufacturer.¹¹¹ Louis C. Embody served during WW II. Enlisting 2 Dec 1942 at Syracuse, New York, as a private, while residing in Cayuga Co., New York. He was married and his civil occupation was "semiskilled occupations in manufacture of boots and shoes."¹¹² His last residence was Auburn, Cayuga Co., New York.¹¹³ Louis C. Embody's obituary appeared on 23 Oct 1987 in the *Citizen Advertiser*, Auburn, N. Y. Louis C. Embody, age 86. Born in Auburn, son of Clarence H. and Alice Gilling Embody. Long a resident of Aurelius. He operated a greenhouse in a vegetable farm for many years. He was also a long time employee of Dunn & McCarthy Co., and the Marshall & Meadow Shoe Company. Veteran of World War II. Survived by one sister, Marjorie Embody Pearce of Auburn; one niece, Mrs. Jean P. Schmitz of Auburn; five nephews, Carl R. Pearce of Dryden, Ronald C. Pearce of Voorheesville, William E. Pearce of Phelps, John R. and James L. Pearce of Auburn.; several great nieces and nephews. He was predeceased by his brother, Robert W. Embody.¹¹⁴
- 18 iii. Margery was born on 17 Nov 1913 Auburn, Cayuga Co., New York.¹¹⁵ She married Richard Pearce.¹¹⁶ She died on 21 Dec 2009.¹¹⁷

She appeared on the census on 30 Jan 1920 Aurelius, Cayuga Co., New York, age 6.¹¹⁸ She appeared on the census in 1930 Aurelius, Cayuga Co., New York, as Marjorie Embody, age 16, living in her mother's household.¹¹⁹

12. CHARLES^d EMBODY (William³, Isaac², Daniel¹) was born on 14 Feb 1880 Auburn, Cayuga Co., New York.¹²⁰ He married **Flora M. Roe** circa 1904.¹²¹ He died in 1937.¹²² He was buried Soule Cemetery, Sennett, Cayuga Co., New York.¹²³

He appeared on the census on 3 Jun 1880 Auburn, Cayuga Co., New York, age 3 months, "Feb."¹²⁴ He appeared on the census on 28 Jun 1900 Aurelius, Cayuga Co., New York, as Charles Emboddy, age 20, born Feb 1880, living with his parents, "at school."¹²⁵ He appeared on the census on 15 Apr 1910 10th Ward, Auburn, Cayuga Co., New York, as Charles W. Embody, age 30, born in New York, both parents born in New York. Employed as a cashier in an office. With him is his wife Flora, they are living at 3 Elm Street.¹²⁶ He appeared on the census in Jan 1920 6th Ward, Auburn, Cayuga Co., New York, as Charles Embody, age 39, born in New York. The census states that his father was born in Pennsylvania, and his mother in England which is clearly an error for his wife. He is a cashier for a harvester company. With him is his wife Flora and daughter Clarice. They are living at 149 Curtis Place.¹²⁷ He appeared on the census on 16 Apr 1930 Auburn, Cayuga Co., New York, as Charles W. Embody, age 50, born in New York, both parents born in New York. Employed as a cashier for a farm impliment company. With him are his wife Flora R., mother Ella A. Embody, sister-in-law Nellie Corse, age 55, and servant Annie Norrie, age 59. They are residing at 149 Curtis Place.¹²⁸

Children of **Charles^d Embody** and **Flora M. Roe** were:

- 19 i. Clarice⁵ was born on 29 Apr 1910 Auburn, Cayuga Co., New York.¹²⁹ She married Lee Henderson.¹³⁰ She died on 24 Sep 1990 Simsbury, Hartford Co., Connecticut.¹³¹
 She appeared on the census in Jan 1920 6th Ward, Auburn, Cayuga Co., New York, age 9.¹³²

Generation Five

13. DANIEL R.⁵ EMBODY (George⁴, Daniel³, Isaac², Daniel¹) was born on 10 Jul 1914 Ithaca, Tompkins Co., New York.^{133,134} He married **Margaret Gran.**¹³⁵ He died on 31 Jan 2007.¹³⁶

He appeared on the census on 10 Jan 1920 4th Ward, Ithaca, Tompkins Co., New York, as Daliel R. Embody, age 5.¹³⁷ He appeared on the census on 3 Apr 1930 Ithaca, Tompkins Co., New York, as Daniel R. Embody, age 15, living with his parents.¹³⁸ His last residence was Hyattsville, Prince Georges Co., Maryland.¹³⁹

Children of **Daniel R.⁵ Embody** and **Margaret Gran** are:
