

## Early Hunterdon County, New Jersey Deeds, 1716-1730

Abstracted from FHL film #0818213. A list of the grantors and grantees found in Book A (dated Jan 31, 1716/17) and presented in the order in which they appear. Please note that many of the deeds are lengthy, contain descriptions of the property involved, and at times mention earlier conveyances regarding the property being described. The purpose of this list is simply to list those persons involved as principals in each deed. There is no index for this book. Researchers who find, on this list, a deed that interests them are advised to order the above referenced film from their local Family History Center.

Page 1. **Samuel Davis** of Hopewell, Burlington Co., yeoman, to **Powel Huff** of Maidenhead, Burlington Co., yeoman. (Mentions prior deed of **Mary Davis**, widow and mother of **Samuel Davis**). 20 2<sup>nd</sup> Month 1701.

Page 5. **Cathren Davis** of Hopewell to **Powel Huff** of Maidenhead. (Mentions prior deed of **Mary Davis**, widow and mother of **Cathren Davis**). 25 2<sup>nd</sup> Month 1701.

Page 9. **Joseph Sackett** of Newtown, Queens Co., New York, to son **Richard Sackett** of Maidenhead. (Land formerly of **Johannes Lorosons**). 4 July 1707.

Page 10. **Daniel Bailey** of Maidenhead, Hunterdon Co., to **William Osborn** of Maidenhead. 6 March 1716/17

Page 13. **William Osborn** of Maidenhead, to **Francis Hornen** of Piscataway, Middlesex Co. 18 Feb 1716/17.

Page 16. **Garrett Cook** of Maidenhead, to **Richard Scudder** of Hopewell. 10 June 1715.

Page 18. **Joseph Sackett** of Newtown, to son **Simon Sackett** of Hopewell. 3 April 1711.

Page 19. **Richard Scudder** of Hopewell, to **Simon Sackett** of Hopewell. 20 October 1712.

Page 21. **Thomas Stevenson** of Bucks Co., Pennsylvania, to **George Ryason** of Poquanick, Bergen Co.; **Paul Vandercook** of same place; **Symon Vandercook** of Horseneck, Essex Co.; **Michael Vandercook** of same place. 4 June 1713.

Page 24. **Thomas Stevenson** of Bucks Co., Pennsylvania, to **George Ryason** of Poquanick; **Paul Vandercook** of same; **Symon Vandercook** of Horseneck; **Michael Vandercook** of same. 3 June 1713.

Page 25. **Thomas Stevenson** of Bucks Co., Pennsylvania, to **Humphrey Davenport** of Newark, Essex Co. 1 June 1718.

Page 29. **Jacob Doughty** of Chesterford, Burlington Co., to **Zebulon Clayton** of Freehold, Monmouth Co. 14 May 1718.

Page 31. **Andries Bouttenhouse** of Burlington Co., to **Richard Comton**. 1 January 1711.

Page 33. **Joshua Wright and Rebecca his wife** of Burlington Co., to **Timothy Baker** of same place. 22 Nov 1707.

Page 35. **Jonathan Roberts** of Hopewell, to **Caleb Carmen** of same place. 21 January 1719/18 (*sic*).

Page 37. **William Coate** of Amwell, Hunterdon Co., to **William Cornwells** of Hopewell. 20 February 1728.

Page 42. **John Alsop and Abigail his wife** of Ulster Co., New York, to **Joseph Moon** of Newtown. 15 May 1727.

Page 46. **Robert Shaw and Elizabeth his wife** of Hopewell, to **Peter Berrien** of Newtown. 17 April 1727.

Page 49. **John Sackett** of Newtown, to **Joseph Moore** of Newtown. 5 November 1728.

Page 52. **Samuel Allen** of Hanover, Hunterdon Co., to **John Mott** of Middletown, Monmouth Co. 30 march 1726.

Page 55. **Samuel Coat** of Amwell, **oldest son to Samuel Coat late of the same place, yeoman, dec'd**, to **William Cornwall** of Hopewell. 23 September 1729

Page 57. 14 August 1729. **John Reading** of Amwell to **Henry Brochloess** of Pomton, Bergen Co. Mentions **John Reading father of above named John Reading late of Amwell, dec'd**.

Page 61 17 September 1728. **John Reading** of Amwell to **Johannes Miller** of Roughaguay River, Hunterdon Co. Land formerly of **Richard Bull**.

Page 64. 18 September 1728. **John Reading** of Amwell to **Johannes Miller** of Roughaway River, Hunterdon Co. Land surveyed for **Richard Bull**.

Page 71. **James Bollen** of the City of Philadelphia in Province of Pennsylvania, millwright, to **Samuel Allen, David Allen** both of Whippany alias Hanover, Hunterdon Co. 7 August 1722.

Page 74. 2 July 1725. **James Bollen** of Philadelphia to **Gershom Mott** of Middletown, Monmouth County in the Eastern Division of New Jersey **Junior, yeoman**. Mentions the will of **George Hutchison** formerly of West Jersey, afterward Philadelphia, merchant, since deceased, his will dated 29 April 1698, devised unto his daughter **Rachel**, but should she die before the age of marriage, then to be divided as said will specifies to each of his son **Samuel's children in England; his daughter Mary; daughter Martha; children already born and to beborn of daughter Elizabeth Peers (?)**. Mentions

**George Hutchison of London, merchant, grandson and heir at law to above mentioned George Hutchison.** Above named **Martha, then wife of said James Bollen.**

Page 80-81. **Joseph Bill** of Amwell appoints in his place his **trusty and loving wife Frances Bill** my lawful attorney. Mentions a lot in Trenton on Kings Street formerly in possession of **Nathaniel Roswell.**

Page 83. **Ralph Bunt/Hunt** and **John Bainbridge** of Maidenhead, by deed dated 13 October 1702 to **Richard Bunt/Hunt/Burt.** Mentions **Joseph Burt** with date 9 April 1723.

Page 85. **John Bainbridge, Samuel Coat, Thomas Curtis, Joshua Anderson, Andrew Smith, Nathaniel Leonard,** all freeholders of Hunterson County chosen to serve the townships of Maidenhead, Hopewell, Amwell, Trenton, received of **Capt. Ralph Hunt,** ninety pounds for the support of Government. 24 August 1723.

Page 85. 18 February 1720/21. **Samuel Hoffmire, Benjamin Hoffmire, William Hoffmire** all of Middletown, Monmouth Co., to **Charles Mott** of Hempstead, Queens County, on the Island of Nassau.
