"The Grand Jury brought in a seven to one against Nicholas BREWER of Rumbout Precinct for stopping up an Old Road and not making and mending the new Road which are left unpassable and dangerous. Ordered that the said Nicholas BREWER be fined in the sum of Ten Shillings and that he forthwith repair said road according to law and that he be served with a copy of this rule."
