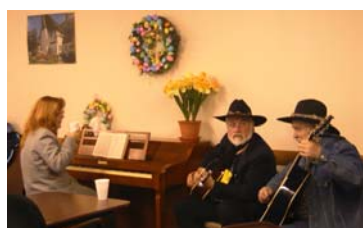

This day came the Plaintiff by her attorney and this cause is continued until next term and it appearing to the satisfaction of the Court that the Defendant is not a resident of this state, it is ordered that notice of the pendency of this libel be published in the Indiana Gazette printed at Corydon for four weeks successively and that the Defendant do appear here on the first day of the next term to answer the same or that things therein contained will be heard and determined in his absence.

Thomas Winters, assignee vs. John Kellar — Debt.

At this time came the parties by their attorneys and the Defendant filed his general demurrer to the Plaintiffs Declaration which is joined by the Plaintiff and after

argument the Plaintiff withdraws his joinder and has leave to amend his Declaration and this cause stands continued until next term — And thereupon came Archibald Sloan and surrendered the said Kellar into Court in discharge of his bail bond. Whereupon came David Wallace and acknowledged himself special bail for the said Defendant Kellar.

John Flanary, Sr. vs. John Flanary, Jr. — Foreign Attachment.

Continued until next term.

Milo R. Davis vs. Thomas N. Aubrey — Trover.

Continued by consent of Plaintiff and at his costs.

William Wilbur vs. Daniel Chapin — Appeal.

And now at this time came the Defendant by his counsel and on his motion this appeal is dismissed.

Samuel Moore vs. John S. Goodman —

At this time came the Plaintiff and this cause is dismissed at the Defendant's costs — It is therefore considered by the Court that the Plaintiff recover his costs from the Defendant.

S. M. and Z. Levenworth vs. William Amos — Debt.

At this time came the Defendant in his proper person and confessed a judgement for the sum of two hundred three dollars and ninety cents with interest thereon from the twenty fourth day of June 1820 until the seventh day of October 1820, to be credited by eighty dollars and fifty-five cents paid on the said seventh day of October 1820 and also for interest on the sum of one hundred twenty-three dollars and thirty-five cents, the balance remaining due after deducting the above credit until paid — It is therefore considered by the Court that the said Plaintiffs recover of the said Defendant the sum of one hundred twenty-three dollars and thirty-five cents together with seven dollars and fifty and three-fourths cents damages, making in all the sum of one hundred thirty dollars and fifty and three-fourths cents as also their costs by them about this suit in this behalf expended.

State of Indiana vs. Henry Barker — Motion for New Trial.

At this time came the Defendant by Dewey & Dunbar, his attorneys, and filed the following reasons for a new trial:

1. Verdict against the law
2. Verdict against evidence

And after argument had the motion for a new trial is sustained and this cause stands continued until next term. — Whereupon came the said Henry Barker and James Barker, John Samuels and Thomas Fleming and severally acknowledged themselves indebted to the State of Indiana for the

use of Crawford County to be rendered in the sum of five hundred dollars for Henry Barker and two hundred dollars each for the sureties, to be levied of their respective goods, chattels, lands and tenements if default be made on the condition under written which is that the said Henry Barker shall personally appear before the Court on the first day of the first term and then and there answer an Indictment now pending in said Court against him for perjury and not depart said Court without leave, then this recognizance to be void, else to remain in full force and virtue in law.

John T. Jamison, assignee vs. James Barker — Debt.

The rule for a new trial is made absolute and this cause is continued on affidavit filed at the Defendant costs and attachments are ordered against Richard French, Thomas C. Davis and John Dawson returnable to next term.

Moon & Nelson vs. Thos. N. Aubry — Domestic Attachment.

Continued by consent.

State of Indiana vs. John Stephenson — Jail Breaking.

On motion of the Prosecuting Attorney this cause is continued until next term. And now at this time came the said John Stephenson and Thomas Flemming and Daniel Weathers and severally acknowledged themselves indebted to the State of Indiana for the use of Crawford County to be rendered in the sum of one hundred dollars for John Stephenson and fifty dollars each for Flemming and Weathers, to be levied of their respective goods, chattels, lands and tenements if default be made on the condition under written which is that the said John Stephenson above bound, shall personally appear before the Court on tomorrow morning and then and there answer an Indictment now pending in said Court against him for jail breaking and not depart said Court without leave, then this recognizance to be void, else to remain in full force and virtue in law.

George Bentley vs. Allan D. Thom — Debt.

On this day came the Defendant in his proper person and confessed a judgement for the sum of four hundred dollars. District of Indiana on 28th day of March, 1821 personally appeared in open Court, being a Court of Record, the Circuit Court of Crawford County, State of Indiana, William Rowse, aged 54 years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provisions made by the Acts of Congress of the 18th of March, 1818 and the Act May, 1820 that he, the said William enlisted for the term of five years during the war on the _____ day _____ month in the year _____ in the State of Pennsylvania in the Company commanded by Captain John Hews in the Regiment commanded by Colonel James Marshall in the Line of the State of Pennsylvania in the Continental Establishment that he continued to serve in the said corps until one year or about one year expired, when he was discharged from said service in Washington in the State of Pennsylvania, that he has no other evidence now in his power of his said service, and in pursuance of the Act of the 14th of May, 1820, I do solemnly swear that I was a resident citizen of the United States on the 18th day of March, 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby to diminish it as to bring myself within the provisions of an Act of Congress entitled "An Act to Provide for Certain Persons Engaged in the Land and Manual Services of the United States in the Revolutionary War" passed on

the 18th day of March, 1818 and that I have not nor has any person in trust for me any property or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereunto annexed and by me subscribed, to-wit: Three cows, one horse, two sheep, fourteen hogs, household furniture to the amount of: two small beds, six pewter plates, two small iron pots, one ten-gallon kettle, four knives and forks, six cups and saucers, six spoons, 2 plows, two axes, one broad ax, three sets of chains, Haine and barb band for harness, two hoes, one sprouting hoe, two old wheels, one reel, one gun and one-half quarter section of land with only one payment made on it.

Biographies of Men of the 49th Indiana —

William H. Bullington

William H. Bullington, was born December 28, 1839 in Crawford County, Indiana to Daniel Bullington, and his wife Hattie (Lower) Bullington. William was 21 years old when he enrolled with the 49th at Camp Joe Holt on November 4, 1861. He is discribed as 5'6" tall, dark complexion, black hair and eyes, and was by occupation, a cooper. He continued with the 49th from November 1861, through March/April 1862, when he was listed as being sick at Lexington, Kentucky, until July/August 1862, when he was listed as being present through May/June 1863. He again was listed as being sick in May/June 1863, when again he was listed as being sick in the hospital, at Lexington. He was then discharged for disability June 26, 1863, at Black River Bridge, Mississippi, by reason of Chronic Diarrhea. Upon his discharge and return home, his occupation was that of a farmer. He continued having difficulty with his disorder for the remainder of his life.

William was married twice, his first wife, Anabell B Johnson, died December 20, 1878. they had six children; Harriet M (Bullock) born August 31, 1864
 Ida (Brown) born March 31, 1866
 Leonard T. born January 12, 1868
 Charles H. born December 26, 1870
 George P. born March 6, 1873
 William H. born January 15, 1878

After Anabell's death, William married Tabitha Williams (Sheckell?) on December 20, 1879, and together they had four children;

James A. born March 6, 1882
 Albert A. born July 20, 1884
 Elida E. born June 6, 1887
 Nellie N. (Yates) born September 13, 1889

William died July 17, 1921, and is buried at Flower Point Cemetery, Marengo, Crawford Co, Indiana.
