John R. McMickle, joined the 49th Indiana, Co. I, on the 20th of November, 1861, as a Private when he was 37 years old. He Served in the 49th until March 18, 1864, when he was transferred to the Veterans Reserve Corps. He was then reported to have died, April or May 1, 1864 of Chronic Diarrhea.

John was married to and divorced from Falitha J. Williams. Upon his death, his two children were placed under the Guardianship of William G. McMickle.

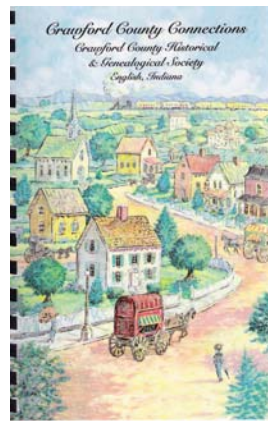
