This is what I have and it isn't much. Maybe we all can figure it out and update a lot of records:

I have that a Mary C. Stroud (14 October 1869-18 September 1898) married Cadmus C. Funk.

Cadmus was a son of Abraham Clark Funk, Reuben Funk, John Funk Sr, HENRY FUNK-Rev War solider)

I do not have Mary's parentage in our 2000 Funk Book, but I have a note later that her parents are Isom and Christina(? maiden name) Stroud...but don't have the source, so I am not sure....a note for me to research.

I have her buried at the Milltown Cemetery. I double checked this as she is not listed in the newest addition of Cemeteries of Whiskey Run. But I have older cemetery records from the city hall which has Mary Funk with the above dates. Mary Funk is also in another listing by Donald Condra. I may also have pictures of this. If I remember right, all three of them are together; he married a second time.

Cadmus and #1 Mary married 1890; marriage info is on file in Crawford County.

Mary and Cadmus had one child:

E. Hazel Funk (1890-1946, died in Lafayette Indiana). This is a male. He married Lydia Albright 1919. E. Hazel Funk and Lydia had one child, Dorothy Lou Funk, born 1920 m. Everett Burnworth.

After Mary's death, Cadmus married #2 Emma Jones in 1899. Emma Jones' dates are 1871-1951. Her parents???? But I'd like to know. They had one child: Rossen B. Funk.

I have not had time to update this line, and I'd appreciate more info.

About the relationships: If what you are looking for is of this line, it goes back to Henry Funk-Rev War solider. Arville Funk is not of this line.

Henry's brother, Jacob, who also came to S. Indiana and settled in Harrison Co, platted New Amsterdam (but he was not a Rev War solider) Arville Funk, lawyer and historian, is a direct descendant of this Jacob Funk.

Of course, Henry and Jacob have the same father, Henry Funk, Sr. of VA...who never came to Indiana. Henry and Jacob were the only sons in this family. There were some sisters, staying in VA.

At one time, descendants of Abraham Clark Funk were active in the Funk reunion: Reunion for descendants of Henry Funk-Rev War solider. We have been meeting since 1939, and there is a reunion coming up on Sunday, 28 June 2009 in New Albany at IUS. Email me if more info is

# Mary Ann Golden — Need Children Dear Becky

Evelyn Lasley said I should write you and see if you could help me with a Crawford County problem.

One of my relatives was a Mary Ann Golden (dau of Thomas L. Golden) b. ca 1823. She married a John William Kellems 5 Oct 1843 Crawford Co., Ind. It appears that she was still living in Nov. 1850 when her father wrote his will and she is mentioned. I had originally thought that she may have died by 13 Sep 1849 when John re-married to Sarah Jane Stewart...but this may be in error.

I have attached a Group Sheet for both families. I have been working on the Goldens of Crawford County for many years with very SLOW progress.

Hopefully, I would like to be able to validate my theory that Mary Ann Golden was the mother of one or two children.

The Nancy Ella Kellems would seem like a more possible child than Manerva...but Mary Ann Golden had a sister, Minerva, so I am looking at that also.

I am seeing conflicting information about Nancy Ella Kellems. One source shows that she is the daughter of a Wesley Kellems and Rebecca Jenkins and born in 1823 (this would make her a sister to John William Kellems).

Census records do support the marriage of Nancy E. to Lawrence McMahel, and they are found in Perry County in 1880. After Lawrence died in 1882, Nancy married James F. Campbell. When Nancy died in 1910, the Death Certificate lists her as Nancy Campbell. Parents listed as John McKellums and Gracey.

After a tedious and vexatious delay, the car containing the cans came Saturday and was placed on the spar at the factory. Several hundred gallons of blackberries were at the factory having been purchased with the expectancy of canning them soon. A few hands took hold of the work in the afternoon and over sixteen hundred cans were snugly sealed in a very short time. Many persons were present to witness the commencing of the new and much talked of enterprise. Every part of the factory worked all right, and it was conceded by all present that this new departure in industry was a grand opening for Marengo and the people around. A business is now established that invites the worthy and industrious people to come among us and engage in such work as will find a ready cash market almost at their door, and offers employment for those who may wish to earn an honest livelihood.

Re: John Dyer

I would like to learn more about my grt grt grandfather John DYER b. 1785 Washington or Montgomery Co., VA. Parents: Charles C. Dyer and Mary Hurst; married 24 Jan 1824 Harrison Co., IN to Lydia Shields of Crawford Co. In Marriage Records Bk 2 p. 142.

The Leavenworth "Arena" had a small article that reads: DIED in Union Township on the 9th instant Mr. Dyer," in the 22 Aug 1839 edition. This all the info I have on John DYER except for his family of seven (7) children with Lydia Shields Dyer. There is a record of the birth of a son to her Feb 1840 and a record of marriage of Lydia Dyer to John BUTT on 5 Apr 1840 Crawford Co. IN. Census records of 1840, 50 & 1860 also show the combination of the Lydia Dyer and John Butt families.

My purpose of this inquiry are strictly for genealogical reasons. Would like to find a death certificate for John Dyer to verify death date also his parents names, wife's name and a **possible death date for Lydia Shields Dyer Butt** although there is a Tax Assessment of Sept/Dec in Indiana 1862-1918 Jan/Mar 1863, May 1865, 1866.

I do not expect any research to be free so if someone could help me— please send me an estimate of time possibly involved and cost. Reply either my e-mail or snail mail would be appreciated.
