Larry;

I am happy to report that I have found the death dates of Chesterfield and Cynthia VanMeter Weathers for Mary McCalmont in Las Cruces, NM. She had called leaving a message before we arrived home, telling me that this was the only piece of evidence that she needed for her DAR application.

Today, I called the Health Dept. about the d/c and they told me again that the deaths were not reported until 1899 in Crawford County. I went to the cemetery burials in the Marengo Cemetery and Cynthia's is not listed but Chesterfield's was.

Edith was at the Archives and she suggested we look in her "church rolls book" and there was Cynthia's death reported as being 06 JAN 1886 (pg. #98). Conclusion: Cynthia is in an unmarked grave beside her husband. Then I checked for Chesterfield and his was listed (pg. 101) as dying 15 MAR 1893. So the only documentation available of their death was the book that Edith had typed. So this is a good argument for getting this in print and Edith says there is no reason why we can't. She is going to write you a letter stating so and with some suggestions. I left you a note at the Archives but I just now talked to the lady and she is so excited and I had to share this with you. —ej

## Publisher's Note:

The book mentioned above is one that Edith Key and other DAR members from Orange and Crawford Counties published back in 1972 for the records of the DAR organization. The manuscript was type-written and placed in a book. The book had no copyright notice on it.

Edith passed the document to me and asked if I was interested in printing it. I took the document home and completely typeset the book into Adobe Pagemaker and printed it out and spiral-bound it. As suggested by Edith, I removed any and all references to the DAR and offer it only as a reference for

genealogy research in Crawford and Orange counties. The book contains some 145 pages and gives membership rolls of the early 1800's from the Valeene "Bluff Creek" Church, the Marengo "Big Springs" Church, the Goodman Ridge Church and some others from other counties, all members of the Church of Christ. The book also contains the early minutes of the Indiana Christian Conference from 1817-1830's. These minutes are the earliest known of the church known as: Campbellites, Disciples of Christ, and simply Christian Church. The Crawford County Historical & Genealogical Society has this book for sale, price \$30.00.

## OBITUARY - Rev. and Mrs. J. E. Crecelius

[*Crawford County Democrat*, 08-06-1936]

(found May, 2003 by E. H. Jackson)

Marengo - Joint funeral services for the Rev. Jerry E. Crecelius and his wife, Mrs. Lottie Crecelius, were held Tuesday at 2:00 P.M. at the Murphey House in Marengo, with Rev. L. Cort Murr, of Indianapolis, former pastor of the Marengo and Milltown Methodist Churches, officiating. United and congenial companions during 66 years of married life, they were laid side by side in the family lot in Marengo Cemetery.

The Rev. Jerry E. Crecelius was born in Crawford County on November 19, 1848 and died at Marengo, August 1, 1936, age 87 years, 8 months and 12 days. He was the son of Jacob

and Lucy Crecelius, who with his brothers preceded him in death.

Mrs. Crecelius was born in Crawford County, June 27, 1852 and died August 2, 1936, about 33 hours after her husband, aged 84 years, 1 month and 5 days.

They were married on October 27, 1870. To this union 11 children were born, five of whom have preceded them in death; Rosie, Minnie, Zona, Elmer and Emery.

Mr. Crecelius had been in feeble health for several years and seriously ill for several months, during which he was tenderly cared for by his devoted wife. She was taken seriously ill three weeks ago and from the first her life was de-

spaired of. Saturday morning, August 1, at 2 o'clock the husband passed. His wife, who was never conscious of his death, survived until Sunday, August 2, at 11:50 a.m., when she followed her husband to the celestial city. During his illness Mr. Crecelius often expressed the wish that he might die and his wife heard to say that she did not care to survive him.

They were members of the United Brethren church. The Rev. Mr. Crecelius was a minister of that church, and spent many years of his early life preaching at the different churches of the county. He never accepted an appointment from his church, but gave what time he could in evangelistic services and accomplished much good, as many still living can testify. He was a fine singer of old hymns and was in great demand at revivals held by other ministers, whom he assisted, among them, the Rev. Murr, who officiated at his funeral. He and his wife lived on a farm near Marengo, but being unable to work they came to Marengo a few years ago.

Surviving them are three daughters; Mrs. J. F. Hannum of Bristol, Tennessee; Mrs. V. E. Funk, of Indianapolis; Mrs. Lora White of Marengo; three sons; Robert Crecelius of Marengo; Mitchell Crecelius of Nashville, Tennessee; and Charles W. Crecelius of Lexington, Kentucky, and several grandchildren and great-grandchildren.

Surprises of surprises!!

Adam T. Rankin was buried in the Cap Anderson Cemetery in Meade County which is the "city" cemetery in Brandenburg.

I had contacted the Library there and the gal that answered just now called me and they are really elated that after all this time that the stone was found and "coming home". Their explanation was that the cemetery was damaged so badly in the 70's by the tornado and a lot of the stones have yet never been found.

They believe that this was one that was picked up by the tornado and probably deposited somewhere in Indiana; possibly Crawford and then just kept because of not knowing where it came from. Through my research I found where he was alive in the 1870 census and then he died in 1876 according to the stone and what the library has told me by phone. They are to meet with Hugh and I tomorrow at 12:00 at the research library at Corydon to pick it up. We will take pictures before we give it up. I took talcum powder and sprinkled it on the stone to bring out the lettering and then started researching.

The Meade County Library has already contacted a monument dealer there to reset the stone....all this since 10:00 this morning. They are to bring me copies of the documentation to prove that is where it belongs and I will share it with Larry as it certainly makes an interesting story. —ej

Census records of 1840, 59 & 1860 also show the combination of the Lydia Dyer and John Butt families.

My purpose of this inquiry are strictly for genealogical reasons. Would like to find a death certificate for John Dyer to verify death date also his parents names, wife's name and a possible death date for Lydia Shields Dyer Butt although there is a Tax Assessment of Sept/Dec in In 1862-1918 Jan/Mar 1863, May 1865, 1866. ## Temple Name Found in History of St. Joseph Co., IN

**William L. Temple.** Mr. Temple is truly a self-made man, and from the study of his life one may learn valuable lessons. Depending upon his own resources from the early age of eleven years, he has by sheer force of will and untiring effort worked his way upward until he now occupies a leading place among the businessmen of South Bend, for as president of the Temple & Shaw Cigar Manufacturing Company, he is well and favorably known. He traces his ancestry to the mother country of England, the birthplace of his great-grandfather, while his grandfather, **Caleb Temple**, was a native of the commonwealth which cradled so much of our national history, the Old Dominion of Virginia. His son and the father of him whose name introduces this review, **William L. Temple Sr.**, was a native of Crawford County, Indiana, where he was well-known as a merchant and leading politician, and for a number of years he held the position of county clerk. His death occurred when he had reached the age of seventy-five years. He was united in marriage to **Martha Landers** [Jan. 4, 1838], a native of Georgia, and in their family were ten children, nine daughters and one son. William L. Temple Jr., the only son, and the youngest child of the family, is also a native of Crawford County where he was born on the fifteenth day of January, 1858, and there he was reared and received his limited educational training. At the early age of eleven years he started out alone to battle with the world, for three years working in the county treasurer's office. On the expiration of that period he came west to Lincoln, Nebraska, where at the early age of fourteen he became a guard in the penitentiary, remaining there for two years, and at the end of that time he was serving as the warden's private secretary. Returning thence to Leavenworth, Indiana, he became deputy clerk of Crawford County and on the expiration of his four year term in that position, he was elected county auditor being then but twenty-one and the youngest county official in the entire state of Indiana. Despite his years, however, the duties of the office were discharged with a promptness and fidelity worthy of all commendation for four years, and at its close he entered upon the duties of a travelling salesman, thus continuing for the long period of twenty-one years, and during that time he traveled throughout every state in the Union selling cigars. It was in the year 1891 that he came to South Bend and organized the firm of Temple, Hummel & Ellis Cigar Manufacturing Company which later became Temple & Ellis and subsequently the present firm of Temple & Shaw, one of the largest cigar manufacturing firms in this section of the state, their plant being located at 301 S. Carroll street. They began their business with 30 employees and now employ 350. (page 775)
