that I John Barritt of the District and State of South Carolina in Conveyance of these Heretofore and fifty dollars to me paid by Alexander Gilliland of the District & State of South Carolina have granted & bargain sold and released and by these presents do grant bargain sell and release unto the said Alexander Gilliland all that Tract or parcel of Land containing One Acre or thereabouts be the same more or less situated in Anderson District on the Branch of Saddle Creek near the mouth of Saddle River it being part of three original grants viz part of a Tract originally conveyed to John Barritt for 500 acres on the 15th Sept 1793 by the Family of S and granted to the said John Barritt on the 1st December 1794 and a small part of which was originally surveyed for Jacob Brazetton and a part of which was originally surveyed for William Stephenson the 27th of January 1786 bounded by Land now belonging to James Mob also to me Rush Edmund Hacker and Mrs Sedwitt Land for a more full description of the said premises reference may be had to a plat of a Survey of the same made by James Gilmer of South Carolina the 16th March 1837 Together with all and singular the rights appurtenances thereto and appurtenances to the same belonging or in anywise incident or appurtenances to have and to have all and singular the premises above mentioned unto the said Alexander Gilliland his heirs and assigns forever and I do hereby bind myself my heirs Executors & Administrators to warrant and forever defend all and singular the said premises unto the said Alexander Gilliland his heirs and assigns against myself and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof Witness my hand and Seal this 21st December Eighteen Hundred and thirty seven and in the sixty first year of the independence of the United States of America signed sealed & delivered in the presence of John Barritt Esq of Hosea Miller

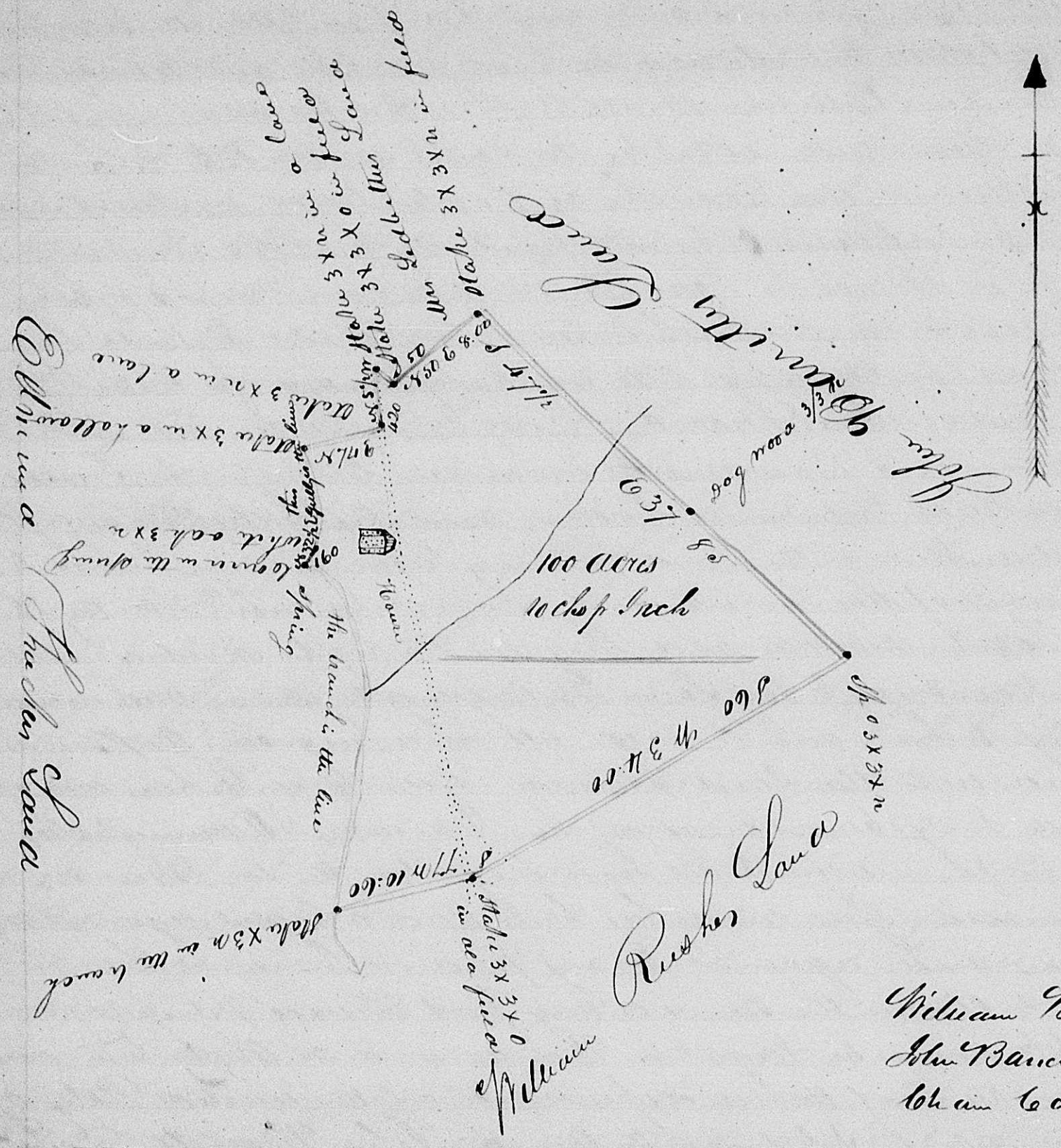
