Enclosed for processing is completed VA form 40-1330 to apply for a government headstone for Captain Haile Talbot who served in the Revolutionary War as Captain of the Bedford County Virginia Militia. Captain Talbot moved to Missouri in 1809, and died in this state in 1828.

Enclosed as documentation of this service is the veteran's name in the reference "Historical Register of Virginians in the Revolution," (Gathmey 1938) where it is shown that the veteran attained the rank of Captain of the Bedford Militia on August 28, 1780.

As additional documentation, information from the NSDAR is provided to document this service. The enclosed lineage book (1907) from NSDAR shows on page 263 that Haile Talbot was Captain in command of the Bedford County, Virginia Militia during the Revolutionary War. Also, the veteran's name is included in the DAR reference "A Compilation of Revolutionary Service Records of Veterans buried in the State of Missouri," by Houts (1966). The Houts reference also is verification of the dates of birth and death contained in the enclosed application.

To my knowledge, this veteran never received any bounty land or pension for this service. Your assistance in this matter is most appreciated. If I can be of further assistance, please contact me.
