Dear Bernice:

I again find myself looking forward, not only to receiving your letters, but in writing to you. In many ways you have become my confessor regarding my journalistic shortcomings as well as the hidden hand that motivates. Without your being particularly aware of it you have done an awful lot for me in many ways. In fact, I never intended to write the damn story in the first place. It was an accident. I began to write a story of a later period and was so naive that I believed I needed some sort of pre-introduction. This led me into "Rails North" which so absorbed my interest that I couldn't seem to let it go.

By now you may be (but I don't believe it) quite bored with the whole matter; still I must take the time to answer your remarks of 9 Dec 66 which were very enlightening.

- 1. The Poker Game: I see your point of 8 pages and will figure out how to simplify it although not right away. This hurt a little as I love poker and enjoyed writing the story. Men (poker players) however, seem to like it but dyed-in-the-wool players are not numerous and your point is well taken.
- 2. Blue Cafe (and the paragraphs concerning boxing in schools): It may be that on international issues you are a "Dove" whereas I am obviously a "Hawk". If so, we need more doves - as well as more hawks! What kind of nonsense is this I'm saying? Anyway, I had presumed it was necessary to toss in the Blue Cafe episode as an indirect method of developing the thoughts and personality of the two main characters. I conceed that you are correct about the boxing-in-school and Infantry bit as it becomes obvious that the author has either an axe to grind or is attempting to directly influence the reader. In many cases it may violate their personal belief. I'll scratch this before publishing.
- 3. The Ball Game: The author's ego sticks out here like a sore thumb. Teenagers, however, seem to go for it. It also fits because not only did it happen this way but it affords the natural reaction after the courtroom anxiety. So here you lose.
- 4. The Hoop: I realize that the detailed description belongs in the story much earlier. The trouble is, the Boy had not evolved his thorough knowledge of the hoop until this period and was in the process of testing its advantages and variations. You will note that I have tried to keep pace with the Boy's mental growth in many ways. To describe it earlier would be to incorporate improvements he had not yet learned. I think now I'm just being stubborn. I'll check this out with the publisher.

I appreciated your comments on the likeable portions. As a result I have further reedited most of the first book and provided a scattering of phrases along this line.
You were the first to particularly comment on the Odie Beal portion, the buzzard, the
man with the boils or to catch the remark about the Indians (remind me sometime to
write about Indian matters.)

Amazing how long it has taken to gather helpful comments from people even when they are very interested. A week ago I sat for 2 hours with 2 male friends who took it apart with me. Their conclusions may be interesting to you:

- 1. The technique of seeing Jess thru the boxers eyes (Bucky) was approved. Use the same technique thru the eyes of the Grizzly. (This I have since done and enjoyed.)
- 2. Develope the future plans of the Boy while riding home in the last chapter and more of his conclusions (since done).
- 3. Develope the Boys affair with the prostitute in Missoula regarding his reaction (since done I believe tastefully).
- 4. Explain why he never carried a canteen (since done on page 38).
- 5. How do Hobos ride rods? (Since explained on page 140).
- 6. Why was the Ghost Town in such good condition? (Since explained on page 87A).
- 7. Develope more of Old Al's character and explain his impasse with Boy (don't know that I should).
- 8. Tag Jess earlier as being No. 1 Buddy (can do more here).
- 9. Why Boy felt so strongly about his film when crossing the desert? (Sime explained).
- 10. Look at Boy thru Al's eyes somewhere (I'm afraid to.)
- 11. Why strikers assumed Boy was a scab when in San Francisco (I thought it was obvious.)
- 12. Lack of interest (by one man) in Boys thoughts on Trinity Peak. (I'm running scared on this comment. What do you think?)
- 13. Reference to Boy on first page of Introduction leaves the reader wondering who he is. It was also recommended that I delete the "Heavy stuff". (Don't know what to do.)

I should have dedicated this book to you. Please use the stamps enclosed to return the volumes. I'll refit them with the new pages and send them back to you - to keep, I hope, once and for all. I am sure that you will be far more pleased with it. I have improved most of the pages from 60 to 184.

Regarding Oklahoma Press, I requested them last week to return the manuscript for correction and advised that I intend to re-submit. Haven't submitted to any other University.

This re-write and assembly is tedious but I must do it before I get into the next story. You say you won't dig me on this point anymore but if you don't no one else will as you are my No. 1 confidant in that matter.

Now you can go back to your research. Please let me help you here wherever possible. I wasn't a brain in school but did learn a few things since.
