CORRESPONDENCE BETWEEN GLENN MAGILL AND JACK & BERNICE MCGEE

To put things in somewhat of a time frame, the McGees had written their article "Invitation to a Ghost Walk" that appeared in the April, 1966 issue of <u>True West</u> magazine. The article involved Clarence Mitchell's interpretation of the Peralta Stone Maps. Glenn Magill on the other hand had filed on the Lost Dutchman Mine in May of 1966.

A Mrs. Bilbrey, of Frederick, Oklahoma, was in touch with both Magill and McGee and she was pushing them to contact each other. It's not clear what she hoped to gain but eventually they got together. The subject largely involved the stone maps. There were notes taken from telephone calls, a couple of letters from the McGees that they saved copies of and the letters from Magill.

The McGees had their article "Are Peralta Stone Maps A Hoax?" published in April – May 1973 in <u>Frontier Times</u> magazine. They were moving on to other projects and this was about the end of their involvement with the Superstition Mountains. You will see that they had already become disenchanted with the authenticity of the stone maps by the time they became involved with Magill.

I have included all of the available correspondence in the format in which I received it. It is in chronological order.

It's sometimes hard to follow the content and it is helpful to have a handle on the time frame and the subject. Even then some of it may prove difficult. The notes for the telephone conversations are particularly difficult for me. In the main, the letters reflect only one side of the conversation. There were two letters from the McGees to Magill that survive and they were copied via the old carbon copy technique and they may prove difficult to read on your computer screen.

I hope you enjoy them and can possibly make use of them in your own research.

AUGUST, 29, 1966

MR. CLENN MACILL CALLED AT 12:05 PPM. FROM OKLAHOMA CITY, OKLAHOMA WE SPOKE FOR ONE HOUR, AND THESE NOTES WERE TAKEN:

MR. MAGILL APOLOGISED IF WE THO GHT OUR FIRST CONVERSATION HAD BEEN FORCED ON HIM BY MRS. BILEREY. HE SAID HE HAD BEEN WANTING A CHANCE TO TAKK TO US, AND THIS WAS USED FOR AS AN EXCUSE.

HE STILL WANTS TO TALK WITH MARIOWE. THE FINDING OF THE DUTCHMAN IS AN HISTORICAL EVENT AND THE NEWS HAS RICOTCHETED AROUND THE WORLD. HE HAS HAD TELEPHONE CALIS EVEN FROM OLD MEXICO. HE KNOWS THE EXPERIENCES MARLOWE HAS HAD SINCE HIS NOTERIETY. MAGILI SAID THAT HE DID NOT WANT THE PUBLICITY BUT THE NEWS BROKE PREMATURELY, AND EXPLAINED HOW IT HAPPENED.

MAGILLS BROTHER IS A CITY POLICE OFFICER, WHO HAS WORKED CLOSELY WITH HIS BROTHER ON THIS THING BUT WHO HAS NOT BEEN TO THE MOUNTAINS. HE TOLD HIS WIFE ABOUT IT.

SHE WORKD FOR A NEWSPAPER IN OKIAHOME CITY, AND IN TURN TOLD A CUB REPORTER ABOUT IT. THE CUB REPORTER WENT TO SHE MR. MAGILL AND OVERHEARD CONVERSATIONS WHICH WERE COMING AT A FAST RATE OF SPEED OVER THE TELEPHONE, THEREFORE WAS ABLE TO PIECE MUCH OF THE STORY TOGETHER. THE BOY WROTE THE STORY AND IT A PEARED WITHOUT MAGILL'S KNOWLEDGE. THE PUBLISHER APOLOGISED AND FIRED THE CUB REPORTER. THE OTHER PAPER WAS MAD AT MAGILL. EVEN THOUGH HIS WITE'S BEOTHER WORKS FOR THE PAPER THAT GAVE OUT THE STORY, MANY OF MAGILL'S FRIENDS WORK ON THE COMPETITING NEWSPAPER.

WHEN MAGILL FIRST SAW THE LIFE STORY. HE THOUGHT MR. MATLOWE WAS INCOMPETANT FROM WHAT HE READ. LATER HE SAW MR. MARLOWE'S BOOK, AND SAW THE OTHER MAPS FOR THE FIRST TIME. HE TRIED TO WORK FROM THE LIFE MAGAZINE WAPS, AND WOULD EVEN GET UP IN THE NIGHT TO STUDY THEM. LATER ON HE SAW MARLOWE'S THOUGHTS PARALLED WITH HIS OWN, AND BEGAN TO SEE THE IMPORTANCE OF THE MAPS. HE DISAGREE'S THAT THERE ARE IS MINES AS STATED IN THE MARLOWE STORY WE WROTE. HE SAYS THERE WAS ONLY ONE?

HE HAS THE ABBERT MAPS OF ADOLPH RUTH.

RUTH, SON OF ADOLPH RUTH.

ERWIN RUTH IS NOW 75 YRS. OLD, THE SAME AGE HIS FATHER

WAS WHEN MURDERED IN THE SUPERSTITI) NS. HE CALLS THEN THE GONZALES MAPS, OF WHICH

THERE ARE FOUR IN NUMBER. SAYS HE HAS A PERAITA MAP OF 1912, ALSO. HE HAS THE

TRUE STORY OF ADOLPH RUTH. HE CONFIRMED THE REPORT RUTH'S SON HAD THE MAPS PRINTED

IN THE PHOENIX PAPERS AS REVENGE FOR HIS FATHERS DEATH. THEY WOULD DO THE MURDERERS

NO GOOD ONCE MADE PUBLIC. MAGILL SAID THEY WERE NOT PRINTED IN THEIR ENTIRETY

AND WERE NOT EXACTLY THE SAME AS HE NOW HAS. SAID MANY OLD WOULN DS WERE OPENED UP

WHEN HE TALKED TO ERWIN RUTH, , RUTH HAD MANY MEMORIES REVIVED AND HE STILL FEELS

RESPONSIBLE FOR SENDING HIS FATHER TO HIS DEATH, AS HE WAS THE ONE WHO OBTAINED MAES

IN THE FIRST PLACE. DR. RUTH IS SOMEWHAT BITTER AGAINST BARRY STORM FRO PRINTING

WHAT HE DID IN HIS BOOK. IT WAS DONE WITHOUT RUTH'S PERMISSION. HE SAW STORM ONCE

OR TWICE, TALKED BY TELEPHONE, AND HAD WRITTEN LETTERS. THEN THE BOOK CAME OUT.

HE IS VERY BITTER TOWARDS STORM. (SEEMS STORM IS RATHER AN EGOTIST AND NOT LIKED

AT FIRST SIGHT.)

MACILL ALSO WANTED TO STRAIGHTEN OUT A MISUNDERSTANDING FROM OUR LETTER TO HIM.

HE WANTED TO CLARIFY THAT HE DID NOT MEAN THE PERALTA'S NEVER HANDLED THE MAPS.

HE IS CERTAIN THEY USED THEM. EVEN THOUGH THEY AEE JESUIT MAPS...HE WANTS TO

MAKE SURE WE UNDERSTAND THE PERALTA'S DID HANDLE THEM. M

DR. RUTH IS VERY SUSPICIOUS OF EVERYONE. HE EVEN HAD TWO MEN WHO CALIMED TO BE

FROM THE SHERRIF'S OFFICE, AT TIME OF FATHERS DEATH WHO WANTED TO KEEP THE MAPS AS EVIDENCE, AS MR. RUTH HAD TO BE AWAY FROM ARIZONA. SEEMS HE THOUGHT THEY ONLY WANTED TO HAVE THE MAPS IN THEIR POCESSION FOR MERCINERY REASONS. DR. RUTH HAS BEEN BADGERED TO DEATH ABOUT THE MAPS. EVEN BARRY GOLDWATER HAS SEARCHED FOR THE LOST DUTCHMAN.

(AFTER FITTEEN MINUTES OF CONVERSATION I WAS ASKED TO HOLD THE LINE, WHEN HE RETURNED, HE SAID THERE WAS SOMEONE AT THE DOOR. I HAVE BEEN WARNED ABOUT PEOPLE TAPING CALLS. AND IT MOMENTARILY CROSSED MY MIND. AM GETTING AS JUMPY WS A REAL TREASURE HUNTER. DO NOT LIKE TO FFEL SUSPICIOUS... IS A NEW SENSATION, AND I DON'T LIKE IT.)

HE SAYS AGAIN THE STONE MAPS WERE MADE BY SIMPLE PEOPLE WITH SIMPLE WAYS, PEOPLE WHO DID NOT HAVE MODERN TOOLS, AND PEOPLE WHO HAD A LOT OF LEISURE TIME. (JESUITS) THE PERALTA'S WERE IN A HURRY. WERE MINING MEN AND BUSINESS MEN. MADE THE SET OF MAPS HE HAS, AND THEY SHOW ALL BUSINESS BY BLOOD AND GUTS MINERS. NOT MADE PERALTA'S (STONE MAPS) BUT WERE CARVED WITH ETHERIAL MEANING OF THE MOST RELIGIOS SENSE.

IN HIS MANY TALKS WITH JESUITS PRIESTS, HE HAS LEARNED KIND GOT INTO TROUBLE BY STRAYING OUT OF HIS PIMERIA ALTA, WHERE HE WAS TO HAVE STAYED ... WITHIN THE LIMITS OF THE MISSIONS IN HIS KEEPING. THE MODERN JESUITS SAY HE WAS A MISCHETVIOUS, CURIOUS, EXPLORING MAN. HAD MADE THE LONG JOURNEY TO SEE CASA GRADE, EVEN THOUGH HE SHOULDN'T HAVE. FATHER KINO HAD HEARD OF THE "CASA GRANDE" OF AN ANCIENT CULTURE, AND MADE THE LONG JOURNEY TO SEE IT. MAGILL SAID TO READ THE "REALM OF CHRISTIANDOM" WHICH TELLS OF KINO'S HEARING OF CIBOLA AND OF FOUR CITIES OF AN ANCIENT CULTURE WITHIN THE SUPERSTITIONS. SAID THE EXPLORERS ALWAYS SKIRTED THE SUPERSTITIONS ON THEIR WAY TO KANSAS OR COLORADE. (MARCOS DE NIZA AND OTHERES) WHY DID FATHER KIND NAME THE GILA RIVER HILD ON HIS MAPS ? IN HIS OWN TONGUE GILA WOULD HAVE SPELLED AND BEEN PRONOINCED HE LA AS IT IS NOW. WHY DID HE CALL IT HILO? FATHER KINO NAMED THE SALADO RIVER ALSO. HOW COULD HE HAVE NAMED IT WITHOUT SEEING IT????? HE WAS NOT SUPPOSED TO HAVE CROSSED NORTH OF THE GILA, AS THIS WAS FRENCH TERRITORY, NOT OF SPAIN. THEREFORE FATHER KINO DID SEE THE SUPERSTITIONS, AND WAS THOUGHT TO CONVERTING OR VISITING THE APACHES. IT WAS DRUING THIS TIME HE COULD HAVE SEEN THE TREASURES AND THE ANCIENT DITIES. HE USED TO VANISH INTO THE MOUNTAINS AT THE MOUTH OF THE GILA. (?) DID HE MEAN SALT RIVER, RIO SALADO?) THE MOUTH OF THE GILA WOULD BE AT YUMA. BUT HE DID GET INTO TROUBLE WITH CHURCH FOR GOING OUT OF HIS JURISDICTION OF TERRITORY. (SUPERSTITIONS) HE SAID FATHER KINO KNELT AT THE SHRINE PRAYING ... IT WAS HIS TITH HOUR AND HE KNEW IT. THIS WAS JUST BEFORE THE EXPULSION OF THE JESUITS PRIESTS. HE BURIED CHURCH VASES, ETC. MUST SPEAK OF THIS IN "REALMOF CHRISTIANDOM". WAS HE PRAYING FOR ATONEMENT OF HIS PREMISCIOUS TRIPS INTO THE MOUNTAINS NORTH OF THE GILA, OR BECAUSE OF SEEING THE HANDWRITING ON THE WALL TOWARD THE JESUIT EXPILSION. (MAGIL SAID BURIED VASE'S IN A CAVE) KINO BURIED THEM THERE.

THERE WERE 18 MISSIONS FROM KINO'S JURISDICTION (DELORES, NORTHWARD TO THE GILA)

AND FOUR MISSIONS OR CITIES IN THE SUPERSTITIONS. (YO VOY 18 LUGARES)

SAID THE PERALTAS NEEDED NO COMPASSES. (?) THEY TYPE OF THAT PERIOD WAS VERY CUMB*

ERSUME. THE 8-N-P AS TRANSLATED BY MARLOWE IS INCORREST ACCORDING TO MAGILL.

P IS NOT THE WORD FOR PACES. THERE IS NO SPANISH WORD FOR PACE BEGINNING WITH THE

LETTER P. MAGILL'S WIFE IS SPANISH AND A CATHOLIC. P STANDS FOR PADRE. * 8-NORTH

OF PADRE" IS MAGILLS TRANSLATION. (PADRE BEING THE PRIEST ON STONE MAPS) SAYS

HE DOESN'T KNOW HOW JACK FOUND THE SECOND MAP BY STEPPING OFF 8 PACES. WAS IMPOSSIBLE.

SAYS THE PERALTAS DID NOT LEAVE THE CACTUS MARKERS.

FAMILY INTO THE DANGEROUS HELL*HOLE OF THE SUPERSTITIONS, DANGEROUS WITH IN DIANS,

ETC.? MOST MARKERS ARE ONLY COINCIDENTAL....! (?) PERALTAS KNEW CACTUS DIED, WERE

AFIRE WITH LIGHTENING OR SEASONAL BRUSH FIRES. TOO EASILY DESTROYED FOR PERMANANT

MARKERS. (THEY DIDN'T KNOW THEY WERE GOING TO DIE, AND HOW LONG IT WOULD TAKE

FOR FAMILY TO KNOW WHAT HAPPENED TO THEM .ARGUMENT.)

I ASKED MAGILL WHY HE KEPT COMING BACK TO APISPE IN THE CONVERATION. HE SAID IT IS DOCUMENTED FACE THAT THE PERALTA'S HEADQUARTRED IN ARISPE. BUT HAD HOMES ALL OVER SONORA, CHIHUAHUA AND MEXICO CITY. THEUR BUSINESS WAS WELL SCATTERED OVER MEXICO. HE HAS SPOKEN WITH PERALTA RELATIVES IN MEXICO CITY. DIDN'T KNOW WHY TREASURE HUNTERS THOUGHT PE ALTAS WERE SO HARD TO FIND. HE FOUND THEM WITH RELATIVE EASE. THEY DO NOT LIKE TO TALK ABOUT THEIR FAMILY MUCH, BUT THIS IS UNDERSTANDABLE.

CERON IMO HATED MEXICANS BEYOND BELIEF. HIS ENTIRE FAMILY WAS KILLED BY MEXICANS.
AT ARISPE. EVEN WHEN IMPRISONED, GERON IMO SAID THE THING HE REGRETTED MOST WAS
THAT HE WOULD NOT BE ABLE TO KELL MORE MEXICANS. READING BARRETT'S BOOK "GERON IMO"
WILL ONLY ENLIGHTEN US AS TO THE THINKING OF THE APACHE IN THOSE DAYS...NOTHING
ABOUT PERALTA'S OT TREASURE.

CHARLIE IS MAGILLS PARTNER AND A VERY CAPABLE PILOT WHICH HE HAS TO BE FOR FLYING OVER THE SUPERSTITIONS. THE MOUNTAINS ARE DANGEROUS WITH DOWN DRAFTS, AND HIGH POCKY PEAKS. CHARLIE HAS TAKEN ALL THE AERIAL PHOT('S WHICH MAGILL SAYS ARE EXCELLENT. THEY HAVE 400 SLIDES TO PROVE WHAT THEY SAY.

SAID HE WAS NOT TRYING TO BE SMART OR TO SAY "HA HA WE'VE FOUND IT AND YOU HAVEN'T"

JUST FACT AND KNOW THEY ARE CORRECT. TWO OLD PROSPECTOR'S CAME INTO THEIR CAMP,

AND WHEN TOLD THEY HAD FOUND THE DUTCHMAN, THE PROSPECTOR'S SRATCHED THEIR HEADS,

LOOKED AROUND AT OPERATIONS AND SAID, "YEP, YOU FOUND IT" BUT WHEN READY TO LEAVE

SAID THEY HAD TO GET BACK TO WORK...LOOKING FOT THE DUTCHMAN MINE. HA. IS A TYPICAL

EXAMPLE OF HOW PEOPLE DO NOT WANT TO BELIEVE, AND NEVER WILL GIVE UP LOOKING.

MAGILL BECAME INTERESTED IN DUTCHMAN AND REALLY SET OUT TO DISPROVE THERE WAS A MAN CALLED DUTCHMAN AS WELL AS DIPROVING THE MINE EXISTED. THE MORE HE INVESTI*
CATED THE MORE HE BECAME INTERESTED AND THE MORE THINGS HE FOUND THE MORE HE
BECAME INTERESTED.

HE ALSO SAID ABOUT CACTUS MARKERS BEING TOO FLIMSY A TRAIL HAD THE PERALTAS MADE THEM FOR FUTURE FAMILY EXPEDITIONS. ONE DOWNED CACTUS AND THE TRAIL WAS BROKEN. THE CHAIN OF MARKERS WOULD BE LOST. AN AWFUL LOT OF WORK TO LAY OUT SUCH A TRAIL AND USE SOMETHING THST WOULD EVENTUALLY DETERIORRATE.

HE SAYS MARLOWE IS WRONG ABOUT HORSE MAP TOO. HE FEFLS MARLOWE REALLY BELIEVES
IT, BUT THIS IS THE INVESTIGATOR SPEAKING...TRAINING FROM LONG EXPERIENCE...SAME
AS TRACKING DOWN A MISSING PERSON. SAME PROCEDURE. (IN THE CASE OF TRACKING
DOWN THE LOST DUTCHMAN, WALZER.)

ELEPHANT BUTTE DIDN'T HAVE THE NAME SEEN IN THE DAYS OF PERALTA'S. (BUT IT STILL LOOKED LIKE AN ELEPHANT. ARGUMENT.) NOONE COULD MISTAKE IT AND CALL IT ANYTHING EISE. ONCE SEEN) MAGILL HAS FOLLOWED US IN STORY OF GHOSTWALK VERY CAREFULLY AND SAID IT DID HIM SOME GOOD IDEAS THAT REALLY WERE WORTH THINKING ABOUT, BUT THE ELEPHANT BUTTE IS WRONG AS TRANSLATED BY MARLOWE. (HE HAD NEVER HEARD OF OR SEEN ELEPHANT BUTTE ON THE TRAIL UP FROM CHIHUAHUA TO SANTA FE NEW MEXICO.)

COULD BE WHERE THE PERALTA'S COT THE IDEA. SANTE FE WAS A PROMINABT PLACE IN NEW SPAIN...AND PEDRO PERALTA WAS IT'S FIRST GOVERNOR, SO ASSUME FAMILY MENBERS HAD SEEN THIS ELEPHANT BUTTE ON THE COLORADO RIVER WHILE TRAVELING FROM SONDRA OR CHIHUAHUA TO SANTA FE, NEW MEXICO.

MACILL SAYS IT IS EL CABALLO (THE HORSE) DE (OF THE, OR ON TOP OF) SANTE FE (SAINT OF FAITH) "THE HORSE OF THE FAITH" (?)

THE SMALL S-M BESIDE HORSE ON MAP MEANS. S.M STOOD FOR SU MAJESTIA (? SPELLING)
YOUR MAGESTY, HIS MAJESTY, (MAJESTIC WEAVERS NEEDLE)

THE SMALL HEART MAP IS INTRICATE AND WITHOUT IT THERE IS NOTHING. OTHER PART OF TRASURE. THERE ARE TEN DOTS BETWEEN X'S(X...........X) I,2,3,4, (BREAK IN BEADS) X COME BACK AND COUNT I, 2,3,X OR BREAK, COUNT AGAIN 1, 2,3,4,5,6,7, IN BREAK WHAT NUMBERS SHOW ON MAP...4 he said on first count.

5 HEADS BETWEEN CROSSES ON ROSARY....5 BEADS BETWEEN HEART ON ROSERY. 5 BETWEEN EACH HEART AND CROSS. IL STEPS OF THE ROSERY.

GET A ROSARY HE SAID, AND A BOOK ON THE ROSARY, AND SAY YOUR PRAYERS OF EACH BEAD, AS FATHER KINO WOULD BE SAYING THEM IN THIS SITUATION. READ LIKE KINO WOULD HAVE FELT IT, AS HE SAID HIS ROSARY. PRIEST DID...ONE WITH PERALTA EXPEDITION??? (?)

THE SMALL INTRICATE HEART MAP IS THE PIECE MISSING FROM THEIR PLANS. THE 1847 date IS NOT A DATE...THIS IS ONLY COINCIDENTAL TO PERALTA'S TIME IN THE MOUNTAINS. THE 1847 IS THE SUM TOTAL OF THE SOLUTION TO THE MAPS. A MATHMATICAL SOLUTION USING THE 8 AS A COMMON DENOMINATOR. AT THE END OF HEART IS 1847 SOLUTION.

HE SAID THE JESUIT ORDER SCROLLS ARE LOST (DURING THE EXPULSION) KINO SCROLLS AS WELL AS ALL OTHERS. As a matter of fact, the water holes were frozen solid--- and our sleeping bags were caked with ice. We called it a "forced death march on the way out!" It took us some eleven hours to walk out. We finally arrived at First Water about 11:30 P. M. on a Friday night!

Yes! I'm vaguely familiar with the Heavener mystery. It appeared in our new-papers. You probably know that our U.S. Senator, Fred Harris and his wife are interested in this? Please let me know what progress is made on this. I'm only curious!

By the way, Mrs. McGee, I'm now certain that I was right about the things we discussed regarding the Superstitions and its treasures. I'm also afraid that Mr. Marlowe made a serious mistake in not accepting my offer to talk. I have no doubt but that he and I were searching for the same and identical thing--- except that he had one source of information--- and I another. Now--- after being priviledged to have both sources, his and mine, I am certain that they both point to the same thing. It was just a simple matter of one person having his own way of maping something important to him--- and another person having a similar but different method! I will soon prove this point!

From my own personal experience with "writers", I have discovered that they don't like to write. Therefore, I suppose you can be excused for not answering my letter promptly!

Thanks for the information on the Runestones. But why did they go to all the effort just to chronicle the date? I read the entire story in "Orbit." It was very interesting--- but certainly mysterious! I don't get it. Why were these symbols so mysterious and what purpose do they serve?

By the way--- a local friend of mine, who has been working with me on the "Dutchman," told me about some carvings and symbols on some rocks out in the country near Oklahoma City. One Sunday I drove out to look at them. They are carvings of "rattle snakes" cut deep into solid rock. They take on different shapes and curves (). On one large rock, which is situated in the bed of a creek, there is the largest of the symbols and the snake is carved in such a way that its curves match exactly with the course of the creek, itself. There must be some message here, but I'm unable to decipher it! Charlie, my friend, says that they mean "treasure is burried nearby!" If you follow the signs, however, you go around in a circle and come right back where you started. Interesting?

If you would like to see these, I'd be glad to show them to you!

What a surprise! That you might like to have the Fort-Worth Star Telegram's book-review by Leonard Sanders. Haven't heard from you in quite a while, so this book was really a pleasant surprise!

Our telephone began ringing eabut 5:00 P.M. last evening. Friends were first to tell me to look at the paper. Ha! Ordinarily I never read the thing. Jack is the only one in this family that scans it from front to back.

"Curt Centry" is too beautiful to be real. Mobody is given a name that good! Ha! I know! Look at mine. I'm one out of a million that can't wear a monogram. Try it and see!

Naturally we are panting to read "The Killer Mountains"! I only hope to the author did as beautiful a job on it as you did in telling about it on the phone. You should have written it yourself! As I have teld you before, your story made more sense than any we had heard...anywhere!

Now, I'm anxious to read a more detailed account in your book.

NAL-World is unknown to us. Will the book be available at any good bookstore? Hope you sell the devil out of them!

We just finished up on the Oklahoma Runestone story. Just sent the manuscript into the publisher today. After two years research on that thing, I sure hope we don't have to eat it!

I am enclosing the newest brochure, just off the printing press. This is the third edition as new material keeps popping up...and is finally spilling over into Texas, as we had hoped!

After two years of wrestling words like "Flateyjarbok" and "Futhork", and "Karlsefni", we are more able to handle the Texas stuff from this end. To date, only five stones have been authenticated in Oklahoma, but others are being studied. The "Albion Stone" might not fall into the pure Futhork category, as it seems flavored with Latin. We have a tissue-tracing taken from the stone, and it is really a brain-buster! I've made copies and sent to Dr. Vincent Cassidy, Dr. Cair Compton, and Thomas Bent, owner of the "Tucson Artifacts". Cassidy and Compton are History prof's, but we send anything in the Latin vein to Bent, whose artifacts are inscribed in 7th and 9th Century Latin...imagine finding those things in the middle of the Great Ponoran Desert?? Fantastic story!

In trying to tie-in the Arizona inscriptions, with those of the Viking colony, we had tried for years to locate Thomas Bent. After "Mysterious West" was published, Cheral Pepper put us in direct contact with him. At that time we were not sure what type of inscriptions were to be found on the lead-crosses, swords, and church-oriented artifacts. He sent us 10 some-odd photos, showing the actual excavations in 1925-28, and of course all the inscription-bearing objects.

A few weeks later he sent the 350 pg. report of his lip years work! We have sent the photos on a whirlwind tour of Universities. Hope some more answers come from this effort. Poor guy has felt the sting of being called "hoaxer", etc. Anyone who has read this report, taken from newspaper files; U. of A. reports on excavations; letters from Smithsonian and scholars who helped recover the objects, would be a fool to call them "planted"!

New, latin inscribed objects are even being found in the Yucatan's cenotes, such as Chithenitsa. A gobernale has been found beneath the sands of the Yucatan coast, bearing carvings of European peoples. The gobernale is the big side steering oar, used in Viking, and other craft, before the advent of the rear rudder. With the help of my professor driends, we are trying to get photoss of this object, now in the Campeche Civic Museum. Might help Bent's Latin quest, and again it might help the Viking cause! I rather lean to the Romans, as the gobernale is of ebony. But who knows? Will have to wait and see. Just sent Bent a packet full of material adding strength to his inscription-told story of the Roman colony named "Terra Calalus".

Only the artifacts have been found. As in the case of the Viking colony, their settlement has never been longed. Terra Calalus was flourishing at the time of Arizona's Casa Grande! It is strange that objects found beneath the ruins of Casa Grande, bear the same symbols as some found on the Roman artifacts. And in Hieroglyphic Canyon, (and I'm certain you know where that it) the Roman-Hebrew glyphs are duplicated. Since the colony thrived for ISO years, it is possible the Superstitions were used for something. What, I don't know. The artifacts were roughly made from ores found near Tucson, so maybe they did prospect. Could have been for water, game, or only God knows!

We recently ran across another piece of evidence, a legend as told by Apache Chief, Esconolea, to James H. Tevis, back in the I850's. It told of a great army of foreigners whose weapons defeated the Apache-ancestors and made slaves out of the Indian. The army was followed by a vast number of people who built a great city, using Apache slaves to build it and work the land. The city was built on both sides of a stream running thru a valley. It took almost a hundred years before the Indians rebeledd, and it took a year to starve them out!

Esconolea took Tevis to see the place. Was up by the Verde River area now known as Montezuma's Castle. But, Montezuma's Castle are cliff dwellings. This city was in the valley, on both sides of the stream, and it took them two days of riding over it for exploration. Tevis said it had been a "Populaced city".

Esconolea said the legend had been handed down from father to son over many years. In the legend, the superstitions indian believed the foreigner was charmed, as the shield he wore broke the lance. Tevis found breastplates and helmets, which accounted for the "magic shield". The story of slavery and revolution co-incides with the Latin-told inscriptions. Mr. Bent is looking into this story. Is possibly in the area of Tuziggot.

The apache legend told of packtrains leaving the city every few days. This could be why only artifacts have been found near the Old Nine Mile Water Hole, outside Tucson. An ore-gathering party?

It has been established the Bent artifacts were rough-cast, as pouring molten-metal into a sand-cast! On the spot forging. Esconolea also told Tevis that the foreigners built furnaces in the mountains which melted rock into water.

The Lovelace legend as read in "Lost Mines and Hidden Treasures", chpt. on "White Strangers and Papago Gold" runs a close parallel to both stories, but for the one fact that the Papago ancestors said the milk-skinned strangers were pentle. It has been suggested that I50 years of ekeing-out auryival among indians, would change the gentle ways! We.

Tevis's narrative can be read in the New Mexico Press (University of New Mexico Press) copyright 1954, "Arizona in the 50's".

Nothing surprises me anymore, concerning new finds proving pre-columbia voyages. Some of these old-school ideas will be changed in the next five to ten years. The young professors have a broader outlook than some of these egotistical jackasses who have held-up pre-columbian explorations, setting back theories at least a hundred years!

As proof of this, one NEARA member wrote me: After Hardlykka passed away, his puccessors were horrified to see what had been stuck-away in the Smithsonian's basement. Hidden away, sort-of-speak. Some of the old "hard-heads" would rather hide the evidence than admit they could have been wrong! Times are changing, Glenn, and for the good!

Cetting backto questions you had asked concerning runestones; why did they go to so much trouble to chronicle the date? After plowing thru Landsverk and Monge's "Norse Medieval Cryptography in Runic Carvings" (several times) I should be able to give tou a simple answer, but there "aint no way".

The Benedictine manks were about the only ones able to read and write runes. If a Norse, Dane, or Swedish King wished to send a message, the mank had to write it! Another mank had to read it when it got where it was going. But both manks had to understand the message written in their own Benedictine-devised code. To them, it was an art....devised like a game of chess. Just as the name implies, it was cryptographic.

As to why they used it in this country, I don't know. Perhaps it was personal pride in their art, and obviously the monk, or monks, expected it to be admired by those who were expected to follow. Each voyage carried one or more monks...and for colonization purposes, more ships were expected. If not, why in the heck bother? Altho, each date is special to the Norse Christian Calader: Could be commemorative monuments for holy days.

It is interesting to see how mispelled words can be used by someone good in cryptography. Could the Jesuits have had their own brand of "chess"? Those mispelled words on stone maps have always bugged me! If you like, I can loan you my "cryptography in runic-writings". Might find something pertinent to Jesuit puzzads. If I had only known you were writing a book, I could have sent you a bunch of stuff!

The Old World was fond of the secret and mysterious. Even with the Bent inscriptions, two different periods of Latin grammar was used! Why?? Oklahoma Runestones used two different "Futhork Alphabets" Why?

By God, I hope you haven't had your history lesson for today, cause you just got one! Ha. Sorry about these four pages of, what might be, boredom. Every facet of history (Early) fascinates me, and sometimes I have the mistaken idea that it fascinates mthers too!

Its rather difficult to start a letter, but once I start typing, I can't shut up! My point is: there is probably a solid idea, somewhere, behind the Jesuit, and/or, Peralta maps, showing illiteracy with such simple words as "Boy" for Voy, etc.

In tracking down what we had hoped would be another runestone, we spent months trying to see a stone, bought in a Gripple Greek, Golo. antique shop, but now in Monroe, La. It was thought by the purchaser to be a written treaty between Indian and whites! After a very long story, the people brought it our home.

Since the Viking-route on the Arkansas River is fact, we were hopeful that this would be a western-most marker of their travels, since the Arkansas headwaters in the Rockies, not fab from Cripple Creek. Thing weighs 55 lbs., is II" by Ih", and has 37 symbols.

Within two weeks time the thing had underg ne geological composition analysis by T.C.U. and U.S.L.; (Both agreed it did come for Cripple Creek) had been photographed, rubbings made, and plaster casts were made. Translations were finally made in Greek. Ancient Greek! How does that grab you? "Here I slew/sacrificed my slave/servant, Palladeis" or, "Here lies the servant of the God, Palladeis".

We were sick! Instead of Vikings, we wound up with Cripple Greek Greeks! But, there are a few symbols which don't fit into the right pattern, and believe it will behow....two different stages of Greek, combined,... or, two different languages, combined!

Dr Vincent Cassidy, of University of Southwestern Louisiana, and Dr. Cyclone Covey, of Wake Forest, are wrestling with it now. Clad its their problem now, and not ours.

Am arxious to see what you had to say about the translations...a la Jesuit! Nowhere on the maps is gold, or mines, mentioned! Wouldn't it be funny if they were for mapping purposes, or some other reason?

I lost faith in those maps a long time ago, and perhaps your book will'g give me the reassurance so badly needed! Wish we could have gotten up to Oklahoma City to see the promished slides. Still might make it one of these days. If you and your wife are ever down this way, throw them in the car, and stop by. Steaks and whusky are in order any time.

Apparently you never received my first letter, which I sent you several years ago. At that time I was conducting my research on the Peralta Maps that I received from Dr. Erwin C. Found the advance topo map; marked on, but at least it shows what you want. I hope? The other advance is "Pinyon Mt.", taking in Apache Lake, Reavis Ranchy Fish Creek, Lewis & Pranty, etc. Was a little east of your area, so did not send it. Should you want it, holler!

Jonathan Burbridge did write of the old trail into Mexico from the mountains north of the Gila River, **UpQtherSanePedro*, down the Gila to Twin Buttes, cross Gila up pass the Old Silverbell, continuing on to Cottonwood Wash, travel north-west along foothills, and on into the Superstitions. (Water, being the main reason for this old route.) His source was an old packer by the name of Johnson. Yet he again mentions the trail being mentioned in the 1969 issue of "Gold", which I have, but Johnson is not mentioned by the author, John A. Taylor. If you really want confusion, read the half-dozen accounts of the Lost Dutchman in Gold! I guess they tried to please everyone?

You asked I send anything out of files that might be of interest to you. Where do I begin? Haven't the vaguest idea. To us every letter, book, magazine, news clipping, and map is extremely interesting and important. Not knowing what you have...compared against what we have, is like sending one verse out the Old and New Testaments! And I would imagine your collection is larger than ours. Our library is small (re Superstition material) but is complete with all books on the subject. One was missing, and that was the original Storm Book, but having the small reprint is almost as good. Dear Jack & Bernice:

Just a note to let you know that I have not forgotten your old military maps. Its just that I am still trying to get ample time to study them. Lately, its been just one big problem right after another and I haven't been able to devote much time to them. Meantime, however, if you need these maps, please let me know and I will rush them on to you promptly.

In case you haven't already heard, my good friend and companion, AL MORROW, was found dead in his Tunnel in Needle Canyon this past week. According to the Sheriff's report, it had been raining (about nine inch rainfall over a single week-end) and the tunnel caved in on Al.

My last letter from Al, which I believe was the very last letter he ever wrote to anyone, reveals that Al had been sleeping in his tunnel. He said it was about 70 degrees in the tunnel and over 100 degrees outside. I know that he kept his food stores and water inside the tunnel because of the extreme heat in his camp.

Although it was his request, and the request of the family-to seal Al inside his tunnel in the event of his death, the Authorities had to bring him out of the mountains for an autopsy. Since he was already in a bad state of decomposition it was necessary to bury him at Desert View Cemetary. It was Al's wish to be sealed in his tunnel and the entrance blasted shut. He often told me to arrange for this in the event of his death. It was too late, however, when I received news of his death. They had his funeral the same day I received word.

The Superstitions will hardly seem the same to me ever again. Without Al, my future trips in the mountains will be lonely, indeed. His camp was always our first stop and overnight resting place before going on to our projects.

And, too, he was my only reliable source of information concerning the current events in the mountains. Like a periodic newspaper, Al kept me informed on all the happenings in and around Bluff Springs Mountain and Needle Canyon. Someday, someone will write a full length book on Al Morrow. During his twenty three years in Needle Canyon, he became a legend in his own time. I have been informed that the Forrest Rangers will destroy his camp. They more than tolerated Al - they actually welcomed him. He was, perhaps, the biggest asset they had in there. He kept them abreast of trouble in the mountains, and often alerted them to hazzards and forrest fires in time to save a tragedy. They will level his camp to prevent squaters from moving in.

He will be missed by many. Especially those who received a cold drink of water, or a visit in the shade of his camp. To those who stumbled into his camp lost and exhausted, he was a miracle. There is no way to count the number of individuals he has assisted during his stay in those mountains.
