*Fly Your Flag - Join the Hawkins Worldwide DNA Project!*

School has started here, the forecast for the week is for highs in the low 90s (OK, beats the 99s), Congress will soon be back in session (God help us), football is back, Santa is refusing to lay off any of his elves and there are trillions (that's bigger than I can count) to be spent on our recovery (help).

Let's talk about the numbers. The following panel is part of the report (the first 12 markers/locus/DYS#s that participant #57097 received from Family Tree DNA when he tested with them. I am sure that when he received them that there was a very helpless feeling of "what does this mean to me?" So, let's look at it.

The locus is just the location (spot) on the DNA double helix in the Y-chromosome that Family Tree DNA chose to identify as "1" (or 2, or 12).

That particular locus, 1 for example, was at the position identified in commonly used genealogical DNA testing as DYS #393 (all testing companies would identify this particular location on the DNA chain as DYS #393). DYS #s 390, 19, and 426 are all different locations on the chain.

Alleles (the possible variations of repeats at a DYS marker are known as alleles), 13 for example, means that the particular DNA sequence at a specified location repeats itself (AGAT, AGAT, AGAT, etc.) 13 times. Why? Excepting the Y, all the other chromosomes come in pairs, one from the father one from the mother. If you receive a Y chromosome (boys only) it comes only from the father. If a single Y (AGAT) were to be defective there would be no second choice from the mother. WOW, big trouble. But fortunately for the boys it has gotten around that danger by stringing together more than a single DNA sequence (AGAT) so that the chromosome can bypass a bad AGAT, and choose a good AGAT (13 times is a lot of making sure). Now, read these last three paragraphs again (again, again is OK).

The varying values (or alleles) of the different DYS (DNA Y-chromosome Segment) is how DNA testing distinguishes and identifies participants as members of a particular Hawkins-Group (line). For example the common allele for my Group-04 is also 13 at DYS #393, but at DYS #390 it is 25 rather than 23. But let's stay with participant #57097 and his defined line, Hawkins Famil Group-03 for now.

Following is a copy of the lower left corner of our project Hawkins Family Group-03 results table where we copy the above results for comparison purposes. In the table the columns are participant, born, Fam. Grp., haplogroup (maybe next month), DYS 390, DYS 393, etc. The bottom line displays the values probably common to the eldest ancestor common to all the participants in the group (currently 18 in Hawkins Family Group-03 and majority rules for the bottom line).

Note that participants 37319 and 123477 match the bottom line, but looking at the other three shown here, they have a different number (blue) of repeats (AGAT, AGAT, etc). The blue numbers indicate a mutation at that DYS#/location. The mutations indicate a smaller branch off the trunk, or off a larger branch. Mutations do not happen often (in my Group-04, in these first 12 DYS, only one shows mutation).

OK, I am not going to save it until next month. A haplogroup is a family line as defined by the bottom line in our tables (you thought it was hard didn't you, but no, just learning the language).

See how simple it all is. Of course I'm kidding. I hope this helped some of you.

Having a family member tested is truly important. If you have good history (as my Group does), Great! But still, someone should test. Your line/haplogroup should have a tested record in the file. Too many lines have daughtered out, and now there is no Hawkins male to test.

I keep finding that there are Hawkins that have tested, and assume that they are participating in our project, but are not (and I am never notified that they have tested). If you tested with Family Tree DNA go to [www.familytreedna.com](http://www.familytreedna.com) and log into your account. In the left column, under My Project Groups you should see Hawkins listed (side point: you have to have the button selected to see your matches within the group). If Hawkins is not listed, then I do not know that you exist. Look to the right under My Account and select Join Projects, and add Hawkins.

If you tested with a different company, then you must contact me. We want all Hawkins that have tested, Ancestry, Sorenson, where ever to join. We are free and we need you.

It is rather slow going, but I did purchase them so that they are permanently at the local church. Have not turned up much that I have not already reported, but the search goes on.

After 18 years of research, a 'brick wall' is an understatement. The names of my 4<sup>th</sup> Great grandparents, John & Winney and their son William Hawkins, were all too common and no siblings were ever found. William's death record at Culpeper Courthouse revealed them and they were confirmed by an 1851 news obituary held by a D.A.R. ancestor; William, in his 16th year of age (1781) enlisted for his father John, traveled to Stafford Co. Va. and returned home after time served in the Revolutionary War." The original was burned on the courthouse steps during the Civil War and Stafford is a burn county.

Fountain Melvin Hawkins, my 2<sup>nd</sup> Great grandfather, was born in Liberty, Bedford Co in 1808. He was the 6<sup>th</sup> of 9 children born to William Hawkins & Jane Bayne, daughter of George & Jane Bayne of Fredericksburg (1790) & Culpeper by 1795. His sister, Catherine (Estes) was born in 1798; George Wm. b:1799; Juliet Margaret (Love) b:1801 Bedford Co., as were Harriet (Love) b:1804; Gilley Amanda (Eakin) b:1806; Fountain b:1808; Spotswood Nelson b:1810 & Harvey Bayne b:1812.

They lived on a 96-acre farm between Liberty & Lowery along Rt# 122 which had been part of a 579 acre farm purchased in 1800 by William's father-in-law. George Bayne had left Culpeper for Bedford with William's family. We believe this included his father John Hawkins...Winney must have died before the move. By 1805 William lived on the north side of Rt# 122 while George purchased two more tracts of 226 acres to the west in the Lisbon district of Thaxton on Rt#681. We believe George's youngest sons, Thomas & Griffin Bayne, worked on this land under the watchful eye of William's father John, as overseer. When John died in 1820/21, William was the administrator of his estate, totaling \$221. A malado boy named William was \$200 and the rest was a saddle, shot gun, trunk, bed & blankets.

Fountain married Celine Catherine Spiers White on 4/15/1831, daughter of Jacob Washington White Jr. & Matilda Buford of Otterview in Charlemont district. Shortly thereafter her widowed mother Matilda married founder of the town, William Thaxton on 11/18/1835. When George Bayne died 1821 (Will probated 1824), Fountain's sister, Catherine and husband Edward Estes purchased in 1825 the Thaxton 226 acres from Baynes estate. They had married in 1815 and had helped run the farm. By 1833 they sold 98+ acres to Fountain & the adjoining 120 acres to brother George & wife Nancy E. Hatcher. These brothers remained in Thaxton when their parents, William & Jane, moved in 1829 to Craig Creek, Botetourt Co (becoming Craig Co.1851)

Fountain had eight children; 1) Matilda 1833-1880 m:1858 Henry C. Cobb; 2) Fannie Lewis 1834-1912 m:1855 Francis Hopkins; 3) Harvey Bayne 1837-1864 m:1857 Sarah Snell in MO.; 4) Martha 1839-? m:1845 John P. Meador; 5) John Henry (my line) 1841-1926 m:1867 Molly Hurt; 6) Mary Elizabeth 1842-1907 m:1866 Henry S. Huddleston; 7) Sally 1850-1869 m:1868 Lewis Riley; 8) Spotswood Brown 1852-1939 m:1876 Lelia O. Newsom. With Spotswood's birth on 5/20/1852, Celine died of complications on July 6, 1852.

John Henry & Edward returned home April of 1865 after four years in the Civil War. The joyous homecoming was cut short. Fountain, now 57, died of smallpox on July 6 1865 in the home of daughter, Matilda Cobb, then living on his land. John, now 24, became guardian of Sallie & Spotswood and shared executorship with Henry Cobb. After John married Molly Jane Hurt (1867) their first son William Henry was born. With Fountain's estate still in Chancery & hard economic times, John entrusted his share to Cobb in 1869 and moved to St. Joseph MO where Walter Gibbs was born 1870. Walter shot himself 6/9/1903 in Marion Co KS when my father, Claude Sr. was only 6 and his wife Anna was 8 months pregnant. It was due to the flood of Cottonwood Creek, which washed away 80 acres of his first year crops that was to pay for the home they just moved into. Claude Sr. was born 1897 in Mina KS, which no longer exists in Marion Co.

Overcome with grief, Anna then lost her newborn, Walter Jr., b:7/11/1903 d:10/8/1903 and entered Topeka Mental hospital with her five children going to live with various relatives. I went to live with John Henry whom he grew to dislike. After shooting his pit bull for killing John's chickens, at 14, the participant left for nearby Aunt Ida Carnes farm. John's wife, Molly died in Axtel KS. 1/13/1921 and John 12/28/1926, both being buried in Rose Hill Cem.

Claude Sr. Had listened to many of his grandfathers Civil War stories, one of which advised him "not to join the Army or you'll spend all your time knee deep in mud like I did with my artillery guns." This may have saved his life, for Claude joined the Navy in WW1 and lived to raise a family until his death at age 97 in 1995.
