"I think that after having given money for the new library building, in which there are to be rooms for the Industrial School, my wishes in the matter should have been consulted before the Governor dismissed

Dr. Houghton.
"Now remer "Now remember, I do not want to east any reflection upon Dr. Jenvey, whom I regard as an able and efficient man, whom everybody trusts and respects. will prove an excellent member of the board, and Gov. Griggs could not have appointed a better man in Dr. Houghton's place. I am satisfied, too, that the appointment came to him unsolicited. The board will act harmoniously with him, and there will be no trouble."
