THE CHRISTY SURNAME

The name Surname Christy / Christie is a name almost entirely associated with Scotland. The name is a derivation of either Christian, or the female Christiana, or Christopher, themselves being derivatives of the Roman (Latin) "Christopherus". The name means "Christ bearing" and was rare before the Norman Conquest of 1066.

DATES

For the most part, many conflicting dates were easily straightened out by simply rechecking the source material or official records. In some cases, however, marriage dates may vary from other published works because the researcher used the date of a marriage bond, or the date a marriage license was issued, instead of the actual marriage date. Even though some of the source material I used did not specify the origin of the marriage date given, I have tried to substantiate the marriage dates as accurately as possible.

In a number of cases an approximate date of marriage, using the abbreviation "ca." for circa (about), is shown based upon information provided in various censuses and other documents. This is also true with respect to death dates which may also vary in that the date of burial, or the date a last will and testament was written or submitted for probate, will sometimes be cited by others instead of an actual death date. In those cases where I was unable to determine an actual death date the abbreviation "ca." may be used, or only the known year of death may be cited.

Another common dating conflict involves the use of the Julian Calendar versus the Gregorian Calendar. On 14 September 1752, the Gregorian Calendar was adopted in both Great Britain and its colonies in North America, and the first day of the year then became January 1. Prior to that date, the Julian Calendar was in effect and the first day of the year was March 25. As a consequence, many dates found in the 1600's and first half of the 1700's for the months of January, February, and March reflect, or should reflect, a double date, such as 15 February 1735/1736. Even though both dates may be perfectly acceptable based upon the calendar that was in use at the time, to be consistent with current dating procedures the second year is most accurate.

LOCATIONS

With respect to the location at which an event took place, there were many cases when it was not possible to find any record giving the exact location that a birth, marriage or death took place. Because I feel quite strongly that dates should always be accompanied by places, if for no other reason than to aid future research, I made a number of assumptions regarding location based upon available information. For instance, if a family is found in the Fayette County, Indiana census records for 1840 and 1850, and they also show up in the deed and tax records of that county for the same period, I did not feel that it was unreasonable to assume that any children they had during this period were probably also born in Fayette County. In some cases, however, my comfort level with assuming a possible location was limited to a state only.

GENERATION ONE

1. Samuel Christy. *

NOTE: Much of the information pertaining to Samuel Christy and his children was provided in two letters written by his grandchildren, James and John Christy, sons of Julius Christy. These letters are listed as references 1 and 2 of this write-up.

Samuel Christy is the earliest known, and very likely the immigrant ancestor of our Christy family. ¹ It is believed that Samuel was probably married in Great Britain prior to coming to America, where he is said to have originally settled near the mouth of the York River in Gloucester County, Virginia prior to moving to King and Queen County, Virginia. ² While residing in King and Queen County, Samuel and his family were living within the boundaries of Stratton Major Parish. ³ Although very little is known regarding Samuel, one early reference which pertains to him was found in the Vestry Book of Stratton Major Parish. ³ It was dated Friday, 10 April 1741, and reads as follows:

"Ordered that the Church-Wardens do bind William Kettle Blackwell to Samuel Cristy to learn the Blacksmiths Trade and the Said Samuel Cristy to give him Education according to Law Untill he attains the Age."

According to a letter written on 25 December 1844 by his grandson, John Christy, Samuel Christy apparently died in Virginia intestate, and his eldest son, who was also named Samuel, became heir to the entire estate according to traditional English inheritance law. ² Samuel Christy may have been residing in Essex County, Virginia at the time of his death. Unfortunately, the name of Samuel's wife has not been determined.

2. Samuel Christy.

Samuel Christy was the eldest son of Samuel Christy, Sr. ² As yet, neither the date, nor the place, that Samuel Christy was born have been determined. Even though Samuel is known to have been married, neither the name of his wife, nor her parentage, have been determined either. ² Because Samuel was the eldest son of Samuel Christy, Sr., he apparently inherited his father's estate in Virginia according to traditional English inheritance law. ² Shortly thereafter, however, Samuel and his wife and children all died of smallpox. ²

3. Mildred Christy.

Mildred Christy (some records refer to her as Ann) was the daughter of Samuel Christy. As yet, neither the date, nor the place, that Mildred Christy was born have been determined. Mildred was apparently married twice during her life. Although she is known to have married first to a man named Edward Blackburn in Virginia, the actual date and place of their marriage are also unknown. ² Edward, who had been born in Middlesex County, Virginia on 30 November 1729, was subsequently christened on 21 December 1729 in the Christ Church Parish in Middlesex County. ⁶ He was the son of William and Elizabeth Blackburn. ⁶ Edward is believed to have died in about 1770 in Culpeper County, Virginia.

After Edward passed away, Mildred married in Culpeper County, Virginia for a second time to a man named Medley. ² Although it remains to be verified, Mildred's second husband may have been John Medley, Jr., the son of John and Eleanor Medley. Although some of Mildred's children later moved west into the state of Kentucky, Mildred is believed to have resided in Culpeper County for the remainder of her life.

4. Julius Christy. *

Julius Christy, the son of Samuel Christy, was a twin child. ^{1,2} He is said to have been born in about 1730 near the mouth of the York River in Gloucester County, Virginia. ² Because Julius Christy's father passed away without leaving a will, his older brother, Samuel, inherited all of their father's lands, as well as his slaves, according to old English inheritance law. ² Shortly thereafter, however, Samuel's entire family, and all but one of his slaves died from smallpox. ² Julius, who had recently been apprenticed to a man named James Booker to learn the carpenters trade, was away from home at the time and fortunately did not catch the fever. ² The one surviving black was subsequently inherited by Julius, and worked for him as a carpenter's assistant for many years. ²

Sometime later, Julius moved into that portion of Virginia where Orange and Culpeper Counties come together, and it was in Culpeper County that he married his wife, Agatha Barnett, in about 1755/1756. ^{1,2,5} Agatha, who was also a native of Virginia, was the daughter of John Barnett and Marran Gibbs. ⁵

NOTE: Agatha's ancestry on her father's side traces back to Bedfordshire, England through Richard Barnett and Anne Corderoy (also written Cordray), who immigrated into Virginia prior to 1650. They apparently settled in that portion of York County, Virginia that was later formed into Gloucester County, Virginia in 1651. On her mother's side, Agatha traces back to England through the immigrant, John Gibbs, who originally settled at Jamestown in 1619. A few of the surnames associated with these families in England are: Goddard, Woolhouse, Muscote, Haselwood, Baker, Marmion, Seymour, Winchcombe, Kingsmill, and Goring. ¹⁴

Later, on 15 August 1754, Julius purchased 100 acres of land in Culpeper County, Virginia from a man named Charles Walker for 36 pounds. ¹⁵ This property was located along the Rapidan River which serves as the border between Culpeper and Orange Counties, Virginia. ^{2,16} Julius subsequently acquired an additional 200 acre tract of land from a Mr. Benjamin Head on 10 September 1759 for 40 pounds, and another 1 acre tract from a Mr. Harry Beverly on 28 February 1760 for 20 shillings, for the purpose of building a gristmill. ^{15,17} He also acquired 250 acres of land that adjoined his other purchases from a Mr. Thomas Chew on 16 July 1760. ¹⁵ Although Julius and Agatha later sold 350 acres of this property to his brother-in-law, John Gibbs, on 17 November 1762 for 70 pounds, they retained the 1 acre gristmill site and the 200 acre parcel purchased from Mr. Head. ¹⁵

Several years later, in August of 1771, Julius purchased 129 acres of land situated in Orange County, Virginia from a Mr. William Beverly for 32 pounds, which he later sold on 4 May 1774 to his brother-in-law, John Gibbs. ¹⁸ These lands were subsequently resold by Julius and Agatha Christy "of Botetourt County" and John Gibbs of Culpeper County to a Mr. Anthony Foster on 17 January 1778 for 140 pounds. ¹⁹ Julius and Agatha had previously sold the property that was purchased from Benjamin Head to a Mr. Benjamin Pollard on 21 June 1775 for 95 pounds. ²⁰

Based upon the above deeds, Julius and Agatha Christy appear to have moved in about 1776/1777 to western Virginia, where they settled in that portion of Botetourt County that was later made a part of Greenbrier County, Virginia (now within West Virginia) in March of 1778. ^{2,21} Their daughter, Anna Christy, was later married in Botetourt County, Virginia in about 1777 to a man named John Valentine Lindsey, the son of David and Catherine Lindsey. ^{4,22} John had been shown in the March and August 1775 list of Botetourt County, Virginia titheables who were residing in the Greenbrier area. ¹⁵

NOTE: Although there is some question as to whether or not Julius Christy actually served in the Revolutionary War during the time he was residing in Botetourt County, Virginia and/or Greenbrier County, Virginia (now West Virginia), a Revolutionary War veterans tombstone was erected in the Christy Cemetery in Lewis County, Kentucky which indicates he served as a Lieutenant Colonel in the Virginia Continental Line during the War. ²³

In the record of Land Entitlements for Greenbrier County, Virginia (now West Virginia) dated 11 January 1780, Julius Christy is found receiving title to 400 acres of land in Greenbrier County "by right of settlement prior to 1 January 1778." Julius was subsequently listed as being one of the residents of Greenbrier County who signed a petition on 5 December 1780 to raise "twenty tunns of hemp off the tithable persons in this county for the purpose of making a market road from this place to Richmond." ²⁵

Sometime prior to 1789, Julius and his family moved further west into the state of Kentucky, where they settled in that portion of Fayette County, Kentucky that was formed into Woodford County, Kentucky in 1789, but was later formed into Scott County, Kentucky in 1792. This is substantiated by the fact that Julius Christy was listed as a taxable inhabitant of Fayette County, Kentucky in 1789, as a taxable inhabitant of Woodford County, Kentucky in 1790, and as a taxable inhabitant of Scott County, Kentucky in 1800. This youngest, of Scott County, Kentucky, was later found in two Fleming County, Kentucky deed records, both of which were dated 3 February 1803. In one he is selling a Negro named Lemmon to his son, James Christy, and in the other he is selling a Negro woman named Lillis, some livestock, and some farming utensils to his youngest son, Samuel Christy.

Julius Christy subsequently died in 1808 in Clark County, Kentucky. ⁴ His will, which was dated 5 December 1805, was later probated on 25 July 1808 before the Clark County Court. ⁴ Although Julius Christy's actual place of burial is unknown, a U. S. Veterans Tombstone has been erected for his Revolutionary War service in the Christy Graveyard in Lewis County, Kentucky. ²³ Although Agatha also passed away in Kentucky, the date of her death has not been determined.

With the exception of Mildred Christy, all of the below listed children, including the married names of daughters, were mentioned in Julius Christy's will. ⁴

5. Juda "Judith" Christy.

Juda Christy, the daughter of Samuel Christy, was a twin child. She is said to have been born in about 1730 near the mouth of the York River in Gloucester County, Virginia. ^{1,2} Juda was later married in Virginia to a man named John Gibbs. ² John, who had been born on 17 November 1729 in Middlesex County, Virginia, was subsequently christened on 14 December 1729 in the Christ Church Parish in Middlesex County. ⁶ He was the son of Zachariah Gibbs and Mary Massie. ^{6,51}

Sometime after their marriage, John and Juda Gibbs moved to Orange County, Virginia, but later settled in that portion of Culpeper County, Virginia that was formed into Madison County, Virginia in 1792. ²⁶ John died in Madison County in 1804. ⁵² His will, which had been written on 18 October 1803, was subsequently probated before the Madison County Court on 28 June 1804. ⁵² Because Juda (Judith) was named in John's will it is known that she survived him. ⁵² And, even though she too is believed to have died in Madison County, Virginia, the date of her death is not known. With the exception of Mildred (Gibbs) Clark, who was deceased, the following children were named in John's will. ⁵² The exact order of their birth is not known, however.

11. Elizabeth "Betsy" Christy.

Elizabeth Christy, the daughter of Julius Christy and Agatha Barnett, was born in about 1756/1757 in Culpeper County, Virginia. ^{4,5,31} She was later married in about 1774 in Virginia to a man named William Glass. ^{4,32} William was the son of Jehu Glass and Elizabeth (Dozier) Belfield Wilson. ³³

Although William and Elizabeth appear to have remained in Culpeper County, Virginia for many years after their marriage, sometime during the year of 1792 they apparently moved to Scott County, Kentucky, where William was later found on the 1795 list of taxable inhabitants of Scott County. ^{33,61} Upon arriving there, they settled first on Cane Run west of Georgetown, but later settled on what was called McConnell Run south of Stamping Ground. They eventually settled north of Georgetown along the Long Lick Pike, however. ³² William and Elizabeth owned property in that part of Scott County that was later formed into Owen County in 1819, as well as in that area that remained Scott County. Several of their children later settled on the Owen County property.

William and Elizabeth Glass are believed to have resided in Scott County, Kentucky for the remainder of their lives. Although William Glass was last found in a Scott County, Kentucky court record dated 6 February 1815, his actual death date is not known. ³³ Elizabeth, on the other hand, appears to have died in 1825 based upon an estate settlement carried out by the Scott County Court during the November 1825 term. ³³

12. Anna Christy. *

Anna Christy, the daughter of Julius Christy and Agatha Barnett, was born in Culpeper County, Virginia. ^{4,31} Anna was apparently married twice during her life. She married her first husband, John Valentine Lindsey (also written Lindsay), in about 1777 in that portion of Botetourt County, Virginia that was later formed into Greenbrier County, Virginia (now West Virginia) in March 1778. ^{4,21,22} John, who was calculated to have been born in about 1757 in Frederick County, Virginia, was the son of David and Catherine Lindsey. ^{22,74,75} His year of birth was calculated from a deposition that he gave on 13 December 1803 at the Boone County, Kentucky Courthouse, in which he stated he was "about 46 years" of age. ⁷⁴

On 8 January 1780, John Lindsey obtained a grant of 400 acres of land on the north side of the Greenbrier River "by right of settlement prior to 1 January 1778." ²⁴ He subsequently acquired another grant of 400 acres of land on the north and northwest side of the Greenbrier River under the same condition on 15 January 1780. ²⁴ John Lindsey later acquired an additional 236 acres of land in Greenbrier County by State Treasury Warrants. ²⁴ These warrants were for 11 acres on 18 June 1785, 100 acres on 1 September 1785, and 125 acres on 20 March 1786. ²⁴

According to available court records, during the 1780's John and two of his sisters, Rebecca (Lindsey) Gillilan and Sarah (Lindsey) Lockridge, were involved in a number of court cases in Greenbrier County, and John also served on several juries during 1783 and 1784. Feven though the disposition of all of John Lindsey's land holdings has not been determined, on 26 February 1788 he sold portions of his land to Andrew Hamilton and to William Elliot. Soon after this, he and his family appear to have moved further west into the state of Kentucky, where they settled in that portion of Fayette County, Kentucky that was later formed into Woodford County, Kentucky in 1789, but was eventually formed into Scott County, Kentucky in 1792.

John Lindsey subsequently died in Scott County Kentucky during the latter part of 1805. His will, which had been written on 29 September 1805, was admitted for probate before the Scott County Court during the January 1806 term. 77

After her first husband passed away, Anna married for a second time to a man named Spencer Stone. ²² Although this marriage is believed to have taken place in about 1818 in Scott County, Kentucky, many of the Scott County records were destroyed in a fire and no documents have been found to confirm this. ²² Spencer Stone was the father of the Elias Barbee Stone who had married Catherine Houston Lindsey, one of John and Anna Lindsey's daughters. ²²

Although Anna and Spencer probably resided for a short time in Scott County, Kentucky, they eventually moved to Lincoln County, Kentucky, where Spencer owned a small farm on the banks of the Dix River that he had been granted for his Revolutionary War service. This farm was located in that portion of Lincoln County, Kentucky that was later formed into Boyle County, Kentucky in 1842. And, it was there that Spencer Stone later died on 1 January 1838.

Shortly after her second husband passed away, Anna moved to Fayette County, Indiana to be near some of her children from her first marriage to John Lindsey. Anna (Christy) Lindsey Stone subsequently passed away in Fayette County, Indiana in 1844. Her will, which had been written on 8 October 1844, was submitted for probate on 19 November 1844 before the Fayette County Court. 80

The children listed below have all been identified through correspondence with members of the Lindsey family, as well as through other documents and records, as being those of John and Anna (Christy) Lindsey.

Mildred Christy, the daughter of Julius Christy and Agatha Barnett, was born in Culpeper County, Virginia on 21 March 1759. She was later married in Virginia to a man named Belfield Cave. Although no record of their marriage has been found to date, based upon the age of their first child, Elizabeth Cave, it is believed to have taken place in about 1777. Belfield, who was the son of Benjamin Cave and Elizabeth Belfield, had been born in Virginia on 23 October 1756.

After their marriage, Belfield and Mildred Cave resided on a farm which was situated on the south side of the Rapidan River in Orange County, Virginia. Belfield, who was a veteran of the Revolutionary War, served as a Captain of Infantry in the 7th Virginia Regiment of the Orange County, Virginia Militia, and fought at the Battle of Yorktown.

Belfield Cave died in Orange County, Virginia on 4 June 1811. ³⁵ His will, which had been written on 4 May 1811, was subsequently admitted for probate before the Orange County Court on 26 August 1811. ⁹³ Mildred, who survived Belfield by approximately eighteen years, died in Orange County, Virginia on 6 August 1829. ³⁵

14. Agatha Christy.

Agatha Christy, the daughter of Julius Christy and Agatha Barnett, is believed to have been born in about 1760/1761 in Culpeper County, Virginia. ^{4,31} According to Julius Christy's last will and testament, which was dated 5 December 1805 and probated on 25 July 1808 in Clark County, Kentucky, Agatha was married to a man named Kirtley. ⁴

NOTE: While researching the Christy family, I found a number of genealogies and sites that indicated that our Agatha Christy, the daughter of Julius Christy and Agatha Barnett, was married to a man named Francis Kirtley, son of Thomas Kirtley and Judith Calloway. However, I found most other genealogies and sites indicated that this same Francis Kirtley was actually married to a woman named Sarah Frances Buford. To confuse the situation even more, both camps show the same birth and death dates for Francis Kirtley, as well as his having the exact same children. To put it bluntly, someone is putting out some inaccurate information.

I personally have not been able to come up with any documents or other tangible evidence that sheds any light on the given name of our Agatha Christy's husband. Because of this, and because of the conflicting claims mentioned above, no information will be presented on this family until this issue can be resolved.

15. Frances Christy.

Frances Christy, the daughter of Julius Christy and his wife, Agatha Barnett, is believed to have been born in Culpeper County, Virginia in about 1763. ^{4,31} She was later married to a man named William Cave on 11 June 1783 in Orange County, Virginia. ^{4,36} William, who was the son of John Cave and Mildred Bell, had been born in 1763 in Orange County, Virginia. ³⁷

Sometime prior to 1795, William and Frances Cave apparently left Virginia and moved to Kentucky, where their three daughters were born. They were later found on the 1810 federal census Kentucky residing in Stoner Township in Bourbon County. William and Frances later sold their land in Bourbon County, Kentucky, as well as another parcel which was situated in Harrison County, Kentucky, in 1813 and 1817, respectively. 33

After selling their property in Kentucky, William and Frances moved into the state of Missouri, where they settled near the town of Columbia in Boone County. William Cave later died in Boone County, Missouri on 6 August 1841, while Frances died there on 18 June 1848. ³⁷ Both were subsequently buried in the Cave Family Cemetery in Boone County. ³⁷ William named his wife, Frances, and the three daughters listed below in his will. ¹⁰⁰

16. James Christy.

James Christy, the son of Julius Christy and Agatha Barnett, was calculated to have been born in Culpeper County, Virginia in 1766. ^{1,4,31} This year is based upon a letter he wrote on 7 December 1844 in which he stated he was 78 years of age. ¹ James was later married on 10 March 1787 to a woman named Elizabeth Armstrong in Greenbrier County, Virginia (now within West Virginia). ³⁸ Elizabeth, who had been born on 9 April 1769 in Virginia, was the daughter of Robert Armstrong and Jane Jameson. ^{108,109}

Sometime after their marriage, James and his family, along with his younger brother, Samuel Christy, apparently moved west to Kentucky, where they eventually settled in what became Fleming County, Kentucky in 1798. ²⁶ James was subsequently found in the Fleming County deed records buying and selling a number of properties between the years 1799 and 1847. ¹¹⁰

James and his brother, Samuel, who was still residing in Fleming County, Kentucky at the time, both acquired personal property from their father, Julius Christy, by two recorded bills-of-sale that were both dated 3 February 1803. The bill-of-sale involving James indicated that he had purchased a Negro named Lemmon from his father. ³⁰

One of the last documents to have been found which pertained to James Christy was the letter he wrote to a nephew who was residing in Missouri. ¹ In that letter, which had been written on 7 December 1844, James Christy mentioned that his wife, Elizabeth, had died on 1 August 1843, and that he was residing at Poplar Plains in Fleming County, Kentucky at the time. ¹ Elizabeth, therefore, is believed to have died in Flemming County, Kentucky.

The last document that was found that involved James Christy, however, was a deed between James and a Mr. Peter Lewis for 894 acres of land. ³⁹ This deed, which was dated 17 May 1847, indicated that James was residing in Morgan County, Kentucky at the time. ³⁹ In light of this, it appears that James probably died in Morgan County, Kentucky, where some of his children were residing.

The offspring listed below as (male) and (female) were abstracted from the 1810 census of Fleming County, Kentucky. ¹¹¹ These are also believed to be James and Elizabeth's children, but have not been identified.

17. George Christy.

George Christy, the son of Julius Christy and Agatha Barnett, was born in Culpeper County, Virginia in about 1767. ^{4,31} He was later married in Virginia to a woman named Mary Cave. ⁴¹ Although no record of their marriage has been found, based upon the year of birth of their eldest child Elizabeth Christy, it is believed to have taken place in about 1787/1788. ⁴⁰

George and Mary eventually settled in Boone County, Kentucky, where they appear to have resided for the remainder of their lives. In 1801 George served as the second Coroner for Boone County. George Christy died in Boone County, Kentucky in 1804. His will, which had been written on 28 December 1803, was subsequently submitted for probate before the February 1804 session of the Boone County Court. The below listed children were named in George Christy's will.

Ambrose Christy, the son of Julius Christy and his wife, Agatha Barnett, was born in Culpeper County, Virginia on 10 November 1768. ^{33,43} He was later married in Clark County, Kentucky to a woman named Mary "Polly" Bush on 18 June 1794. ^{33,44} Polly, who had been born on 10 June 1774, was the daughter of Francis "Frank" Bush and his first wife, Lucy Davis. ^{43,125,126}

During the Northwest Indian Wars of the 1790's, Ambrose Christy is said to have served under General Harmer. And, according to Goff Bedford's book "Land of Our Father's" he was a Captain in the 17th Regiment of Militia in Clark County, Kentucky in 1799. ^{33,127} Although Ambrose worked as an inspector of tobacco at times, he also was a tavern keeper. ¹²⁷ In 1820, Ambrose served as a Magistrate in Clark County, and in 1823 he served as the Sheriff of Clark County. ¹²⁷

Ambrose and Polly Christy, along with their daughter, Malinda, later moved to Mercer County, Kentucky, where they settled north of Harrodsburg with their daughter Elizabeth and her family. On 9 January 1838, Ambrose and Polly entered into an agreement with their daughter and son-in-law, Elizabeth and William Bush Vivion, where Ambrose and Polly conveyed a 110 acre parcel of land in Clark County, Kentucky, where they had previously been residing, to Elizabeth and William for their guarantee of providing them "a decent and comfortable support" in their old age. ¹²⁸

Ambrose Christy subsequently died on 18 July 1839 in Mercer County, Kentucky, while Mary died there on 28 October 1849. ^{33,43} Both Ambrose and Mary were buried alongside their daughter, Malinda Christy, in the Vivion Family Graveyard at Shakertown in Mercer County. ⁴³

19. John Christy.

John Christy, the son of Julius Christy and Agatha Barnett, was born in Culpeper County, Virginia on 15 November 1769. ^{4,33} He was later married, possibly in Scott County, Kentucky where his parents were residing, to a woman named Hannah Whaley. ^{33,45,46} Hannah, who was a native of Virginia, was calculated to have been born there in 1777. ^{45,46,138} She was the daughter of James Whaley and Lettice Carter. ^{33,45,46}

Shortly after their first child, James, was born, John and Hannah settled in Clark County, Kentucky. On 28 September 1793, John volunteered to serve as a Mounted Horseman in the Northwest Indian Wars under General Charles Scott. ¹³⁹ He was assigned to Captain John Hall's Company of Lt. Colonel Horatio Hall's Regiment of Kentucky Militia. ¹³⁹ On 4 November 1793, however, he was listed as a deserter. ¹³⁹ According to Ruth Ziegel's booklet "The Descendants of Julius and Agatha Barnett Christy," John later served as a Lieutenant in the 17th Regiment of Militia in Clark County, Kentucky in 1799. ³³

John Christy subsequently died in Clark County, Kentucky on 19 June 1848. ^{33,47} His will, which had been written on 21 January 1846, was later probated during the June 1848 session of the Clark County Court. ⁴⁷ Hannah, on the other hand, died in Clark County on 15 June 1855. ^{33,45} Both John and Hannah may have been buried in the Hunt Graveyard in Clark County, but there are no engraved markers to substantiate this.

20. Sarah Christy.

Sarah Christy, the daughter of Julius Christy and Agatha Barnett, was born in Culpeper County, Virginia in about 1771. ^{4,31} She was later married in Woodford County, Kentucky to a man named Elijah Davis on 21 September 1790. ^{4,48} No additional information has been found concerning this couple.

21. Samuel Christy.

Samuel Christy, the son of Julius Christy and Agatha Barnett, was born in Greenbrier County, Virginia (now within West Virginia) on 21 February 1782. ⁴⁹ He later moved with his parents to Kentucky, where they settled in that portion of Fayette County, Kentucky that was formed into Woodford County, Kentucky in 1789, but was later formed into Scott County, Kentucky in 1792. ²⁶

Sometime later, however, Samuel appears to have moved with his older brother, James Christy, to what became Fleming County, Kentucky in 1798. ²⁶ Samuel and his older brother, James, both acquired personal property from their father, Julius Christy, by two recorded bills-of-sale that were both dated 3 February 1803. ³⁰ The bill-of-sale involving Samuel indicated that he had purchased a Negro woman named Lillis, some assorted livestock, and some farming utensils from his father. ³⁰

Samuel was later married in Fleming County, Kentucky to a woman named Mary "Polly" Day on 11 April 1805. ⁵⁰ Polly, who was also a native of Virginia, had been born there on 3 July 1789. ^{49,152} **NOTE:** Although many individuals claim Mary was the daughter of Truman Day and Mary Saunders, this is not correct. Truman's bible record indicates that he did not have any children born before 1790. His daughter, Mary, was born on 27 January 1798, and would have only been seven years old if she married our Samuel Christy. Truman's daughter, Mary, actually was married to a man named Peter G. Oliver on 16 October 1817. As such, Samuel's wife, Mary "Polly" Day, must be the daughter of someone other than Truman Day and Mary Saunders. ¹⁵³

After their marriage, Samuel and Mary remained in Kentucky until the late 1820's, at which time they moved to Decatur County, Indiana. Shortly after arriving in Decatur County, Indiana, Samuel Christy purchased 80 acres of land from a Mr. Isaac Parnell for \$150.00 on 31 December 1829. ¹⁵⁴ He subsequently purchased an additional 40 acres of land in Decatur County from the General Land Office of the United States on 2 April 1835. ¹⁵⁵ According to the 1850 federal census of Decatur County, Indiana, Samuel and his family were residing in Marion Township, where Samuel worked as a boot and shoemaker. ¹⁵² Samuel died at Greensburg in Decatur County, Indiana on 13 September 1855, while Mary died there on 3 April 1866. ⁴⁹ Samuel and Mary were both buried in the South Park Cemetery at Greensburg, Indiana. ⁴⁹

The offspring listed below as (female) was abstracted from the 1810 census of Fleming County, Kentucky. ¹¹¹ This is also believed to be one of Samuel and Polly's daughter's, but has not been identified.
