## **LOCATIONS**

With respect to the location at which an event took place, there were many cases when it was not possible to find any record giving the exact location that a birth, marriage or death took place. Because I feel quite strongly that dates should always be accompanied by places, if for no other reason than to aid future research, I made a number of assumptions regarding location based upon available information. For instance, if available documents indicate that a family was residing for a period of time in a particular county and state, I did not feel that it was unreasonable to assume that any children they had during this period, or reasonable close to this period, were probably born in that county and state. In some cases, however, my comfort level with assuming a possible location was limited to a state only. The same is also true for some marriages and deaths.

## **DATES**

For the most part, many conflicting dates were easily straightened out by simply rechecking the source material or official records. In some cases, however, marriage dates may vary from other published works because the researcher used the date of a marriage bond, or the date a marriage license was issued, instead of the actual marriage date. Even though some of the source material I used did not specify the origin of the marriage date given, I have tried to differentiate the marriage dates as accurately as possible. In a number of cases an approximate date of marriage, using the abbreviation "ca." for circa (about), is shown based upon information provided in various census documents.

Another dating problem involves the recording of marriage banns. A couple's intentions to marry, or banns of marriage, were generally proclaimed in church on three consecutive Sundays, and if no legal impediments precluded the couple from being married, their marriage would be sanctioned after the third proclamation. Unfortunately, the first or second proclamation will often be cited as the marriage date instead of the third. I must admit, however, that this is difficult to avoid in some cases because of missing or damaged records.

Death dates may also vary in that the date of burial, or the date a will was written or submitted for probate, will sometimes be cited by others instead of the actual death date. In those cases where I was unable to verify which of two dates was correct, I generally went with the one that referenced the most credible source material, or simply used the year only.

One of the most common dating conflicts involves the use of the Julian Calendar versus the Gregorian Calendar. On 14 September 1752, the Gregorian Calendar was adopted in both Great Britain and its colonies in North America, and the first day of the year then became January 1. Prior to that date, the Julian Calendar was in effect and the first day of the year was March 25. As a consequence, many dates found in the 1600's and first half of the 1700's for the months of January, February, and March reflect, or should reflect, a double date, such as 15 February 1735/1736. Even though both dates may be perfectly acceptable based upon the calendar that was in use at the time, to be consistent with current dating procedures the second date is most accurate.

**1. John Gibbs. \***

John Gibbs (also written Gibbes), the son of Gregory Gibbes and his first wife, was born in about 1600 in Dorsetshire, England.<sup>1</sup> In 1619, John sailed from the port of Weymouth in Dorsetshire aboard the ship "Supply," bound for the English Colony of Jamestown in Virginia.<sup>1</sup> John Gibbs fortunately survived the massacre of Virginia colonists by Indians in 1622, and even though some historians believed that he was killed, a "List of the Livinge and Dead in Virginia" dated 16 February 1623/1624 listed John as being one of the surviving inhabitants of Jordan's Journey.<sup>1,2</sup> During the following year, 1625, John was commissioned a Lieutenant of Militia at Jordan's Journey.

Although John was later married, neither the name of his wife, nor their place of marriage, have been determined with any certainty. After their marriage, John and his wife appear to have continued to reside at Jordan's Journey, which had been incorporated into Charles City County, Virginia in 1634. He later served as a Gentleman Justice of Charles City County during the period 1655 through 1659.<sup>1</sup> While still serving in that capacity John witnessed an agreement between two merchants in Charles City County on 31 January 1658/1659.<sup>1</sup>

According to available Court Order Books for Charles City County, Virginia, John died in Charles City County on 10 January 1659/1660.<sup>1</sup> John's wife is known to have survived him as Charles City County Court records indicate that she subsequently received her one third right of dower in John's estate in 1660, as well as payments of tobacco in 1661 and 1662.<sup>1</sup> Unfortunately, the date and place of her death have not been determined. The children listed below were taken from the book "From Castle to Country, A Gibbs Family History From 1378 to Present." by Stanley Eugene Gibbs.<sup>1</sup>

### 3. Gregory Gibbs. \*

Gregory Gibbs, the son of John Gibbs, was born on 10 October 1635 in Charles City County, Virginia.<sup>1,3</sup> He was later married in Virginia to a woman named Mary.<sup>1,4</sup>

Sometime prior to 1680, Gregory and Mary apparently settled in Christ Church Parish in Middlesex County, Virginia, as their son, John, was christened there in that year.<sup>5</sup> Gregory Gibbs appears to have later died in Middlesex County, Virginia in about 1683.<sup>4</sup> This year of death is based upon an entry contained in 'Wills and Inventories, 1673-1812 and Other Court Papers, Order Book 2, 1680-1694' by William L. Hopkins.<sup>4</sup> This entry, which was dated 5 November 1683, states: "Mary Gibbs, widow of Gregory Gibbs, binds her son William Gibbs, age 10, to Mr. Richard Willis until age 21."<sup>4</sup> In a subsequent entry dated 3 October 1687, it states: "George Gibbs, the orphan son of Gregory Gibbs deceased, is bound to Robert George for 10 years to learn trade of a shoemaker."<sup>4</sup>

In addition to a listing of Gregory and Mary's children contained in Volume I of the book "From Castle to Country, A Gibbs Family History From 1378 to Present." by Stanley Eugene Gibbs, their children were also identified through various parish and court records.<sup>1</sup>

#### **9. Thomas Gibbs.**

Thomas Gibbs, believed to be the eldest son of Gregory and Mary Gibbs, was born in about 1671/1672 in Charles City County, Virginia.<sup>1,4</sup> He was later married in Virginia to a woman named Mary.<sup>1,5</sup> Unfortunately, neither Mary's maiden name, nor her parentage, are known.

Sometime after their marriage, Thomas and Mary Gibbs apparently moved north into Spotsylvania County, Virginia, where Thomas appears to have died in 1763.<sup>1,6</sup> In accordance with a listing of Administration Bonds which was found in Will Book D (1761-1772) of Spotsylvania County, Virginia, a fifty pound bond was posted by a man named Peter Marye as "Administrator of Thomas Gibbs, deceased, with Joseph Herndon second, October 4, 1763."<sup>1,6</sup>

#### **10. William Gibbs.**

William Gibbs, the son of Gregory and Mary Gibbs, was calculated to have been born in Charles City County, Virginia in 1673.<sup>1,4</sup> According to the Middlesex County, Virginia Court records, on 5 November 1683, William Gibbs, aged 10 years, was bound to a man named Richard Willis until he attained the age of twenty-one.<sup>4</sup> Aside from this record, no additional information has been found concerning this individual.

11. **Joan Gibbs.**

Joan Gibbs, the daughter of Gregory and Mary Gibbs, was born in Charles City County, Virginia.<sup>1</sup> She was subsequently christened on 15 May 1674 in Charles City County.<sup>1</sup> No additional information has been found concerning this individual.

12. **Penelope Gibbs.**

Penelope Gibbs, the daughter of Gregory and Mary Gibbs, was born in Charles City County, Virginia.<sup>1</sup> She was subsequently christened on 10 August 1676 in Charles City County.<sup>1</sup> No additional information has been found concerning this individual.

13. **George Gibbs.**

George Gibbs, the son of Gregory and Mary Gibbs, is believed to have been born in Middlesex County, Virginia.<sup>1</sup> According to the Middlesex County Court records, George was bound on 3 October 1687 to a man named Robert George for a period of ten years to learn "the Arte and Mistery of a Shoemaker."<sup>4</sup> Aside from this record, no additional information has been found concerning this individual.

14. **John Gibbs.** \*

John Gibbs, the son of Gregory and Mary Gibbs, was born in Middlesex County, Virginia.<sup>5</sup> He was subsequently christened in Christ Church Parish in Middlesex County on 10 October 1680.<sup>5</sup> John was later married to a woman named Mary, and even though no record of their marriage has been uncovered, it is believed to have taken place in 1698 in Virginia.<sup>1,5,7</sup> Mary, who was also a native of Middlesex County, Virginia, had been born there in 1684.<sup>8</sup>

At a Court of Claims held for the County of Middlesex on 14 November 1699, John Gibbs received 400 pounds of tobacco as a bounty for the heads of two wolves he had shot.<sup>9</sup> And later, on 5 June 1704, he was appointed a Constable for the Middle Precincts of Middlesex County.<sup>9</sup> On 5 May 1707, John was appointed Surveyor of Highways from Brandon to Grant Church, and from Turkes Ferry over Gardner's Swamp.<sup>9</sup> Although John was released from this position on 7 December 1708, he was subsequently re-appointed on 7 April 1714.<sup>9</sup>

John and Mary appear to have remained in Middlesex County, Virginia throughout their lives. John Gibbs died in Middlesex County on 31 January 1725/1726, while Mary died there on 13 September 1728.<sup>1,5,8</sup> Both John and Mary were subsequently buried in the Christ Church Cemetery at Saluda in Middlesex County, Virginia.<sup>8</sup> John's will, which had been written on 14 June 1725, was later probated before the Middlesex County Court on 5 April 1726.<sup>1,7</sup>

With the exception of Ann Gibbs, all of the children listed below were found in the christening records of Christ Church Parish in Middlesex County, Virginia.

Mary Gibbs, the daughter of Gregory and Mary Gibbs, was born in Middlesex County, Virginia. <sup>1</sup> No additional information has been found concerning this individual.

Margaret Gibbs, the daughter of Gregory and Mary Gibbs, was born in Middlesex County, Virginia. <sup>1</sup> No additional information has been found concerning this individual.

### 17. **Richard Gibbs.**

Richard Gibbs, the son of Gregory and Mary Gibbs, was born in Middlesex County, Virginia.<sup>5</sup> He was later married in Christ Church Parish in Middlesex County to a woman named Penelope Doughton on 16 November 1711.<sup>5</sup> Penelope, who had been born in Middlesex County, Virginia on 12 October 1692, was subsequently christened in Christ Church Parish on 26 November 1692.<sup>5</sup> She was the daughter of Anthony and Elizabeth Doughton (also written Dewton, Douton, and Doulin).<sup>5</sup>

According to the Middlesex County Court Order Books, on 4 August 1713, Richard's name was to be added to the "List of Tythables" for that County.<sup>9</sup>

Elizabeth Gibbs, the daughter of John and Mary Gibbs, was born in Middlesex County, Virginia. <sup>1,5</sup> She was subsequently christened in Christ Church Parish in Middlesex County on 22 January 1698/1699. <sup>5</sup> Elizabeth was later married to a man named Gabriel Ray on 22 November 1713 in Christ Church Parish. <sup>5</sup>

Elizabeth, who was the mother of one child by Gabriel, died on 22 October 1716 in Middlesex County, Virginia. <sup>5</sup>

## 22. John Gibbs.

John Gibbs, the son of John and Mary Gibbs, was born in Middlesex County, Virginia. <sup>1,5</sup> He was subsequently christened on 9 October 1702 in Christ Church Parish in Middlesex County. <sup>5</sup> John died on 31 March 1708 in Middlesex County, and was subsequently buried there on 1 April 1708. <sup>5</sup>

## 23. Zachariah Gibbs.

Zachariah Gibbs (also written Zacharias Gibbs), the son of John and Mary Gibbs, was born in Middlesex County, Virginia. <sup>1,5</sup> He was subsequently christened in Christ Church Parish in Middlesex County on 1 February 1703/1704. <sup>5</sup> Zachariah was later married in about 1728 in Virginia to a woman named Mary Massie (also written Massey). <sup>1</sup>

Sometime prior to 1733 Zachariah and Mary moved into that portion of Spotsylvania County, Virginia that was later formed into Orange County, Virginia in 1734, but was subsequently formed into Culpeper County in 1748. On 3 April 1733, shortly after moving to Spotsylvania County, Zachariah purchased 100 acres of land in St. Marks Parish from a man named Richard Maulder. <sup>6</sup> Zachariah's brother-in-law, John Barnett, purchased the adjoining 184 acres from Mr. Maulder on the same day. <sup>6</sup> Zachariah subsequently acquired an additional 400 acres of land in what had recently become Orange County, Virginia on 9 August 1735. <sup>13</sup> This property was situated near the mouth of Beautiful Run, a small tributary that flows into the Rapidan River. <sup>13</sup>

Zachariah subsequently died on 16 September 1773 in Culpeper County, Virginia. <sup>1</sup> His will, which had been written on 5 August 1773, was later probated in Culpeper County on 16 November 1773. <sup>1,14</sup> In his will, Zachariah named his three surviving sons and one daughter, but referred to four other daughters whose names were not given. <sup>1,14</sup>

Marran Gibbs, the daughter of John and Mary Gibbs, was born in Middlesex County, Virginia. <sup>1,5</sup> She was subsequently christened on 20 April 1707 in Christ Church Parish in Middlesex County. <sup>5</sup> This child died young.

#### 25. Marran Gibbs. \*

Marran Gibbs, the daughter of John and Mary Gibbs, was born in Middlesex County, Virginia. <sup>1,5</sup> She was subsequently christened on 30 January 1708/1709 in Christ Church Parish in Middlesex County. <sup>5</sup> Marran was later married to a man named John Barnett in Christ Church Parish on 13 November 1728. <sup>5</sup> John, who was also born in Middlesex County, had been christened on 3 December 1704 in Christ Church Parish. <sup>5</sup> He was the son of John and Ann Barnett. <sup>5</sup>

Sometime prior to 1733 John and Marran apparently moved into Spotsylvania County, Virginia, where they resided within the boundaries of Saint Mark's Parish.<sup>6</sup> On 3 April 1733, shortly after moving to Spotsylvania County, John purchased 184 acres of land in St. Marks Parish from a man named Richard Maulder.<sup>6</sup> John's brother-in-law, Zachariah Gibbs, purchased the adjoining 100 acres from Mr. Maulder on the same day.<sup>6</sup> This property was situated in that portion of Spotsylvania County that was later incorporated into Orange County, Virginia in 1734. John Barnett died in 1750 in Orange County, Virginia.<sup>20</sup> His will, which had been written on 1 April 1750, was probated on 24 May 1750 in Orange County, Virginia.<sup>20</sup> Although Marran is known to have survived John, and to have also died in Virginia, the actual date her death has yet to be determined.<sup>20</sup>

## 26. Mary Gibbs.

Mary Gibbs, the daughter of John and Mary Gibbs, was born in Middlesex County, Virginia. <sup>1,5</sup> She was subsequently christened on 22 April 1711 in Christ Church Parish in Middlesex County. <sup>5</sup> Mary was later married in Christ Church Parish to a man named George Neville on 20 June 1729. <sup>5</sup> George, who had been born in about 1695 in Virginia, was the son of John Neville and Elizabeth Bohanan. <sup>29</sup> This was George's second marriage, as he had previously been married in Christ Church Parish to a woman named Hannah "Anna" Symes on 22 June 1725. <sup>5</sup> Hannah, who had been born in Middlesex County on 29 September 1706, was the daughter of Thomas and Ann Symes. <sup>5</sup> She subsequently died on 31 December 1728 in Middlesex County. <sup>29</sup> George Neville had two daughters from his previous marriage to Hannah Symes. These were Mary (b. 11 December 1726, m. John Rosser); and Elizabeth "Betty" (b. 3 December 1728 and d. 23 December 1728). <sup>5,10,29</sup>

Shortly after their first child, Elizabeth, was born, George and Mary apparently moved to Prince William County, Virginia, where they owned and operated an ordinary "inn," as well as a saw mill and plantation. <sup>29</sup> This inn was situated in that portion of Prince William County that was later formed into Fauquier County, Virginia in 1759. George Neville subsequently died in 1774 in Fauquier County, Virginia. <sup>10</sup> His will, which had been written on 26 February 1774, was probated on 27 June 1774. <sup>10</sup> Although Mary is known to have survived George, and is also believed to have died in Fauquier County, Virginia, the actual date of her death is not known. <sup>10</sup>

27. **John Gibbs.**

John Gibbs, the son of John and Mary Gibbs, was born on 5 April 1716 in Middlesex County, Virginia. <sup>1,5</sup> He was subsequently christened in Christ Church Parish in Middlesex County on 4 May 1716. <sup>5</sup> John was later married in Virginia to a woman named Suzanne Phillipe. <sup>12</sup>

Although John and Suzanne remained in Virginia for many years after their marriage, they later moved south into the state of North Carolina, where they settled in what was then Butte County. They eventually were found residing in that portion of Ninety-Six District, South Carolina, however, that was formed into Spartanburg County in 1785. Prior to settling in South Carolina, John and Suzanne applied for a North Carolina land grant in South Carolina containing 300 acres of land on Duggins' Branch of Fairforest Creek, a tributary of the Tyger River. This land was subsequently surveyed on 8 December 1766. <sup>35</sup>

Although John Gibbs is believed to have died in Ninety-Six District, South Carolina, the actual date of his death is not known at this time. His widow, Suzanne, however, was last mentioned in a property deed between Philip Gibbs of Wilkes County, Georgia and Henry Ayres, which was dated 29 September 1786. This document, which was found in "Spartanburg County-District, South Carolina, Deed Abstracts, Books A-T, 1785-1827," compiled by Albert Bruce Pruitt, states in part "..... except for ½ land where Susanne Gibbs, mother of Philip Gibbs, now lives and ½ of the orchard to be Susanne's as long as she pleases or lives: John Gibbs, deceased, gave his place to his son Philip Gibbs by a will." <sup>36</sup> This deed was signed by Philip and Phebe Gibbs. <sup>36</sup>
