THE LINDSEY / LINDSAY SURNAME

The surname Lindsey is an English surname that was originally derived from the territory of Lindsey in Lincolnshire, from the Old English toponym Lindesege ("Lindum Isle"), i.e. "marshlands of Lincoln." The variant surname of Lindsay was later established in Scotland from whence our particular family is believed to have come from. Although David and his descendant's were identified by both spellings, as well as other variations, the Lindsey spelling became used most often.

DATES

For the most part, many conflicting dates were easily straightened out by simply rechecking the source material or official records. In some cases, however, marriage dates may vary from other published works because the researcher used the date of a marriage bond, or the date a marriage license was issued, instead of the actual marriage date. Even though some of the source material I used did not specify the origin of the marriage date given, I have tried to differentiate the marriage dates as accurately as possible.

In a number of cases an approximate date of marriage, using the abbreviation "ca." for circa (about), is shown based upon information provided in various census documents. This is also true with respect to death dates which may also vary in that the date of burial, or the date a will was written or submitted for probate, will sometimes be cited by others instead of an actual death date. In those cases where I was unable to determine an actual death date the abbreviation "ca." may be used, or only the known year of death may be cited.

LOCATIONS

With respect to the location at which an event took place, there were many cases when it was not possible to find any record giving the exact location that a birth, marriage or death took place. Because I feel quite strongly that dates should always be accompanied by places, if for no other reason than to aid future research, I made a number of assumptions regarding location based upon available information. For instance, if a family is found in the Fayette County, Indiana census records for 1840 and 1850, and they also show up in the deed and tax records of that county for the same period, I did not feel that it was unreasonable to assume that any children they had during this period were probably also born in Fayette County. In some cases, however, my comfort level with assuming a possible location was limited to a state only.

GENERATION ONE

1. David Lindsey. *

David Lindsey (also written Lindsay, Linsay, and Linsey, etc.) is the earliest known progenitor of our Lindsey / Lindsay family to have been positively identified to date. Although very little is known about David, the earliest references which were found that pertain to him were found in the Frederick County, Virginia Court and Militia records. ¹ Those entries are as follows:

Court Records

1749 - Terrance Carrol ordered to pay David and Catherine Lindsey 50 pounds of tobacco each for three days attendance in court on his behalf. ¹

June 1752 - David Linsey ordered to pay John Funk 1 pound, 16 shillings, and 6 Pence. ¹

3 June 1767 - William Dempster ordered to pay David and Catherine Lindsey 50 pounds of tobacco each for their attendance in court to testify in a suit with Ralph Withers. ¹

Militia Records

2 September 1755 - David Lindsey is listed as a member of the Frederick County Militia in the Company commanded by Captain Marquis Calmes. ² David was one of the Militia members living in that part of Frederick County that later became Clarke County, Virginia in 1836. ² Also listed were: Captain John Lindsey, and privates John Lindsey, Abraham Lindsey, Isaac Lindsey, and Edmund Lindsey. ²

Based upon these entries, David and his family were evidently residing in Frederick County, Virginia during the period 1749-1767, but how long before or after this period is not known. Although it is known, based upon the above court records, that David was married prior to 1749 to a woman named Catherine, nothing else has been found concerning her, or her parents. ¹ David and Catherine are not only believed to have been married in Frederick County, Virginia, but based upon the time period they are known to have resided there, all of their children would have been born there as well. ¹

Even though it has yet to be proven, it is very possible that David was related to the other Lindseys / Lindsays listed above, and that Captain John Lindsey may even have been his father. Captain John Lindsey was found in some of the earliest Frederick County records as taking up land in 1735, and David named a son John. Regardless of the above, all available data suggests that David was probably born someplace other than Frederick County, Virginia and moved there as a child.

Sometime prior to early 1771, David and his family had apparently left Frederick County and moved southwest into that portion of Botetourt County, Virginia that was later formed into Greenbrier County, Virginia in March 1778 (now within West Virginia). ³ David and Catherine Lindsey, as well as several of their children, were found in a number of Botetourt County, Virginia records during the 1770's, including the ledger books of the Mathews Trading Post. ⁴ This trading post, which was owned and operated by Sampson and George Mathews, was situated along the Greenbrier River in what is now Greenbrier County, West Virginia. ^{3,4}

David Lindsey appears to have died in late 1772, or very early 1773, in that portion of Botetourt County, Virginia that is now within Greenbrier County, West Virginia. ^{3,4} This is confirmed by two entries in the Mathews Trading Post ledger. ⁴ One entry shows that David Lindsey purchased salt and a weeding hoe from the trading post on November 1772, while the other entry, which was dated January 1773, refers to Catherine Lindsey as being a "widow." ⁴

Catherine Lindsey was later found, along with two of her children, in the "Virginia Heads of Families, Greenbrier County, 1783-1786." ⁵ She was also found in a Greenbrier County deed record that was dated 11 July 1785. ⁶ This deed record, which consisted of a bill of sale between John Lindsey and his mother, Catherine Lindsey, involved the sale of a negro woman named Nan, as well as various items of household furniture and tools. ⁶ Whatever became of Catherine Lindsey after 1785/1786 is not know at this time.

The following children were identified from the ledger entries of the Mathews Trading Post. ⁴

GENERATION TWO

2. Robert Lindsey.

Robert Lindsey (also written Lindsay, Linsay, and Linsey), the son of David and Catherine Lindsey, was born in Frederick County, Virginia. ^{1,4} His name was later found in the records of the Mathews Trading Post making purchases of various and sundry goods during the years 1771 through 1774. ⁴ Robert was also shown in the March and August 1775 list of Botetourt County, Virginia titheables who were residing in the Greenbrier area. ¹⁵

According to the available Botetourt County, Virginia will records, Robert apparently died there in 1776. ⁷ This is further supported by a 1776 entry found in the Mathews trading Post ledge, which refers to the "estate of Robert Lindsey," indicating that he was deceased in that year. ⁴ And, even though Robert was shown on a 1776 roster of men called into service during the Revolutionary War, a notation by his name stated he was exempt from service because he was deceased. Robert is believed to have been unmarried at the time of his death.

3. John Valentine Lindsey. *

John Lindsey (also identified in various records as John Lindsay, Linsay, and Linsey), the son of David and Catherine Lindsey, was calculated to have been born in Frederick County, Virginia in about 1757. ^{1,4,8,9} This year was calculated from a deposition that John gave on 13 December 1803 at the Boone County, Kentucky Courthouse, in which he stated he was "about 46 years" of age. ⁹

Verification that David and Catherine Lindsey were indeed the parents of our John Lindsey was discovered in the deed records of Greenbrier County, Virginia (now West Virginia). ⁶ This document, was a bill of sale involving John Lindsey and his mother Catherine Lindsey. ⁶ It states:

"I hereby acknowledge that I have sold unto Catherine Linsay, my mother, a Negro Woman named Nan (which I had of Rob't Allen), all the bed and household Furniture thats in the House, and all the working Tools of whatever kind, on the plantation of my property, the Right of which I hereby deliver unto said Catherine, her heirs and assigns for ever, for and in Consideration of a Bond she had on me of Five hundred pounds penalty, for her dower as Widow and Relict of David Lindsey, my Father, as Witness thereof I have hereunto set my Hand and Seal this 11th July 1785." ⁶

After the Lindsey family settled in Botetourt County, John was next found in the records of the Mathews Trading Post making purchases of various and sundry goods during the years 1771 through 1777. ⁴ John was also shown in the March and August 1775 list of Botetourt County, Virginia titheables who were residing in the Greenbrier area. ¹⁵

John Lindsey was later married to a woman named Anna Christy. ^{8,10,11} Although no record of their marriage has been found, it is believed to have taken place in about 1777 in that portion of Botetourt County, Virginia that was later formed into Greenbrier County, Virginia (now within West Virginia) in 1778. ^{3,8,10,11,16} Anna, who was a native of Culpeper County, Virginia, was the daughter of Julius Christy and Agatha Barnett. ^{10,11}

On 8 January 1780, John Lindsey obtained a grant of 400 acres of land on the north side of the Greenbrier River "by right of settlement prior to 1 January 1778." ¹⁷ He subsequently acquired another grant of 400 acres of land on the north and northwest side of the Greenbrier River under the same condition on 15 January 1780. ¹⁷ John later acquired an additional 236 acres of land in Greenbrier County by State Treasury Warrants. ¹⁷

According to available court records, John and two of his sisters were involved in a number of lawsuits during the 1780's, and John served on several juries during 1783 and 1784. ¹³ Although the disposition of all of John Lindsey's land holdings has not been determined, on 26 February 1788 he sold a portion of his lands to Andrew Hamilton and William Elliot. ⁶ Soon after this, he and his family appear to have moved further west into the state of Kentucky, where they settled in Scott County.

Unfortunately, little information concerning John has been found covering the time he spent in Kentucky. His will, which was written on 29 September 1805, was admitted for probate before the Scott County Court during the January 1806 term, thereby indicating the period within which he passed away. ¹² An Inventory of his estate was submitted to the Scott County Court on 27 January 1806. ¹²

John's widow, Anna, remarried several years after John's death to a man named Spencer Stone. ^{8,10} Although this marriage is believed to have taken place in about 1818 in Scott County, Kentucky, many of the Scott County records were destroyed in a fire and no documents have been found to confirm this. ⁸ Spencer Stone was the father of the Elias Barbee Stone who married Catherine Houston Lindsey, one of John and Anna Lindsey's daughters. ⁸

Although Anna and Spencer probably resided for a short time in Scott County, they eventually moved to Lincoln County, Kentucky, where Spencer owned a small farm on the banks of the Dix River which he was granted for his service in the Revolutionary War. ^{8,18} This farm was located in that portion of Lincoln County, Kentucky that was later formed into Boyle County in 1842. ¹⁹ It was there that Spencer Stone passed away on 1 January 1838. ^{8,20} Shortly after this, Anna moved to Fayette County, Indiana to be near some of her children from her first marriage to John Lindsey. Anna died in Fayette County, Indiana in 1844. ²¹ Her last will and testament, which had been written on 8 October 1844, was subsequently submitted for probate before the Fayette County Court on 19 November 1844.

4. Sarah "Sally" Lindsey.

Sarah Lindsey (also written Lindsay, Linsay, and Linsey), the daughter of David and Catherine Lindsey, was born in Frederick County, Virginia. ^{1,4} She was later married in Greenbrier County, Virginia (now in West Virginia) to a man named William Lockridge (also written Loughridge) on 10 April 1778. ^{13,14} William, who is believed to have been born in about 1748 in Augusta County, Virginia, was the son of William Lockridge and Agnes Gwinn. ^{14,34}

Sarah was later listed in the Greenbrier County Court records as a defendant in a lawsuit, along with her brother, John, and sister, Rebecca, in May of 1784. ¹³ Although William Lockridge and his brother John Lockridge had moved from Augusta County, Virginia to Greenbrier County, Virginia (now West Virginia) his parents remained in Augusta County. William was last mentioned in his father's will, which had been written on 12 March 1793 and probated during the September term of the Augusta County, Virginia Court. ¹⁴ William and Sarah Lockridge are believed to have moved to Kentucky, where both may have eventually died. ¹⁴

5. Jane Lindsey.

Jane Lindsey (also written Jean Lindsay, Linsay, and Linsey), the daughter of David and Catherine Lindsey, was born in Frederick County, Virginia. ^{1,4} She was shown in the "Virginia Heads of Families, Greenbrier County, 1783-1786," along with her mother, Catherine, and brother, John. ⁵ She was also found in the Mathews Trading Post ledger under the years, 1772 and 1774. ⁴ No additional information has been found concerning this individual.

6. Rebecca Lindsey.

Rebecca Lindsey (also written Linsay, Linsey, and Lindsey), the daughter of David and Catherine Lindsey, was born in Frederick County, Virginia. ^{1,5} She was shown in the Mathews Trading Post ledger under the year 1773 as "Miss Rebecka Lindsey." ⁵ Rebecca was also listed in the Greenbrier County Court records as a defendant in a lawsuit, along with her brother, John, and sister, Sarah, in May of 1784. ¹³ This lawsuit also verified that Rebecca Lindsey was married to a man named James Gillilan (also written Gilliland). ¹³

7. Elizabeth "Bettie" Lindsey.

Elizabeth Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and Anna Christy, was born on 10 May 1778 in Greenbrier County, Virginia (now in West Virginia). ⁸ She was later married to a man named Henry Dicken in Scott County, Kentucky on 24 April 1800. ⁸ Henry, who had been born on 23 March 1775 in Culpeper County, Virginia, was the son of Richard Dicken and Martha Lewis. ^{8,35,36}

Elizabeth subsequently died on 31 July 1842 in Fayette County, Indiana, while Henry died on 11 April 1857 in Wabash County, Indiana. ^{8,35} Henry was subsequently buried in the Daniels Cemetery at Servia in Wabash County, Indiana. ³⁵

8. Robert "Robin" Lindsey.

Robert Lindsey (also written Lindsay), the son of John Valentine Lindsey and Anna Christy, was born in Greenbrier County, Virginia (now in West Virginia). ⁸ Although the name of Robert's wife has not been determined, he is believed to have been married in about 1806/1807 in Scott County, Kentucky. ⁸

Robert and his brother, John, later purchased land in Scott County, Kentucky from Spencer Stone and their mother, Anna (Christy) Lindsey Stone, on 28 May 1818. ⁴² Robert and his family were later enumerated on the 1820 census of Scott County, Kentucky. ⁴³ The last document in which our Robert Lindsey was found, was a mortgage which had been drawn up between Robert and a Mr. B. S. Chambers. ⁴² This mortgage was for \$600 and dated 20 December 1826. ⁴²

Even though the actual date of Robert Lindsey's death has not been determined, it is believed that both Robert and his wife died in about 1828/1829 in Scott County, Kentucky. ^{8,22,23} With the exception of his eldest daughter, all of Robert's other daughters were shown residing with his unmarried sister, Rebecca Lindsey, on the 1830 census of Scott County. ²² Unfortunately, what became of Robert's sons has not been determined.

The offspring listed below as (male) and (female) were abstracted from the 1820 and 1830 census enumerations of Scott County, Kentucky. ^{22,43} Although these are all believed to be Robert's children, some of their identities have not been determined.

NOTE: Although there was a Robert Lindsey listed on both the 1820 and 1830 federal censuses of Scott County, Kentucky, I do not believe that these are the same Robert Lindsey, however. Of those seven children who were listed with the Robert Lindsey on the 1820 census, only three match up with those children who were listed on the 1830 census. The Robert Lindsey who is shown on the 1820 census is believed to be our Robert Lindsey, while the Robert Lindsey who is shown on the 1830 census had twelve children, and is known to be the Robert Lindsey who settled in Highland County, Ohio in 1834. In addition, none of the children who belonged to the Robert Lindsey who was listed on the 1830 census and moved to Highland County, Ohio had the same given names as the two known daughters of our Robert Lindsey; namely Ann and Amanda Lindsey.

9. Mary "Polly" Lindsey.

Mary Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and Anna Christy, was born in Greenbrier County, Virginia (now in West Virginia). ^{8,19} She was later married to a man named Titsworth. ⁸ No additional information has been found concerning this couple.

10. Rebecca Lindsey.

Rebecca Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and Anna Christy, was calculated to have been born in 1784 in Greenbrier County, Virginia (now in West Virginia). ^{8,24,25} She was residing with her niece, Ann Lindsey Fox, in Trimble County, Kentucky at the time of her death. ^{24,44}

Rebecca Lindsey apparently remained single throughout her life, and died without issue on 15 April 1854 in Trimble County, Kentucky. Her death record indicates that she was seventy years of age, the daughter of John and Ann Lindsey, and that she had been born in Greenbrier County, Virginia (now in West Virginia). ²⁵

11. Sarah "Sally" Lindsey.

Sarah Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and Anna Christy, was probably born in Greenbrier County, Virginia (now in West Virginia). ⁸ She was later married to a man named Mitchell. ⁸ No additional information has been found concerning this couple.

12. Frances Lindsey.

Frances Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and Anna Christy, was calculated from her tombstone to have been born in Scott County, Kentucky on 12 February 1787. ²⁶ Frances was apparently married twice during her life. She married first to a man named James Bryant in Kentucky. ⁸ No issue are known from Frances Lindsey's first marriage to James.

Sometime after her first husband passed away, Frances married for a second time to a widower named John Embree (also written Embry) on 24 May 1820 in Lincoln County, Kentucky. ²⁷ John, who was the son of John Embree, Sr. and Frances "Fanny" Burris had been born during the month of March 1763 in Orange County, Virginia. ^{47,48} This was John's second marriage as he had previously been married to a woman named Susannah Frances Prewitt in Mercer County, Kentucky by a marriage bond that was dated on 5 November 1792. ^{45,48}

Frances and John later moved to Wayne County, Indiana, where they were found residing as late as 1848 according to a deed record. ⁴⁹ Because they were not found on the 1850 census of Wayne County, Indiana, however, they probably moved prior to that date to Missouri, where they settled in Howard County. ^{48,50} John Embree died in Howard County, Missouri during the month of September 1852. ⁴⁸ Frances, who survived John by ten years, eventually moved back to Wayne County, Indiana, where she died on 18 December 1862. ²⁶ She was subsequently buried in the King Cemetery at Richmond in Wayne County, Indiana. ²⁶ No issue are known from Frances' second marriage either.

13. Agnes Lindsey.

Agnes Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and Anna Christy, was probably born in Scott County, Kentucky. ⁸ No additional information has been found concerning this individual.

14. Catherine Houston Lindsey. *

Catherine Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and Anna Christy, was born in Scott County, Kentucky on 17 September 1795. ^{8,28} She was later married in Scott County, Kentucky to a man named Elias Barbee Stone. ^{8,28} Although no record of their marriage has been found to date, based upon the date of birth of the eldest child, Sarah Stone, it is thought to have taken place in about 1812/1813. ⁵¹ Elias, who had been born on 20 February 1790 in Lincoln County, Kentucky, was the son of Spencer Stone and Nancy "Sally" Smith. ⁸

Although Elias and Catherine were married in Scott County, Kentucky, by the time the 1820 census was taken they were residing in Lincoln County, Kentucky. ⁵² Two years later, however, Elias and Catherine moved to Indiana, where they resided first in Fayette County, but later moved into Wabash County. ^{53,54,55,56} Elias Stone, who had been a miller and farmer throughout his life, died on 27 July 1870 in Wabash County, Indianan. ^{8,28} Catherine, on the other hand, died on 21 August 1873 at the home of her nephew, Hiram Lindsey, in Liberty Township in Wabash County, Indiana. ^{8,28} Both Elias and Catherine were subsequently buried in the Boundary Line Church Cemetery near La Fontaine in Wabash County.

This cemetery, which was situated upon land that Elias had acquired for such a purpose, was originally established as a private burying ground in 1863. ²⁸ Its use was later opened to the general public, however. ²⁸

15. John Valentine "Jack" Lindsey.

John Valentine "Jack" Lindsey (also written Lindsay), the son of John Valentine Lindsey and his wife, Anna Christy, was born on 5 September 1797 in Scott County, Kentucky.

He was later married on 21 August 1827 to a woman named Catherine Miller in Lincoln County, Kentucky.
Catherine, who was also a native of Kentucky, had been born there on 14 September 1809.

Sometime prior to when the 1830 federal census of Indiana was enumerated, John and Catherine Lindsey had moved north into the state of Indiana, where they settled in Fayette County. ⁵³ Although not much is known about John and Catherine Lindsey, it is believed that they resided on a farm in Fairview Township in Fayette County, Indiana until John's death in 1861. ⁸ What ever became of Catherine is not known, however.

16. **Jane Lindsey.**

Jane Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and Anna Christy, is believed to have been born in about 1799 in Scott County, Kentucky. ⁸ She was later married on 28 October 1824 in Lincoln County, Kentucky to a man named Cuthbert Burton. ²⁷ Cuthbert, who was calculated to have been born in 1769 in Virginia, was the son of Charles Burton and Mary Hunt. ⁶⁹ This was Cuthbert's second marriage, as he had previously been married to a woman named Martha Willis. ⁶⁹

Shortly after their marriage, Jane and Cuthbert moved to Allen County, Kentucky, where Jane is believed to have subsequently died. Jane was last found on the 1840 census of Allen County, Kentucky. ²⁹ Cuthbert, on the other hand, died in Allen County in 1864. ⁶⁹ His will, which had been written on 17 May 1855, was later probated during the July 1864 term of the Allen County Court. ⁶⁹ Although Cuthbert and his first wife, Martha, are known to have had a large family, no issue are known from Cuthbert's marriage to Jane. ⁶⁹

17. Permelia Lindsey.

Permelia Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and Anna Christy, is believed to have been born in about 1801 in Scott County, Kentucky. ⁸ She was later married on 5 December 1818 in Lincoln County, Kentucky to a man named William R. Feland. ³⁰ William, who had been born in about 1795 in Lincoln County, Kentucky, was the son of James Feland and Isabella Robinson. ^{70,71}

After their marriage, Permelia and William resided on a farm along the Hanging Fork tributary of the Dix River in Lincoln County. William Feland is believed to have died in about 1836 in Lincoln County, Kentucky. ⁷² This is based upon the will of James Feland, which was dated 2 March 1837, in which he mentions "William Feland of Lincoln County, Kentucky, lately deceased." ⁷² Whatever became of Permelia is not known.

The offspring listed below as (male) or (female) were abstracted from available pre-1850 census records. These are all believed to be William and Permelia's children, but their identities have not been determined as yet.

18. Martha "Patsy" Lindsey.

Martha Lindsey (also written Lindsay), the daughter of John Valentine Lindsey and his wife, Anna Christy, was calculated to have been born in 1803 in Scott County, Kentucky. ³¹ She was later married on 21 December 1824 in Lincoln County, Kentucky to a man named Ludwell Duncan. ³⁰ Ludwell was the son of Moses Duncan and Cynthia Withers. ^{74,75}

By the time the 1830 federal census of Kentucky was enumerated, Ludwell and Martha had moved to Oldham County, Kentucky, where Ludwell's parents and siblings were residing. ⁷⁴ Ludwell subsequently died in Oldham County in 1836. ^{74,75} His will, which had been written on 29 August 1836, was submitted for probate before the Oldham County Court on 17 October 1836. ^{74,75}

After her first husband passed away, Martha married for a second time to a man named Jesse Sage on 11 April 1838 in Oldham County. ^{31,32} Jesse, who was a brick maker by trade, was calculated to have been born in Kentucky in 1815. ³¹ He was the son of the Alexander Sage and Lucy Bennett who had been married in Mercer County, Kentucky by a marriage bond that was dated 4 March 1793. ^{45,76} Jesse Sage, who, appears to have died in Oldham County, Kentucky sometime prior to 1860, as he does not show up on the federal census for that year. ^{31,33} Martha was listed on the 1860 census of Oldham County, however. ³³
