I, VIVIAN J. WHITTED, a resident of and domiciled in Chiefland, Levy County, Florida, do make, publish and declare this to be my Last Will and Testament, hereby revoking all Wills and Codicils heretofore made by me.

ARTICLE ONE

I direct that my funeral expenses, the cost of administration of my estate and all my lawful debts be paid as soon as reasonably possible after my death.

ARTICLE TWO

I specifically give and devise to my sister, HELEN L. TRENT, the following items of tangible personal property: China cabinet and matching server; all of my dishes; my four cane back chairs and my desk.

All of the rest, residue and remainder of my estate, including real and personal property of every kind and nature, wheresoever the same may be situated, I give and devise to my step-son, ALLEN O. WHITTED and his wife, ROSANNE WHITTED, or the survivor of them if one of them should predecease me.

ARTICLE THREE

In making this Will, I have considered each person who is related to me or to my deceased husband and have intentionally made

no provision for any persons other than those specifically named in the foregoing Articles.

ARTICLE FOUR

I hereby nominate and appoint my step-son, **ALLEN O. WHITTED** as personal representative of my estate. In the event that my step-son, **ALLEN O. WHITTED** should predecease me or for any reason not be willing or able to serve as personal representative, then I nominate and appoint my sister, **HELEN L. TRENT** as my alternate personal representative. I vest my personal representative with full power and authority to sell, transfer and convey any property, real or personal, which I may own at the time of my death, at such time and price and upon such terms and conditions as he or she may determine and to do every other act and thing necessary or appropriate to the complete administration of this Will and my estate. I direct that my personal representative shall not be required to furnish bond or other security for the faithful performance of his or her duties as my personal representative, in any jurisdiction whatsoever, or if any bond be required in any jurisdiction, he or she shall not be required to furnish any sureties thereon. I have the utmost confidence in the ability, honesty and integrity of the persons named above as my personal representative and my alternate personal representative.
