farmer being of sound mind memory and understanding do hereby
make publish and declare this as and for my last Will and
Testament hereby revoking all other Wills and Testamentary
dispositions (if any) at any time heretofore made by me.
I hereby will devise and bequeath to my Executor and
Trustee hereinafter named all property of every nature
kind or description real or personal which I may die
possessed of or entitled to Upon Trust in the first place
to pay all my just debts funeral and Testamentary expenses
thereout and after payment of same Upon Trust to allow
my sisters Bridget Walsh and Katie Lane during the term
of their natural lives and the life of the survivor of
them to reside in the dwellinghouse on said lands and to
have the entire use and benefit of my said lands during
the term of their natural lives and the life of the
survivor of them and on the death of the survivor Upon
Trust to sell and convert into cash all my estate and
assets and after providing for the funeral expenses of
my said sisters to divide the monies then on his hands
in the following manner:

1. To pay to my cousin Fr. Tom Lane who is at present in
England the sum of £200.0.0.
2. To pay to his brother Fr. Michael Lane the sum of £200.0.0.
3. To pay to his brother John Lane (my Executor and Trustee
hereinafter named) the sum of £200.0.0.
4. To pay to my cousin Mrs. Alice Ryan of Fir Hill Parteen
the sum of £200.0.0.
5. To pay to the Parish Priest for the time being of the
Parish of Clonlara for Masses to be celebrated by him in
public in Ireland for the repose of the souls of my deceased
wife parents brothers sisters and self the sum of £150.0.0.

To pay to the Curate for the time being of the Parish of Clonlara for the like purposes the sum of £150.0.0.
7. To pay over the residue then remaining on his hands to my niece Mrs. Mary Killeen who at present resides in America, should she be living at the date of the death of the survivor of my said sisters and should she be then dead said residue is to go in equal shares amongst her children then living

I will and direct that if for any reason of Law or otherwise the legacies in favour of the said Parish Priest and Curate should become void or fail to take effect the amount of said legacies shall not fall into the residue but shall go to the said Parish Priest and Curate for his own absolute use and benefit

I hereby nominate constitute and appoint my cousin John Lane of Shroveton Clonlara in the County of Clare the Executor and Trustee of this my Will
