The fact that I have been asked to write about my father, and his brothers, has disturbed some of my relatives. They are not in favor of me disclosing the "Family Secrets". BUT, this is my computer. And, here goes. One thing, he was against the World War statue of a "Doughboy" soldier, that stood in the lawn at the Harlan Court House. He said it did not resemble a "Doughboy", because, the uniform was an officers.

The following is memories of mine, from my age of TWO years old until John B. Lankford's death. My aunts marveled that I remember thing at the age of TWO. One, is Milt and Sudie Thomas's child that died, about six months after birth. A boy. Aunt Sudie had brought the baby boy to our home, during the summer of 1936 or 1937. This is my time periods for memory as a child: 1934-1937, lived in Cawood. 1937-1941, lived in the Nolan Hotel, 409 Mound St., Harlan, Kentucky. Nolan Hotel, was owned by my grandmother, Elizabeth Ann Hall (Lankford) Nolan. The things that I remember that happened in Cawood, had to fall in that time period. So, here goes. I remember mother, mostly, as any child would. She was very stern in what she did. my uncles said she used the Egg turner on me, when I needed it, And shortly after my first birthday, Uncle Roy, got me drunk on Moonshine. He was known to drink all his life. As with most of the Lankfords. Until 1940, the name Lankford was Langford for all except grandfather Rob Lankford. When or why, the spelling changed, was around the time of Rob. Lankford and Elizabeth Ann Hall (my grandmother) were divorced. 1906?. But, the Lankford (K) came back in 1940. To prove this, I have two birth certificates. 1936, Langford; 1940, Lankford. 1940, was the year Uncle Green told my father that he had went to London(?) and found the correct name spelling as LANKFORD. Numerous cousins, still have the LanGford, on their birth certificates, as do my Children.

Back to my memories of my Cawood era. Mother and her sisters wore no bloomers. Mary Lankford chewed Red Ox Twist Chewing Tobacco, and the other women dipped snuff. All wore long dresses. Except for the young girls.

Mother and I went to Bobs Creek on her Uncle Bill Shackelford (married to Nancy Ledford's sister) electric railroad Car thing, that he used to check the railroad. There was a commissary in Bobs Creek, at that time. Sometime, we would go to Three Point, to visit Aunt Nan and John Day. They ran the commissary, there. And people would go there, to have one of Uncle John's famous Hamburgers. 1930s, Popeye and Wimpie were becoming famous. Wimpie for his always eating hamburgers, in the cartoons.

At night, I would help dad stack pennies. The pennies were from the fares, of the "Brown Cow" the he used as a taxi to take the coal miners to and from work. The "Brown Cow" was a T-Model Ford, that dad had made into a bus. The back parts was built and cover, to keep the miners dry. (Todays pickup truck with a camper).

During the flood of 1936 or 1937, dad roped the Outhouse to the Birch Nut tree, to keep them from washing away. The frame of the "Brown Cow" is in the creek bank behind Homer's house. And can be seen, today, after the flood, men would go across the creek to gamble. They made a round table of rocks, with a hole next to the cliff, behind Rob's house. The property had several houses, along with Chas. Pennington's old store. Crate "Bulldog" Wallins, lived in the boarding house. Tom Blackburn, in one of the houses, Daisy Mitchel, in another. Green built a three room house. Rob Lankford's house. The Penning store had three family units, and a garage that later became a shoe repair shop, and Mary's, ("Mammie Lankford) fruit cellar. And another two room house for renters. The store was torn down by Roxie, Homers wife, and a House was built in it's place. All the Lankford children were born on the property in 1930s to 1950s.

The history of "Bloody Harlan" County, Kentucky, happened around this time (1934-1937. Dad was one of the bidders on a Bus Line franchise, to run in Harlan County, Ky. to Pennington Gap, Virginia. The Coal Miners Union was up in arms, the moonshiners were killing each other, and "Revenuers", too. And other family feuds. The Governor sent in the Kentucky National Guard, to stop the killings, that had been going on since the 1880s or earlier. Relatives of mine that were killed, 1889, Nathan Hall, great grand father; 1920s, Finley Lankford, son of Stone Wall Lankford; and Hobert Hall, mothers uncle. And, during one year, six Harlan County Sheriffs were killed. Along with about 137 other murders. About 1936 or 1937, we moved into grandmothers Nolan Hotel, 409 Mound St., Harlan, Kentucky. Dad junked the "Brown Cow", and was driving a

those days, with the flanges. Dad's chest hit the steering wheel, but it didn't seem to bother him, much. So, we had to go back to Cawood. Virgie stayed at Mammie Lankford's. Dad wanted me to stay at Uncle Green's, but because of the size of his family, I went at Uncle Will's. Dad went back to Dover, and we heard that he was in the hospital for pneumonia. We were notified on the 15th of December, 1941, that he had died. They brought dad back to the Nolan Hotel, in Harlan, for the funeral. He is buried in the Mary Helen Cemetery of Coalgood. About a mile from where he was born. After Virgie got able to, she went back to her parents. On the 16th of May, 1942, we were notified, she had a boy. Named him James Elbert Lankford. I never saw Virgie, after she left for her parents. And didn't know where my brother was, until 1963. Aunt Roxie, Homer's wife, was working in a hospital, in Dayton, Ohio. James's grandfather saw her name tag, and ask her about the Lankfords. I was in the Army, and stationed at Fleigerhorst Caserne, near Hanau, Germany. James was, also in the Army, and stationed in Fulda, Germany. He was 21 years old, at this time. Due to Aunt Roxie's name, and James' grandfather meeting in Dayton, I had found my only brother, James. Ironically, Uncle Will had gotten a job in Cincinnati, making Rifle barrels for the M1 rifles of the War, and his family and me, were living in Hamilton, Ohio. Near where the child was killed. James told me, that he lived in Hamilton, and had a family there, it was amazing that we were so near, but so far apart. And in Germany, we were stationed about 30 miles apart.

tried to get Grandma Nolen to go to Sarasota, Florida, for the winter months. The family owned property, there. She used to send a crate of oranges to the Hotel. They had a large goldfish pond in the back yard. Belle and Oscar, also, owned a Motel and Restaurant, in Lafollette. I don't remember seeing Aunt Belle's sons. During the War, they were in the military. Her two Twin daughters, Doris and Dorothy, came to Grandma Nolen's in Harlan, numerous times, during the summer months, 1936 to 1945.

The fact that I have been asked to write about my father, and his brothers, has disturbed some of my relatives. They are not in favor of me disclosing the "Family Secrets". BUT, this is my computer. And, here goes. One thing, he was against the World War statue of a "Doughboy" soldier, that stood in the lawn at the Harlan Court House. He said it did not resemble a "Doughboy", because, the uniform was an officers.

The following is memories of mine, from my age of TWO years old until John B. Lankford's death. My aunts marveled that I remember thing at the age of TWO. One, is Milt and Sudie Thomas's child that died, about six months after birth. A boy. Aunt Sudie had brought the baby boy to our home, during the summer of 1936 or 1937. This is my time periods for memory as a child. 1934-1937, lived in Cawood. 1937-1941, lived in the Nolan Hotel, 409 Mound St., Harlan, Kentucky. Nolan Hotel, was owned by my grandmother, Elizabeth Ann Hall (Lankford) Nolan. The things that I remember that happened in Cawood, had to fall in that time period. So, here goes. I remember mother, mostly, as any child would. She was very stern in what she did. my uncles said she used the Egg turner on me, when I needed it, And shortly after my first birthday, Uncle Roy, got me drunk on Moonshine. He was known to drink all his life. As with most of the Lankfords. Until 1940, the name Lankford was Langford for all except grandfather Rob Lankford. When or why, the spelling changed, was around the time of Rob. Lankford and Elizabeth Ann Hall (my grandmother) were divorced. 1906? But, the Lankford (K) came back in 1940. To prove this, I have two birth certificates. 1936, Langford; 1940, Lankford. 1940, was the year Uncle Green told my father that he had went to London(?) and found the correct name spelling as LANKFORD. Numerous cousins, still have the LanGford, on their birth certificates, as do my Children.

Back to my memories of my Cawood era. Mother and her sisters wore no bloomers. Mary Lankford chewed Red Ox Twist Chewing Tobacco, and the other women dipped snuff. All wore long dresses. Except for the young girls.

Mother and I went to Bobs Creek on her Uncle Bill Shackelford (married to Nancy Ledford's sister) electric railroad Car thing, that he used to check the railroad. There was a commissary in Bobs Creek, at that time. Sometime, we would go to Three Point, to visit Aunt Nan and John Day. They ran the commissary, there. And people would go there, to have one of Uncle John's famous Hamburgers. 1930s, Popeye and Wimpie were becoming famous. Wimpie for his always eating hamburgers, in the cartoons.

At night, I would help dad stack pennies. The pennies were from the fares, of the "Brown Cow" the he used as a taxi to take the coal miners to and from work. The "Brown Cow" was a T-Model Ford, that dad had made

into a bus. The back parts was built and cover, to keep the miners dry. (Todays pickup truck with a camper).

During the flood of 1936 or 1937, dad roped the Outhouse to the Birch Nut tree, to keep them from washing away. The frame of the "Brown Cow" is in the creek bank behind Homer's house. And can be seen, today. after the flood, men would go across the creek to gamble. They made a round table of rocks, with a hole next to the cliff, behind Rob's house. The property had several houses, along with Chas. Pennington's old store. Crate

cliff, behind Rob's house. The property had several houses, along with Chas. Pennington's old store. Crate "Bulldog" Wallins, lived in the boarding house. Tom Blackburn, in one of the houses, Daisy Mitchel, in another. Green built a three room house. Rob Lankford's house. The Penning store had three family units, and a garage that later became a shoe repair shop, and Mary's, ("Mammie Lankford) fruit cellar. And another two room house for renters. The store was torn down by Roxie, Homers wife, and a House was built in it's place. All the Lankford children were born on the property in 1930s to 1950s.

The history of "Bloody Harlan" County, Kentucky, happened around this time (1934-1937. Dad was one of the bidders on a Bus Line franchise, to run in Harlan County, Ky. to Pennington Gap, Virginia. The Coal Miners Union was up in arms, the moonshiners were killing each other, and "Revenuers", too. And other family feuds. The Governor sent in the Kentucky National Guard, to stop the killings,that had been going on since the 1880s or earlier. Relatives of mine that were killed, 1889, Nathan Hall, great grand father; 1920s, Finley Lankford, son of Stone Wall Lankford; and Hobert Hall, mothers uncle. And, during one year, six Harlan County Sheriffs were killed. Along with about 137 other murders. About 1936 or 1937, we moved into grandmothers Nolan Hotel, 409 Mound St., Harlan, Kentucky. Dad junked the "Brown Cow", and was driving a Taxi. We were on the second floor of the Hotel. Sometimes, dad would come home, drunk, and mother would raise hell with him. She would not let me go around dad, when this happened,

Sometimes, I would go with dad, on his trips. He would point out thing on the highway, where people lived and sometimes stop to talk. The original road built from Harlan to Pennington Gap, had many things of interest. Dad would point out where the old road was, going up past the Browning house, then up the mountain side, from near Chevrolet to Mary Helen. High on the bend over Lenarue, (Glidden when he was born), the road builders had found an Indian Grave. He said the Indian was a Chief, because of the Headdress Feathers and the clothes on him. He said the Indian was sent to the University at Lexington. The grave was overlooking the Lankford homestead, on the south side of the railroad stop, Glidden. It burned down, and the Lankford's moved over to Lenarue. Uncle Milt Thomas, stayed with the Lankford's, in the 1910s. Changed to Lenarue, and now, Coalgood. The Turtle Creek Inn, made of logs, was not that old, according to dad. Up the road, at the curve, dad would stop and cross the railroad trestle, only way over, to visit an old woman, related to dad. before leaving, he would always ask her, if she need anything, and she would reply, no. As you come into Cawood, there was a D. A. R. marker with a flag pole, for Mary Stewart Turner Cawood. First white child born in Harlan County. The cement holder, is still there, but the marker is with a relative of Mary Stewart Turner Cawood. Around the bend, from it, under the cliff, is where the women used to wash clothes in the big iron kettles. Mostly for the miners. A spring was nearby. Now gone, because of the buildings built there. One of the original buildings, across from the cliff, was Charles Ledford's store and Post Office. Uncle Rus was always glad to see me. An uncle of mothers. I remember an old woman would walk from Martins Fork, to pick up mail, and deliver it. Walking several miles, to and from. Across from Ledfords, was the old wooden bridge, that crossed Cawood Creek, to go up Martins Fork, to Smith, and two places that crossed the mountain to Rose Hill, Virginia. One of the roads, was called "Sugar Run", because of the Moonshiners going to Virginia, to get sugar for their whiskey stills. My aunts told me of the times when they walked to Virginia to stock up on supplies. This had to be around 1910. Everyone went to Virginia for trade, since MT. Pleasant had few stores. The coal mines and the railroad changed all that. The WALK had to be Twenty miles, or more, ONE way. No wonder the people of this time, lived to be 100, or died very young. When the family went to trade, the whole family went. Even the babies were carried.

Behind Ledford's store, a road went up the hill to the school, and to Little Creek. The original road in Cawood, in 1936 was replaced by the new road, US 421. The original bridge, that crossed the forks of Little Creek and Crummies Creek, to become Cawood Creek, parts can still be seen. It was where Daisy Cawood's house stood. And a new road to the school and Little Creek settlement. The railroad, that went from Crummies Creek to Bobs Creek has been remove. The forks where Little Creek, Crummies Creek came to Cawood Creek, was a pool, used for Baptisms. Through Crummies and over the mountain and down on the other side to Cranks Creek, was a Historical Marker that tells of the Federal Communications Lines, of the Civil War. When you leave Cranks Creek, up the mountain, at the big curve, dad said they found a bear, hibernating in a cave. Over in Virginia, There was a spring by the road, where everyone stopped to fill up their containers. the best water in the two state area. Then, as you rounded another curve, on the side of the mountain was "Niger Head Rock". named for the lower fat lip, that stuck out. Now, changed to "Old Stone Face".

Back from Harlan to Pineville, was "The Seven Sisters". Several large parts of the mountain, that was so steep, no vegetation grew on them .One of the land marks, that was seen, from the road. And better, from the passenger train. Torn up, by the new road, and the passenger train no longer runs. You could buy Picture Post Cards of them and "Niger Head", in the stores at Harlan.

In 1938, we were living at grandma Nolan's hotel, 409 Mound St., Harlan. Grandma said the street was named, because of several India mounds found, during construction.

During this time, dad was arrested for murder. He gave a shot gun to someone to kill someone. When mother and I went to visit him, The jail doors were never locked, and I had free reign of the place. I don't remember seeing any other persons, in the jail. In the late 1950s, Lige Burgan, a cousin, would get drunk, and mad at me. Claiming dad had killed his cousin. Dad and his half brothers were also, accused of blowing up some ones home. And I it's said the "Brown Cow" was a victim, of these times. You may have to look in the Court House, as to the trial, and whatever. During the 1920s and 1930s, numerous Lankford names will appear on the docket. Dads name appeared in the 1920s docket, don't know why. Also Stonewall Lankford. Several times. Not long after dads trial, he left Harlan County, to work in Cincinnati, Ohio, to work. During the next two years, I don't remember him staying, long, when he visited.

During this year, mother decided to live with her father, John Clem, at Grays Knob. This lasted for about two weeks, because of grandpa Clem, was always beating his wife, Inge. Inge raised all of John Clem's children, from childhood, after their mothers deaths. I can remember riding on the work horses, grandpa had. He worked for the neighbors, plowing fields and gardens, in the Grays Knob area. The house caught fire, one day, and cousin Elmer Day, Nan's boy, put out the fire, using the slop bucket. After we went back to the Nolan Hotel, mother became sick, and had to stay in bed. Grandma "Bets-Ann" Nolan, as she was called, would put a cot behind the Hotel, for mother to get some sunshine. This was all that grandma Bets-Ann would let her do. Mother had to stay in the room, unless the sun was out and the day was warm. The Nolan Hotel had everything that a "rich" house could have. Living room, down stairs, had a piano, with large couches and chairs, a big dinning room, with all the hutches of fine silver and dinner settings a person would dream of. One room for grandma's mementos, had all the picture of her family. Dad and Finley, in their uniforms of W. W. 1., and other things of importance from her past. On the second floor living room, up stairs, there was an organ, and the bathroom, and several room. On the third floor, is where all my toys were kept. The third floor had rooms, but was unfinished. Mother and me lived in the Front room of the second floor. During winter months, I would sleep with grandma in her big feather bed. In the summer, up stairs with mother. There was a Mrs. Cawood, that lived across the street, and Dr. Baileys family, at the bottom of Baileys hill, where Mound Street ended. I was allowed to roam almost any where in Harlan. Everyone knew me, and if grandma wanted to know where I was, someone would always know where I was. Sometimes, she would give me show fare for the movies. Once, she made a special trip to the New Harlan Theater, and I made me see the movie "Gone with the Wind". I loved going to the movies, but "Gone with the Wind" has ever since, has been my favorite. Grandma Bets-Ann had lived through the hard times, after the Civil War, during which time armed raiders would come through Harlan County. The Civil War did not stop in 1865, for MT. Pleasant (Harlan). I have heard tails from the old people about the Rebels, still raiding for numerous years. In Cranks Creek, Martins Fork and other places of Harlan County. When the family went to trade in Virginia, the men carried their guns, for protection, in case of "Bush Whackers".

Back to my mother, Eulah Margaret (Clem) Lankford. During her sickness, she went to D. Bailey. And I had to go, also, and get fluoroscope, and other nasty things. Mother was always getting some kind of medical shots. When I started school, in Harlan, 1940, she would awaken me when the school bell rang, and I was always late. We had no clocks. Grandma Bets-Ann would have me a cup of tea, with cream and sugar, in the morning, Sometimes, she would put me at the big dinning room table. I don't remember mother eating. So, she must have had her meals in her room. After the sickness started, I would sleep with a mosquito net over my bed. Sometimes I would get into bed with mother, and grandma would have a fit. "Out, Little John". The date of March 11, 1941, is still in my memory as if it happened yesterday. That day, after school, mother had dressed in her finest. And claimed, she had not felt this good in all her life, and wanted to go out. Grandma argued with her over going out, for a while, and mother had to stay at home in her room. And looked down hearted for the rest of the day. The next morning, I awoke, and was wondering why mother had not awaken me when the school bell rang. Aunt Nan was there, by the bedside, with a banana. She always gave me a banana, when mother and I would go visit her at John Day's store, in Grays Knob. It was then she told me of mother passing away. The time she died was 1;00 AM, March 12, 1941. Before her funeral at the hotel, Aunts Nan and Sudie, combed her long black hair, because they said it wasn't fixed right as mother liked it. After the funeral, at Grays Knob bridge, Grandpa John Clem stood in the middle of it, and would not let father and me go to the cemetery,

where mother was to be buried. There had always been 'bad Blood between dad and Grandpa. That never ended until both were dead. The next time I saw him, was in 1950. I was visiting Aunt Nan and John, and he came to the store. Aunt Nan asked him if I knew me, and he asked if I was Raymond (Ledford), Aunt Lilies boy. And when Aunt Nan told him, I was Eulah's boy, Johnny, he immediately started crying, turned and started back to his house. I was going to say something, and Aunt Nan told me to be not to talk, and he would be alright. I never say him again. No one notified me, when he died. At his grave site, his children put a monument to him. My mother, Eulah Margaret Lankford, was the first person to be buried in the Clem Section, of the Hall Cemetery. John Clem was buried on her left and above her. Mothers grave marker was made by John Day, of cement, and eroded with the passing of time.

After my mothers death, dad took me to Cincinnati with him. We visited Dayton at his sisters. And I was left at a house, on Second Street in Hamilton, when he was at work. While I was at Hamilton, a small boy, age 5 or 6, that lived nearby, was playing on a garbage truck. I say him fall under the truck rear wheels. I beat on the truck door, and was yelling for him to stop, but the truck had moved, and the boy was crushed to death. Dad took me to the boys mother to talk about this, several times. We then went to Dover, New Jersey, We went to Show, Kentucky, to get Virgie Davison, age 18 years old, to baby sit me while dad was at work. Re worked in the ammunition plant at Dover. Virgie got pregnant, and dad married her. He was then 57 years old. We came back on vacation, to Cawood, Thanksgiving of 1941. Going back to Dover, we picked up Virgie's brother, Carlo Davison. We had a car wreck near Abingdon, Virginia. Virgie's leg was cut very bed, from the car heater, of those days, with the flanges. Dad's chest hit the steering wheel, but it didn't seem to bother him, much. So, we had to go back to Cawood. Virgie stayed at Mammie Lankford's. Dad wanted me to stay at Uncle Green's, but because of the size of his family, I went at Uncle Will's. Dad went back to Dover, and we heard that he was in the hospital for pneumonia. We were notified on the 15th of December, 1941, that he had died. They brought dad back to the Nolan Hotel, in Harlan, for the funeral. He is buried in the Mary Helen Cemetery of Coalgood. About a mile from where he was born. After Virgie got able to, she went back to her parents. On the 16th of May, 1942, we were notified, she had a boy. Named him James Elbert Lankford. I never saw Virgie, after she left for her parents. And didn't know where my brother was, until 1963. Aunt Roxie, Homer's wife, was working in a hospital, in Dayton, Ohio. James's grandfather saw her name tag, and ask her about the Lankfords. I was in the Army, and stationed at Fleigerhorst Caserne, near Hanau, Germany. James was, also in the Army, and stationed in Fulda, Germany. He was 21 years old, at this time. Due to Aunt Roxie's name, and James' grandfather meeting in Dayton, I had found my only brother, James. Ironically, Uncle Will had gotten a job in Cincinnati, making Rifle barrels for the M1 rifles of the War, and his family and me, were living in Hamilton, Ohio. Near where the child was killed. James told me, that he lived in Hamilton, and had a family there, it was amazing that we were so near, but so far apart. And in Germany, we were stationed about 30 miles apart.
