### GENEALOGICAL RECORDS.

#### Explanations, Abbreviations, etc.

For convenience the records of the various Lewis families are divided into Books and each Book into chapters. At the head of each Book appears the name of the earliest known ancestor of that family. The List of Books is a complete index to the Books as published to this time. New Books will be added from time to time as new branches of the Lewis family are found. As soon as Books are proved parts of others they will be merged into the Books to which they belong. Each name is numbered when first printed and whenever the name is repeated this number follows in brackets. The abbreviations commonly used in genealogical work are used; as b. for born; d. died; m. married; m. (1) first wife; dau. daughter; unm. not married; v. p. see page, etc. Instead of repeating the name of a place in the same paragraph initials only are frequently given.

#### CHAPTER LXXVII.

Rev. John Nitchie Lewis (552 v. p. 115, Vol. VI), a Presbyterian minister, was born in Westchester co., N. Y., in 1808. He graduated at Yale College in 1828 and studied theology both at Andover and Princeton and was licensed at Goshen, N. Y., in 1832. He preached for a number

of years principally in the State of New York and was then chosen Secretary of the Central American Education Society in New York. He was for some time editor of the Seaman's Magazine, and wrote a Manual for the Presbyterian church. He died in 1861.

## CHAPTER CXXL.

Will of James Lewis, v. p. 133, Vol. VI.

In the name of God Amen. The fourth day of May, 1752 I James Lewis of Richmond in Kings County In the Colony of Rhode Island etc. Yeoman being sick and weak in body but of perfect mind and memory thanks be given to God:

Therefore calling to mind the mortality of my body and knowing that it is appointed for all men once to die, Do make and ordain this my Last Will and Testament, That is to say Principally and first of all I give and recomend my soul into the hands of God that gave it and my Body I recomend to the earth to be buried in Decent Christian Burial at the discretion of my Executrix hereafter named and as touching such worldly Estate wherewith it hath pleased God to bless me in this Life. I give devise and dispose of the same in the following manner and form:

Imprimus. I give and bequeath to Susannah my dearly beloved wife the choice of my cows.

Item I give and bequeath to my well beloved son James Lewis Twenty pounds old tenor.

Item I give and bequeath to my well beloved son Jacob Lewis Twenty shillings old tenor.

Item I give and bequeath to my well beloved daughter, Sarah Lewis Twenty shillings old tenor.

Item I give and bequeath to my well beloved daughter Abigail Lewis my worsted combs and my comb Pott.

Item I give and bequeath to my well beloved daughter Mary Ladd twenty shillings old tenor.

Item I give and bequeath to my well beloved daughter Hannah Lewis my foot wheel which she used to spin on.

Item I give and bequeath to my well beloved daughter Elizabeth Lewis twenty shillings old tenor.

Item I give and bequeath to my well beloved daughter Ruth Lewis a foot wheel which she spins on.

Item I give and bequeath to James Fordice my soninlaw twenty shillings old tenor.

Item I give and bequeath to my daughterinlaw Sarah Fordice twenty shillings old tenor.

Item I give and bequeath to my soninlaw John Fordice thirty pounds old tenor.

Item I give and bequeath to my daughterinlaw Susannah Fordice thirty pounds old tenor.

Item I give and bequeath to my three daughters Abigail Lewis Hannah Lewis Ruth Lewis one quarter part of my movables (after my debts last sickness and funeral charge and all the legacies before given, be satisfied and paid out of my estate at inventory price as my Executrix shall turn to them.) To be equally divided between them and all their beds bedding chests boxes wheels cheers clothing and all other goods that they have in their possession and custody.

Item I give and bequeath unto my dearly beloved wife Susannah one-half part of my movable estate after my just debts last sickness and funeral charge and the above s'd legacies be satisfied and paid.

Item I give and bequeath to my well beloved daughter Patience Lewis one half part of my movables estate which makes the whole of my movable estate.

Item I give and bequeath to my two well beloved sons (viz) William Lewis and Gideon Lewis all my lands to them their heirs and assigns forever to be equally divided between them.

And further my will and pleasure is that if my wife Susannah should have another child by me whether it be son or daughter that the said child shall have one-fifth part of my lands before willed to my two sons (viz.) Wm. Lewis and Gideon Lewis.

And I do likewise constitute make and ordain my trusty and dearly beloved wife Susannah Lewis my sole Executrix of this my last will and testament and I do hereby utterly disallow revoke and disannul all and every other former Testaments, Wills Legacies and bequests and Executors by me in any ways before named willed and bequeathed ratifying and conforming this and no other to be my last Will and Testament. In witness whereof I have hereunto set my hand and seal the day and year above written.

CHAPTER LXXXIX.

A brief statement of evidence that Joseph (11 v. p. 104, Vol. V.) is a member of the Malden line, Book XXXVI.

Joseph (49) m. Hannah Jones and Sybil (50) m. Samuel Howard, both at Malden "in ye year 1700." (Malden Records.) Joseph went to Woburn and settled and had children. Note. Woburn was a part of Charlestown called Charlestown Village until 1642 when incorporated.

Mary the widow of John (1) Book 36, married John Cutler of Woburn and remained there and Samuel (5) son of John, was also there.

Joseph (11) m. Mary Jones and she returned to Malden after the Massacre by the Indians at Swansea, and m. Jan. 11, 1676-7 at Malden, Obadiah Jenkins and had several children. She was the daughter of Robert Jonas of Hull. Robert Jones m. Ann Bibble and had several children. Ann Bibble was the dau. of John and Sybil Bibble of Malden, later of Hull. Sybil Bibble, widow of John, m. Miles Nutt and on Oct. 30, 1674, became the wife of John Doolittle of Malden where she died and her gravestone says Sibble Doolittle, wife of John, aged about 82 years, Sept. 23, 1690.

Documentary evidence to prove this statement will follow.

[There seems to be little or no evidence that Joseph (11) belongs to Book XXIV. But as he and his descendants have been placed here (v. p. 22, Vol. III.) it seems best pending this discussion to keep them here. Those interested will notice on another page claim with proof that Joseph belongs to Book XXXIII. Ed.]

## CHAPTER XIII.

By GEO. HARLAN LEWIS, N. Y. CITY.

On file in the office of the Clerk of the

Court at East Cambridge, in the trial of James Hall, 1671, 4, 20. Testimony of Bryan Bredane, aged about 28 years, says "James Hall had his mare to carry his Bryan's sister-in-law to Concord. Hall lodged at his house on his way to Marblehead on Thursday after election day. Examination of James Hall, seaman, details his voyages. Went to Marblehead, returned and went to Malden the next day after election and lodged at Bryan Bredane's. The occasion of his going to Malden was for good will he bore to Bryan Bredane's wife who lived there, who he was acquainted with when she lived at Mr. Parker's by the pump near the old meeting house. He had a mare of Bryan Bredane and carried Sarah Lewis (7, v. p. 3, Vol. III.) behind him to Concord and there left Sarah at her brother Joseph Lewis's (3) and Joseph came down with her last Tuesday night, etc., June 20, 1671, testimony was taken. This shows that Joseph was in Concord keeping house at that time and not at Swansea.

Hall had probably gone to Marblehead to see Elizabeth Lewis who had lived at Mr. Parker's at Marblehead, and he was sent to Bredane's who lived at Black Ann's corner, between Malden and Saugus, on a strip of land that was part of Rumney Marsh. Bredane was Irish.

Isaac Lewis (12 v. p. 104, Vol. III. and p. 39, Vol. VII.) d. Apr. 3, 1691, ae. 34 yrs., as on Apr. 6, 1691, Mary, his widow filed an inventory of his estate amounting to £320-6-0. Real estate as per 2 deeds, £160-10-0. Personal estate £150-16-0, appraised by Wm. Ireland, Samuel Townsend and Wm. Hasey. (Suffolk Probate Records, Vol. VIII, p. 212.) Letters of administration were granted Apr. 10, 1694, v. p. 8, Vol. VII.

Savage's Dictionary in giving the children of Isaac (12, v. p. 104, Vol. III.) names Elizabeth, 5th ch. b. Feb. 12, 1689. The following will show there were but 5 ch. at time of Isaac's death and his heirs.

Suffolk Probate Records, Vol. XVII, p. 474. Assignment of Personal Estate of Isaac Lewis of Rumney Marsh, intestate. Inventory filed July 28, 1691 by Mary Pratt, formerly Lewis, now wife of Thomas Pratt, amounting to £150-16-0, and the said administrators declaring through ignorance of their duty, they have been negligent and remiss in keeping exact and particular account of what debts, charges and payments were by them made thereout and being unable to vouch the same, for the love and affection which they bear to the children of the said deceased and in consideration of the small income received from the real estate, they the said administrators are willing to be accountable for the full personal estate according to the inventory, to be distributed in manner as the law directs, without subduction for the loss and charge by them expended in educating and bringing up the said deceased's children or any of them, (being five in number) most of them very young, or for any charge they have been out about the said estate. I do therefore assign to said Mary Pratt, relict of said deceased, Isaac Lewis, one third part of said personal estate amounting to £50-5-4, over and above her dower in the real estate and to said Isaac, Joseph John and Abraham and Mary (now wife of Wm. Sargent of Malden, Yeoman.) children of said deceased, the several sums following as their respective parts and proportions of the remaining  $\frac{2}{3}$  parts of the personal estate of deceased, (discounting what has been to them or either of them already advanced. Isaac, eldest son, his double share £33-10-2½, and to Joseph, John and Abraham and Mary (Sargent) £16-15-1½. Dated Boston, June 20, 1712.

In Suffolk Probate Records, Vol. XXI., p. 810, file 4352. Brian Breeden of Rumney Marsh, Will, Sept. 26, 1720. His sons James and Samuel administrators. Gives personal estate in doors to his two daughters, Abigail and Mary "and to no others" equally, a cow and £20 each. Lands to sons, James and Samuel.

Peter R. Livingston and his brother,

Maturin were among the most constant of the visitors in Queen Street; the attraction for the latter was his cousin, Margaret Lewis. She was just seventeen when he first made his proposals. The General decided that she was too young to bind herself for life, that she must be allowed at least a year for consideration before he would consent to an engagement. At the end of the year my father renewed his offer and was accepted. They were married at Staatsburgh, on the 29th of May, 1798.

The wedding dress of Margaret Lewis was an embroidered India muslin; the waist made a *l'enfant* with short sleeves; the skirt short in front, scant, but not tight, with a long train, trimmed with French lace; the hair waving and curled was worn at full length.

My mother's hair, a glossy brown on the top, shaded gradually into a bright auburn, as it fell in profusion far below her waist. She was not above the middle height, perfectly well made, with beautiful feet. Her head phrenologically was fine. She had large, brown eyes, delicate features, teeth like two rows of pearls. In complexion she was a light brunette with a good deal of color. All her life she was the picture of health. She preserved her appearance to the last.

Maturin Livingston and Margaret Lewis were both descended from John Livingston, the Commissioner. My father, through James, one of his elder children, my mother, through Robert, the youngest child and first proprietor of the Manor. There were four generations between my father and John Livingston. James, the name of his wife I have not yet ascertained. Robert Livingston, the nephew, married Margareta Schuyler; James Livingston married Maria Kiersted; Robert James Livingston married Susan Smith. There were also four generations between my mother and John Livingston, the Commissioner. Robert Livingston, first proprietor of the Manor, married Alida Van

Rensselaer vorn Schuyler; Robert Livingston of Clermont, married Margaret Howerton; Judge Robert Livingston married Margaret Beekman; General Lewis married Gertrude Livingston. They were also cousins through Margareta Beekman, granddaughter of Robert Livingston, the nephew, and of Margareta Schuyler, who were also the great-grandparents of my father.
