L. L. L. EFFORTS SUCCESSFUL.**September 23, 1904.****"LEWIS DAY" AT WORLD'S FAIR.**

On January 6th, E. C. Culp, secretary of the Committee on Ceremonies of the World's Fair at St. Louis, 1904, announced that the request of the "Loyal Lewis Legion" had been granted and Sept. 23, 1904, the anniversary of Lewis and Clark's return to St. Louis, would be designated as "Lewis Day." The committee has a large number of applications for special days and "Lewis Day" was secured only by the herculean efforts of Hon. Edward S. Lewis of Supreme Castle of L. L. L. with the active co-operation of a number of other influential citizens of St. Louis.

That immediate steps be taken to place this information before all people of the name of "Lewis" and to plan that the day be celebrated in a way that will reflect credit upon our name demands organized effort by a recognized committee. The following is suggested:

Hon. John C. Lewis, Louisville, Ky., His Honor Luasford L. Lewis, Richmond, Va., representing the Warner-Hall-Lewises in the Book XXXV in general.

Before this is read the committee

will undoubtedly have organized and taken steps to have its numbers increased by the appointment of a Lewis delegate by every patriotic society of our country, an enthusiastic Lewis worker to represent each State of our Union and a representative from each of the families whose records have appeared in LEWISIANA.

Lyman (1613) b Nov. 18, 1815 (not 1818 as given on p 78 Vol. XII) went in the fall of 1828 from Whitehall, N. Y. to Canada, settling in Yarmouth and later in Elgin County. He was at one time a school teacher. In those days the woods abounded with nearly every kind of game, large and small. In 1830 Lyman with several young men went to Bradley's sugar camp. Their dogs began barking furiously at the roots of an upturned tree on a hill-side where two bears in trying to get out had become wedged in the entrance of a cavern. Lewis with a club and Bradley with an axe killed the bears which they dragged to the top of the hill, and then the continued barking of their dogs called their attention to a third bear coming from the cavern. Instantly starting in pursuit, the hillside being very icy, all came sliding down top of bear and dogs. Bruin, stunned and confused, Lewis crippled with a well directed blow of Bradley's axe and soon killed. Shortly after this he killed a fine large buck with a musket ball from a shot gun.

In 1860 Lyman (1613) came into possession of his father's [Barnabas (1240) v. p. 78 Vol. XII] old farm which he made one of the finest farms in the town. In 1882, he moved to Aylmer, Ontario, where he built a fine brick house where his wife and dau. now reside. He is the author of the very unique and burlesque sermon entitled "The Harp of a Thousand Strings." His discourses and lectures were often interspersed with rich and amusing anecdotes.

Into the President's hands Meriwether Lewis (64) placed the precious journals, obtained at such a cost in toil and travel. Each pocket volume, morocco-bound, had as soon as filled been cemented in a separate tin case to prevent injury by wetting. But now Lewis had slipped the cases off and displayed them neat and fresh as on the day of writing.

On rocking boats, on saddle pommels, and after dark by the flickering campfire, had the writing been done. T's were not always crossed, nor i's dotted, as hurriedly each event was jotted down to be read and criticised after a hundred years. Written under such circumstances, and in such haste, it is not remarkable that words are misspelled and some omitted. A considerable collection of later letters gives ample evidence that both the Captains were graceful correspondents.

In 1774, when the British Army was in Boston, Lewis dispatched his son-in-law with proposals to General Gage, then the Commander-in-Chief, for supplying the Army with everything wanted in each respective department, and stipulated the price at which it could be done. The General, however, had made his contracts. Lewis's proposals were of course rejected. A proposal of this kind was treason with the mob at New York. It was therefore concealed as long as possible. It at length took wind. It flew like wildfire. The leaders of the populace called upon him to know the truth of the report. The fact was denied upon honour. Honour never satisfied a mob, something more was to be done. He appeared in the Fields, and openly in the presence of all the ruff and low fellows headed by the republican faction, swore, upon the Holy Evangelists of Almighty God, that the report was totally and absolutely false. A Committee was shortly after appointed for the City to correspond with other Committees of the respective Colonies. The people were called together for this purpose in consequence of anonymous advertisements. The Loyal gentlemen made a point to attend. It was held at the exchange. The meeting was numerous. A Committee was appointed. It consisted of fifty members. The Loyalists so contrived matters that above thirty of the members were strict and steady friends to government. A few days after this, Lewis prevailed upon the mob to call another meeting of the town to elect another member,

as the Committee, he thought, ought to consist of an odd number. A meeting was called, and Lewis was chosen the member. This made the number fifty-one. Of this Committee, Isaac Low, of seditious, factious and rebellious memory, was the Chairman. This was done to please the mob.

A copy of the deed conveying the site of the grave of Lincoln's mother has been found among the papers of the late Captain. John Burke, who was a great admirer of Lincoln. This instrument relates to a half acre of woods, situated on a hill a few hundred yards from Lincoln City Junction in Spencer Co., Ind., and the gentlemen who conveyed the land were then all well-known residents of Cincinnati.
