The Automatic Gate has more points of vantage than any other. It can be operated any distance from gate or in any direction. It can be raised to swing above snow drifts. Its construction is marvelously simple and is as enduring as the material of which it is made. One little piece of iron two feet long, two levers and a few shillings worth of wire is all there is of it.

Whereas King James, of famous memorv, late King of England, Scotland, France, Ireland, by his Highness's Letters Patent and Royal Grant under the Great Seal of England, bearing date the third of November in the eighteenth year of his reign of England, France and Ireland for the cause therein expressed did absolutely give, Grant and confirm unto the said Council for the affairs of New England in America, lying and being from forty forty-eight degrees of northerly latitude and in length by all that breadth aforesaid from sea to sea throughout the Main land, together with all the woods, waters, Rivers, soils, Havens, Harbors, Islands and other commodities, whatsoever thereunto belonging, with divers other privileges, preheminances, profits and liberties by sea and land as by the said Letters Patent (amongst other things contained, whereunto due relation being had) more at large, it doth and may appear.

Bryn Mawr.

From Merion in the Welsh Tract.

It is generally supposed that "Bryn Mawr," so well known as the name of a station on the main line of the Penn. R. R., was chosen at haphazard, because it had a pleasing sound, and, above all, was Welsh. No place in Pa., however,, could be more appropriately designated.

Along the rolling side of a steep ascent, less than a mile out on the winding road leading southward from the old market town of Dolgelly, in Merionethshire, basks on the sunlit, craggy hills that ancient messuage, tenement and field, called since the days of Cadwgan, the renowned Britain, and Heaven only knows for how many hundreds of years before, "Tythyn Bryn Mawr."

The sleepy little pointed stone house, perched on the site of the hendre of an early Welsh Prince, amid its deserted garden, broken down stone walls and dilapidated out-knildings, now the abode of a poor mountaineer, was the birthplace of Rowland Ellis, and was built by his gr. father. Rees Lewis. The property seems to have been lately repaired; a new roof has been put on and the quaint old diamond-pane windows replaced by modern sashes. There was also formerly, it is thought, a portico over the doorway. The walls remain untouched, and the interior is the control of the formula of the descendants; it was a valuable transmit of land and produced every kind grain and vegetables in abundance.

A Pennsylvanian who visited Bryn Mawr a few years since says that it is "a comfortable stone house; the floors are of stone; and it was built by Rees Lewis, gr. father of Rowland Ellis, A. D. 1617, as an inscription on one of the rafters tells. To the right of the house are the remains of an ancient garden which has seen better days. Its walls are gone, but there are traces of old paths, while ancient box and venerable yew-trees tell of what has been."

The Dalton Right. From The Riddell History.

The "Dalton Right," which consisted of 1,140 acres was in a section then known as "Little Falls Plantation, "--since called Phillipsburgh, -now Hollis, York co., Me., on the west bank of Saco River; originally called the "Rope-Walk," because a long and narrow township....This land was deeded by Thomas Cutts, of Saco, Aug. 10, 1797, to James Redlon, Thomas Redlon, John Bryant, Ichabod Cozens, Thomas Lewis, and Rufus Kimball of the plantation of Little Falls, in the County of York... The lot of Thomas Lewis seems to have been larger than the other divisions of the Dalton Right: at any rate, it extended northwest as far as the land now owned by Abijah Usher, and possibly as far as the farm of Orrin Davis and Yates Rogers Thomas Lewis sold his lot to Joseph Ridlen, who built the nice farm buildings now known as the "Uncle Joe Ridlon place" near the village of Bonnie Eagle. The "Dalton Right," has been divided and subdivided many times, but much of the territory is still owned by the Ridlons and their descendants; it was a valuable tract of land and produced every kind of
