## *Descendants of Thomas Marston*

### *Generation No. 1*

1. THOMAS<sup>1</sup> MARSTON was born Bet. 1640 - 1650 in England, and died 24 Oct 1704 in Middlesex Co Va.<sup>1,2</sup> He married MARTHA CARROLL Bef. 1677<sup>3</sup>. She was born Bef. 1662.

#### Notes for THOMAS MARSTON:

Thomas Marston immigrated to Virginia by 11 April 1666 . At this time there were several significant events taking place in England. In 1660 the Monarchy was restored. In 1665 England was at war with Holland and the great plague of London ocured. In 1666 the great fire of London occurred. Thomas Marston appeared in a list of headrights for which John Needles was granted a certificate in Lancaster Co. Virginia. At this time Lancaster included the area that would become Middlesex Co. about 1669. Some of Needles land was located on the NE side of the Peancketank River opposite Store Point. It's entirely possible that Thomas had immigrated 2 or more years prior to 1666.

In looking at births given in the IGI for the range of 1630-1656 for Thomas Marstons there are a total of 38. 74 % of these are in Yorkshire and its surrounding counties. Only two are in London, however a study of the roots of settlers in Middlesex and Gloucester counties Virginia including some associated with Thomas Marston suggests that London should be given a much higher priority as Thomas Marston's previous residence. It's possible that Thomas had a previous family in England, although there is no indication of it.

There has been no connection found between Thomas and the New England Marstons nor a firm connection found with other early Virginia Marstons. Other early Virginia Marstons are not known to have been traced in England but there again it would seem from associations that some preference to the London area should be given fo them as well.

Thomas Marston married by November 1677 Martha Carroll, who was a servant to Robert Couch. Another Robert Couch had land in 1693 in Gloucester Co. adjoining Abraham Iveson . In 1682 Iveson had land near Cow Creek Swamp, mouth of Back Creek and John Reade's old field.

When Thomas bought land in 1681 in Middlesex he was a resident of Kingston Parish [it was later Mathews County, Virginia] and a witnesss to the deed was Thomas Palliser. Palliser owned land in Kingston Parish on the South side of the Peancketank River. Some nearby landowners were William Elliott, John Armistead, John Waters, Gilbert Metcalfe, George Curtis, & Col. Matt Kemp.

The land that Thomas bought in 1681 was located near the Lower Chapel [a Methodist Church today]. It was located near George Barrick and William Hackney and the road. Thomas gave 3000 pounds of sweet-scented tobacco for this 100 acre farm. It was located in the area of present day Hartfield.

At a vestry held for Christ Church Parish 11 November 1690 Thomas Marston was admitted by the Vestry to be Clerk of the Great (Middle) Church for the ensuing year and for which he received a salary of 1200 pounds of tobacco. In April 1689 it was ordered by the vestry that the Parish be served by Three Clerks, each Church having one distinct , who shall duly on ye Lord's Day read Divine Service, and a homily and also hear ye children the Catechisme of the Church of England, moreover each Clerk shall be a man of good sober life and conversation, and carefully look after the Church under his charge keeping it clean & decent also securing it from danger by due and timely burning of the leaves about it. It was also ordered that the Clerks of the upper and lower parts do keep punctually an account of the burials, christenings, and marriages in their respective precinct and make a true and timely return thereof to the Clerk of the Middle Church, who shall insert them into the public register. They must also keep the plate and the linen very clean and decent. The responsibilitys of Thomas was increased in 1693 when he became Clerk of both the Great Church and the Lower Chapel and was paid 1700 pounds of tobacco. He replaced Michael Musgrave (will proved 26 Jan. 1697, made 1695 while in London ) at the Lower Church. He held these positions until about the time of his death receiving as much as 2000 pounds of tobacco. For his final year he was paid only 1300 pounds which suggests that he became too ill to fulfill his final year. He was replaced by Mr. Underwood. The vestry book accounts shows many additional payments made to Thomas including in 1690 the payment of 1000 pounds for keeping a bastard child.

Thomas appears a number of times in the Middlesex Co. Va. records including:12 Nov. 1690-discharged from ever paying levies;6 April 1691ordered to appraise the estate of Wm. Dudley;7 April 1690 ordered to be paid by Alex Snelling for keeping a girl named Ann Chapman-diate & apparell the two years & a half last past;Oct 1697 juror.

Notes for JOHN MARSTON:

John Marston became constable in place of Richard Perrott in April 1707. In 1708 he was appointed surveyor of the highway in place of George Barrick and it was ordered that he cause the roads in his precinct to be well cleared and the bridge made 10 foot wide according to law. John also served as a Clerk for Christ Church Parish.

Notes for ANN (MARSTON):

Ann's maiden name is not known but "possibly" she was the Ann Chapman that was being cared for by Thomas Marston in 1687-1690. For her care it was ordered that Thomas be paid 800 pounds of tobacco by Alex Snelling. Perhaps Ann was the out of wedlock child of Alex Snelling. The vestry book also records the payment in 1690 of 1000 pounds to Thomas Marston for keeping a bastard child. Alex Snelling was the son of Wm. Snelling. He had land in Gloucester Co. near Thomas Chapman decd in 1674.

Notes for JOHN MARSTON:

It is believed that John had other surviving sons in addition to John, Jr. William Mastin appears (3 times) with the Marstons in Spotsylvania as early as 1760 [prb. born bef 1739]. Benjamin Mastin appears (2 times) with the Marstons. He also appears on a road gang in Spotsylvania in 1755 [prb. born before 1741]. Reuben Mastin appears in the Spotsylvania Co. Records in 1773 [prb born before 1752]. Given the ages and association, it is very plausible that John could be the father of William and Benjamin. Reuben Mastin might also be a son, grandson or other relative. There's no solid proof for the additional sons but it's probable that William, Benjamin, and Reuben are close relatives to John.

Following the time line, It is believed that John lived before Spotsylvania and after Middlesex Co., in Caroline Co. Va. as Henry Armistead's overseer. Also in Caroline County were a James Mastin 1752-3 and an Edward Mastin 1732-34. It is not known if they were relatives of John and no further is known about them.

John, known only as a Marston in Middlesex County Virginia, can be found in all following records only as Mastin. Mastin has been a very common spelling variation of Marston virtually down to the present day. The paper trail shows that some confirmed Spotsylvania Marstons were the ancestors of those that adopted Mastin as their surname. Recent Y-DNA results [25/25 markers] prove that this writer and a Mr. Mastin [of Virginia lineage- probably Spotsylvania County] both descend from a common paternal ancestor and there is an 85% chance that the common ancestor is back 8 generations or less. John [b. 1700] is a "potential" ancestor of Mr. Mastin. John's father, who was also named John Marston, is the 6th great grandfather of this writer and "possibly" the 6th great grandfather of Mr. Mastin as well. This would be 8 generations back for either of us.

Notes for MARY MARSTON:

Mary, in publications has often been reported to be the daughter of a Hugh Marston and Elizabeth Towles. In checking various "original" documents, Hugh has always been found as a Martin and not a Marston or Mastin. Further, records in a chancery case in Madison Co. Va show that the Sparks Family was traced to Owen Co. Ky and paid but there was not even a determination of any descendants for Elizabeth, wife of Hugh. The heir, Mary Towles, sister to Elizabeth Towles, married Thomas Sparks and her descendants were entitled to a share in the estate of Henry Towles. Had Elizabeth been the mother of Mary, then there were other descendants in Owen Co, that were neighbors to the Sparks Family, who would have been heirs also.

Generally it has been considered that Mary migrated to Kentucky with her family but that may not be the case. In 1823 in Owen County there is a Power of Attorney from William R. & Fanny Clarke Smoot to their son William Smoot. William was to receive their proportion of the estate of Mary Clarke deceased of the executors of said Mary who was the wife of the late James Clarke of Culpeper Co. Va. Mary did have family back in Madison Co. Va (formed from Culpeper) as not all of her family came to Ky. Taken at face value there is at least an equal chance of Mary dying in Virginia as in Ky. Although absence of evidence is no evidence of absence, there is no will or estate record [executors] recorded for Mary in Owen County. An examination of Madison Co. Va records may clarify this issue.

Notes for JOHN MARSTON:

It is believed that John is the soldier that served under Andrew Lewis in Washington's Virginia Regiment during the Ft. Necessity Campaign in the summer of 1754 [French & Indian War]. John bought 20 acres on South Elkhorn Creek in 1793 from Mack McDaniel. This land was part of a larger tract that had been patented by Andrew Lewis.

A probable relative of John's was Joshua Marston who appeared on a list of insolvents for Spotsylvania Co. Va in 1791 [Virginia Genealogist, 1978, V 22 No. 1, page 127]. Also in Blanton vs Marston, at first Joshua Marston is included in a list of John's children, but later it states that there was "no such brother as Joshua".
