I, Samuel Todd, of Ohio township, in Beaver IN THE NAME OF GOD AMEN: County and state of Pennsylvania being in good health of body and of sound and disposing mind and memory, praised be God for the same and being desirous to settle my worldly affairs while I have strength and capacity so to do, Do make and publish and declare this my last swill and testament hereby revoking and making void all wills by me made at any time heretofore. And first of all and principally, I commit my soul into the hands of my Creator who gave it and my body to the earth to be intered at the discretion of my executors hereinafter named. And as to such worldly estate wherewith it hath pleased God to intrust me I dispose of the same in the following manner Viz: First I will that my whole estate real and personal be sold excep so much as is hereinafter otherwise disposed of and all my just debts and faeral expenses paid and the balance or residue of my estate be put to intrest. And if my beloved wife largy should be living at my decease I will that she shall have one years provision for herself and Lucy Mc Farlane my Grand daughter (who is to live with her and assist her in her infirm and declining years) And also it is my will that the my beloved wife shall have one bed stead one bed and bedding one bureau, one trunk and two chairs and all my clothing to dispse of as she may think proper and it is also my will that she my beloved wife shall receive the intrest of my whole estate during her natural life for the support of herself and Lucy McFarland, my Grand daughter and at the decease of my beloved wife Lucy it is my will that my whole estate be devided into ten equal sharesand I will to my son Alexander Todd one equal share and to Silas Caughey and Josephua Caughey one equal share to be equally divided between them, and to my Grand son Samuel Smith one equal share and to my son Benjamin Todd one equal share to my son Joshua Todd one equal share to my son Samuel Todd one equal share to my son Jacob Todd one equal share to my daughter Lucy Scott one equal share to my two Grand children Lucy McFarland and George McFarland one equal share to be divided between them equally, and to my daughter Sarah Biddle one equal share. And I do make and ordain my two sons Slexander Todd and Jacob Todd executors of this my last will and testament.

IN WITNESS WHEREOF, I have set my hand and seal this fourth day of January in the year of our Lord one thousand eight hundred and forty one.



WHEREAS I Samuel Todd of Ohio Township in the county of Beaver and State of Pennsylvania having made and duly executed my last will and testament in writing bearing date the fourth day of January One thousand eight hundred and forty one. Now I do declare this present writing to be as a codicil to my said will and direct the same to be annexed thereto and taken as part thereof. I give and bequeath unto my beloved wife Lucy sould she be living at my decease the use of the whole of my person estate for two years from the time of my decease, should she live so long and also the whole of the rent or profit arising from my real estate to be and remain during the said term of time for her use and support and for the support of my three Grand children, Harriet Todd Lucy McFarland and George McFarland. Should they remain with and take care of their Grand mother, provided that no part of the estate shall be destroyed or unnecessarily disposed of during said term of time.

And lastly my express will and desire is and I do hereby order and appoint that if any difference or dispute question or controversy shall arise or happen concerning any gift bequest or other matter or thing in this my will given and bequeathed expressed or contained. That then no suit or suits in law or equity or otherwise shall be brought commenced or prosecuted for and concerning the same but the same shall be referred wholly to the award or and determination of my esteemed son in law Robert Scott, and what the said Robert Scott shall order direct or determine therein shall be binding and conclusive to and on all and every person and persons therein concerned.

IN WITNESS WHEREOF, I the said Samuel Todd have to this cocidil set my hand and seal, this first day of December A.D. one thousand eight hundred and forty two.

A Sarah Calhoun patented land called "Sarah's Choice" in 1802. It was located in South Beaver Township (later Ohio Twp.)—on the north side of the Ohio River.73 "Sary Calhoun" left a will in 1811 stating she resided in Ohio Township. It named children Samuel, Adam, James, Elizabeth, Nancy, Mary Todd, Rebecka Chook. Subsequent quit claims indicate that son Adam lived in Moon Township (south of Ohio River) and had a wife, Jane. Sary's will stated that her son Samuel would keep the land until his death after which the other children would receive it.74 Between 1819 and 1825 the legatees quitclaimed their rights under the will to Alexander Todd, presumed husband of Mary Todd. These quit claims imply that Samuel had died between 1811 and 1819. The quit claim of James shows that he also lived in Ohio Township (north of the Ohio River). The quit claim of Adam shows that he lived with his wife, Jane, in Moon Township (south of the Ohio River).75

(One possibility is that Alexander Todd, son of Samuel, married Mary Calhoun prior to 1811, and that she died soon thereafter and that he then married Sarah Stephens about 1812 or 1813. This interpretation would require that he retained the land rights of Mary Calhoun. This is the only way I can explain how Alexander Todd's sons Benjamin and Samuel were able to convey the land of Sarah Calhoun to their brother Nicholas in 1865 as part of the settlement of the estate of their father Alexander Todd.)

Mr. Todd is a native of the old Keystone State, and by birthright he is to be associated with the sturdy yeomanry which has ever constituted the bulwarks of our national independence and prosperity,-for he was born on the parental farmstead, in Beaver county, Pennsylvania, on the 12th of March, 1843, being the seventh child of Jacob and Jane (Thomas) Todd, who became pioneers of Wells county, Indiana, as will be duly noted later on. Jacob Todd was born in Beaver county, Pennsylvania, August 15, 1805, being the youngest son of Samuel and Lucy (Shivers) Todd, who became the parents of seven sons and seven daughters. Samuel Todd was the son of Alexander Todd, one of the early settlers in Baltimore county, Maryland. Jane (Thomas) Todd, mother of our subject, was born in Columbiana county, Ohio, on the 2d of January, 1807, and was the eldest of the twelve children-three sons and nine daughters-of Enos and Margaret

Senr. of Frederick county and State of Maryland being weak in Body but of sound disposing mind and memory doth make and ordain this my last will and Testament in the following manner and form, that is to say after my funeral charges and all my Just Debts be paid I give and bequeath unto my beloved wife Rachel Todd all my Lands lying in Frederick County and in Baltimore County being parts of Two Tracts of Lands known by the names of Parr's Range and favour and Ease, with all my Personal property during her natural life only subject to the following remembrances hereafter mentioned - I give and bequeath unto my Daughter Lucy one cow and one feather bed to be paid to her at the age of Sixteen years and fifty pounds to be paid to her after the Death of my wife - I give and bequeath unto my Daughter Elener one cow and one fether Bed to be paid to her at the age of Sixteen years and it is my will and desire that after the Death of my wife that all my Estate both real and personal be sold at public sale and the moneys arising from such sale after the above fifty pounds first paid out of said money to my Daughter Lucy, all the residue or remainder of the money to be equally divided amongst my children namely Benjamin and Basil and Elisabeth Bevonton and Samuel and Alexander and Joshua and Rachel Bidel and Warfield and Lucy and Susanah Hambleton and Eleanor Todd to their heirs or to there Assigns and I do hereby constitute and appoint my well beloved Wife Rachel Todd sole Executrix of this my last will and Testament and after her Death I do appoint and constitute Alexander and Joshua Todd Executors of this my last will and Testament. There is a report on Ancestry that Samuel Todd b 1795 married Susan Biddle in 1825 and had Harriet, born 1828, Alfred b 1829, Lucy b 1832, William 1842-1869 - all born in Beaver Co. And that Susan died in 1855 in Bedford Co: howver, we have Samuel married to Mary in the 1850 census and 1860 census; I suspect that Susan Biddle died prior to 1840; that Samuel married Mary Reeder Williams in 1840 and had William.



### MARY REEDER TODD

Mary Reeder born Pennsylvania August 25, 1798; came to Hanover with parents at age of 8 years; married Owen Williams, early postmaster of Hanover; husband died in 1837; became wife of Samuel Todd 1840; died Hanover April 15, 1881.

So where can we find a Samuel born in the 1780s who would be the son of Basil? We know that Samuel Todd married Sarah Reifsnider /Ralphsnyder in 1812 in Columbiana County. There are ancestry.com reports that this Samuel was the father of John Jacob Todd b 1820 Richland Co. We find there is a Samuel Todd in Richland Co in 1820 (born 1776-1794), 1830 (born 1780-1790). So he at least is the right age to be the son of Basil Todd. He has 3 sons b 1810-1820 and 3 sons b 1820-30. Sarah Todd b 1790-1800 appears in the 1840 census with no husband, but 4 sons born 1810-1820, 2 sons born 1820-30, 1 son born 1830-35. This all fits together. This Samuel I assume to be the likely son of Basil.
