

# Todd Families Settlement in NW South Carolina

## Background

At least eight different Todd families settled in northwest South Carolina in the colonial and early national period. This essay seeks to sort out the various families and indicate their relationships or potential relationships. The TF number indicated with each family is the Todd Family Number assigned to that family to keep track of all the different families.

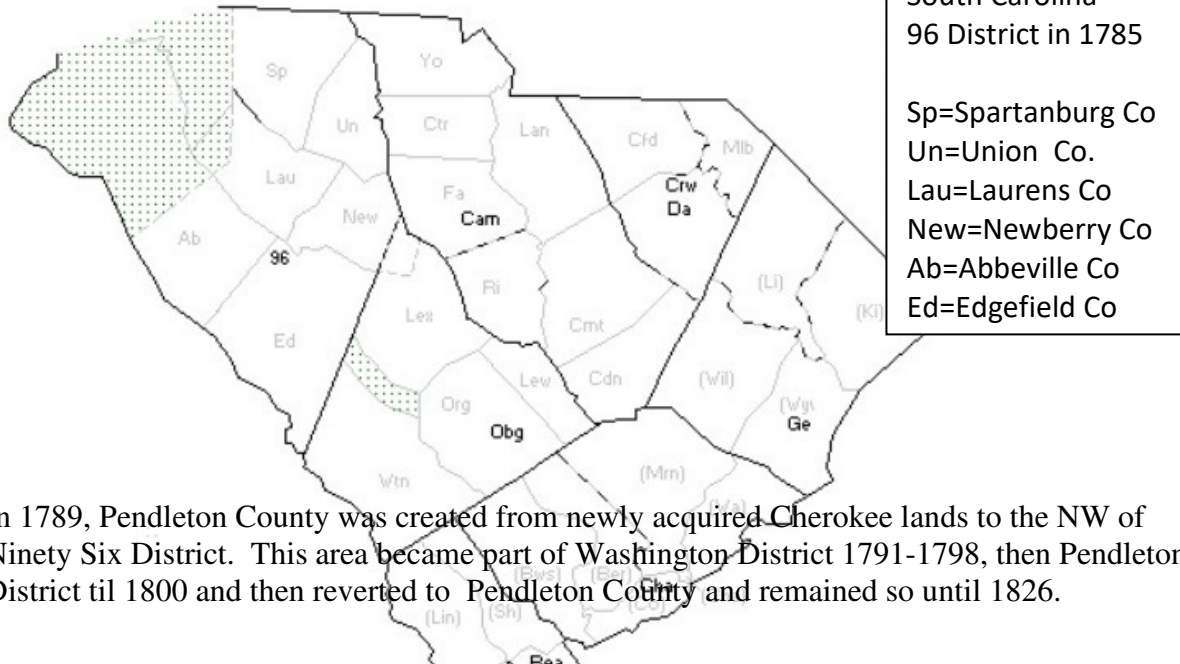
Based on existing DNA evidence, four of those families (Nathan and Patrick: TF 47 and 48 who settled along the Saluda River in Laurens Co and James Todd md Jane Erskine TF 53 and Robert Todd TF46 who both settled in Pendleton Co by 1802) share DNA with each other and with the Todds who lived in the Ballyalbanagh/Ballyclare area of central County Antrim, the same general pattern as the Mary Todd Lincoln group of Todds, referred to as the Group 1 Todds. This pattern is different than the DNA of the other families in the area that have been tested. Three of the families (Archibald TF52 who settled on Ninety-Six Creek in what became Greenwood County, Robert TF 50 who settled on a branch of the Saluda, but further upstream than Nathan and Patrick in Laurens, and the brothers Andrew, John, and Samuel TF 49 who settled in or north of the village of Laurens) all share a DNA pattern identical or similar to each other and to the Todds of County Down and Northern County Antrim/Coleraine.

With respect to the subset of the NW SC Todds who are Group 2 Todds, the Big Y male DNA testing revealed for the Archibald Todd family (TF52) had the same DNA pattern as the Todds of Fenwick, Ayrshire Scotland, the parent pattern of the Group 2 Todds. And Andrew, John, Samuel Todd (TF49) had a mutation pattern most closely related to the Todds of Aghaderg in southern County Down. The Robert Todd (TF50) had a pattern mostly closely related to a County Antrim family that came to Nashville TN by 1780 and then to Xenia Ohio. This pattern was not a descendant of the Northern County Antrim Todds but a parallel branch from the ancestral pattern of the Todds. .

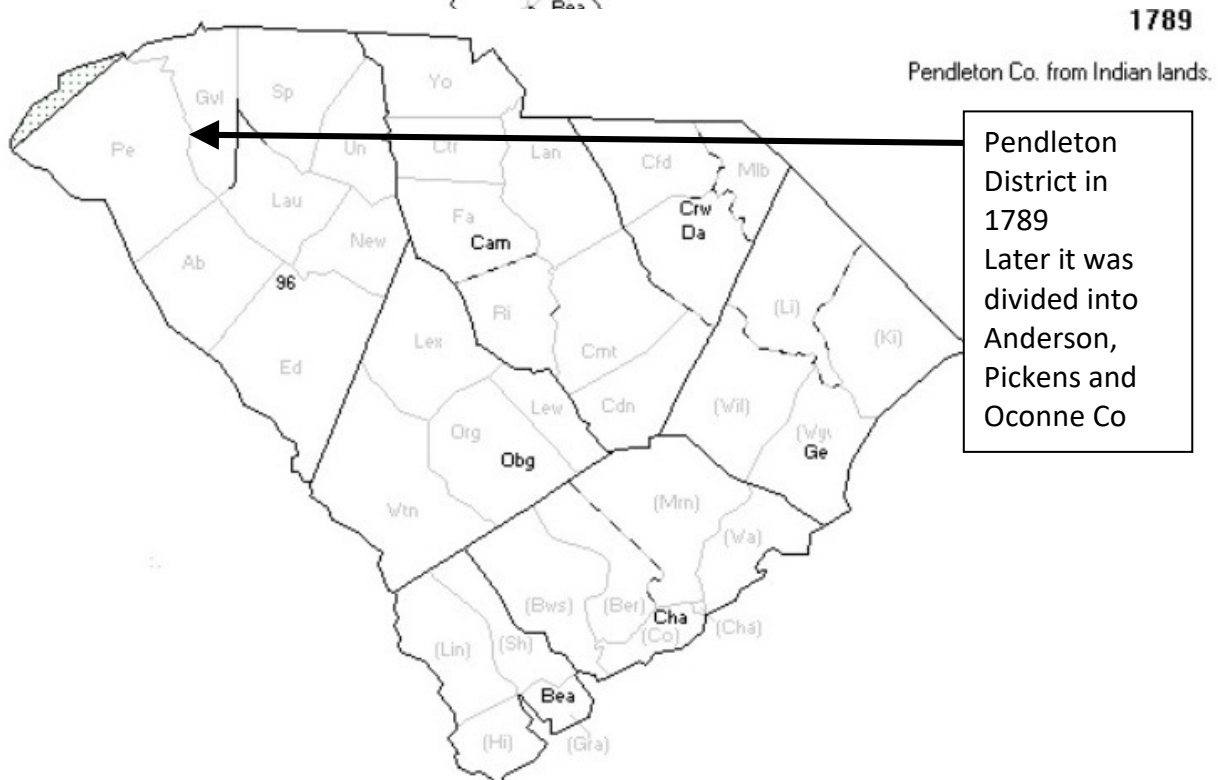
With respect to the subset of the NW SC Todds who are Group 1 Todds, the Big Y male DNA testing revealed that the two Todd families that came to Pendleton District between 1799 and 1802 were most closely related to the Todds who came to Hunterdon Co New Jersey about 1749 and to a Todd family that lived in the townland of Rashee in County Antrim in the early 1800s. The Nathan/Nathaniel Todd d 1828 Laurens Co SC family is its own branch from the trunk of the Todd genetic tree. The Patrick Todd d 1852 Laurens Co SC family has the same pattern as the Todds of the townland of Ballyalbanagh, Co Antrim and the Todds who can be traced back to the 1500s in Haghill of Glasgow, Scotland.

Much of the original research for on these families was done by David Lee Todd, Ann Lackey, Jane Presseau, Dee Bardes, Pat Baron, Myran Morgan-Trask, Benjamin Harris Todd, Leslie Cleveland Todd, Larry Todd, Katheen Williard, Lee A Todd and others.

In 1768, South Carolina created Ninety Six District which included the swath extending between what became in 1785 Spartanburg and Union county in the north, to Laurens and Newberry in the middle and Abbeville and Edgefield in the south.



In 1789, Pendleton County was created from newly acquired Cherokee lands to the NW of Ninety Six District. This area became part of Washington District 1791-1798, then Pendleton District til 1800 and then reverted to Pendleton County and remained so until 1826.



First Wave of Settlement

The first Todds to settle on this frontier were

- (1) Jean Todd and Archibald Todd who sailed from Belfast to Charleston on the ship Pennsylvania Farmer arriving on December 19, 1772,
- (2) a Robert Todd and Margaret Todd who sailed on the ship Lord Dunluce from Larne on January 6, 1773 and
- (3) a Thomas Todd who settled in what became Spartanburg County<sup>i</sup>.

The first two came over on one of five shiploads of immigrants organized by Reverend William Martin, a covenanter minister of Co Antrim. According to Jean Stephenson who studied the immigration of the families brought to SC b Rev Martin:

"The majority of them were probably from the vicinity of Ballymoney, Ballymena, Kellswater, and Vow, County Antrim." (page 15).

Ballymoney was in the NW of Co Antrim where there was a large concentration of Todds with the DNA pattern of Archibald Todd; Ballymena and Kellswater were in south-central Co Antrim. A Todd family lived in Maxwells Walls, about 3 miles east of Kellswater.

#### Archibald and Jean Todd

Jean and Archibald both settled in the part of Ninety Six District that became Edgefield County in 1785, later Greenwood and Saluda Co. Their lands may have been only a few miles from each other.

Jean Todd's 1773 grant for 100 acres was on Sleepy Creek of Ninety Six District in what became Edgefield County. Sleepy Creek runs into Turkey Creek which flows into Stevens Creek which flows south to the Savannah River near Augusta GA. The land probably lay near the present Sleepy Creek Road about 10 miles SE of Greenwood and probably lay near Ephraim's Branch.<sup>ii</sup>

Mr. Drew Welch ("Drew Welch" <[dwelch@windstream.net](mailto:dwelch@windstream.net)>) cited the following in his study of Sleepy Creek:

1772- Jane/Jean Todd, 100 plat. Moses Kirkland, William Anderson, Thomas Youngblood. SCDA

1774- Jean Todd (later wife of John Walker), grant 100 acres. The Walkers sold the land to Samuel Ramsey and he sold it to William Robertson and Robertson sold it to Azariah Lewis. 1793 Azariah Lewis sells the 100 acres to Thomas Youngblood. Deed Bk 21: 251-253.

1793 ? Azariah Lewis sold land to Thomas Youngblood. Deed Bk 21: 254- 256. Thomas Youngblood and wife Amy sold 60 of these acres to James Adams in 1801. Deed Bk 22: 305-307. 1822- David Youngblood to William Williams, 200 acres between Sleepy Creek and Ephraims Branch being part of grant to Azariah Lewis. William Youngblood and James Youngblood. John Dorn, M. Adams, Thomas Youngblood. Deed Bk 40: 132.

A map of the location of the creeks mentioned in the Todd land records shows that Jeanne Todd's land was not adjacent to Archibald's but may not have been more than 5 miles away. The reference to Jean Todd later marrying John Walker by Drew Welch supports the contention of Todd historians that Jean Todd was not the wife of Archibald. She may have been a sister or possibly a widow Todd.

Archibald Todd also received land in the portion of Ninety Six District that became Edgefield County, but on Ninety Six Creek which flows north towards the Saluda River. The southern branch of this creek lay only about 5 miles NE of Sleepy Creek. The plat for the land grant states:

date 5 Jan 1773.. unto Archibald Todd a tract of land containing 250 acres on the waters of Ninety Six Creek and Ninety Six District bounded NW by Robert Dickie and Mc Good Land, Ne by Jane Brownlee's land all other vacant. (Plat shows Robert Dubrie rather than Robert Dickie)

Archibald seems to have had the following children:

1. John Todd b 1760s died 1822 Jackson Co GA married Lucinda (possibly Bennett)
2. William Todd b 1760s d 1822 Abbeville Co SC married Elizabeth LNU
3. Sarah Todd<sup>iii.iv</sup> 1774- 1828 Anderson Co. married abt Elisha Bennett d 1833 Anderson Co.
4. Adam Todd b 1780d 1832 Anderson Co SC married Mary Warnock

Archibald's son William Todd secured grants between 1786 and 1793 for over a thousand acres of land on Sleepy Creek, Mountain Creek, Halfway Swamp.

About 1790, the family began moving northwest to the new Pendleton District. In 1789, John Todd bought 200 acre on Hencoop Creek in the portion of Pendleton that became Anderson County.<sup>v</sup> By 1790, we find a Jeanne Todd and a John Todd in Pendleton County, reflecting their recent move. Jeanne had 2 males under 16, therefore born after 1774, presumably Adam Todd b1780 and one other. John had a male under 16, presumably his son James. So this fits with this Jeanne and John being the pair mentioned in the 1793 deed since they did not appear in the census elsewhere in 1790. John Todd also got a grant on McAdoo's Creek for 796 acres – over a square mile which he sold in 1815 (wife Lucinda) when he lived in Jackson Co GA.

In 1793, William sold some of his lands in Edgefield County. That same year, in September 1793, John Todd, his wife Lucy and John's mother Ginnet Todd sold, for the sum of fifty pounds sterling, "one certain tract or parcel of land containing two hundred & fifty acres more or less lying on the head of Ninety Sisc Creek Bounded by lands of Nacerness Good Jane Brownlee Robert Dicke" in the presence of William Todd, Thomas Clement Wade, and Joseph McKown- signed John Todd Lucindy B. Todd ( her mark) Jeanny Todd ( her mark). Ed. note: accompanying documents list the mother as Jennet and as Jinit Todd. Recorded 29th Janry 1794. Source: Deed Book 7, pp. 176-178, Probate Judge's Vault, Edgefield County, SC.

Note that the size of the plot (250 acres) and the neighbors are the same as the plat that Archibald received in 1773. Hence, we know that this John Todd who married Lucindy/Lucy/Lucinda B

was the son of Archibald Todd and that the William Todd mentioned therein must be close kin and was probably also a son of Archibald.<sup>vi</sup>

Family tradition states that their daughter Sarah Todd married Rev. Elisha Bennett. Elisha and Sarah Bennett (they had a son Adam Todd Bennett and Archibald Todd Bennett) and Jean Todd are found on deeds together in Pendleton District SC in the 1790s.<sup>vii viii</sup>

John Todd died in Jackson Co AL in 1822; William died in 1822 in Abbeville Co SC; Adam died in 1832 in Anderson Co SC; and Sarah Todd Bennett died in 1828 in Anderson County.

#### Robert Todd and Margaret Todd

Both Robert Todd and Margaret Todd got their own 100 acre grants in 1773, soon after their arrival, both on Rabon Creek, a branch of the Saluda River, though perhaps on different branches of the Rabon.<sup>ix</sup> This may be the Robert Todd who appears in the 1800 and 1810 census in Laurens Co<sup>x</sup> and is the Robert Todd referred to in a 1785 sale of land to William Martin on Todds Branch and Rabon Creek and on William Martin's 1796-1800 sale of that land to John Todd.<sup>xi</sup> Robert Todd is mentioned in a will of Thomas Hood in 1796 in Laurens Co. Another plat to a James Todd in 1816 on Reabon Creek mentions Robert Todd.<sup>xii</sup> This James is probably the male living with Robert in the 1800 census aged 16-25.

James is probably the James Todd b 1774 who migrated to Henderson Co. TN and is probably the son of Robert Todd.

Robert bought an additional 220 acres on Todd's Branch from Charles Madden in 1799<sup>xiii</sup> and then sold 187 acres of it to John Todd in 1808.<sup>xiv</sup> Since this deed of Robert Todd's has a Robert Todd as witness, it could be that Robert Sr had a son Robert Jr.

Robert's son John was the John Todd who appears in the 1800 census with four sons under 10 years old.<sup>xv</sup> John died in 1821. John's will mentions his son-in-law Robert Bryson, his sons Robert, John, James and Charles, his daughter Mary and his wife Nancy.<sup>xvi xvii</sup> Some of these sons (Robert b 1799 to Meriwether Co GA, Charles b about 1790 and John b 1798 to Cass Co GA, and possibly James b 1788 in Spaulding Co. GA.

#### Thomas Todd

Thomas Todd received a 500 acre land grant between the Tygart and Enoree Rivers in Ninety Six District in 1775. This would have been in what became Spartanburg County. Thomas is on the 1790 and 1800 census in Spartanburg. He is a witness to a will in Spartanburg in 1801.<sup>xviii</sup> Stephen Layton was executor of the will of Ambrose Yarborough for which Thomas Todd was a witness in 1788.<sup>xix</sup> Peter Pinell, the son-in-law and second executor of that will witnessed a sale of land to Thomas Todd in 1799 between the Tygart and Enoree Rivers.<sup>xx</sup>

Thomas Todd and wife Ann sold to Edward Musgrove: Plantation on north side of Enoree River; 100 acres, part of property of William Cox, dec'd which he sold to John Briggs, now dec'd whose heirs sold to Thomas Todd. Spartanburg Deed A-69 1785

Thomas Tod and wife Ann to Tilman Bobo - 500 acre grant of Thomas Tod 15 June 1775, Spartanburg Deed A-59, 1786

Thomas Todd to John Thomas Sr of Spartanburg Co 440 acres on south side of Tyger River above ancient boundary. Being part of 640 ac grant to Major Parsons 21 Jan 1785, the other part being land where said Maj. Parsons now Lives Spartanburg Deed A-79 1786

An Andrew Todd b 1795 Co Antrim came into Charleston SC in 1810 and by 1818 was in Garrard Co KY where he married Millie Layton who had lived in the vicinity of Thomas Todd. This could be coincidence or could reflect a kinship between Thomas and Andrew.

### Second Wave

In the 1790s, there was a second wave of immigration – this time to Laurens County - though we are not quite sure about the fate and identity of all of these immigrants.<sup>xxi</sup> The ones we do know are two brothers born in Co Monaghan, northern Ireland, who came to South Carolina about 1790, namely, John Todd 1762-1835 and Samuel Todd 1762-1825. They were both medical doctors.

John Todd married Elizabeth Julia Spencer in 1800 in Laurens. Samuel originally settled in Newberry County but then moved to Laurens.

These two brothers were brother to Andrew Todd b 1756 in Co Down who came to Laurens County in 1816, bought land also immediately<sup>xxii</sup> and was naturalized in 1822. A county history reports that Dr. John and Samuel Todd were brothers of Andrew who came over earlier and the Samuel Todd went back to Ireland to marry.<sup>xxiii</sup>

Slightly later were the migrations of Patrick Todd and Nathan Todd. Patrick and Janet Carmichael Todd arrived in 1798 and settled in Laurens County on Banks Creek a branch of the Saluda River. Nathan Todd bought property in Edgefield, Newberry and Laurens County 1794-1797, eventually settling near Patrick.<sup>xxiv</sup> Nathan appears on the census in 1800 in Newberry and in 1810 in Laurens.<sup>xxv</sup> They share the same DNA pattern – that of the Todds of Ballyalbanagh-Ballyclare area in south-central Co Antrim, the pattern of the Mary Todd Lincoln group of Todds.

### Third Wave

In 1802, a Robert Todd (1784-1844) came to Pendleton District/County and was naturalized in 1813. He married Olive McAllister, daughter of Andrew McAllister almost immediately after arriving.<sup>xxvi</sup> He bought 100 acres on Governance Creek in 1805.<sup>xxvii</sup> In 1830, he obtained a grant for 202 acres on Governor's Creek (a tributary to Rocky River in Anderson District).<sup>xxviii</sup> According to Myran Morgan-Trask, Nathan McAllister was a witness to the 1813 naturalization papers that documented that Robert was from Co Antrim. Since it seems like Archibald's

family was already living next to Nathan McAllister, it seems possible that Robert was kin to Archibald. DNA shows a match with the Group 1 Todds/MTL group of Todds..

James Todd 1766-1850 and Jane Erskine Todd came to South Carolina between 1799 (birth of their son James in Ireland) and 1802 (birth of their son John in 1802).<sup>xxix</sup> He appears in the 1800 census for Pendleton<sup>xxx</sup>

He first, in 1801, bought 200 acres on Broadmouth Creek from Charles Clements which he sold in 1813 to William Owens.

Then, in 1803<sup>xxxi</sup>, he bought land on Broadway Creek from Daniel McAlister (325 acre) and from John Parker (100 acres). In 1809, he sold 200 acres of this to his sons James and John. Then in 1805, he got a grant for 535 acres on Twenty-Six Mile Creek a mile or three west of his Broadway Creek land which he transferred to Joseph Green prior to 1813. In 1820s, he bought and sold land on Broadaway Creek. In 1826, he sold 100 acres on Broadaway Creek to his son James.

and a grant for 802 acres on Cain Creek of Keowee River in what became Oconee County.

About 1833, he had remarried to Sinai Duncith (spelling?) and by 1834 had a son Robert F Todd with her. He died by 1835 and his widow sold another 100 acres of the Broadaway Creek land. At this time, the land was bordered by the lands of his sons James Todd and John Todd. By this time, William Todd may have moved to Pickens Co (the portion that became Oconee County).

William Todd, son of James Todd Sr., got a grant for 500 acres on Beaverdam Creek in 1805 and purchased 380 acres on Beaverdam Creek in 1808. In 1823, he sold 200 acres of this land on Big Beaverdam Creek.

### Loose Ends

Family Interrelationships: DNA analysis is underway to determine which of the NW South Carolina Todds are related to each other and which are unrelated families that simply crossed paths during the settlement of South Carolina.

Archibald Todd family: There were two Archibald Todd's in Anderson Co – one was the son of Adam Todd who witnessed the guardianship records for Archibald Todd son of Adam's brother William. The 1822 will for William Todd d 1822 states that Archibald Todd was the oldest child of William Todd and the 1830 estate settlement record indicates that he was over 14 and under 21 years old in 1830, hence born 1809-1816.

James Todd/Jane Erskine family: There is a Thomas Todd b 1815-1824 who married Caroline Watson about 1845 and moved to Gwinnett Co GA by 1850. Caroline died in the 1850s and her daughter Jacoline came to live with James Todd back in Anderson County. So we know this Thomas was some kin to the James Todd b 1799, son of James Todd/Jane Erskine. Jacoline's obituary in 1873 stated she had come to live with her uncle James Todd. For James Todd b 1799 to be her uncle, then Thomas Todd b 1815-1824 would have had to have been a much

younger brother of James Todd b 1799. DNA from a descendant of Thomas b 1815-1824 matches the James Todd/Jane Erskine family.

The census evidence is hard to interpret and a bit contradictory but there does seem to be a male who could be this Thomas associated with the family of James Todd/Jane Erskine. The 1820 census shows a male born 1810-1820 who could be this Thomas, but it is not clear whether this young male was a later child of James Todd and Jane Erskine or a first born to James Todd b 1799. The census does not show an older woman and hence Jane Erskine Todd must have died by 1820; but there is a younger woman born 1794-1804 who could either be the second female daughter listed in the 1810 census or could be the new wife of James Todd b 1799 and that young male could be the newborn son of James Todd b 1799, assuming that the young male was closer to being born around 1820.

The 1830 census for James Todd b 1799 includes an older male b 1810-1815 which doesn't quite match with the older male b 1815-1820 in the 1820 census unless he was born 1815. If Thomas was born 1815, then there would have been a 13 year gap between the birth of John Todd in 1802.

John Todd 1800-1860 and Lucinda Wilson Family: This John Todd was in Anderson Co in 1850 and went to Paulding Co GA where he died in 1860. DNA suggests he was kin to the Laurens Co Todds of Raborn Creek.

Below are miscellaneous records that we do not have the patience to put in order.

\*\*\*\*\*

Note: In one source I see:

For instance, each Scottish Covenanter was entitled to 100 acres for himself and 50 acres for his spouse, and an additional 50 acres for each child brought to South Carolina (From Scotch-Irish Migration to SC).

In another source, I see that it was 50 acres for each person in the family.

So for Archibald to get 250 acres under the first scenario would mean Archibald, his wife and 2 children. Under the second scenario, getting 250 acres would be for Archibald, his wife and 3 children. In 1773, Archibald had only 2 children: John and William. His dau Sarah was born 1774 and son Adam was born 1780/81.

In the 1850 census for Cass County (now Bartow County) GA,

Charles Todd 60 b SC abt 1790

Elizabeth Todd 50 b SC

Sarah Todd 18

Margaret J Todd 15

Charles M Todd 12 b abt 1838 SC

Eliza F Todd 7

In addition to Charles in GA, we have in Cass Co a John Todd b 1798 SC and in Meriwether we have a Robert Todd d 1797 SC. And a James b 1788 in Spaulding.



Luckily, we have a DNA sample from Leslie Cleveland Todd a descendant of Robert Todd b 1794/9.

Also, I found this:

As early as December 1, 1786 William Hubbs witnessed a land deed between Haisten Doyall ( Haystin Dial) and wife Rebecca to John Todd.[1]The identification of William's wife comes from a deed dated 11 Dec 1789 in which William Hubbs sells to George Fuller for L20 100 acres on Sm Branch on the North Side of Reaburns Creek originally granted to Margaret Todd. Conveyed to Frederick Little and in 1787 to Wm. Hubbs.. His wife Elizabeth signs her release of Dower rights.[2]

These are in Jackson Co GA. What is strange is the reference to lands of Archibald Todd. This would be worth getting a copy of.

1818 Dec 27 Deed Book G pg 154. Robert Dowdy to John Wallace both of Jackson 38 ac on Mountain Creek in land of Archebald Todd. signed Robert Dowdy. Wit: Thomas Langley, Joseph Davis. Recorded Jan 14 1820.

1819 Jan 23. Deed Book G pg 149. Robert Dowdy of Hall GA to Robt Venable of Jackson 124 ac on waters of Walnut Fork of Oconee it being part granted unto Charles Sewal and others. signed Robert Dowdy. Wit: Jacob Braselton Jr, John Todd,. Recorded Jan 13 1820.

Adam Todd signed a "willingness to accept". Adam Todd was described as a steady and honest man, excellent and undoubted character, in good circumstances and in every way qualified to discharge the duties of a guardian (document dated 6 Jun 1830).

Serena was the youngest child, being under 12 years. Documents bear the signature of Elizabeth Todd, wife of William. When Uncle Adam Todd died (19 Oct 1832), a John Todd (unspecified relation) was appointed guardian of Serena.

Berkley County but now called Edgefield County, originally granted to Elizabeth Verditty, who in her lifetime conveyed said land to George Haig, now deceased, George Haig, son of George Haig, deceased, and Andrew Brown. This land bordered on the Santee otherwise called the Saludy River (Edgefield Deed Book #9, pages 264 - 269).

On January 20, 1797 Nathan Todd bought 150 acres on Smith's Creek near the Saluda River in Laurens County, SC from Thomas Fakes for 75 pounds sterling. The land was bordered by that of the Widow Proctor, John Meeks, and William Watson, and was in the Spring Grove Section near Cross Hill (Laurens Co. Deed Book F, page 225). Elijah Stone got a plat on Smiths Creek page 236 26.5 acres location Book E 1791-1803. Thomas Fax got a plat on a Branch of Smith's Creek, p 239 151 acres. In 1835, Samuel and Thomas TODD received \$23.60 from Nathan T. PROCTOR as "our mother's share of the tract of land lately owned by Nathan TODD..." (Laurens Co., Deed Book "N," page 106).

On February 22, 1797, Nathan Todd purchased 72 1/2 acres in Newberry Co., SC on Mudlick and Mill Creeks for 30 pounds sterling from William Day. The land he bought had originally been part of 300 acres granted to John Red (Newberry County Deeds, Volume C, page 1044). This property is close to the Newberry Co. and Laurens Co. line, very near Nathan's Laurens Co. property.

A deed recorded April 7, 1800, states that Richard Tear of Newberry County sold to Nathan Todd of Laurens County 100 acres on Kings Creek for 35 pounds sterling. It goes on to say that this land was part of 300 acres granted to Francis Davis and conveyed by him to John Adkins and by Adkins to Charles Wilson and by him, dated November 7, 1798, Richard Tear (Newberry County Deed Book "D", pages 529-530).

A deed dated October 12, 1802 states that Nathan Todd of Newberry District for a sum of \$1,000 sold to William Stewart of Edgefield District 200 acres on the south side of the Saluda River originally situated in Berkely County, SC but now called Edgefied District. Furthermore, this land was orginally granted to Elizabeth Verdety in 1754, sold to Andrew Brown, and then sold to Nathan Todd. The deed also states that Isbell Todd, wife of Nathan Todd, did sign her right of dower to the within named 200 hundred acres (Edgefield Co., SC Deed Book 23, page 311).
