aleville is a rather young town with a long history.
Settlers began to come to the area that is now Daleville early in the 1800 s In 1852, a rail road ran from Indianapolis to the town.
Hoosier poet James Whitcomb Riley even made a meager living for a small even made a meager for Daleville busi-
nessmen.
Daleville gained national notoriety on uly 17, 1933, when a young John Dillinger started one of the most infamous crime sprees in U.S. history by obbing the Daleville Commercial bank, ust weeks after being released from the Indiana Reformatory at Pendleton.
Not bad for a town that has really ly been around since 1982
It was in 1982 that the town of Daleville, which since the turn of the century has had more than 1,000 citicentury has had more finally incorporated itself.

Bob Hurst moved to Daleville the year the town incorporated. He set up shop three years ago on Indiana 32 to shop three years ago on indiana
sell leather apparel and clothing for
motorcycle enthusiasts. He said Daleville has changed a lot since the incorporation.
"When I first came here there was no police department or town hall," he said. Today, four police officers keep the Today, four police officers the town of about 1,700 people. Hurst said he moved to Daleville from Anderson so he could live in a small town. He said he liked living in a small lown. He said he liked could safely walk community where he could salely waik to the grocery store and the post office whenever he felt like it.

Across the street from Hurst is Daleville Furniture. The building is triangular in shape. For over 85 years sofas, chairs and other furnishings have been sold there. About 26 years ago,

Dallas Wilson bought the store. Today, he is training his three sons Greg, 39 Barry, 36, and Chris, 30, his trade. All of the Wilson boys graduated from
Daleville High School.

"This is a nice, clean small communi ty", he said as he sat in a rocking chair on the store showroom floor. "But things are changing, and you have to keep up." are changing, and you have to keep up

One major change is the addition of the Indiana Factory Shops on Indiana 67. A drugstore that used to be across the street from Wilson's store has been the street from Wison's location for Overland Tours.

Wilson said that even though the business community in Daleville is changing the old touches keep things
secial for people who choose to do business in Daleville
"Business is changing" Wilson said. But still, when you call here, you'll get me or one of my sons instead of a recording."
Recreation in Daleville is a matter of Recreation in Daleville is a matter of
simple pleasures and old-fashioned pastimes.
"I would say that for fun, most people go to church," said Wilson, who closes the shop on Sundays for that purpose. Hurst, on the other hand, likes to take advantage of Daleville's rural flavor.
"I have lived in big towns," Hurst sai as he examined a piece of leather he had just fashioned. "But I like this small town fine."
