(Please note that this census was taken preparetory to a vote on a petition to incorporate Hartford as Hartford City, Indiana and they were the residents of the plat as surveyed, May 21, 1857, by a A.Cassel, Blackford County Surveyor. A vote of eligible voters was taken Sept. 28, 1857, showing 35 in favor and 18 against. As a consequence the county commissioners declared the town incorporated on Dec. 7, 1857, page 409 of Book 2.)
