After maturity each instalment of the note or notes described above shall draw interest at the rate of _____ percent per annum. At the request of the Seller, Purchaser agrees to execute a chattel mortgage covering the equipment ordered hereunder to secure payment of said note or notes. If any sales, excise, floor or processing taxes now in effect shall be increased, or any new sales, excise, floor, or processing taxes shall be imposed by Federal, State or local laws, the Purchaser agrees to reimburse the Seller for any and all such increased or new taxes that the Seller may be required to pay or to reimburse to others by reason of the manufacture, purchase or sale of the equipment covered by this order. The amount of such increased or new taxes may be billed as a separate item or added to the price of the equipment, at the Seller's option.

If for any reason delivery of the equipment covered by this order is not made within ten (10) days of the date of this order the cash selling price quoted herein will be subject to adjustment to conform to the Seller's regular cash selling price of the equipment covered by this order in effect at the time of delivery. If the price adjustment results in an increase in price the Purchaser shall have the privilege of accepting delivery at the increased price or canceling this order by giving written notice of such cancellation to the Seller prior to delivery and within five (5) days after notice of such price increase is given to the Purchaser. If the price of the property covered by this order is increased as provided above and the purchaser does not exercise the privilege or option to cancel this order, a new order shall be written to reflect such price increase and shall supersede this order.

The Seller agrees to deliver the equipment as ordered unless prevented by causes beyond his reasonable control. After delivery all of the equipment shall be held and used at the Purchaser's risk and expense, but title with right of repossession for default is reserved to the Seller until the full purchase price has been paid in cash.

The Warranty on the back hereof is in lieu of all other warranties express or implied and all other obligations or liabilities on the part of the Seller.

The Purchaser acknowledges receipt of a copy of this order, which, together with the Warranty on the back hereof, is understood to be the entire contract relating to the sale of the equipment covered by this order.
