A BRIEF NOTICE from the National Timberwolf Association is directed not to individuals interested in wildlife conservation but to

those who served with the 104th Infantry Division in World War II. That was the Timberwolf Division, according to Thomas F. Miechur, 141 S. Iroquois Trail,

Wood Dale, Ill., 60691.

The division was activated at Camp Adair, Ore., Sept. 15, 1942, less than a year after the United

States entered the war.

It saw fighting in France, Belgium, Holland and Germany after the Allies landed at Normandy June 6, 1944, and began their march to liberate nations occupied by Nazi Germany's forces for varying amounts of time.

Troops of the division spent 195

without relief. During the Battle of the Bulge at the end of 1944, the division defended the Ruhr area. Sent back to the United States in June 1945 after the surrender of

consecutive days on the front lines

June 1945 after the surrender of Germany the previous month, the division was scheduled to head for the Pacific Theatre of Operations and a possible invasion of Japan when that part of the war ended in August 1945.
