## DAVID SANDERS

David Sanders appears on the tax list for Franklin County, Ga. in 1800-1803 as a single poll indicating he must have turned 21 years of age before 1800. He married Mary Allred in 1802 and their eldest son, Moses Martin Sanders was born 17 Aug 1803. Two other children were born to this couple while living in Franklin County, Ga., William Hambleton born 5 Apr 1805 & Sarah 26 Dec 1807. In 1802 the Grove Level Baptist Church was constituted. Among the charter members were David Sanders, Polly Sanders, Francis Sanders & Polly Sanders Sr.

David Sanders received a grant of land from his father, Moses Sanders, as recorded in the Franklin County, Georgia Deed Book. "This is sufficient deed of gift made the tenth day of July 1803 by Moses Sanders Senr. unto David Sanders his son a part or parcel of land lying and being in the county and state above written it being a part of a tract of land lying on the Grove River and to wit the said land lies on the South Side of the grove containing fifty acres be the same more or less it being a part of a tract of land originally granted to Lieutenant Henry Long conveyed by said Long unto the said Moses Sanders Sen. And by him unto David Sanders beginning at a stake on the bank of the river thence running S 50 until it strikes the river thence down the main meanders of the river down to the beginning so as to include all the bents of the south side of the river to have and to hold the above mentioned premises the said David Sanders his heirs and assigns forever and I the said Moses Sanders Sen. Do warrant and defend the above mentioned premises against any heirs and assigns and all claims under me or mine unto the said David Sanders his heirs and assigns forever as witness my hand and seal the day and date above written. Moses Sanders, Seal. Witnesses: Moses Sanders Jun., Aaron Sanders. Georgia, Franklin County: This day came Aaron Sanders and made oath that he saw Moses Sanders devise & sign the above deed of conveyance and that he also saw Moses Sanders Jun. subscribe his name as a witness. Sworn to and subscribed to before me this 20 Day of 1807 Obadiah Hooper, J.P. Recorded this 11th December 1811."

According to the Feb 1805 minutes of the Grove Level Baptist Church, Mary Allred was dismissed by letter. The Oct 1806 minutes indicates David Sanders was appointed to cite Silas Sanders & Anderson Ivy to the next meeting. At the Feb 1807 meeting David Sanders & his Uncle Francis Sanders are appointed to cite Bro. Jones to the next meeting. The Sep 1807 minutes state Polly(Mary) Sanders is received by letter and then Bro. Francis Sanders & Sis. Polly Sanders, Bro. David Sanders & Sis. Polly Sanders are dismissed by letter. This letter was likely to introduce them to a new Baptist Church in Tennessee.

The second land lottery of Georgia was conducted in 1807. Williamson County Georgia Land Lottery (Film 519,059) Page 61 is a document indicating David Sanders of Wemms District, Franklin County received 202 1/2 acres of land as Lot 217 District 6 in Wilkinson County. Following David's death, his brother Aaron Sanders paid the taxes on this property until at least 1834 as the property of David's Heirs.

David Sanders sold the fifty acres he received from his father to his brother in law Obadiah Hooper in 1809. "This indenture made this eleventh day of January in the year of our Lord one thousand eight hundred and nine between David Sanders of the State of Tennessee and Franklin County of the one part and Obadiah Hooper of the State of Georgia and County of Franklin of the other part Witnesseth that the Sd David Sanders for and in consideration of the sum of two hundred dollars to me in hand paid at or before the sealing and delivering of this deed the receipt whereof is hereby acknowledged have granted bargained sold and conveyed and confirmed unto Obadiah Hooper his heirs & Assigns all that tract or parcel of land containing fifty acres be the same more or less situated lying and being in the County of Franklin in

Georgia on the Grove River beginning at a stake on the South Side of Sd river in a line that was granted to Henry Long running South fifty west so as to include all of that part of the tract or parcel of land that was granted to Henry Long on the South Side of Sd River down the meanders of Sd River to the beginning together with all the above mentioned premises rights members hereditaments and appurtenances thereunto belonging unto the Sd Obadiah Hooper his heirs and assigns and I the said David Sanders do warrant and defend from me and my heirs the aforesaid tract of land. In witness whereof I have here unto set my hand and seal the day and date first written. David Sanders. Signed sealed and delivered in presence of tests: Aaron Sanders, John Sanders. The Said David Sanders do promise to deliver to Obadiah Hooper the deed of gift that I have got from my father for the afore described tract of land Witness my hand and seal this 11th day of January 1809. David Sanders, Seal. Test: Aaron Sanders, John Sanders.

Georgia, Franklin County: This day Personally came Aaron Sanders & John Sanders and made oath that they saw the above deed of conveyance assigned by David Sanders and they were subscribing witnesses to the same. Sworn to and subscribed to before me this first day of February 1810. Aaron Sanders, John Sanders. Bryant J. P. Recorded this 11th December 1811."

In checking the deeds of Bedford County, Tenn. to determine David Sander's residence we find the following: (Film 476,352 Deed Book F Pages 392-395) "This indenture made this 25th day of December 1810 between David Sanders of the County of Bedford and State of Tennessee of the one Part and William Woods of the County of Giles and State aforesaid of the other part. Witnesseth that the said William Woods for and in consideration of the Sum of 165 dollars to him in hand paid by the said David Sanders the receipt Whereof is hereby acknowledged Hath given granted bargained sold alienated conveyed and conferred unto the Said David Sanders his heirs and assigns forever a Certain parcel or Tract of land lying in Bedford County on Rock Creek of Duck River Beginning on the East boundary line of a Survey in the name of David Ross for 1125 Acres at a black Oak Then South With Rosses line 52 poles to a Dogwood and White Oak then East 173 poles to a Hickory then North 116 poles to Two Dogwoods Then West 235 poles to a Black Haw on the East Boundary line of Rosses Survey Thence South to the Beginning To Have and to Hold The aforesaid 130 acres be the same more or less Said land with all the rights profits advantages appurtenances of in and to the same belonging on or any wise appertaining to the only proper use and behoof of him the said David Sanders his heirs and assigns forever and the said William Woods for himself his heirs executors and administrators doth covenant and agree to and with the said David Sanders his heirs and assigns that the before recited land and premises bargained He Will Warrant and forever defend against the right title interest or claim of all and every person or persons whatever. In Witness whereof the said William Woods hath hereunto set his hand and offered his seal the day and date above written. Signed Sealed and Delivered in presence of John Denny, William Dyserk, John Scott & Isaac Allred.

A second indenture reads:" This indenture made this 25th day of December 1810 Between David Sanders of the County of Bedford and State of Tennessee of the one part and William Woods of the County of Giles and State aforesaid of the other part. Witnesseth that the said William Woods for and in consideration of the Sum of 67 Dollars to him in hand Paid by the Said David Sanders the receipt whereof is acknowledged hath given granted bargained sold

David Sanders sells property to Agness Appleby (Film 476,351) Deeds of Bedford County, Tenn. Bk D Page 394-395) "This indenture made this thirtieth day of December in the year of our Lord one thousand eight hundred and twelve (1812) between David Sanders of the one part of the State of Tennessee and County of Bedford and Agness Appleby of Maury County and State aforesaid of the other part. Witnesseth that by and in consideration of the sum of fifty six dollars and fifty cents to him the said David Sanders in hand paid the receipt whereof is hereby acknowledged hath granted bargained and sold and by these presents doth grant bargain and sell all that tract or parcel of land lying and being in the County of Bedford and State aforesaid in the Second District on the waters of Rock Creek on the South Side of Duck River containing forty five acres beginning at a Cedar corner the South East corner of Said Sanders eighty five acre survey running thence East Sixty two poles to a Hickory corner thence north with John Dennys West Boundary line one hundred and 15 1/2 poles to two dogwoods thence west sixty five poles to an elm and dogwood thence South to the Beginning 115 1/2 poles including in all forty five acres with the hereditaments and appurtenances thereunto belonging to in any wise appertaining to the proper use benefit and behoof of Agness Appleby her heirs administrators and assigns forever against the said David Sanders his heirs executors and assigns and against the lawful claims of all and every person whatsoever and that if the said David Sanders shall warrant and defend the same in testimony whereof I have hereunto set my hand and affixed my seal this day and year first above written Signed and acknowledged in presence of Allen Leeper, James L. Ewing & David Appleby. //David Sanders/Seal The words (the same) entered in the 24th line before signed.

State of Tennessee, Bedford County September Sessions 1813 Thomas Moore Clerk of the Court of pleas and quarter sessions of the County of Bedford do certify that the execution of within deed from David Sanders to Agness Appleby was proven in open court by the oaths of Allen Leeper & David Appleby two of the subscribing witnesses thereto and ordered to be certified for Registration given under my hand at office this 25 day of September 1813. //Thos. More"

A fourth child of David Sanders & Mary Allred named Nancy was born about 1810. David Sanders enlisted in the West Tennessee Militia as a private in

Captain Andrew Patterson's Co. of Inf., 1 Reg't Tennessee Militia on 13 Nov 1814. He served 3 months 15 days and received \$28.28 pay. He died 25 Feb 1815 according to his military record. The following is found on page 178 of the book entitled "War of 1812 Soldiers of Maury County Tenn"(Lib. No. 976.859 M2g): "+David Sanders. Service not determined. Died at N. Orleans under Maj. Genl. Carrol Division in the Service of the United States against the Tories of Great Britain." "Entry found in Rock Creek Baptist Church Minutes, March 1815."

The introduction of this book contains the following statement: "Tennessee became known as 'The Volunteer State' during the War of 1812, and Maury County's contribution might be considered typical of the time. Ten companies were formed in the county which in 1812 had 1,864 free white males(1005 voters) - and this book contains the names of 1,335 soldiers and patriots from the county, 58 of whom died or were killed in service. Two men from Maury County were among the seven killed at the Battle of New Orleans on 8 Jan 1815."

An abstract of the proceedings of the Rock Creek Church are found in a book entitled "The Maury Genealogist Vol. I." It begins: "Whereas the Baptist Church on Leper's Fork of West Harpeth on the Saturday before the third Lord's day in February 1810 did appoint John Record, Sion Record & Joshua Caudle to sit as an arm of that Church to receive members at the house of Hugh Smiley's on West Rock Creek... and from time to time said church met until considered strong enough for a constitution...and was constituted on the Saturday preceding the 2nd Lord's day in August 1814. The number of members at present in fellowship at the end of 1814 were 84."

Another reference which helps identify it's location appears in March 1815: "The arm at Cedar Creek petitions the body to receive them and resolve their holding church in that place..." Also in the March 1815 proceedings are the following: "Resolved that we call our meeting house Shiloh." "Brother John Jennings sickened and died at N. Orleans in Maj. Genl. Carroll's Division in 1815." "Brothers Michael Sholfer and David Sanders died at N. Orleans under Maj. Genl. Carrol Division in the Service of the United States against the Tories of Great Britain."

The Nashville, Tenn. Archives (Film 436 C3644) "Military and Political Career of William Carroll" by Cora Norton Henderson 1930, details the New Orleans conflict. "The summer of 1814 Andrew Jackson received appointment of Major General in the U. S. Army. A little later he was ordered to the Gulf Coast to defend it against the British. He went first to Pensacola and Mobile and later when he convinced the attack would be made at New Orleans he hurried to that point arriving Dec 1, 1814.

In the meantime William Carroll had been granted Major General to succeed Jackson in the command of the Second Division of the Tennessee Militia. This was about the middle of October 1814.

Before leaving for New Orleans, Gen Jackson ordered Gen. Carroll to assemble the Second Division and come via the Mississippi River to his aid as soon as possible. Carroll immediately issued the call to his command, and on the appointed day, Nov 18, 2500 yeomanry of the State appeared in Nashville. They worked steadily for eight days building the necessary flatboats. By the time these were finished the unprecedented early November rains brought a flood, which enabled them to cut cable and swing out in the Cumberland for the voyage to New Orleans sooner than they expected. Gen. Carroll and his Tennesseans left Nashville 27 Nov 1814. This was a splendid group of men, but the majority of them were without experience and discipline. About 800 had rifles and were veterans of the Creek War. Some were poorly armed. while the rest had no arms at all. Secretary Monroe had ordered the commandant at Fort Lafayette near Pittsburg, to send a supply of Arms and munitions to New Orleans immediately and one of these boats traveling faster than the others

overtook Carroll's fleet. Carroll wrote from Natchez, asking Johnson's permission to supply his men with arms from it. He took the responsibility later of "impressing" 1,100 stands to make up the deficiency in his command.

Carroll, desirous that his men be ready for action upon arrival, seized every opportunity for their improvement & whenever he was compelled to stop on account of adverse winds he used the time for instructing & drilling his men & often the decks of the boats formed a field for maneuvers so that by the end of their journey they were not so raw as they would have been had it not been for his foresight.

Carroll, realizing Jackson's precarious situation at New Orleans sent his aide de camp, Col. Hynes to notify the General he would reach him at the earliest moment possible, but that his progress was being retarded by winds.

Gen. Jackson dispatched a steamboat up to speed their arrival. On the 21 Dec. Gen. Carroll went into camp 4 miles above New Orleans with Gen. Coffee, and after reporting to the commanding general, he had his officers busily engaging in drilling, maneuvering and organizing the troops in order to be ready for action on a moments notice.

Eaton says, 'to the industry of Gen Carroll in hastening these arrangements; and to his fortunate arrival is greatly to be attributed the reason that success did not result to the enemy in his first assault, or that Louisiana escaped the impending danger,' and Parton states that Carroll's quick actions may almost be said to have saved New Orleans.

When Jackson learned that the British had landed and were encamped nine miles below the city, he announced that the enemy would not 'sleep on our soil,' and ordered Generals Carroll and Coffee to join him at once. Hearing the British were attempting a ruse to draw the Americans to the point below New Orleans, while the main body of the enemy would attack the city through Chef Menteur, the commander-in-chief stationed Gen. Carroll and his Tennesseans, with the Louisiana Militia, on the Chef Menteur or Gentilly Road to guard and defend the city, while he marched with a force to meet the enemy and attack him in his first position.

After a successful night attack on the 23rd Dec., Jackson believed that by renewing the attack at dawn the next day he could capture the British, and sent a dispatch for Carroll to join him, in case there had been no sign of the enemy in that quarter. Carroll lost no time in obeying these orders, but circumstances caused the General to forgo any further offensive efforts. He fell back to a more protective situation the Roderinguez Canal, 2 mi. nearer the city to await the enemy.

In forming the line of defense at New Orleans Carroll's Division; supported by the Kentucky Militia under Gen. Adair; was placed in the center. The evening before the memorable 8 Jan 1815 a deserter informed the enemy that the weakest point in the American line lay in the center, being defended only by militiamen.

As a result of this information, Gen. Packenham led his strongest column against that part of the fortification held by Gen. Carroll's command. On account of a heavy fog the advancing army was within a few hundred yards of the American lines before it was discovered. However, Gen. Carroll had ordered his troops to reserve their fire until the enemy was near enough to present a sure mark. The men kept one eye on their chief and one on the advancing column. Carroll coolly waited until the enemy were within 200 yards before he gave the command to 'fire.' Then the flash went forth that sent hundreds to their death.

The British had advanced with all confidence, but the incessant and deadly fire had thrown their ranks into such confusion that they fell back. Gen. Packenham rallied them and renewed their assault. Again the leadened hail drove them back. A third daring charge was made but the same fate awaited them. The result was a decisive victory for the Americans.

During an interval of quiet, Gen Jackson heartily extolled the firing of the command under General Carroll, and in his official report, when speaking of the courage and skill of his men, he said: 'Twice the columns which approached me on my left were repulsed by the troops of General Carroll, those of General Coffee, and the division of Kentucky Militia and twice they formed again and received the assault. At last, cut to pieces they fled in confusion in the field.'

Gen Carroll later became Governor of Tennessee.

Moses Martin Sanders gave his father's death date as 11 Jan 1815 while his military record in the National Archives states his death as 25 Jan 1815. State of Tennessee, Bedford County, Court: April sessions 1815. "Whereas it appears to this court that David Sanders is dead, having no will or testament, and application being made by Mary Sanders and James Allred to have letters of administration granted to them on the estate of the said David Sanders deceased, having given bond and security as by law in such case is required, whereupon the court orders that they have letters accordingly; these are therefore to authorize and empower you the said Mary Sanders & James Allred to enter into and upon all and singular the goods and chattles, rights and credits, of the said David Sanders deceased, and the same into your possession take wheresoever to be found, in this state; and a true and perfect inventory thereof make and return into our ensuing county court, on oath, and all the just debts, of the intestate, to pay, so far as the said estate will amount or extend; and the residue deliver to those who have a right thereto by law, herein fail not; Witness, Thomas Moore, clerk of said county court, at office the fourth Monday in April A.D. 1815 and 39th year of American Independence. Thomas Moore."

David Sanders' youngest son, David James, was born 14 Jun 1815. A book written about the old cemeteries of Marshall County, Tenn., describes the "Old Shilo Cemetery" as being four miles west of Lewisburg, on left of Old Columbia Road ...Site of Old Shilo Baptist Church - - dead end road. There are 50 unmarked graves here (crude native stone) and two pyramids with the lettering gone. This notation was made 5 Sep 1958. A map of the Lewisburg Quadrant mapped and edited by the Tennessee Valley Authority and published by the Geological Survey shows the site of the old Shiloh Baptist Church. Lewisburg is located on the Big Rock Creek and there is a fork to the east called the East Rock Creek. The designation of the property of David Sanders as contained in the indentures of sale by his heirs indicate their property is between the Rock Creeks. About two miles south of Lewisburg is a Sanders Creek which joins the Big Rock Creek and is likely the location of the Sanders property. Big Rock Creek was near the dividing line between Maury and Bedford Counties so their home was in Bedford and the church in Maury. The entire area is now in Marshall County.

Headwaters of Spring Creek are near the old Shiloh or Rock Creek Baptist Church and it flows to the northwest where it joins Fountain Creek which flows into Duck River. Spring Creek appears to be only about eight or nine miles long and it would appear from a map of Maury County that about six or seven miles of its length are in that County. This evidence indicates the David Sanders and Richard Fausett residences were probably no more than about five miles apart and both are now in Marshall County which is about ten miles wide.

Reading further in the minutes of the Rock Creek Baptist Church following the death of David Sanders, we find: Apr 1817 Report that Sister Sanders is in disorder, Tho. P. Green and Zedoc Aydelott shall cite her to attend next meeting. May 1817 'With regard to Sister M. Wright, Brother Aydelott reported that he and Brother Green visited her and she came according to the request of the church. The reports against Sister Wright (Sanders had been marked out) were that she was married to a man that had another wife, also



that she gave her Father abuseful language. Sister Wright gave the church satisfaction and denying the reports. Resolved that the church clerk henceforth record the marriages of females of this church that change their names, also that he record the marriages of Sisters Sanders, Christian Caudle and Rebecca Whalton. Sister Christian Caudel was married unto William Turner and Rebecca Whalton to Durham Collins and Sister Sanders to Willis Wright. June 1817 Sion Record informed the church that certain papers had come to hand that certified that Willis Wright the man that was married to Sister Sanders was married to another woman. June 1817 (possibly should be July, but June given) Sion Record reported that he got a copy of a paper which proved that Willis Wright was married to a certain Elizabeth Jones, and there is not testimony produced whether Mrs. Wright is dead or a living. Sept 1817 - Mary Wright is not in order and she is excluded from the fellowship of this church. No further reference is made to either Sanders or Wright. The Sanders Family completed temple work in St George for Willis & Harry Wright. Mary Allred Sanders died 19 May 1820 according to her son Moses Martin Sanders.

The Maury County Tennessee Marriage Records 1807-1837 Vol 1 (Call No. 976.959 V28a) include: Moses M. Sanders to Amanda Fossett. License issued 5 Jan 1826. Solemnized 12 Jan 1826 by James Baldrige. Hiram Davidson to Sally Saunders 17 Apr 1826. Solemnized 19 Apr 1826 by Mathew Moore Justice of Peace.

Moses Martin Sanders moved to Montgomery County, Ill. sometime between 18 Feb 1829 when he sells his property in Bedford County and 2 Nov when his sister Sarah sells her property. The 1830 census for Montgomery Co., Ill. lists a male between the ages of 10-15 living with Moses Martin Sanders indicating the youngest son, David, may be living with him.

Appleby and H.V. Turners and others with the hereditaments and appurtenances thereunto belonging or in any wise appertaining to the proper use benefit and behoof of the said Hamilton V. Turner his heirs administrators and assigns for ever against the said Wm H Sanders his heirs administrators and assigns and against the lawful claim or claims of all and every person or persons whatsoever and the said Wm H. Sanders shall warrant forever defend the same to the said H V Turner his heirs or assigns forever In testimony whereof I have hereunto set my hand and affixed my seal the day and year first above written. William H. (Hambleton) Sanders married Elizabeth M. Hooper about 1826 and their first child, Richard H. Sanders was born 13 Oct 1827. A second child, David M. Sanders was born 15 Aug 1829. Following the sale of his inheritance, William H. Sanders moved to Tipton County, Tennessee where he appears on the 1830 census (Film 024,539) as a male 20-30, with 2 males under 5 and 2 females 15-20. He later moves to Texas where he dies 11 May 1836.

In testimony whereof we have hereunto set our

hands & affixed our seals this day and year first above written Signed Sealed & acknowledged in presence of us. David Appleby, Jurat Hiram Davison, his mark David C. Creswell Jurat Sally Davison, her mark.

State of Tennessee Bedford County Court: November Session 1829. I certify that the execution of the foregoing deed of conveyance from Hiram Davison & his wife Sally to Hamilton V Turner, was proven in open court by the oaths of David Appleby & David C. Cresswell the subscribing witnesses thereto as to the said Hiram Davidson whereupon the said Sally Davidson wife of said Hiram was examined separated & apart from her said husband touching her free will of consent in executing the same who thereupon acknowledged that she signed sealed & executed the same truly & voluntarily without fear, coercion or constraint of her Sd. husband whereupon this court ordered the same to be so certified for Registration. Given under my hand at office the 7th Novr. 1829. Registered 7th day of November 1829, Thomas Davis Regis. Bedford County.

No record has been located where Nancy Sanders sells her one fifth interest in her father's estate. The 1850 census for Montgomery County, Ill. (Film 1001633) lists Robert Clark 55 farmer born Kentucky, Nancy 40 born Tenn.; and children John 16, David 13, James 10, William 8, & Ansyline 7 all born Ill. The 1860 census for the same county (Film 446,701 page 230) Nancy Clark 51, farmer born Tenn.; William Myers 18 farm laborer born Ill; Nancy J. Clark 10 born Ill.; & Lurance 8 b. Ill. Further research will be required to determine if this is the correct Nancy Sanders.

The Bedford County Tennessee Deed Book T pg 388 contains John Orr's deed to land given to him by David Sanders and recorded March 20th 1861: "Know all men by these presents that I David Saunders of the County of Shelby and State of Missouri of the sum of eighty dollars to me in hand paid by John Orr of the County of Bedford and State of Tennessee the receipt whereof is hereby acknowledged do hereby grant bargain and sell to the said John Orr his heirs and assigns to his and their use and behoof for ever and I do covenant with the said John Orr his heirs and assigns that I am lawfully seized in fee of the premises that they are free of encumbrances and that I will warrant and will defend the same to the said John Orr his heirs and assigns forever against the lawful claims of and demands of all others In witness whereof I have hereunto set my hand and seal this 10th day July 1836 David J. Sanders, Seal." This is the year David turned 21 years of age and became legally eligible to make the sale. This is followed by an affidavit: "State of Missouri, County of Shelby, I James Foley presiding justice of the county within and for the county aforesaid do certify that on the 11th day of July 1836 before come David J Sanders being personally known to me to be the person whose name is signed to the foregoing deed and acknowledged the same to be his act and deed for the purposes therein mentioned. In testimony whereof I have hereunto set my hand the day and date aforesaid. James Foley P. J. Ct." Another document follows: "State of Missouri, County of Shelby, I Thoms J Bonds, Clerk of the circuit court within and for the County of Shelby do certify that James Foley the person that signed the foregoing certificate of acknowledgement is duly commissioned and qualified and is now acting as presiding Justice of the county court within and for said County of Shelby and State aforesaid. In testimony whereof I have hereunto set my hand and affixed my private seal (there being no official seal yet provided) done at office at Oakdale this 11th day of July in the year of our Lord Eighteen Hundred and Thirty Six. Thomas J. Bonds C Crk." Filed in my office on the 11th day of February 1861 1 o'clock P. M. W. N. Cowden (Bedford Clerk) The 1840 census for Shelby County, Mo. (Film 014858) lists David J. Saunders 1 male under 5; 1 male 20-30; 1 female 20-30, engaged in agriculture. The 1850 census for Schuyler County, Mo (Film 443,627) taken 2 Sep 1850 Page 93, 91st district, David J. Saunders 34, farmer, real estate valued at 300, born

Tenn.; Alcey Saunders 31, born Ohio; Mary A. 9, born Missouri.

Schuyler County is about 10-20 miles from Shelby Co. The 1860 census taken 27 Jun 1860 for Schuyler Co., Mo. (Film 803,646) Page 73 Independence Township, Postoffice: Lancaster, Mo.: David J. Sanders 44, farmer, real estate 600 personal 500, born Tennessee; Elsey Sanders 42, born Ohio. The 1870 census (Film 552303) Schuyler Co. Mo. page 339 printed Independence Township, Lancaster, Mo. Post Office, David J. Sanders 55 born Tenn. & Elsia Sanders 51 born Ohio. The 1880 Soundex of Missouri, Schuyler Co. lists Nathan L. Gier who at that time had married May Matilda Sanders and living with them is his smother in law Essy Sanders 61, born Ohio.

#### MARY ALLRED

Mary Allred and David Sanders were married sometime prior to the birth of Moses Martin Sanders 17 Aug 1803. They apparently met while their families were living in Pendleton, South Carolina, before moving to Georgia where Moses Martin was born.

Mary was the daughter of William Allred and Elizabeth Thrasher, who were the parents of 8 children:

1. Sarah - md John Anderson Ivie. They remained in Bedford County, Tenn and had 9 children. A son, James Russell Ivie md Eliza McKee Fausett, Amanda's sister and a daughter Elizabeth md William Hackley Allred, son of Sarah's brother James.

2. Mary Allred - md David Sanders

3. James - md Elizabeth Warren 14 Nov 1803. Joined LDS Church 10 Sep 1832. Went with Zions Camp, was member of High Council, acting Bishop at Council Point. Came to Utah in 1851, settled at Manti and later Spring City, Sanpete County. He had 12 children. He died 10 days before his 92<sup>nd</sup> birthday in 1876 and at that time had 12 children, 104 grandchildren 302 great grandchildren & 29 great, great grandchildren.

4. Elizabeth - no more is known.

5. Isaac - md Mary Calvert 14 Feb 1811 & had 13 children. Married Matilda Stewart 5 Nov 1852 and they had one child. He died 13 Nov 1876 at Spring City, Sanpete County.

6. William - md Sarah Warren 10 Mar 1813. Parents of 11 children before his death in Pike County, Ill. 28 Jul 1841.

7. John Allred - md Nancy Warren 6 Aug 1816

8. Martha - married an Ivie.

Nothing is known concerning Elizabeth Thrasher & her name is known only by way of temple work.

Thomas Allred was Mary's father & his wife was Elizabeth Twigg. William & Elizabeth lived in Randolph Co., North Carolina where 10 children were born.

1. James Allred - 10 children in 1800 census for Randolph Co., No. Carolina.

2. William Allred - Mary's father.

3. Elias - born 6 May 1758. Died about 1840 age 82. 9 children 1800 census.

4. John - md Ruth. Died before 1841 when baptism was completed in Nauvoo, Ill. Three John Allreds in 1800 census for Randolph Co.

5. Rachel Allred - md Robert Brown, deceased before 1841

6. Moses Allred - md Elizabeth Hollingworth

7. Eli Allred - is in 1800 census but no children

8. Elizabeth Allred - md a Jones.

9. Thomas Allred Jun - md Margaret Alldredge

10. Levi Allred - between 26 and 45 in 1810 census.

Archibald Bennett completed research for the Allred Family, which is published in a book entitled "The Allred Family in America." This publication indicates Mary Allred's grandfather was a son of a John Allred or Aldridge who was born in Wicomico, Numb. Co. Va. This John is a son of William Aldridge of Wicomico who has two wives: Sarah & Alice. William Aldridge is

the son of Clement Aldridge who was christened 25 Sep 1636 at Worstead, Norfolk, England & his wife Elizabeth Tills. Clement Aldridge is a son of John Aldred (or Aldrich) of Worstead. John Aldred is the son of Rev. Henry Aldred and wife Elizabeth of Worstead, Norfolk, England. The author has not verified this work.

After Mary's husband, David Sanders, was killed New Orleans, she married Willis Wright. Nothing further is known about Willis after Mary's death in 1820. Moses Martin Sanders was baptized for Willis Wright & Harry Wright in the St George Temple 6 Aug 1878- where they are listed as "friends."

NANCY SANDERS

Nancy Sanders is identified by Moses Martin Sanders in the vicarious ordinances performed in both Nauvoo and St George.

She is presumed deceased at the time of her father's will and testament when he wills one dollar to her husband, Richard Maulden. No offspring are mentioned in the will. Richard

Maulden was present when the Grove Level Baptist Church was constituted in 1802 and he bought property adjoining Moses Sanders 23 May 1803. Film 361,854 page 43 Will of Richard Malden:

"in the name of God Amen, I Richard Maldin planter of the County of Franklin and State of Georgia being weak in body by reason of affliction, but of sound and disposing mind and memory, and understanding (Thanks be to God for the same) do make this my last will and testament, in manner and form following: That is to say, I order my executors herein after named to pay all my just debts First I will and give and bequeath unto my beloved wife Elizabeth Maldin all my estate both real and personal consisting of the tract of land wherein I now live, and the tract or parcel of land whereon my son Egis Malden now lives, also the following personal property that is to say two negroes named Pat and Johan, and also all my personal property consisting of goods and chattels, household and kitchen furniture stock and implements of husbandry to be at the disposal of my beloved wife aforesaid during her natural life, or widowhood, and after her decease, I will and desire that all the estate both real and personal be equally divided amongst all my children, after the younger children are made equal with the Elder, then for the remainder whatever it may be, to be equally divided among them all. Lastly I do hereby nominate, constitute and appoint Egis Malden & John Henderson Executors of this my last will and testament, and I do hereby make void all other wills by me heretofore made, and do declare this to be my last will and testament. In witness whereof I have hereunto set my hand and affixed my seal this 22nd day of July in the year of our Lord 1833."
