



Dear Streeter Descendants:

The Streeter Family Association is an international non-profit all-volunteer organization for anyone who descends from any Streeter family. We are not affiliated in any way with any commercial enterprise. Our primary focus is collecting and sharing genealogical information for all Streeter families. Here is the mission statement from our constitution and by-laws:

The object of this association shall be to promote among the members of the association a mutual interest in the surname from the time of its origins up to the present, with a view to obtain items of interest in connection with the surname and to furnish, provide, and classify such facts pertaining to the surname and its history as will be of interest in genealogical investigations.

Award-winning author and master bookbinder, William W. Streeter of Northampton, Massachusetts, USA, founded the association in June 1984. In June 2019, The Streeter Family Association celebrated the 35th anniversary of its founding! In recognition of this milestone, we would like to share more information with you about the association and its accomplishments. As you read the following, we ask you to please consider joining The Streeter Family Association.

THE ORIGINS OF THE STREETER SURNAME

The name, Streeter, is of English origin and designates one who lives near an ancient roman road or on the main street of a village; it is almost exclusively unique to Sussex. It is a variation of street, which comes from the Old English *stroet* for roman road which comes from the Latin *strata*, from the past participle of *sternere*, to strew, cover, surface. Other variations include Strete, Streete, Streets, Streater, and Streat, as well as Streater (Patricia Hanks and Flavia Hodges, *A Dictionary of Surnames*, [Oxford University Press, Oxford, 1988]).

Thus, with few exceptions, all Streeters can trace their origins to Anglo-Saxon or Norman forebears in Southeast England. However, multiple English Streeter families adopted Streeter as their surname so not all Streeters are related. Exceptions include Streeters whose ancestors adopted the surname as an Anglicization of a non-English synonym surname, such as the German surname, Streider. In the United States, there are also African-American Streeter families who acquired the Streeter surname during slave-holding times. All are welcome in The Streeter Family Association!

KNOWN STREETER IMMIGRANTS TO NORTH AMERICA

The majority of North American Streeters descend from early colonists Stephen and Ursula (Adams) Streeter of Kent, England and Gloucester, Massachusetts. However, there have been other Streeter immigrants to North America over the centuries. Members of The Streeter Family Association are actively researching the ancestors and descendants of the immigrants listed below. Association members are extremely fortunate to have the personal research assistance of Director and Genealogist, Lola Barrett. Lola resides near Salt Lake City, Utah and has provided a tremendous amount of assistance to countless Streeter researchers by accessing the incomparable collections of The Family History Library of the The Church of Latter-day Saints (The Mormons) on their behalf.

 - Thousands of messages have been posted since the list's inception in 1997.
- **Y-Chromosome STREETER Surname DNA Project.** The goals of this project include:
 - Identifying how many distinct Streeeter families originated in Southeast England, particularly in the counties of Sussex, Surrey and Kent.
 - Enabling living Streeeters around the world to identify their family of origin by comparing the DNA test results of those with unknown lineages to those with well-documented lines of descent.
 - Determining whether or not any of the English Streeeter emigrants to a given country were related to each other or not.
 - Over 20 participants have joined the project since its inception in 2003.
