Source: Maryland Prerogative Court, Testamentary Proceedings, Vol. 23, p. 86. Comment: One of the sureties for a widow's administration of her husband's estate was usually a relative of the widow. Was Mary a Fenwick or a Miller? On the other hand, if Patrick and Mary came into Charles Co. as a married couple, she might not have had relatives locally. Jan. 22, 1716/7 - The Charles Co., Md. Inventory of Patrick Mowland [sic.] Appraisers: John Dent, Samuel Turner (value 57/19/7.) Next of kin: "none." Source: Skinner, V. L., Jr., "Abstracts of the Inventories and Accounts of the Prerogative Court of Maryland, 1715-1718," p. 41. Comment: The absence of any kin signing the inventory suggests that Patrick may have had no relatives in the area. This, in turn, suggests that Patrick may have come into Charles Co. as an adult. Most frequently, adult children will sign the inventory of their father as kin. In this case, however, Patrick's children were still minors (see below) so they could not sign the inventory. A Jacob Moreland is found in Southern Maryland at the same time as Patrick. To date, no evidence has been found that they were related although they may have been. May 1717 - The Charles Co., Md. administration account of Ralph Lomax shows that Lomax's estate had received a payment from Patrick Moreland. Source: Skinner, V. Dec. 11, 1717 - The Charles Co., Md. Administration Account of Patrick Moreland. Inventory value: 57/19/7. Payments made by the estate: 19/5/7. Mentions: orphans (unnamed.) Administratrix Mary Magraugh/Magrah, wife of John Magraugh/Magrah.

Comment: This record shows that Patrick Moreland's widow Mary had m. John Magrah by Dec. 1717. Although his name is usually spelled "Magrah," this may be the name we think of today as "McGraw." Patrick's estate made payments to William Chapman, Mr. Robert Hanson, Mr. Charles Yates, Mr. Richard Edelin, and Peter Harris on account of Thomas Truman Greenfield.

June 1719 - Charles Co., Md. Land Records. We, John Magrah and George Dement, of Charles Co., planters, bind ourselves, jointly and severally, unto John Moreland, Philip Moreland, Mary Moreland, Patrick Moreland, William Moreland and Jacob Moreland [hereinafter called "Moreland children"] in the sum of 104/3/2 current money of this Province. There remains due to the above named [Moreland children] 52 pounds, one shilling and 7 pence current money of this Province, being their portion of the balance of their deceased father Patrick Moreland's estate in the hands of ye above bounden John Magrah. The condition of this obligation is such that if ye abovesaid John Magrah shall well and truly pay unto the said [Moreland children] or their guardians when thereunto required their parts of the said sum of 52/1/7 currency, then this obligation to be void and of no effect, else to remain and be in full force and virtue. Signed John Magrah (makes his mark), George Dement (makes his mark.)

Comment: When a list of children intersperses the girls among the boys, as here (as opposed to listing the boys first and then the girls), it usually means that the children are being listed in their birth order. In the case of the Moreland children, nothing contradicts this interpretation except for a record stating that son William was age 50 in Feb. 1768. If William's age is given correctly, he was born posthumously and the children are not listed in their birth order in this June 1719 record. Alternatively, William's age was misstated in Feb. 1768 and he was older than 50 at that time.

The mention of guardians in this record is because, as

long as the children were minors, they could not receive their shares of their father's estate without a guardian having been appointed for them.

George Dement is the surety for Magrah's performance of his obligation, and is liable in the same amount as Magrah if he does not do so.

May 31, 1729 - Maryland Prerogative Court. The following proceedings were exhibited from Charles Co., Md. George Dement, his will and testamentary bond in common form by William Dement his executor with Edward Davis, Jr. and John Magrah his sureties in 150 pounds sterling, dated May 31, 1729.

One of the kin who signed George Dement's inventory was John Hunt. Patrick Moreland's son William Moreland m. a dau. of Thomas Hunt.

Feb. 1737/8 - William Middleton and John Magrah are sureties for the Charles Co., Md. administration of the estate of Joseph Gardiner by Mary Keech, wife of James Keech.

At the June 1743 Court Middleton obtained a judgment against Joseph Estep in the amount of 6/8/2, and a writ of attachment was issued directing the Sheriff to attach the property of Joseph Estep wherever found in order to satisfy the judgment. In July 1743 the Sheriff, in the presence of Jacob Moreland and Thomas Hunt, attached property of Joseph Estep's in the hands of Philomon Estep sufficient to cover the judgment.

Also, "I have received 2 Shillings and 9 pence for Rents to Micha's [Michaelmas] last on 3 acres Short Charged on Debt Book. Patent may therefore issue with his Excellency's approbation." Signed Dec. 2, 1766 by Edward Lloyd. Approved by H. Sharp. Source: Carol Molen.

July 24, 1744 - "Jacobs Birth Right," containing 113 acres in Charles Co., Md. Composed of the 2 following tracts: "Preston," 61 acres; "The Wilderness," 51 acres. Resurveyed for and escheated by Jacob Moreland July 24, 1744. Beginning at a bounded hickory standing by the original beginning of the "Wilderness." Patented Dec. 2, 1766.

Signed Jacob Moreland. Catherine, wife to said Jacob Moreland, relinquished her right of dower.

My said securities may sell the above at public sale if Hanson puts the bond in suit, and not in less than 1 month after said bond is put in suit. Signed George Adams. [not signed by the other parties]



Introduction.

There is some thought that 6. Jacob Moreland is the Jacob Moreland who is found in Fairfax Co., Va., beginning in 1769. Further evidence on this point is needed. Fairfax Co., Va. is directly across the Potomac River from Prince George's Co., Md. and Washington, D.C.

1753-4 - The Charles Co., Md. Debt Books of 1753 and 1754 show Jacob Moreland as the owner of: --"Preston," 60 acres --"Wilderness," 50 acres

RELIGIOUS AFFILIATION: Protestant. OCCUPATIONAL PROFILE: merchant. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, St. Mary's County, 1697/98-1700. LOCAL OFFICE: justice, St. Mary's County, 1696-at least in 1705. MILITARY SERVICE: captain, 1698; lieutenant colonel, by 1701. WEALTH DURING LIFETIME. PERSONAL PROPERTY: owned a sloop, 1698."

a bill of exchange to Mr. Strangways Mud, merchant in London, directing him to pay Jacob Moreland 5 pounds sterling, and Wheeler assumed upon himself the obligation to pay Jacob if Mr. Strangways Mud did not do so. The bill was presented to Mud in London in Oct. 1695 and he refused to pay it. In 1696 Jacob brought suit against Wheeler in the Charles Co. Court. At the Nov. 1696 Court the parties acknowledged that the case had been settled.

Mar. 1696/7 - Charles Co., Md. Court. Jacob Moreland vs. James Bigger, of Charles Co., Gent. Moreland alleged that as of Aug. 29, 1696, at Portobacco. Bigger owed him 2078 lbs. of tobacco, being the balance due on Bigger's account, which was produced in Court. The account showed that Bigger owed Moreland for various items purchased from him during the period 1694-1696, and for a credit Moreland had extended to John Murth on Bigger's behalf. The items purchased were a variety of drygood, brandy, a bushel of malt, sugar, gunpowder and 4 jews harps. At the Mar. 1696/7 Court, Bigger's attorney stated that his client had provided him with no defense to the complaint. The Court then awarded Jacob the 2078 lbs. of tobacco, plus costs.

Edenfield's attorney appears [although there is still no indication that Edenfield has been found within the Court's jurisdiction] and requests that Edenfield's writing be read. This is done, the writing stating that Edenfield obligates himself to pay Jacob Moreland [no reference to a Company] 2270 lbs. of tobacco [one half the amount sued for] convenient in Patuxent River by Oct. 10th next. The Court then orders that one of the coroners [not the Sheriff] attach Edenfield's property in the hands of Capt. John Bayne, High Sheriff of Charles Co., to the value of <u>5500</u> lbs. of tobacco.

At the Nov. 1699 Court, Benjamin Hall, coroner, states that he has attached in Bayne's hands the sum of 2918 lbs. of tobacco. Moreland and Company request that the property be condemned to their use, and the Court orders that this be done. At this point, John Bayne demands an appeal from the Court's judgment to the Provincial Court of Maryland.
