PART SECOND.

BIOGRAPHICAL SKETCHES AND FAMILY RECORDS.

THE records and personal sketches which follow in this volume are the collected labors of hundreds of persons. There was very little available for this department of the History of Barnet when I began the work of its preparation. There has never been a resident of the town who gave, as the late Edward Miller gave to Ryegate, days, and months and years to the collecting of the annals of its people. A few sketches of the older Scotch families prepared many years ago by George Mason, and preserved from destruction by Mr. Miller, contained much which otherwise had been forgotten. In the case of a few families, some one of an early generation has rendered service to his descendants by having the names and dates of birth of his children recorded on the town books. It is only within sixty years that the registration of births, marriages and deaths has been required by law.

Consequently many persons and families once prominent in this town have no local memorial or living representative. This work will preserve the memory and deeds of hundreds of residents who would otherwise be forgotten. It has been my first purpose to collect the annals of the pioneers, those who came here more than a century ago, and their descendants. Barnet is one of the few towns in the State in which settlement began before the Revolutionary War. and these records cover a century and a half.

The collection and arrangement of some of these records was the labor of love with some representative of each family. In the case of others I have compiled the data offered by members of separate branches. With others their preparation has cost much research in quest of widely scattered members, branches of older families not known to each other, but whose younger members were glad to know their ancestry and living relatives.

There were other families of whom all that could be gathered was so meager that I have had to find missing names and dates from any source that I could. I have examined the records of several towns, the memories of aged people have been taxed, cemeteries have been visited, town and family histories consulted, and I have added hundreds of dates and names where they could be gathered from authentic sources.

I have written numberless letters of inquiry, and the few which were never answered probably never reached those for whom they were intended. The response has been most gratifying.

This volume will not only preserve the names of the noble men and women who have lived in Barnet, but will help to solve the problems of relationship which inter-marriage among families in long settled communities always produces.

A WORD FROM THE COMMITTEE

HE Barnet History just grew up of its own accord. The Secretary of the "committee" found the Ryegate History helpful in his McIndoes parish, and came to feel that it would be a bit of great good fortune for the town of Barnet to have its story told by the gifted author of the Newbury and Ryegate books. He talked with Mr. Wells about it in March, 1917. He talked with many Barnet people. John G. Roy spoke the first encouraging word. Presently Horace Warden and Walter Johnson joined in the conversations.

While we were wondering how to interest others in different parts of the town, Mr. Wells was turning to other work. To save Barnet's opportunity, this small self-appointed committee made a personal contract with him August 13, 1918. A suggestion that the town share in the undertaking was discussed in town-meeting in March, 1919-and not accepted. Realizing the priceless value of the material brought to light by Mr. Wells in seven months, the committee went ahead on their own responsibility-still planning to enlarge their numbers. They signed the printing contract October 9, 1919-and kept on paying bills and giving more and more time to the work, until now-at the end of 1922-the book is nearing completion in their hands.

The words of the book were left to Mr. Wells. At his request we did what we could with the pictures. All parts of the town were asked repeatedly to cooperate—a final message going to every family last August. All contributions have been used. We are indebted to Arthur Bliss Seymour of Harvard University for the camera with which many of the photographs were made; to the following for samples of their work: Katherine Bingham of St. Johnsbury, Ernest F. Skinner of Passumpsic, Mrs. Lizzie Kendall of East Barnet, Mrs. E. B. Chase of Barnet Village, Miss Lucy Buffum of McIndoes and Lyman E. Field of Worcester; to the Connecticut Valley Lumber Company for the lot map; to Miss Edith Wallace for various suggestions; to many persons for the loan of family portraits, and above all to the illustrator, Charles F. Lester (the Secretary's room-mate at Yale) for many long hours of work over the 140 photographs in his studio at 11 East 14th Street, New York City.

The book has been delayed beyond many promises—growing better all the time. It is not perfect yet. Such books never can be. But the committee is glad for what has been done. They are sure it will be of real service to the town, in making the seven parishes better acquainted with each other, with Barnet men and women of former days and other places and with their cousins in England and Scotland.

The committee takes keen pleasure in presenting the Barnet History to the people of Barnet at home and abroad.

INTRODUCTION

HIS work completes the story of two colonies from Scotland which began settlement in adjoining towns in Vermont just before the outbreak of the Revolutionary War.

There is no reason to suppose that there was any previous acquaintance between the people of Renfrew and Lanarkshires who settled Ryegate, and those of Perth and Stirling who settled in Barnet. Communication between different parts of Scotland, a century and a half ago, was slow and uncertain. People who lived thirty miles apart were widely separated. Ryegate was chosen by the influence of Rev. Dr. Witherspoon, President of Princeton College, afterwards one of the signers of the Declaration of Independence, and Barnet was chosen for settlement because of its proximity to land which people from Scotland had begun to settle a year before. The letters of James Whitelaw show that if the war had not come on when it did, other companies from Scotland would have purchased lands and settled in the immediate vicinity. But the war changed all this, and Ryegate and Barnet, considered as one community, remain the only one in Vermont settled by a body of people from beyond the Atlantic. A curious circumstance is noted, that the brig "Molly," Capt. Thomas Cochran, Master, which left Greenock on the 25th of March, 1773, with James Whitelaw and David Allan, for New York, was the same vessel which, on the 19th of May in the next year, left that port for Philadelphia with Alexander Harvey and John Clark as passengers.

The materials for this work were less abundant than for the History of Ryegate. The business papers and correspondence of General James Whitelaw, carefully preserved by his family, guide us safely through the early years of that town, and have afforded much aid in narrating the carly annals of Barnet. But, with the exceptions of the journal of Colonel Harvey, and the fragments that remain of that of Samuel Stevens, very little has come down to us regarding the work of the early settlers of this town until after the war. The loss of the early town records deprives us of much that nothing else can supply, and we are obliged to look elsewhere for our information regarding the small part which Barnet had in the Revolutionary War. The Bedel Papers, and the Hibbard Collection, owned by the New Hampshire Historical Society, some papers preserved at Montpelier, and the valuable Bayley and Johnson papers owned by the Tenney Memorial Library of Newbury are our authorities for the events of that period.

About sixty years ago Rev. Thomas Goodwillie prepared an historical sketch of the town for Miss Hemenway's Gazetteer of Vermont, which is of great value. But he seems to liave made no research for materials outside of the town. His narrative is mainly confined to the Associate Presbyterian Church, of which he was the honored pastor, and he makes no mention of a fine class of settlers from southeastern Massachusetts, who located along the valley of the Passumpsic in Barnet, Waterford and St. Johnsbury, from which came some of the most prominent families in Caledonia County. This deficiency has been supplied, largely, by information from Hon. Elmore T. Ide.

In the preparation of this volume, the files of the North Star, in the State Library have been consulted; those of the Caledonian, in the St. Johnsbury Athenaeum; also the bound volumes of the Aurora of the Valley, the Democratic Republican, the New Hampshire Patriot and the Courier and Enquirer, in the library at Newbury.

The editor returns thanks to all in Barnet who have, in any way, aided in this work, and to the members of Barnet families, everywhere, who have contributed records. Acknowledgements are also due to the town clerks of Lyman, Bath and Haverhill for their assistance; to the State and Historical Libraries at Concord and Montpelier; to the town of Ryegate for the use of the records given in its History; to the present owner of the diary of Albert Mason; to Mr. Henry N. Stevens of London for the loan of the Stevens journals and other valuable papers. To Miss Annie Harvey for the use of the journal of Colonel Harvey, thanks are also given.

Much assistance has been furnished by the late Governor Ide, and by Hon. Elmore T. Ide of St. Johnsbury; by Hon. John B. Gilfillan of Minneapolis; and by the late Dea. A. M. Whitelaw of Ryegate in the use of the General Whitelaw papers.

And last, but by no means least, acknowledgments are due to the publishers, and the engravers, by whose experience and skill this volume is made attractive to its readers.

HENRY, OR HENDRY.

THOMAS¹ HENDRY and wife came from Scotland in 1801 in the "Phoenix."

With them came the Wallace and Fulton families of Newbury, the Robens,
Andrew Buchanan and others of Ryegate, the McNabs of Barnet and others.

He lived first in Newbury, then in Barnet. He was a moulder by trade, and worked in Brandon several years, and some of his children settled there. He was noted for his skill in the management of bees. His wife d. and he m. 2nd Sept. 19, 1811 Mary dau. Samuel Lindsay of Newbury and lived on the Wright farm in Ryegate between 1839 and 1840. Rem. to Connecticut and d. 1868 at Forestdale.

HOYT, OR HIGHT.

Sergeant John Hoyt was the immigrant ancestor of great numbers of the Hoyt and Hight families of New England and elsewhere. He was living at Salisbury, Mass. in 1639, and may have been there some years. Was prominent in his time in both town and church, and the militia. He was also state senator. He d. in 1688. The name is spelled Hoyt, Holt, Hight, and Height. His descendants near Dover, N. H., spell the name Hight, as do many of the Maine families. The following incomplete record will show the ancestry of several families. John Hoyt had four sons, of whom John and William are understood to have settled at Newington, N. H., from one of whom John¹ Hight who settled in Barnet, is probably descended.

Dennis Hoyt was taxed at Barnet in 1794 for 1 poll, 95 wild acres, and 6 improved acres; he then disappears from the Town Records.

WILLARD HOYT FAMILY.* (came to Barnet from Craftsbury)

WILLARD, 1 HOYT b. Craftsbury ab. 1800; rem. to Jay when the country was new; and came to Barnet in 1868 and settled with his son, Hubbard on what is now called Tripp Lane in the county, where they farmed. Some time after 1887 Willard¹ and Hubbard² rem. to the Joe's Brook Road where lived six generations of Hoyts, the house being sold by his grgrgr-grandaughter after the d. of her mother and her own marriage; part of the farm continues (2007) to be owned and occupied by the last male Hoyt of the line (sixth generation).

Willard¹ was living with his son, Hubbard², on the Joe's Brook Road when he d. Dec. 18, 1889. Although he d. quite suddenly, he was over 90 years of age, and it was not supposed to be from any contagious disease. However, a few days later his grandson, Seth, took sick from malignant diptheria and d. after a few days' illness on Dec. 30. A day later Hubbard, Seth's father, was taken with the same disease and d. Jan. 5; meanwhile Jasper, another son, became sick, but was reported as "doing well"; however by Jan. 16, he too, was gone. The Caledonian reported that great difficulty was encountered in getting help and a nurse and the mother and two younger children (ab. 6 & 12) might also have died had it not been for the assistance of Mr. Wilbur Nelson, Mr. Hoyt's son-in-law, who stayed throughout. Willard m. 1st Sarah Berkley of Lyman, N. H. by whom he had four children, three of whom lived to grow up. Child' s says he "m. 2nd Lydia Clough of Lyman; she had one child, Hubbard H."; but, Hubbard' s dc gives his mother' s name as "Sarah Berkley". Willard is buried at Passumpsic with his son, Hubbard' s family. Hubbard Hastings² Hoyt b. Jay ab. March 21, 1841 came to Barnet from Lyman, N. H. about 1868 with his father, they settled on what is now called Tripp Lane in the county, where they farmed. Some time after 1887 rem. to the Francis Butler Goss place (previously the John Buchanan farm), q. v. (p. 466), on the Joe's Brook Road, where he died; m. Hannah Elizabeth Foster of Haverhill, N. H. (b. Haverhill ab. May 1847; d. Dec. 13, 1926) dau. Amos C. Foster, b. Landaff, N. H. and Hannah Elizabeth (Morse)b. Haverhill, N. H, q. v. (HoH p. 604). Hubbard² d. at home Jan. 5, 1890 of the diptheria that killed his father and two of his children. Both buried Passumpsic with his father and three of their children.

HOYT, OR HIGHT.

Sergeant John Hoyt was the immigrant ancestor of great numbers of the Hoyt and Hight families of New England and elsewhere. He was living at Salisbury, Mass. in 1639, and may have been there some years. Was prominent in his time in both town and church, and the militia. He was also state senator. He d. in 1688. The name is spelled Hoyt, Holt, Hight, and Height. His descendants near Dover, N. H., spell the name Hight, as do many of the Maine families. The following incomplete record will show the ancestry of several families. several families. John Hoyt had four sons, of whom John and William are understood to have settled at Newington, N. H., from one of whom John¹ Hight who settled in Barnet, is probably descended.

DENNIS HOYT was taxed at Barnet in 1794 for 1 poll, 95 wild acres, and 6 improved acres; he then disappears from the Town Records [Grand List].

Willard¹ was living with his son, Hubbard², on the Joe's Brook Road when he d. Dec. 18, 1889 [OBIT]. Although he d. quite suddenly, he was over 90 years of age, and it was not supposed to be from any contagious disease. However, a few days later his grandson, Seth,³ took sick from malignant diphtheria and d. after a few days' illness on Dec. 30. A day later Hubbard², Seth's father, was taken with the same disease and d. Jan. 5; meanwhile Jasper, another son, became sick, but was reported as "doing well"; however by Jan. 16, he too, was gone. The *Caledonian* reported that great difficulty was encountered in getting help and a nurse and the mother and two younger children (ab. 6 & 12) might also have died had it not been for the assistance of Mr. Wilbur Nelson, Mr. Hoyt's son-in-law, who stayed throughout [FAMILY OBITs CalRec 1/9/1890 & 1/23/1890]. Willard¹ m. 1st Sarah Berkley [son Hubbard's dc] of Lyman, N.H. by whom he had four children, three of whom lived to grow up [Child's]. Child's says he "m. 2nd Lydia Clough of Lyman; she had one child, Hubbard H."; but, Hubbard's dc gives his mother's name as "Sarah Berkley". June 21, 1826 R. H. Deming & Jonas Flint filed papers in Caledonia County Probate Court requesting an inquiry into "William Hoit Jr" who "in our opinion has become insane and is thereby rendered incapable of taking care of himself, family, or property". March 28, 1828 papers were signed ordering his real and personal estate sold to settle his debts, excepting one "two year old heifer assigned to wife, Mrs. Hoyt" and "Assignment of guardianship of the minor children of William Hoit Jr.(sic), an insane person residing at St. Johnsbury . . . assigned to Mr. Ide [ProbateRecs (10:171)]. It is unknown from whence came the tiltle "Capt.", as there is no William Hoit/Hoyt listed in the 1933 "State of Vermont Roster of Soldiers in the War of 1812", and he was only about age 40 when declared insane, was this merely a title of endearment used at the poor farm?

<u>NOTE</u>: to the right of a "W.H.H." footstone in the Goss Hollow Cemetery (believed to be the son of Capt. William Hoyt) is the Brown family lot in which are buried Nathan & Rebecca Brown, parents-in-law of Capt. William Hoyt.

In the Centervale Cemetery are found the coped white marble gravestones (w/o footstones) of Capt. William and wife, and the white marble monolithic gravestone of his brother, Nathaniel. However, that cemetery was not chartered until 1864 - after Capt. William and Nath' l had already been buried.

There are coped white marble gravestones dated (1840-80) near Lucinda Hoit in the Goss Hollow Cemetery that are accompanied by white marble monolith footstones, which leads one to entertain the possibility that maybe Capt. William Hoyt was buried with his wife, brother, son, and sister Lucinda and when his daughter-in-law died (after the new cemetery was opened) he, his wife, and son, were moved there and the son's footstone left behind. The only W. H. Hoyt found in St. Johnsbury, d. May 19, 1872 and shares a gs next to his father, Capt. William at Centervale, with his widow who d. Dec. 30, 1877. William H. Hoyt's hexagonal spire monument at Centervale matches that of Nathan & Rebecca Brown's at Goss Hollow which adds to the probability that he belongs to the lone footstone at Goss Hollow and was originally buried there. {A William Harrison Hoyt (1816-1897) lived in Lyndon and, although I have not found his grave, his father & son are both buried at Lyndon Ctr., so he is not likely the Goss Hollow "W.H.H."}.
