

STROBRIDGE.

This record is from the "Strobridge Genealogy," with additions.

I. WILLIAM and MARY (Henry) STROBRIDGE came from the north of Ireland, ab. 1715, and settled at Middleborough, Mass. They were Presbyterians in Ireland, but became members of the Congregational Church at Middleborough. He d. Nov. 14, 1777, aged 87. She d. Dec. 8, 1776, aged 85. Seven children.

II. JAMES, b. 1729, at Middleborough, Mass.; m. Mary Gordon of Voluntown; rem. to Northfield, Mass., ab. 1783, and d. there, Oct. 23, 1811. She d. March 3, 1817, aged 84. Ten children.

III. WILLIAM, b. Oct. 19, 1756, at Middleborough. He m. 1st, Sept. 25, 1779, Susan, dau. Rev. Ebenezer Hinds, who d. soon after; 2nd, Oct. 10, 1784, Hannah Tuttle. Lived in Claremont, N. H., several years; rem. to Barnet, Vt., ab. 1803, where he was town representative and held other office. He d. Feb. or March 9, 1843; his 2nd wife d. Aug. 1, 1855, more than 90 years old. He served in the Revolutionary War in Capt. Isaac Wood's Co., Colonel Cotton's Regt., in 1775, three months, also in same years, 50 days, also in same company in 1777, 35 days, and in secret service, Sept. 28-Oct. 31, same year.

The genealogy of this family is counted from William who first came to Barnet.

XI. William;² b. Barnet, March 18, 1805; m. 1st, Oct. 1, 1837, Effie, dau. John Cameron (b. Ryegate, July 24, 1813; d. Frankfort, Ky., Dec. 24, 1875).

XII. Oliver;² b. Barnet, March 14, 1808; m. Esther Mason. Served in a Wisconsin regiment in the Civil War; d. Cairo, Ill., Feb. 18, 1865. Six children.

XIII. Hannah;² (twin to Oliver), m. Warren Gray of Essex, N. Y.; d. in Wisconsin, Dec. 6, 1872.

(1) EBENEZER HINDS² (William¹), b. Claremont, N. H., Aug. 19, 1785. Came to Barnet with parents. Farmer on homestead. Always called "Hinds" Strobridge. Named for Rev. Ebenezer Hinds of Middleborough, Mass. Lived to be nearly 93 years, retaining his memory to the last. He m. July 4, 1815, by Rev. David Goodwillie, Elizabeth, dau. Col. Alexander Harvey (b. Jan. 30, 1787; d. Jan. 25, 1847); 2nd, ———, 1851, Margaret, dau. William Somers, q. v. Children all b. in Barnet: (p. 617).

(2) PHAEDUS² (William¹), b. Claremont, N. H., March 17, 1787; m. 1815, Margaret Laird of Barnet (b. 1789; d. 1861), q. v. (p. 525). He d. March, 1833.

(3) MEROE² (William¹), b. Claremont, N. H., Feb. 14, 1791. Came to Barnet with parents; m. Nov., 1807, Geo. W. Clark of Peacham, where she d. Feb. 20, 1880, in her 90th year. In the first year of her married life she spun and wove a piece of cloth which she exchanged with a cabinet-maker for a writing desk, still in use.

(4) WILLIAM HARVEY³ (E. Hinds,² William¹), b. Barnet, Jan. 9, 1822; m. 1st, at Haverhill, N. H., Dec. 24, 1847, Margaret Lucretia Rix, who d. in Brooklyn, N. Y., Jan. 21, 1855; 2nd, June 12, 1858, Sarah Janette Wilcox. Lived at Haverhill, N. H., some years, but rem. to Brooklyn, N. Y. Dealer in rare coins, paintings and objects of art. He had considerable literary talent and contributed much to the press. Mr. Strobridge was blind in his later years.

(5) LAFAYETTE³ (Turner,² William¹), b. Peacham, Sept. 12, 1824. Kept tavern at Peacham many years; later, retired. Justice of the peace 30 years; member of Congregational Church, 65 years. He m. May 8, 1848, Elizabeth, dau. Russell and Florella (Foster) Clark, (b. Feb. 1, 1826; d. Feb. 21, —). Their house was the home of many boys and girls attending the academy. He d. Feb. 10, 1908. She was many years president of the Ladies' Missionary Society of Peacham. Celebrated their golden wedding May 4, 1898. 1899

Stone-cutter at St. Johnsbury; farmer on homestead, 1870-1886; employed two years by the Pacific Improvement Co., San Francisco, Cal.; farmer at West Barnet till death. Elder 28 years in Presbyterian Church, and for many years superintendent of the Sunday School. He m. May 3, 1886, Mary L. Gilker-son. He d. Nov. 15, 1914. Children living were Mrs. E. X. Somers,⁵ q. v. of (p. 443) Barre; and F. Edwin Strobbridge,⁵ who m. Feb. 5, 1905, Ruth A. Hoyt. Children: Dorothy,⁶ b. July 28, 1913; and Frances,⁶ b. Sept. 5, 1919, q. v. (p. 495).
