WALLACE.*

JONATHAN,¹ b. near Paisley, Ayshire, Scotland [1764{1923ed}] ab. 1758 [gs], for several years a cabinet maker and corn merchant at Galston, came to Worked some years in Campton, Sandwich, and America in 1785. Moultonboro, N. H. Res. in Ryegate at time of his marriage [NEGR v.54 p.284 (Marriage Records of Rev. Jeremiah Shaw of Moultonboro)]. He m. Moultonboro June 10, 1789 Abigail Richardson of Moultonboro [ibid], dau. of Bradbury Richardson. They lived in Ryegate till 1797, when he bought a farm near the Four Corners in Barnet where he lived til his death, Apr. 5, 1854, aged 95 [gs]. His wife d. Sept. 27, 1853 Æ 85 [gs]. Both bur. Center Cem. He worked also as a carpenter and mill-wright, building the first grist-mill in Wheelock. He brought from Scot-land the brass works for a tall Scotch clock. Being a cabinet maker by trade he made a case from a Sheraton pattern. This clock is now [ca.1923] owned by his gr. gr. dau., Miss Edith Wallace, and keeps good time.

Jonathan¹ Wallace was appointed by Governor Chittenden, in 1794, lieutenant in the 1st Regiment, 2nd Brigade, 4th Division of Vt. Militia. He and his wife were members of the Center church. The Wallace family in Scotland from which he came, claim kindred with that of Sir William Wallace, the hero of Scotland.

June 1808 [gs-d.Æ96y2m]] [June 1, 1800 Æ94y2m1d {dc-BVR(3:44)} but, age calculates to June 1, 1810]; d. at the home of his nephew, Thomas Steveson [OBIT], Aug. 2, 1904 [1923ed/dc(3:44)/gs] [Aug. 3 {BVRdr}/{CalRec 8/10/1904}] Æ96ys 2ms [gs], the oldest person in town [OBIT]). They lived and she died Aug. 14, 1883 [dc-BVR(1:73)] on the Wallace homestead near the Four Corners in Barnet; after she d. he sold the place and boarded in different families 'til d., leaving "all that he had (abt. \$900) to the Center Cem. to keep it in good condition generally"; both bur. Center Cem., q. v. (p. 438).

(1) BRADBURY RICHARDSON² (Johnathan¹), b. Aug. 27, 1807 [gs]; ?bapt. Feb. 4, 1808? [DW]; d. Oct. 18, 1896 [gs/BVRdc(1:88)]. Kept a country store at the Four Corners. In 1849 he moved to Barnet village and bought what was then known as the Willard Stevens building, built in 1800, and entered into the tin and hardware business, his shop being for some years the only one of the kind between Wells River and St. Johnsbury. He kept two peddler's carts on the road all the time selling his wares. Dealing also in stoves, hardware, and sugar tools; taking, in the early days, rags, horsehair, old metal, cloth, and maple sugar in exchange. In 1855, he took his son, John S. T. Wallace, into partner-ship, the firm being known as B. R. Wallace & Son, until the death of the senior partner. The son carried on the business until March 1909, the busi-ness having been in the family 60 years.

He m. Peacham May 11, 1831 [POP] Jennette Harvey Hight dau. John and Alice (Nutter) Hight (b. Aug. 8, 1808 [gs]; d. Apr. 18, 1869 [gs/BVRdc(1:57)]). Both bur. Pleasant View with his parents [gs].

Educated at Phillips Academy, Danville; and a member of the first class entering McIndoes Academy. In tin and hardware business as before stated. Served in the Civil War in Co. F, 15th Vt. Member of X C. Stevens Post, G.A.R. Charter mem-ber of First Congregational Church, Barnet; treasurer 25 years; clerk 18 years; teacher in Bible class 50 years; sang in choir over 40 years; superintendent of Sunday school many years. He m. Harriet Morey Hazelton of Strafford (b. Strafford, Vt. [dc] Apr. 2, 1833 [dc/gs]; d. Nov. 4, 1899 [gs/BVRdc[2:3]]) dau. Thomas and Sylvia (Kibling) Hazelton [Harriet.dc]. He d. Oct. 24, 1913 [gs/VVRdr calls him John S.L.]. Both bur. Pleasant View [gs].

One daughter, Edith Harriet⁴ who oc-cupies [ca.1923] the homestead on Church St.; b. 1866 [gs]; d. Jan. 20, 1956 [BVRdr]; bur. with parents [gs].

Bradbury Wallace and family, including John S. T. Wallace and wife, are buried in the cemetery at Barnet Village [oblisk monument in center of the knoll at the highest part of the original cem. lists Bradbury & wife, son John S.T & wife, dau. Emeline, & J.S.T.' s dau., Harriet], q.v. (p. 187-8). Miss Edith Wallace rendered valuable service in the preparation of this history of her native town.
