Dear Alex Calzareth:

This is in response to your Freedom of Information Act (FOIA) request received in this office August 15, 2005, regarding the subject: Baer, Alfred.

We have completed the review of all documents responsive to your request and have identified nine pages which are responsive to your request. Enclosed are eight pages in their entirety, and one page in part pursuant to 5 U.S.C. 552 (b)(2) and (b)(7)(C). The basis for the deletions in part is as follows:

Freedom of Information Act 5 U.S.C. 552 (b)(2)

Exemption (b)(2) provides protection for records that are related solely to the internal personnel rules and practices of an agency. The types of documents and/or information withheld under this exemption may relate to internal matters of a relatively trivial nature, such as internal personnel rules and practices which could consist of employee identification codes, computer login codes, policies regarding the use of parking facilities and break rooms, employee leave policies and dress codes or internal matters of a more substantial nature, the disclosure of which would risk circumvention of a legal requirement, such as operating rules, guidelines and manuals of procedures for examiners or adjudicators.

Freedom of Information Act 5 U.S.C. 552(b)(7)(C)

Exemption (b)(7)(C) provides protection for personal information in law enforcement records, which could reasonably be expected to constitute an unwarranted invasion of personal privacy. The types of documents and/or information withheld could consist of names, addresses, identification numbers, telephone numbers, fax numbers, or various other documents that are considered personal.

Please note you are receiving the best reproducible copies available.

In the event you wish to appeal this determination, you may write to the USCIS FOIA/PA Appeals Office, 111 Massachusetts Ave., NW, 2nd Floor, Washington, DC 20529, within 60 days of receipt of this letter. Both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
