Dear Alex Calzareth:

This is in response to your Freedom of Information Act/Privacy Act (FOIA/PA) request received in this office November 14, 2007, regarding the subject: Erna Sender.

We have completed the review of all documents and have identified 24 pages which are responsive to your request. Enclosed are 22 pages released in their entirety, and 2 pages released in part. We have reviewed and have determined to release all information except those portions that are exempt pursuant to 5 U.S.C. § 552 (b)(6) of the FOIA.

The following exemptions are applicable:

- ☐ Exemption (b)(6) permits the government to withhold all information about individuals in personnel, medical and similar files where the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy. The types of documents and/or information we have withheld may consist of birth certificates, naturalization certificates, drivers license, social security numbers, home addresses, dates of birth, or various other documents and/or information belonging to a third party that are considered personal.


