Dear Alex Calzareth:

This is in response to your Genealogy request received in this office August 15, 2005, for access to copies of documents relating to Betty Wolf.

We have completed the review of all documents responsive to your request. The record consists of 28 pages of material which are responsive to your request. Twenty-one pages are being released in their entirety. Seven pages are being withheld in their entirety pursuant to 5 U.S.C. 552 (b)(6), of the FOIA. In our review of the pages withheld in full, we have determined that they contain no reasonable segregable portion(s) of non-exempt information. The enclosed copies are the best reproducible copies available. **Old documents/records such as these are maintained on microfilm and the quality of the image is dependent on the condition of the original document when it was filmed.** The basis for withholding pages in full is as follows:

Exemption (b)(6) permits the government to withhold all information about individuals in personnel, medical and similar files where the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy. The types of documents and/or information withheld may consist of birth certificates, naturalization certificates, drivers license, social security numbers, home addresses, dates of birth, or various other documents and/or information belonging to a third party that are considered personal.

Please be advised that the National Records Center does not process any type of petition/application or any other benefit under the Immigration and Nationality Act. Therefore, if you have any questions or wish to submit documentation relating to a pending petition/application or any other matter pending with the bureau, you must address these issues with your nearest District Office.

In the event you wish to appeal this determination, you may write to the USCIS FOIA/PA Appeals Office, 111 Massachusetts Ave., NW, 2nd Floor, Washington, DC 20529, within 60 days of receipt of this letter. Both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."

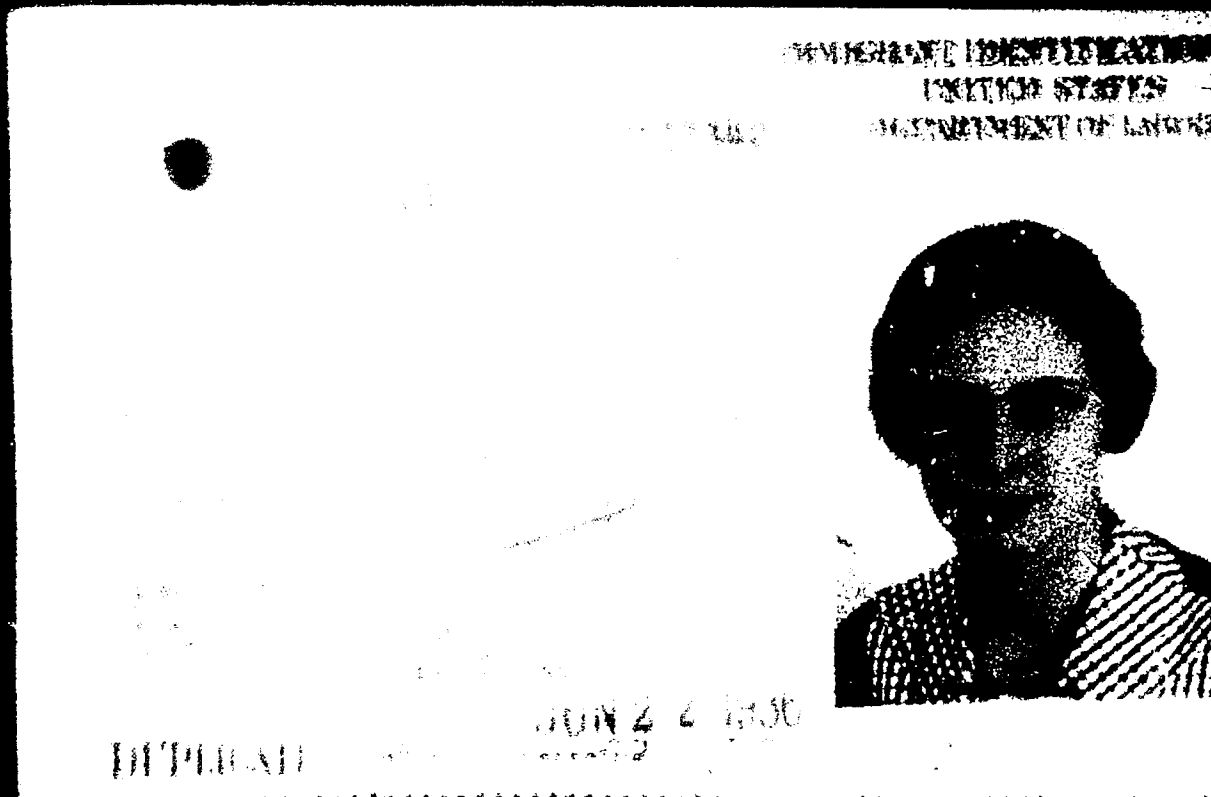
