Old Obituaries reveal family history:

Jay County Historical Society, INC. Portland, Ind. 47371

T.B. Evelsizer - a phsician and surgen, of Green Township removed to Jay County in 1869. His parents were Henry and Mary Jane (Patterson) Evelsizor. His wife Mary (Castle), Evelsizer, daughter of Amos and Rutha Jane (Kim) Castle, was born October 26, 1844, in Fulton County, Illinois.

They were married in Knox County, Illinois, November 18, 1859. Nine chidren have blessed their union, namely:

- -Elnory, born March 5, 1861;
- -Stephen Allen, March 20, 1863;
- George William, November 14, 1865; died Feb. 2, 1867;
- -Viola Jane, Dec. 3, 1867.
- -Margaret Ann, June 10, 1871;
- -Mary Agnes, March 19, 1873, died May 30, 1878;
- -William Henry, Sept. 20, 1875; -Elizabeth Arila, Feb. 15, 1878;

-Aquilla Arilla, May 15, 1880.

Dr. Evelsizer had his birth in Delaware County, Indiana. September 27, 1838. He is the present coroner of Jay County, being elected in October 1878; re-elected in 1880. He graduated and received diploma at the Chicago Medical College, in the autumn of 1858, has practiced

edicine and surgery in Illinois, is at present practicing medicine in Greene Township.

His father, Henry Evelsizer, was one of the early settlers of the county, he aiding in the first survey thereof. His death occured in Jay County October 10, 1879, he being in his eightieth year. Address Greene.

He had been ill for nine years with muscular dystrophy. Funeral services will be held at 10 A.M. Wed. at the Wesleyan Methodist Church, the Rev. C.A.Hoover, pastor officiating. Evilsizer - was born in Kanawa County, Virginia, September 2, 1816 he gains a livelihood by farming. Steeled in Jay County in 1837, and married Frances Dye, in Knox Twp., Jay Col, April 4, 1839. She is the daughter of Minor and Deliah (Long) Dye, who were born in Greene County, Pennsylvania, at which place the death of Mr. Dye occurred. Mrs. Dye met her death in Jay County, Indiana.

Mr. Evelsizer is the father of eleven children, named respectively: - Eliza Ann, born May 30, 1840, died in Miami Co., Ohio March 30, 1842;

- -Matilda Jane, Nov. 29. 1841, died in Miami Co., March 25, 1842;
- Minor, born Feb. 4, 1843, resides in Jay Co., Indiana.
- -Priscilla, born Aug. 19, 1845, resides in Montgomery County, Indiana;
- -James, born and died July 15, 1848 -Margaret born June 15, 1849, is a resident of Jay County;
- -Louis M. born July 16, 1851, resides in Jay County;
- -Mary Frances, born August 19, 1854, is a resident of Montgomery County, Indiana;
- -Albert W., born Sept. 19, 1856, resides in Jay Cunty, Indiana; -Sarah Maria, born September 11,
- 1858, is a resident of Jay County; -Kipher, born July 2, 1861, died Oct. 14, 1865.

Henry and Elizabeth (Idle) Evilsizer, residents of Champaign, County, Ohio, and who were born in Virginai, are the parents of Leonard Evilsizer. His son Minor, fought in the War of 1862. Henry Evilsizer was one of the early settlers. Mail received at Portland.

Leonard M. Evilsizer came to this county in 1837. He cleared 200 acres and has owned 1,200 acres in the county; also owns 193 acres in Iowa.

S.P. Evilsizor, Former Mayor, Dies in Ohio

Samuel P. Evilsizor, village president, of Libertyville in 1931-32 and building commissioner since May 1937, died suddenly at 12:30 P.M.. Sunday, Jan 9, 1938, at the home of his brother, Charles, in St. Paris, Ohio, where he had gone to visit.

Cause of his death was a heart attack occasioned by the excessive strain of a heavy meal on his weakened stomach. He had been troubled before with internal hemorrhages.

Mr. Evilsizor was 64 years old. He had lived in Libertyville more than a quarter of a century, taking a deep interest in civic growth of Libertyville and in the development of the town's business and residence sections. At the time of his death he was the owner of several properties here and was thought to be in fairly good health.

Funeral services were held yesterday at 2 P.M.. from the home of at 336 Milwaukee Ave. The Rev. Samuel W. Vose officiated and pall bearers were: Village President. A.E.Suter, Police Chief Frank Druba, two nephews, James Gannon of Chicago and John Gannon of Evanston; and two grandsons, Bruce and Robert Kilby of Evanston. Burial was in Ascension cemetery.

The body was delivered to the Ray-Burnett funeral home Monday morning from Ohio.

Samuel Paul Evilsizor was born Oct. 23, 1873. He was married on June 30, 1892, to Catherine Wynn at Urbana, Ohio. A year later the couple moved to Evanston. About the year 1902 the family moved to Libertyville. After a residence here of 13 years, Mr. Evilsizor took up work in Paxton, Ill., where they lived for five years. They then returned to Libertyville.

In February, 1922, Mr. Evilsizor was named water superintendent of the village and he held that position until May, 1926, according to records in the clerk's office. At one time he was in charge of Public Service here and later went into his own electrical contracting business.

Mrs. Evilsizor preceded her husband in death on January 25, 1937.

Surviving are four daughters: Mrs. Gertrude Karnitz, Waukegan; Mrs. Florence Kilby, Evanston; Mrs. Ruth Knigge and Mrs. Mildred Delthron, both of Libertyville.

Mrs. Evilsizor became ill about a month ago with an attack of influenza but was considered completely recovered from that sickness. A week ago Sunday, she had gone to the home of her daughter, Mrs. Diethorn, during the afternoon to take care of her grandchildren while Mrs. Diethorn and Mrs. Knigge were away from home. When they returned they found Mrs. Evilsizor unconscious on the basement floor. From that time until her death she had recovered consciousness only for one

Mrs. Evilsizor Succumbs at 72

-Mrs. Rosa Evilsizor, 72, widow of C.I.Evilsizor, well-known former county commission, who died in 1931, died at 11:30 p.m. Thursday at her home, Urbana Rout 4, south of the city. She had suffered a stroke of paralysis on Saturday from which she did not recover.

Mrs. Evilsizor was born in Clermont county, June 23, 1868, but had lived most of her life near Urbana.

Surviving are two sons, Minard, Urbana, and Ivan, at home; three brothers, Christian Spahr, New Moorefield; Leonard Spahr, Springfield; and Charles Spahr, Albuquerque, New Mexico; and three grandchildren.

Funeral services will be conducted from the residence at 2 pm. Monday with Dr. Harry W Barr, pastor of the Presbyterian Church, officating. Entombment will be made by Humphreys and Son Co, in the Grand View Mausoleum. The body was to be returned to the residence late Friday afternoon, where friends may call.

As many of us researchers know there has been an ongoing discussion of the OLD JACOB theory involving documents of a Jacob in Germany while there is also info on a Jacob in America. The Chronological chart in the preceeding pages illustrates the events that took place so many years ago. Flossie Hulsizer and Sandi Kosack did much of the compiling of data to help sort out the data. Sharon Durels has also had an impact on the compiling of this data.

What follows is a letter sent to Sandi Kosack from Dwight Viehland. He has an interesting and plausible theory of our LEGEND Story. Please read for yourselves and let us hear from you of your opinion of this idea!!

" I did some thinking on the information you sent. I pick up that there are actually three UEBELSCHAUSER men:

i. Johann Jacob

ii. Johannes

iii. Nikolas.

Johan Jacob was born 27 DEC 1752, has a record for 'enlisting' into the Hessian Army, was taken as a POW, was made an invalid, returned home, separated from the Army, was married in Germany, and had a daughter.

Johannes was born 30 MAR 1751, has a record for 'enlisting' into the Hessian Army, has no record of discharge from the Army, was married in Germany, and had a son named Johannes Jacob.

Nikolas was born on an unknown date, in an unknown place in Germany, does not have a record for 'enlisting' in the Hessian Army, has a record for desertion from the Hessian Army (presumably between 1778-1780), and has no records after that. (i.e. he disappears).

OK, I think there is a very simple solution to this three body problem. First, all three men speak only German. Consequently, they would have a hard time surviving in Early America, in particular during the Revolutionary War. Probably all three men came from the same area in Germany and were some combination of cousins and/or brothers.

Now, when Johann Jacob was taken POW and later wounded, well from a German perspective he sort of became a hero, and from US perspective it was a sort of tragedy. So, his reputation is not so bad. However, when Nikolas deserted from the Hessian Army, well his reputation was not so good. After deserting from the Hessian Army, Nikolas probably found life in Colonial America quite tough. He could not speak English very well, in addition to being significantly cultural different than WASP America. So, the only way that he could survive was to locate himself in PA German Community. He could then communicate very well, he knew the cultural, he was more probable to find employment, etc.

However, Nikolas had a problem in that his reputation was not so good, as he was one of the 'evil deserters'. Even in America, the PA Germans were still Germans. As we all know, Germans can be very narrow-minded, and value discipline and military service. So, if the PA German community found out about his desertion, well he was in deep trouble. If the war was not over, they might have turned him over to the Hessian Army, at which time he would have been executed. If they did not do that, well they would have tarred and feathered him. Then where does he go? How does he survive? He can't go home because if he is found he will probably be executed.

Nikolas did have one option open to him, in which he could completely cover his tracks. He would become Johann Jacob (his brother or cousin). He would become a 'hero' rather than an 'evil one'. He could find employment in the PA German community, and he could begin to build a new life. He could then later move on out of the community and be forgotten.

I do not think that it is necessary to have Johannes or Johann Jakob have any children in the USA. The children born in Berks Co., PA all probably belonged to Nikolas AKA /Jacob. I do wonder if Nikolas left any family behind in Germany,

So, in conclusion, I think that maybe there is something to the 'legends of "Ole JAKOB". I think the probabilities very high that he is actually Nikolas Uebelschauser.

Chistopher McCarty and wife Elizabeth Evilsizer

Christopher McCarty was born between 1790 and 1795 in North Carolina to unknown parents. He moved to Clark County, Ohio where he married Elizabeth Evilsizer on May 14, 1822. He remained in Ohio until the 1830 Census; and moved to Indiana in 1831 (by birthplace of son Henry). Christopher & Elizabeth had seven children:

1. Elizabeth 1823-1857 (Chiristian Huffman)

2. Henry abt. 1831 - death unknown {Ann Loy}

- 3. William abt 1833, death unknown {Ellizabeth Rader}
- 4. John abt 1837 death unknown {Caroline Poppy}
- 5. Jacob abt 1841 death unknown {Melinda Nicholas}
- 6. Peter abt. 1842 death unknown {Elizabeth Philips}
- 7. Susannah abt. 1842 death unknown. {Susannah's name came from the 1850 Ohio Court Case.}

Christoper was widowed by 1850. In the 1850 Census, he had come to Pulaski County, Indiana from Montgomery County, Indiana where he was in 1840. In 1850, he instituted a court case in which he sued to estate of his late father-in-law, Henry Evilsizer, to get a settlement for his children. He married Julia White on March 24, 1861, in Pulaski

the early 1860's, his son William was declared insane. William and his guardian sued Christopher for money owed to William. Christopher sued his stepson in the late 1860's

Christopher died on April 23, 1869, in Pulaski County. His burial site is unknown but may be an unmarked grave in Sutton Cemetery near his daughter Elizabeth Huffman.

Elizabeth Evilsizer was born in 1800 in Virginia to HENRY and ELIZABETH (Idle) EVILSIZER. LIttle is known about her. She was dead by 1849. Place of death and grave site aere probably in Montgomery or Pulaski County, Indiana.
