INTERNET DECEPTIONS DEATH OF LOUIS EVILSIZER

On Friday, December 13th, 2002, police discovered the corpse of an unidentified middle-aged white male in a hotel room in the Chicago suburb of Palatine. According to police reports, the gentleman's hotel room had been broken into and burglarized, and during the course of the burglary, the man was overpowered, dragged into the hotel room's bathroom, hanged upside-down in the shower and had his throat cut. Police confirmed that the victim had been killed in a manner consistent with murders committed by the so-called "Cult of the Redeemed Apocalypse," a group of serial killers that have been plaguing the Chicago area for some time. The victim was eventually identified as Mr. Louis Evilsizer, the owner the Mystic I bookstore, a specialty store which dealt mainly in "occult tomes" and similar books. Ms. Bree Nails, the general manager of the Mystic I, informed the police that, according to Mr. Evilsizer, he had recently received a few death threats and had had his home burglarized. She believed that the threats and burglary were related to a recent manuscript that Mr. Evilsizer had acquired which originally was going to be sold in a private auction that evening. Mr. Evilsizer's home had been burglarized twice, once on the night of December 7th and then again during the day on December 12th. And hey, if there really is a Louis Evilsizer, I'm sorry, I didn't mean to freak him out by making him think people wanted him dead; I just thought that "Evilsizer" was a really good name and used it for a character in the game! Sorry about that. ; now I'm very nervous about the names of various background characters I've created for these stories we're telling in the game....) -Eric Sasmor, Head Storyteller for Chicago Reborn

MYSTERIES SOLVED from Domestic Relation Records 1808-1939 published by CCGS

Elnora Teets (1881-1942) was married to brothers Joseph Otto Evilsizor and John Ezra "Johnnie" Evilsizor according to her obit. We knew her last name was Sheets, but maybe her maiden name was not Teets, but a spelling error for Sheets. There was a Teets family in the 1880 Logan Co, Census with a daughter Elbora, but she was seven years old. If this was the same Elnora, she would not have appeared in the 1880 census. Until this publication, we never knew whom she was married to:

Champaign Co - Domestic Relation Records 1808-1939 Vol Including Divorce, Bastardy, Adultry, Breach of Contract, some Adoption, by Pat Stickley, CCGS, (Minute Book Records, Supreme Court Records, Urbana Newspaper, St Paris Newspaper), pg180

April 2 1910 Minute book 50 pg 5 Elnora Sheets vs Charles Sheets for divorce on gross neglect. Divorce granted; children to mother

This proves that children Violet and Theodore were children of Charles Sheets and not Evilsizor children as found in the census.

Arena Evilsizer BUCK (1840-1926), probable child of Allen Evilsizer and Elizabeth Journell lived with Edward Buck for several years before they were married, according to the census records. A marriage licence was issued to Edward Buck and Mary A Bunton on 2/9/1860 in Clark Co, OH but a certificate was never filed. (Source Clark Co, Marriage Book Vol 5 (1858-1863). A Marriage application issued November 25, 1876 Champaign Co, OH to Arena Evilsizer and Edward Burke. by Rev J F Kearny, Catholic Priest. No marriage record was found and probably explains why in the 1870 Census she uses her last name Evilsizer. We are now able to determine the following: (Minute Book Records, Supreme Court Records, Urbana Newspaper, St Paris Newspaper), pg28 June 25 1873 Minute Book 32 pg 488 Mary S Buck vs Edward Buck for divorce on wilful absence. Divorce granted alimony \$300. So when she appears in the 1870 Census as wife of Edward Buck, she used her last name Evilsizer, because Mr Buck was till married and not divorced from Mary Bunton. What is strange is that Arena appeared in the census with Edward until she died, but there is a record of Edward Buck in Clark Co, Ohio to a Clara Smith 12/24/1884. There was only one Edward Buck in the 1880 census, so these relationships still contain some mysteries.

Anna Evilsizer (bc1839) another probable child of Allen Evilsizer and Elizabeth Journell. She married James F McIlvaine Oct 12, 1868. No other record was found on her, and the record in this book gives us another lead: (Minute Book Records, Supreme Court Records, Urbana Newspaper, St Paris Newspaper). pg 142 June 11 1873 Minute book 33 pg 86

Anne McIlvaine vs James McIlvaine for divorce on extreme cruelty and gross neglect; they were married Oct 21 1868 in Champaign Co, Ohio. On 31 Dec 1873 in book 38 pg 24 the divorce was granted.

I will now search for a marriage record for Anna McIlwain....(She was not found in 1880 with either name. There IS A POSSIBILITY that this might be Luanne "Annie" Evilsizor, dau of Wm Irvin and Nancy Jenkins Evilsizor who married 1) Tommy Burns and 2) William Clark....see below

Luanna Lucy "Annie" Evilsizor (3/1841-9/25/1907) Oct 23 1866 Minute book 28 pg 484

Thomas Burns vs Luaner Burner for divorce on adultery, they were married 17 Sep 1857 in Champaign County. ON 14 Dec 1866 the marriage was dissolved, her maiden name was Luaner Evilsizer, the adultery was with Henry Ashenfelter in Indiana. She married William Clark 5/31/1879. A marriage to James McIlwain in 1868 and divorce in 1873 fits her profile with the dates. The date of birth is close enough to be her.

(Minute Book Records, Supreme Court Records, Urbana Newspaper, St Paris Newspaper), pg61 Jan 22 1906 Minute book 56 pg 420 Louisa Evilsizor vs ***Edon J Evilsizor*** for divorce on habitual drunk. Divorce granted; \$300 alimony. (This is Alice Louise TRUE) whom he md about a year prior.

The jury hearing the case of **Herman Evilsizer** charged with issuing a worthless check was unable to agree and was discharged. The defendant was released on \$1,000 bond.

Charleston Daily Mail, Charleston, WV Wednesday Evening, Feb 19, 1940
Man Draws Ten-Day Jail Term For Giving False Testimony
For testifying falsely in a circuit court trial, Byron Reinhart, Charleston carpenter, was summarily sentenced to 10 days in the county jail Monday by Circuit Judge Julian F Bouchelle, who declared "I cannot permit an incident like this to pass without punishment." Reinhart, former employee of the Federal Home Improvement company was a witness for that company in its \$1,000 suit against Mr and Mrs W H Evilsizer of near Spencer. The company sought payment for placing an artificial brick covering on the home of Mr and Mrs Evilsizer; who countered with the charge that the work had been improperly done. Reinhart testified that he had nailed lath to the sides of the house before applying the Inselbrick covering and insisted the court had named Contractor C J Kuhn to investigate. Mr Kuhn testified Monday that he had removed 14 panels of the covering from the home and found only a few laths placed. With that revelation Monday morning, the plaintiff took a non-suit in the civil action. Strongly censuring Reinhart, Judge Bouchelle told him: "Not only did you give me your oral testimony that you used laths on the house, but you emphasized it by pointing to an exhibit which was brought into the

courtroom...You not only have betrayed the interest of your employer X X but you have also taken his money for your wages for work which you did not do. You have been dishonest to the people on whose home you were working. Now that dishonesty has been aggravated by your coming into a court of justice and testifying falsely to material facts when you were bound to have known you were so testifying." Pointing out that the witness had stuck to his false story, even when he had an opportunity to correct his testimony, Judge Bouchelle continued: "In order that courts may function properly and that litigants may have a fair trial upon sworn testimony and upon truth given in a court of justice--and you were sworn to tell the truth-- it becomes the duty of the judge in such cases to do what he thinks is right and proper, under the circumstances....I therefore find that you have been guilty of misbehaving in the presence of the court, and you have been guilty by reason of your false testimony of obstructing and interrupting the administration of Justice, and I will impose upon you a fine of 10 days in the Kanawha county jail, that being the maximum which I can give you without a trial by jury."

Margaret "Maggie" Evilsizer, daughter of Leonard Morris Evilsizer and Frances Dye married a John Butcher in Jay County Indiana 2/18/1871. It is known she married a man named Mason before 1/29/1887 because her mothers will names her as Mrs Margaret Mason. No further record was found of her until now-

George William Mason married a lady named Evilsizer by whom there was one child- Morris L Mason. He married a third time to Margaret Bone in Madisonville, Kentucky in 1889 - one child, Clarence Mason born 7/17/1895. George was born Atlas,

Ohio 2/12/1845 and Frances Truax at Antioch Ohio Nov 5 1866. Removed to Jay County Pennville, Indiana in 1867. Francis died 7/11/1878. He then married an Evilsizer lady, name unknown. After his third marriage he moved to Hopkins County Kentucky where he died 1/29/1916. He was the son of William Mason and Nancy Phillips. (1880 Jay Co, Green, Census on page 462B is a widow George W with 4 small children.)

[List of organizations, addresses and phone numbers at bottom; include local chapters, with their addresses, phone numbers and contact persons if available as well as state- national contact information and addresses]

Please remember that my genealogical endeavors consumed a great deal of time, travel, and money.

Therefore it is my desire that the products of these endeavors be allowed to continue in a manner that will make them available to others in the future.
