# Man Draws 10-Day Jail Term For Giving False Testimony

Daily Mail, Charleston Charleston. WV Wednesday Evening, Feb 16, 1940 Firm Sues For Work Done on Spencer Home The Federal Home Improvement company of Charleston went into Circuit court Friday to collect \$650 which it asserted was due for covering with Inselbric the home of W H and Maud Evilsizer in Roane County near Spencer. Mr and Mrs Evilsizer, answering the \$1000 trespass action, contended that the imitation brick covering was not properly applied. Trial of the case was expected to last throughout the day.

Charleston Daily Mail, Charleston, Wednesday Evening, Feb 19, 1940Man Draws Ten-Day Jail Term For Giving False TestimonyFor testifying falsly in a circuit court trial, Byron Reinhart, Charleston carpenter, was summarily sentenced to 10 days in the county jail Monday by Circuit Judge Julian Bouchelle, who decalred "I cannot permit an incident like this to pass without punishment." Reinhart, former employee of the Federal Home Improvement company was a witness for that company in its \$1,000 suit against Mr and Mrs W H Evilsizer of near Spencer. The company sought payment for placing an artificial brick covering on the home of Mr and Mrs Evilsizer; who countered with the charge that the work had been improperly done. Reinhart testified that he had nailed lath to the sides of the house before applying the Inselbrick covering and insisted the court had named Contractor C J Kuhn to investigate. Mr Kuhn testified Monday that he had removed 14 panels of the covering from the home and found only a few laths placed. With that revelation Monday morning, the plaintiff took a non-suit in the civil action. Strongly censuring Reinhart, Judge Bouchelle told him: "Not only died you give me your oral testimony that you used laths on the house, but you emphasized it by pointing to an exhibit which was brought into the courtroom... You not only have betrayed the interest of your employer X X but you have also taken his money for your wages for work which you did not do. You have been dishonest to the people on whose home

you were working. Now that dishonesty has been aggravated by your coming into a court of justice and testifying falsely to material facts when you were bound to have known you were so testifying." Pointing out that the witness had stuck to his false story, even when he had an opportunity to correct his testimony, Judge Bouchelle continued: "In order that courts may function properly and that litigants may have a fair trial upon sworn testimony and upon truth given in a court of justice---and you were sworn to tell the truth-it becomes the duty of the judge in such cases to do what he thinks is right and proper, under the circumstances....I therefore find that you have been guilty of misbehaving in the presence of the court, and you have been guilty by reason of your false testimony of obstructing and interrupting the administration of Justice, and I will impose upon you a fine of 10 days in the Kanawha county jail, that being the maximum which I can give you without a trial by jury."

Defendants Win Suit In Common Pleas Court A Common pleas court jury Tuesday returned a verdict for the defendants in a \$630 suit of the Federal Home Improvement Company against W H and Maud Evilsizer of Etowah. The plaintiff claimed the amount due on a contract to cover a dwelling owned by the defendants with inselbric(sic). The defendants claimed the job was done improperly.

# **Birthday Party in Urbana**

Champaign Democrat July 8 1909 Day of Happy Reminisences

Sabbath, the fourth, records the celebration of a happy day and place of many happy events. One occasion was the 38th birthday of Mrs W H Bumgardner of Urbana, the eldest daughter of Rev and Mrs Isaac Evilsizor, also of Urbana. The companu assembled by wending their way across the hills to the old homestead (the former home of Mr and Mrs Isaac Evilsizor), now occupied by the genial familiy of Mr and Mrs Charles Phillips, situated in Mad River township between Terre Haute and the valley pike. Mr and Mrs Evilsizor resided on this farm for a period of about thrity years, this being the birth place of their large family of children, all being born there except one, their eldest son, Wiley. All assembled there on the Fourth except three sons who live in distant cities as follows: Wiley, Staunton, IL; Weldon, Lima, OH and Samuel, St Marys, OH

Mrs Evilsizor and eight children and fourteen grandchildren were present as follows: Mrs Ida Bumgardner, husband and three daughters; Charles Evilsizor, wife and two sons; Welcie Ballentine, husband and one daughter; Clara Hoberty, husband and one son; Werley Evilsizor, wife and two daughters; Libby Matteson, husband one son and two daughters; Winnie Redman, husband and daughter; Lloyd Evilsizor (single) but had his best girl; Calvin Ward, grandson, son of a deceased daughter.

Mr Phillips opened the doors of his house and home and bade them do as they pleased. Pencil, paper, sanf tongue can but feebly express the gladsome festivities of the occasion. First, a luxurious spread was laid on the orchard lawn and after the Lord's prayer was repeated a sumptous dinner was served.

After every nook and corner of the old home

#### NIGHTWATCHMAN EVILSIZER

Nevada State Journell, Reno Nevada, July 24, 1929

Five Lamar boys were in a car returning from a show Saturday night. As the boys approached the curve of Highway 12 they observed a man in the road with a lantern. They stopped and got out and observed the man with the lantern was Doctor Dimond. He commanded the boys to "stick em up" which they did. He told them he wanted them to help him start his car. They got it started. The Doctor told them they must follow him but on no account must they pass

him. As the boys reached the Ledbetter schoolhouse, the doctor directed them to get out and "stick em up" again which they did. Presently he aroused Doyle Throckmorton at the Liberty Comfort Station, lined the boys up at the lunch counter, and commanded them to eat ham sandwiches. By this time is was 4 o'clock.

Monday, when nightwatchman Evilsizer learned about it he had the prosecutor draw up a complaint charging the Doctor with driving a car when intoxicated.

#### NIGHTWATCHMAN EVILSIZER WORKING ON NEW MYSTERY

Nevada State Journell, Reno Nevada, Aug 29 1929

Nightwatch Evilsizer was informed about 10 o'clock Wednesday evening, that a man lay very sick on the high platform at the rear of the depot. The officer got Dr Miller and drove to the station. They found a small man about 28 years old, lying on the boards. He had two empty bottles, with a lael indicating they contained wood alcohol. Another bottle of the same kind was almost full. The man was too sick to hold up his head.

Mr Evilsizer took the bottle containing the decoction and left the man where he lay. Thursday night he found the same man stretched on a bench in the courthouse yard, again very sick. He had another bottle with skull and cross bones on it, not yet nearly empty.

The inebriate was able to talk some this time. He didn't give his name. The night-watch asked him if he were drinking that stuff in the bottle. He said, "Oh no! he was just rubbing it on his legs for the rheuma-
