Uncovering my Iroquois County Illinois Roots

After the Hessian mercenary founder's service with the British in the American Revolutionary War, the Evelsizer family migrated westward to Pennsylvania "Dutch" country and further with each generation or so. The name changed into three or four major variations, but my line stayed with the Evelsizer spelling. Henry Allen Evelsizer, fifth generation and my great-grandfather, was born in 1852 in Lafayette, Indiana. He would marry Miranda Saylor there. By the time their fifth child and second son my grandfather, Carl Evelsizer, was born in 1888, Henry's family was in Tazewell County, Illinois, in the East Peoria area.

PATERNAL SIDE

The Evelsizer family migrated westward to Pennsylvania "Dutch" country and further with each generation or so. Henry Allen Evelsizer, fifth generation and my great-grandfather, was born in 1852 in Lafayette, Indiana. He would marry Miranda Saylor. By the time their son and my grandfather, Carl Evelsizer, was born in 1888, Henry's family was in Tazewell County, Illinois in the East Peoria area.

I am not sure, but believe Grandfather Carl was living in the Deer Creek area between the ages of eighteen and twenty-one. He and a man by the name of Ed Cooper from Bloomington would attend dances in the Eureka and Secor area, looking for a wife. This is where they met two sisters, Mary and Anna Hexamer of Secor. Ed would eventually marry Anna and Grandfather would wed Mary.

Grandfather Carl and Mary tied the knot in a civil union in Eureka in 1909. They settled on a farm in Congerville in Wood-

ford County. During the five years they lived there, their first child, Lorene, was born. A boy, Floyd, was born in 1913 but died just short of a year later.

In 1914, the family followed older brother William to Bagley, lowa in the first of several moves by train. A daughter, Erma, was born there in 1915. But gathering war clouds brought the family back to the Congerville area in 1918 so that Grandmother would be near her family if Grandfather were drafted.

The return to Congerville saw the birth of more children: Dorothy in December of 1918, my father, Raymond, in August of 1920, and Wilma in 1923, just before the next move. Dorothy died ten days after she was born. Grandmother had contracted the dreaded Spanish Flu of that year, but survived it. The nursing Dorothy did not. So a second child was laid to rest in Imhoff Cemetery in rural Congerville, Illinois.

In the spring of 1924, my grandparents packed up four children and their belongings on a TP&W train and moved, as to a farm at Gilman in Iroquois County. I have heard family stories of Grandmother Mary Stoically packing good dishes in wooden barrels of sawdust along with all the other accouterments of living that had to be packed and moved for yet one more train journey. At least this one would be much shorter than the round trip to Bagley, lowa.

Of course, in keeping with the custom of the day, Grandfather, as the new tenant, had gone to Gilman in the fall of 1923 to do the fall plowing on the new farm. He had to board in Gilman until the work was done and he could return to his family in Congerville for the winter.

When the family moved, Grandmother and the kids would ride in a coach, but the men, Grandfather and assisting extended family men, would ride in the cattle car with the livestock to aid in reducing expenses.

They moved onto a farm located just north of the TP&W tracks on the east side of U.S. Route 45 going north out of Gilman. This would be the south one-half of section thirty-two of Douglas East Township. Grandfather would farm 160 acres of this ground.

This farm was owned by two bachelor brothers and their two unmarried sisters from Peoria. Their name was Sullivans, so, at least in the family, the farm was referred to as "the Sullivan (s) Place."

Grandfather would tenant this farm until the spring of 1942. During that tenure, the family of four children, Lorene, Erma, Raymond, and Wilma, would be increased by the addition of: Kenneth in 1925 and Elsie in 1928. It was on this farm that my father would grow from a three year old to a twenty year old and his marriage in

1940. After 1942, the farm would have several different tenants until it was eventually sold to the Orr family who still own the land today.

In that spring of 1942, the family would buy and move to a farm just north and west of Gilman on what is now county road 620E in the northeast corner of section thirty in Douglas East Township. Lorene and Raymond had married and left their respective nests by this time. The remaining children would all marry before the end of the decade, but Grandfather and Grandmother would continue to live on this farm until retirement in 1958 and their move into Gilman on east third street. Within three or four years, Interstate 57 would be built right down through the middle of the farm.

I have fond memories of this last farm of my grandparents. Between 1946 and 1954, we "townies," my brother Darwin and I, would spend part of summer vacation, "on the farm." We would spend one week with our paternal grandparents on this farm and one week with our maternal grandparents in La Hogue.

What did we do without television and computers? For one thing, we delighted in Grandfather Carl's rubber knee boots and, July heat or not, we would prance around all day in those boots. I loved to "paint" the open, west, "front" porch. The paint, of course, was water. My brother liked to walk around with a more-or-less tame chicken sitting on his head and generally prowl the chicken house.

With that enigmatic smile of hers, Grandmother used to relate how egg production dropped precipitously whenever Darwin was there for vacation. But we were always invited back another summer.

We also liked to listen to the stories Grandfather would tell. One of my favorites told of how he, Grandfather Carl, sleepwalked in his youth. One summer night, while courting my grandmother, he walked in his sleep in the wee hours all the way out to the barn. His parents did not like to wake him unless they had to.

This time they needed to. Grandfather Carl, still deep in sleep and in the inky blackness of a moonless night, was muttering something about visiting his girl while he got the horse fully hitched to the buggy. His father, Henry, finally woke him and told him to unhitch the horse and go to bed. Grandfather Carl had to light a lantern to see in order to unhitch and hang the harness properly on the wall of the barn. Grandmother Mary would sit in her chair and listen to these stories with us, stories she had heard hundreds of times. She always wore that smile I mentioned and a glint of remembered excitement in her eyes.

Grandmother Mary would die in 1971, at age eightythree. Grandpa would live a widower in that east second

MATERNAL SIDE

On this side of the family, my ties to Iroquois County go back to 1884. My mother's family are more recent immigrants than is my father's family.

In this case, it was my maternal great-grandparents that came to this country as young adults from the Ost-friesland area of Germany. Their families settled on farms in the Minonk area of northern Woodford County where they eventually met and married. That would have been Henry and Hilke Gerdes Johnson. In 1884, at the age of forty-one, Great-grandfather Henry would purchase a farm in Danforth Township and move his family into Iroquois County Illinois. He and Great-grandmother Hilke (Gerdes) Johnson would raise seven boys and two girls on this eighty acre farm. One of those boys was my grandfather, Hannes Johnson. This farm was on the "Danforth Slab" four miles west of

town at the intersection of the slab and what is now County Road 300E. The eighty acres runs north and south and lies in the northwest corner of the above intersection

Great-grandfather Henry purchased the eighty acres in June of 1884 for \$1,600 or \$20 an acre. He paid \$100 down and took out a mortgage for the remainder. When it was sold at auction in February of 1934, it sold for \$8,200 or \$102.50 an acre. The farm was sold by order of the chancery court. The family of that purchaser, William Weerts, still owns the land today.

Even though eight thousand dollars was a lot of money in 1934, there were seven surviving siblings and nine survivors of a deceased sibling to inherit. The eldest girl was dead (with the nine children to inherit)) and the

other girl was dead with no children surviving. After court costs and lawyer fees, the total inherited by each heir would not amount to very much. But, in those times, cash was cash.

The sale came about because some of the heirs wanted their share of the money immediately, rather than share in the proceeds of the farm under family management. It was well into the depression years and that was likely the motivation to sell even though others did not want to sell-hence the lawsuit as several heirs persevered and forced the issue into court,

Tales are told in the family of the strict German matron with the iron will in the form of Great-grandmother Hilke. She ruled the family. Grandchildren were almost fearful of going to her house. In the orchard, apples on the ground could be picked up and eaten, but woe to the child that picked one off the tree. Still, she frequently sent fresh-baked pumpernickel bread home with the grandchildren.

In 1917, twenty-six year old Grandfather Hannes left Danforth to join the Doughboys of W.W.I in France. But before he did, he met and married Gaynel Talbot from the Dixon/Sterling area of Illinois. Grandfather would go to that area fairly often to help one of his brothers who lived there. Gaynell was one of the local girls.

Grandfather Hannes returned in 1918 to greet his newborn son and first child, Alfred. The family would live on several different tenant farms On one of these farms was born a second child, Lorene, my mother. The family eventually rented the "Kuiper place" just three quarters of a mile directly south of Hannes' parents on today's County Road 300E. Here they would live for a decade or more through the 1920s and early 1930s.

It was on this farm that the rest of the children of Hannes and Gaynel would be born, a girl, Eileen, and two more boys, Lowell and Hannes Jr. Mother tells about all the kids trekking down the road three quarters of a mile to attend the Shule School for eight years. The oldest, Alfred, rode a horse, but the rest had to walk. Talk about perks.

Life on this farm ended with the move to a tenant farm east of Onarga in 1935. The four younger children would attend Onarga schools for one year. Lorene, the second oldest, was a member of the freshman class.

1936 saw the next move of the family. This time it was to La Hogue, a tiny unicorporated community one mile north of U.S. 24 and five miles west of Gilman. The children would all marry from this house and my grandparents would continue to live here until they moved into Gilman on South Thomas Street in 1966.

It was at this La Hogue house that my brother and I

spent half of our summer vacation. Since I was the first grandchild on this side of the family, I was adored and spoiled by my grandmother Gaynell.

I remember she was terrified of electrical storms, in part because three really huge cottonwood trees stood very close to the house. One or another of those trees usually took a lightening strike in a storm of any severity. She feared the house would be next.

One of the fun things I enjoyed doing here was playing with the "wheelie thing." Two spoked, four foot diameter steel wheels were connected by a four or five foot axle. That meant one could not grab hold firmly as the axle turned with the wheels. Holding lightly, I then ran for all I was worth with the wheels buzzing merrily on either side of me. Hands heated up towards blisters, forcing a rest before running off again.

Aa "townies" in Morton, it was fun for us to drink from the artesian well out by the wash house. It was the only source of water for the house at that time. It was also fun, different anyway, to use the outhouse occupying one end of the cob shed. We did not have to use corncobs, but we did use the old Sears catalog! There was the ubiquitous chamber pot for overnight use. I suspect it would not have been quite so much fun had we been forced to live with these conditions all the time.

Also, brother Darwin and I were there in high summer time. Mother told us of waking up in the upstairs bedrooms in winter with a thin layer of powdered snow on the bedcovers and frozen water in the basin and pitcher. The only heat in the house was the kitchen cook stove and the parlor stove. Two of the bedrooms had floor vents to admit some of this heat, but the fires were banked for the night and not much heat got upstairs, at least not for long as the fire cooled.

Grandfather Hannes would live a little less than two years after the move to Gilman. He would die in March of 1969, at age seventy-seven and only get to see my twin sons, the first great grandchildren on this side of the family a couple of tinesl Grandmother Gaynell would adore those two boys in the years she had left before she died in 1977, at age eighty-one. We brought them to see her quite often. She loved to sit in the porch swing with them and gently swing with one boy on either side of her.

As I related above in the paternal section, my mother Lorene, would marry my father, Raymond Evelsizer, from this La Hogue house in 1940 and within two years, move to Morton.

And me? Well, I grew up in Morton, attending school there from first grade through twelve. I attended ISNU in Normal, obtaining my B.S. in Education in 1962, and my

Masters in Social Science in 1969. My teaching career at Fairbury-Cropsey High School in Livingston County, began that fall. That career ended in retirement thirty-two years later at the same high school, but by then known as Prairie Central High School. My wife and I have resided in the Fairbury-Forrest area since 1963 and in our current rural Forrest address since 1970. But I have very deep roots in Iroquois County

EVILSIZOR, Logan Ray, son of Steve and Christie Evilsizor was unexpectedly taken to be with the Lord the morning of Jan 11, 2007. Although not carried to full term, Logan Ray will forever be cherished by his parents, family and friends. There will be no services.

(I have 3 Steve Evilsizors in my database, so don't know which is married to Christie.)

Eliza Evilsizer age 69 died May 3, 1915 in Athens State Hospital. She was single and names of her parents are not on this death certificate.

Hazel Downard was born Jan 31, 1093 in Wellsville, Ohio, the daughter of Robert Downard and Anna Evilsizer. She died Columbiana Co, East Liverpooll OH April 26, 1941 as the wife of Howard Fisher. In 1910 there is no record. In 1920 in Columbiana Co, Ohio Hazel Downard, age 17 is the foster daughter of Lee and Elsie Herbert.

Ft Worth Register Feb 8, 1902—Indiana—After living for 99 years and 11 months in Indiana, Mrs Rebecca Evilsizer committed suicide. No reason given for this act. But it is supposed she was afraid the newspapers would go to printing her pictures as sonn as she got to be 100 years old, (No Rebecca Evilsizer is found in the 1900 census in Indiana or any other state.)

May 31, 1909 Belleview News-Democrat Death of Woman in Doubt

Junction City Kansas May 31— The dead body of Mrs J H Evilsizer, wife of a well known business man here, was found on the banks of the Republic River near here. Death was due to a shot fired from a pistol found near the body. Letters left by the woman indicate that she committed suicide, but the respective positions of the body have induced the coroner to institute and investigation. (Possible wife of John H in Osage Co, Junction City KS, but he died before 1880, so it is not known why he is mentioned in the obit. Son Harry is single in this county and just a farmer. Harrys mother or father are not found in 1900.
