

Joseph M. Franklin (Chickasaw)

The subject of this sketch was born at Milam, Missouri in Dec 1854. Joseph was the son of Edmond Franklin, of the earliest settlers of Missouri and who came to that country with a little colony from Kentucky. Early in 1865 Joseph emigrated to Barnett County, Texas and in 1874 to Panola County, Indian Territory, where in the year following he married Tinnie Colbert, daughter of Sam Colbert, and by this union became a citizen of the Chickasaw Nation. After marriage Mr. Franklin started farming in Pickins County, close to Berwyn, which place he parted with on the death of his wife in 1877. Moving to Panola he soon located at Pleasant Valley, where he now resides. In 1880 he married Eliza R. Shelton, daughter of J. J. Shelton (one of the earliest of Texas pioneers) and in 1884 was elected member of the House of Representatives, where he served honorably and intelligently for three terms and was again re-elected in 1889. On this occasion, however, he served but eleven days, until he was expelled from the House as a disfranchised citizen. In 1889 Mr. Franklin was a candidate for attorney general, and received the popular vote, but was counted out by the opposite faction, and his place filled by Ben Kemp. On July 21 last, at the progressive convention held at Tishomingo, Joseph Franklin was once more nominated as attorney general, and it may be added that no man in the Nation is better adopted to this responsible office than the present nominee of the progressive party.

Judge J. H. Franklin (Chickasaw)

This gentlemen was born in Jan 1835 in Boyle County, Kentucky close to Perryville. In 1858 he married Martha A. Quick, of Laclede, Missouri who died in Aug of the following year. In 1859 he went to the United States Fair at St. Louis and purchased a large stock of jewelry, which he sold afterward at a large profit in Sherman, Texas in 1860. He left Sherman with W. H. Russell, Major Timmons and Capt. Chapman to inspect the land that was sold in behalf of Texas in the Panhandle Country, and put in the season with the Comanches and Apaches, who at that time were friendly. Besides Albuqurque, El Paso and San Antonio, he wintered at Whitesboro, and in the spring of 1861 taught school at Denton. He joined General Cooper's command at Webber's Falls; was taken sick and got a pass to Burnet County, after which he joined Dorban's Frontier Reserve. He married Annie Crawford while in Burnet County and moved four miles west of Denison; then moved to the Coffee farm, near Preston Bend, where he buried his wife and child in January, 1872. In 1873 he married Martha A. Love, widow of Frank Love and sister of Col. Lem Reynolds, leader of the Chickasaw Battalion.

Mr. Franklin states that there had never been any trouble at any time in the Chickasaw nation until Governor Overton created it by raising the permit money from twenty-five cents to twenty-five dollars. In 1884 he was elected County Judge, but since the expiration of his term has not been a candidate. He has about two hundred and fifty acres under cultivation and employs about twelve work hands annually.

Throughout his life Judge Franklin has been a great sportsman, and at present keeps a pack of fox-hounds and a complete equippage of the chase. In 1872 he entered Masonry, and holds the diploma of the Palm and Shell. He has had six children, only two of which are living, a son and daughter.

Edward Q. Franklin (Chickasaw)

Edward Q. Franklin was born in Lynn County, Missouri in 1859, being a son of Judge J. H. Franklin, of Buckhorn Grove, Panola County. Edward was raised by his grandmother, after his father had departed for the Indian Territory until the year 1873, when the young man came to Panola and sought the home of his

father. In 1883 he married Louisa Calhoun, daughter of Johnson Calhoun, who was murdered in 1881 by unknown parties. After his marriage, Edward Franklin opened a farm of one hundred acres, where he is at present residing. In 1888 he was nominated for constable of Panola by the progressive party, and duly elected, serving until the supreme court decided that none but citizens by blood were qualified to hold office. To this effect he received a notice from Governor Byrd in Oct 1889. E. Q. Franklin's wife has a pair of Chickasaw scissors which belonged to her great, great, grandfather, and which were manufactured by a member of the tribe in 1750, 140 years ago.

Cherokee By Blood

The following information was extracted from Applications filed in the U. S. Court of Claims 1906-1910; *Cherokee By Blood, Records of Eastern Cherokee Ancestry* compiled by Jerry Wright Jordan (1987), published by Heritage Books, Inc. 3602 Maureen Lane, Bowie, MD 20715. The entire collection is in the personal library of Elaine F. Giddens, Rt 2, Box 212, El Campo, TX 77437.

- Henry Franklin full blood Cherokee married Betty Gibbs, a descendant of Sawnooke (Misc. Text page 637 Application #21178). Henry was raised in Burke County, North Carolina. His son:

Henry says that his family had always passed as white people. He also states that he had heard that there was an ancestor by the name of Gardner Green but did not know the relationship.

According to other Applications the Gardner Green (born 1718/1738; died 1835) mentioned above was married to Margaret Coil, a Cherokee Indian. Gardner had a sister Susie who married a Smith. Gardner Green (Application #315) was enrolled in Rocky Creek, Georgia 1835. He went from Clinton County, Kentucky to Fannin County, Georgia in 1832-33 to make treaty and never came back. Fannin County, Georgia is in the upper part of Georgia on the border of North Carolina and Tennessee with South Carolina connection to the East.

Gardner Green's children:

John's Will: "I John Franklin of Nicholas County, Kentucky, do hereby make my last will and testament in manner following that is to say.

1st: I desire that after my decease all the perishable property or part of my estate, be immediately sold and out of the moneys arising therefrom all my just debts and funeral expenses paid and of the balance of sale money, I desire my daughters, Anna Myers, Christana McDannald, and Hannah McDannald to have equal shares, paid to them in money by my executor unto Anna and Hannan and unto Christina in store goods by my executor so soon as her share comes into the hands of my Executor.

2nd: I desire further that all my lands of which I am possessed, into the possession of my FFRU Volume 12 - Page 8 (2nd Edition)

son, Frederick at my death.

3rd: I desire and direct that my son Frederick pay unto my daughter Anna fifty dollars one half within one year from my decease and the other one year after that again.

4th: I direct that out of the money made by the sale of my property as before directed one dollar be paid to William Flora by my Executor.

5th: I direct that my dear wife, Nancy remain if she chooses in possession of my dwelling her lifetime or to dispose of her thirds both of the land and personal property as she pleases.

6th: And lastly, I do hereby constitute and appoint my friend Robert West, Executor of this my last Will and Testament hereby revoking all other or former Wills and Testaments by me heretofore made. In testimony Whereof, I have hereunto set my hand and affixed my seal this 22nd day of May, 1834. Signed John (X) Franklin in the presence of John Franklin, Jr. and Robert West. Franklin, Littleton Purnell, son of Henry and Mary (Purnell) Franklin, was born 18 January 1831, at Berlin, Worcester County, Maryland. His father and mother were natives of Maryland, and both of English descent. His father was a farmer, and a man of high standing in the community, having been called upon to fill several public positions, and chosen as one of the electors for the election of United States Senator. Mr. Franklin attended the public schools in his native country until the age of fourteen, when he went to Bridgeport and studied at the boarding school of the Rev. Henry Jones, preparatory to entering upon a collegiate course. From there he went to Yale College, entering the third term of the freshman class, and graduating with honor at that institution in the year 1849. He then read law with Judge John August 6, 1994. Franklin, recently deceased, of Snow Hill, Worcester County, Maryland, and was admitted to the bar in the year 1852. Being in delicate health in early life, he never entered upon the practice of his profession, and his time has principally been employed in farming. He has been School Trustee for many years; Director of the Wicomico and Pocomoke Railroad; was a member of the Convention of 1867, that framed the present Constitution of Maryland; was elected member of the Maryland House of Delegates, on the Democratic ticket, in 1871; and elected to the Senate in 1877. He was married in his twenty-second year to Miss Sarah E. Chaney, daughter of Thomas and Emily Chaney of Issaguina County, Louisiana. He is a member of the Presbyterian Church, and has for many years filled the position of church trustee, and in every position which he has been called upon to fill, has performed his duty with credit to himself and his constituents.

Franklin, Hon. John R., was born 6 May 1820, near Berlin, in Worcester County, on the old ancestral estate, on which had lived three Henry Franklins of succeeding generations, his father being the last. Mr. Franklin's father was a prosperous farmer, a man highly esteemed throughout the country. He had been a Major in a regiment raised for a home guard in the war of 1812, and was called Major Franklin through life. His death occurred when his son John was about sixteen years of age. The mother of the subject of this sketch was Sarah A., daughter of the Rev. John Rankin, a Presbyterian minister, at one time settled in Berlin. Mr. Franklin was educated at Jefferson College, Cononsburg, Pennsylvania. He entered the Junior class when he was only fourteen years of age, and graduated at sixteen, in the class of 1836. He was considered too young to commence his professional studies, and was appointed a teacher in Washington Academy, near Princess Anne, a popular classical school of that day. He taught two years, after which he commended the law at Snow Hill, under the late Judge William Tingle, who was then on the bench. He was admitted to the bar on his twenty-first birthday, entered upon a profitable practice, and was appointed State's Attorney; but in a short time resigned the office, as it interfered with his civil practice. He participated in nearly all the prominent lawsuits which occurred in his county while he was at the bar. In 1843 he was elected to the Legislature of his State, and again elected in 1849, when he was chosen Speaker of the House. He was, for two years, President of the Board of Public Works. In 1853 he was elected to Congress as a Whig. His party being greatly in the minority, he declined a re-election. In 1864 he was a member of the Chicago Convention, which nominated George B. McClellan for President, and was a delegate to the great Wigwam Convention, which met in Philadelphia in 1866. In 1865 he was elected Judge of the First Judicial Circuit of Maryland, was commissioned, and took his seat upon the bench, but his election was contested before the Legislature by his competitor, Judge James A. Spruce, who succeeded in this claims. After the change in the Constitution in 1867, he was again elected to a seat on the bench, which he retained the remainder of his life. As a Judge he was able, upright, and pure, just and impartial, yet merciful and kind. He was one of the pioneers in the enterprise which resulted in building the railroad through Worcester County, which now terminates at Franklin City - named in his honor - in Accomac County, Virginia. Judge Franklin was a member of the Masonic Society, and belonged at one time to the Evergreen Lodge in Snow Hill. He attended the Presbyterian Church, was deeply interested in its welfare, and contributed liberally to its support, but never made an open profession of his faith. After the dissolution of the Whig party, to which he had always been attached, he allied himself with the Democracy. He was married, in 1847, to Annie F., daughter of the late John P. Duffield, of Snow Hill. She died in 1863, and five years later he was united in marriage with Kate Martin, a granddaughter of the later Dr. John S. Martin. Her death occurred in October, 1877. She left a son eight years of age. Judge Franklin died 11 January 1878.

There were 54,636 applications for pensions filed with the State of Texas based on service in the Confederate Armed Forces during the Civil War. The applications were not only for service in Texas organizations but were for service in many Confederate units and organizations. Most of the Confederate States provided pensions for Confederate veterans and widows based on service and disability, including the states of Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, Missouri, North and South Carolina, Tennessee, Texas and Virginia. The payment of pensions was usually reciprocating between these states. Most of his adult life was spent in Brown County, Texas. He married in Louisiana to Nancy Jane Pugh (born 28 Dec 1852/56 Louisiana; died 9 Nov 1936 Keene, Texas) daughter of J. P. Pugh and Mary E. Pugh.

At one time they lived in Rapides Parish, Lousiana. Was in the Confederate Army at age 14 with 2 older brothers; enlisted 12 Nov 1864 and served 6 months 18 days.

Shortly after the Civil War Thomas and Nancy Jane married and took a trip to Brazil. They went to see

friends. Ben had typhoid fever. Thomas was timid and Nancy talked a lot. Nancy would put food on his plate; heaped; he said that was too much. He was left handed. After his death, Nancy moved to Wells southeast of O'Donnel and stayed with her children. On Saturday she got dressed and just sat on the Sabbath; fussed at her daughter-in-law for working on Saturday.

(Before this could go to press, Liz found the death certificate of Thomas Benjamin Franklin. It says he was born in Georgia. His parents were Theodric and Betty (Berry) Franklin. Betty was born in North Carolina. According to North Carolina Marriage records published in Vol. 11 page 33 a marriage Bond #96875 dated 30 June 1832 (Orange County, North Carolina) is recorded for Theodrick Franklin to Elizabeth Berry. Bondsman Thos P. Berry and William Bowls; Witness J. Taylor /editor).

Recently made a new discovery about the Kanawha County Franklins (1840-1900) I wanted to share with you.

Research now shows that John W. Franklin (1781-1861) came from Nelson County, Virginia into Kanawha County by 1830. All of his children were born in Nelson County.

A Power of Attorney dated 2 Nov 1835 given by John Franklin in Nelson County Deed Book #8, page 180 states his wife, Sallie Franklin is daughter of Thomas Bondurant, dec'd of Buckingham County.

Nelson County Will Book A page 277 dated 27 Sept 1813 John Franklin gives Bond acting as Administrator for Robert Franklin, deceased.

In Prince Edward County records about 1795, Robert Franklin of Charlotte County mentions "my beloved son, John Franklin."

After a decade or more of looking for the father of John Franklin, I feel that he IS this Robert Franklin of Nelson County.


