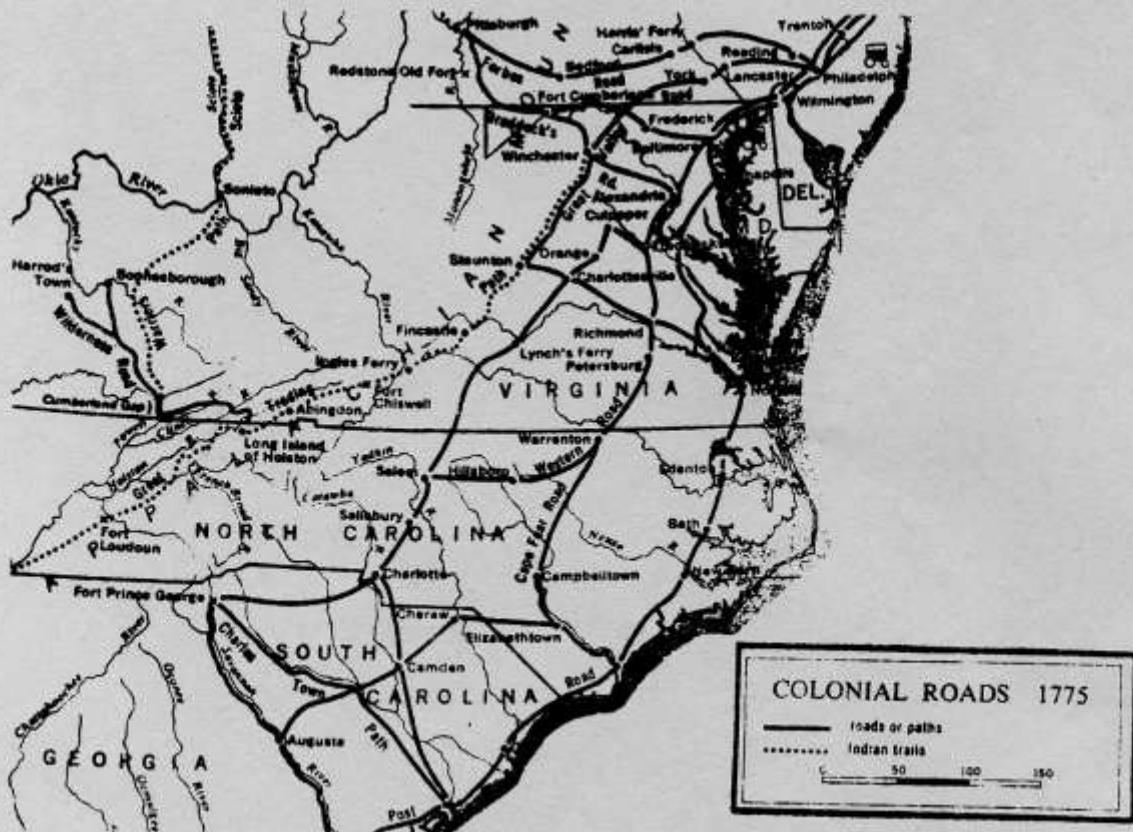

There were 8 children: Elizabeth, b. 24-7-1840; Wm., b. 31-7-1842; Melinda b. 23-4-1844; Emma, b. 31-5-1847; Charles, b. 7-4-1850; Albert, b. 1-12-1851; Mary, b. 1-3-1854; Ellen, b. 21-4-1857. This family was in the 1840 census, living in Pendleton, Niagara Co., NY.; on 1850 census in Vienna, Oneida Co., NY.; and 1860 census of Royalton, Niagara Co., NY.

Elizabeth HAWKINS m. 1774 (?) to Enoch DAVIS, Sr., b. Feb. 14, 1740, in/near Philadelphia. Enoch d. in Wash. Co. IN. in 1837. At least one son, Enoch, Jr., m. in Grainger Co., TN. in 1798, and then lived in Guilford Co., NC before moving to Salem, IN.

A will of Arnult Hawkins, d. 1762 in Chowan CO., NC., listed heirs, Mrs. Jane Bell, Robert, and Elizabeth. Elizabeth Hawkins Davis had at least 3 children, Elias, Abner, and Enoch, Jr. Enoch, Jr. had 10 children, 2 of whom were named Jane and Robert, and also an Elias. This does not mean that Arnult is the father of Elizabeth, but it the evidence that I have at this time. ....Any information appreciated.

### Bits and Pieces of the Hawkins Family Puzzle

Elisha Hawkins, son of William Hawkins and Elizabeth Wall was b. ca 1752 in Orange, CO., VA. He married Elizabeth Edwards, the dau. of Uriah Edwards and Mildred Head of Spotsylvania, CO., VA. Elisha enlisted in the Regular Army in 1776 under Captain Francis Taylor. He served for two years and belonged to the 2nd Virginia Continental Regiment. He was discharged at Valley Forge. Elisha and Elizabeth had four children: Elisha, Jr., Moses, Frances and John Carlostin.

Elisha moved to Kentucky and it is thought that Elizabeth did not accompany them. It is not known if she died or just didn't want to leave Virginia. Elisha married Rachel Scandlund in Kentucky where he lived before 1796 on Dry Run in Franklin, CO.

Elisha Hawkins Jr. son of Elisha Sr. and Elizabeth Edwards was b. in Orange CO. VA.

Moses Hawkins, son of Elisha Sr. and Elizabeth Edwards was b. in Orange CO., VA and moved to Franklin CO., KY. He married Sarah Steele ca 1819 and their dau. Elizabeth was b. ca 1820. Elizabeth married Lawson F. Noel in 1859 in Woodford, CO., KY and she had a dau. Frances Noel b. ca 1861.

Frances Hawkins, dau. of Elisha Sr. and Elizabeth Edwards was b. ca 1779 in Orange CO., VA married William Barnes ca 1798 in Culpeper, CO, Va ca 1798. They had 9 children: Hawkins, Richard, Leland, Ellen, Patsy Evtack, Malinda and Frances.

John Carlostin Hawkins, son of Elizabeth Edwards and Elisha Hawkins was b. in Orange, CO., VA. He married Melissa Barnes and they had a son Jeremiah Vardiman Hawkins, b. March 8, 1811 in Mercer CO. KY.



William Hawkins Sr. was the son of William Hawkins and Elizabeth Wall of Orange, CO., VA. He was b. there ca 1760 and married Mary---. Their children were: Jehu Dyer, Tabitha, William R. (Red Head Billy), Azubah and Annie.

William's second wife was Ann Bohannon Smith, whom he married in Culpeper, CO., Va. They were married by Nathaniel Sanders. Their children were: Smith, Agnes, Lucinda, Elisha Commodore, Sally, Juretta, Joseph Franklin, John Scott and Virginia Ann.

There was a mulatto son named Menoah, b. prior to William's marriage to Ann Bohannon Smith. On the Property Tax List for Culpeper, CO., VA of 1783, William Walker, Gent., listed Menoah as a "Tom". William remembered Menoah in his will but his name was erased from the Family Bible. It was rewritten in the Bible later.

Information on this branch of the Hawkins family is from Mrs. Dorothy Rutherford, of Frankfort, Ky., Mrs. Jean Abrams, a descendant of Sarah Hawkins Hayden and Mrs. Anita Hannah, a descendant of Elisha Commodore Hawkins. Their information is from family tradition, the Steele, Hawkins and Onan Cemetery, The Onan Family Bible, Franklin CO., KY Marriages by Ellisberg, Census Records, Franklin CO. Death Records, Bible records found th the Franklin CO., Historical Society Library in Frankfort, Forks of Elkhorn Church by Erma Jett Darnell and Franklin County Records at the Court House in Frankfort. Information on Mrs. Jean Abrams is on pg. 32.

John Dyer Hawkins, also know as Jehu, Jehudiah, Sebree and William Sebree may be the same person or several. The spelling for Dyer is seen as Dier and Deer. One of these men was the son of William Hawkins Sr. and Mary--- his first wife. He married Mrs. Mary Gaines in Jan. 1773 in Orange CO., VA. There will be more on this family later.

Tabitha Hawkins, dau. of William Hawkins, Sr. and Mary---, married William Foster.

Azubah Hawkins, dau. of William Sr. and Mary--- was married on Sept. 9, 1792 to John Long in Culpeper CO., VA. He was b. in 1750 and d. in 1820. Azubah married her second husband, John Craig in Kentucky.

John Long and Azubah Hawkins had children: Moses, William, Elizabeth, Susannah (Ann), Mary (Polly) and Rebecca.

Moses Long, son of John Long and Azubah Hawkins was b. ca 1801 in Kentucky and married Elizabeth Green, b. ca 1801 in North Carolina. Their children were: Cynthia, b. ca 1831 and mar. Joseph Settle on Mar. 30. 1852. The children of Cynthia and Joseph Settle were: Henry, b. ca 1853, George, b. ca 1857, John L. b. ca 1860, Joseph, b. ca 1869, Aggie, b. ca 1864, Mary L., b. ca 1864 and Millana F. b. Oct 1, 1850, d Oct. 15, 1856.

William Long, son of Azubah Hawkins and John Long was married on Mar. 29, 1826 to Lavinia Green b. ca 1811. Their children were : Moses b. ca 1830, azarby, b, ca 1833, Elizabeth b. ca. 1837, Julie, b, ca 1832, William, b. ca 1852, Martha b. ca 1836, Bella, b. ca 1857 and Jetta b. ca 1859.

Susanna Long married Samuel Bristow. She was the dau. of Azubah Hawkins and John Long. She married Samuel (who was b. ca 1798 -d. May 18. 1868) on Oct. 11, 1820. Their children were: William M. b. ca 1827, John, b. ca 1829, Benjamin, b. ca 1831, Mary J. b. ca 1830, Samuel P. b. ca 1834, Franklin and Francis who were twins b. ca 1843, Zulay b. ca 1837 and Demasthenes, b. ca 1840. Samuel Bristow died at Whitley Point, Moultry CO., Illinois on May 18, 1868.

Mary Long dau of John Long and Azubah Hawkins mar. Benjamin Long.

Rebecca Long, dau. of John Long and Azubah Hawkins m. Joshua or Josiah Green.



Elizabeth Long, dau. of John Long and Azubah Hawkins mar. William S. Hayden on Aug. 22, 1813 in Franklin CO., KY.

Moses Long and Elizabeth Green also had children: Agnes Rebecca b, ca 1835. She died on Sept. 11, 1855. of typhoid fever. . Leander was b. ca 1837.

Mary E. Long, dau. of Moses and Elizabeth Green was b. in 1829. She m. Lawson F. Noel and died of an abortion on Sept. 3, 1859. Lawson F. Noel later married Elizabeth M. Hawkins, dau of Elisha and Sarah Campbell Steele Hawkins.

Annie Hawkins, dau. of William Hawkins Sr. and Mary— was b. ca 1776. She married Edmund Scandland on Apr. 16, 1796. They lived in Franklin CO., KY.

William R. Hawkins (Red Head Billy) was the son of William Sr. and Mary— and was b. in 1776. In 1799, he married Hannah Clemmons who was b. in Pennsylvania. He died in 1854. Hannah was still living during the Civil War and when the Yankee soldiers came to their farm, she stood in front of the smoke house to stop their entry. She was thrown to the ground but, because the hams and bacon were hanging high in the room, they were not discovered. The Yankees took the apple butter instead.

William R. Hawkins and Hannah Clemmons had children: Fielding, Elizabeth, Mary B., Amanda, Emerine, Julia Ann, Thomas Jefferson, Ruth Ann, James C., William H. and Smith.

Fielding Hawkins, son of William R. Hawkins and Hannah Clemmons married —Coons. They had sons: James, Smith, Jefferson, and William. Fielding moved to Missouri.

Elizabeth Hawkins dau. of William R. Hawkins and Hannah Clemmons married Samuel Miles in 1825 in Franklin CO. KY. He was called "one eyed Sam",

Mary B. Hawkins, dau of William R. Hawkins and Hannah Clemmons married Daniel Epperson in 1825 in Frankfort, KY.

Amanda Hawkins, dau. of William Hawkins and Hannah Clemmons married John Scandland. He was the son of Ann Hawkins and Edmund Hawkins. Ann was the dau. of William Hawkins Sr. and Ann Bohannon Smith.

Emerine Hawkins, dau of William R. Hawkins and Hannah Clemmons married John Julian.

Julia Ann, dau. of William R. Hawkins and Hannah Clemmons married Wm. W. Wright.

Thomas Jefferson, son of William R. Hawkins and Hannah Clemmons moved to Missouri.

Ruth Ann, dau. of William R. Hawkins and Hannah Clemmons m. John B. Gaines in 1838 in Franklin, CO., KY.

William R. and Hannah's farm was on the Frankfort Lawrenceburg Road in Franklin County.

William Hawkins Sr. and Ann Bohannon Smith's daughter Sarah A. mar. Thomas Haydon. He was b. Oct. 13, 1795, they were married on June 22, 1814 and his death occurred between 1860 and 1864. His parents were James Haydon and Susannah Gore. Sarah and Thomas had children; Moses b. ca 1830, Sarah, bl. ca 1832 and Mary A. b. ca 1838.

Moses Haydon married Mary Webster and they had children: Annie L. b. 1852, William A. b. 1854, married Teresa Shaw ca 1877. George L. was b. in 1856. Sue P. was b. in 1858.

William Haydon and Theresa Shaw had children Mary, Mattie B. and possibly others.

Juretta Hawkins, dau. of William Sr. and Ann Bohannon Smith married Thomas Wallace on April 5, 1831. Their children were: James b. ca 1833, Reuben,



b. ca 1836, Sarah, b. ca 1838 and Nancy, b. ca 1841. Thomas Wallace was b. ca 1796 and his wife, Juretta was b. ca 1802.

Joseph Franklin Hawkins was b. ca 1803. He was the son of William Hawkins Sr. and Ann Bohannon Smith. He married Mary Ann Hancock, dau. of Benjamin Hancock on Aug. 30, 1824 in Franklin CO., KY. Their children were: Milcha, b. ca 1835, Adelia, B. ca 1839, Albert, b. ca 1841, Thomas B. b. ca 1843 and Joseph, b. ca 1846.

Joseph Franklin Hawkins lived in Owen CO., KY and in 1860 he married America ---. in the New Liberty area of Kentucky.

A descendant, Mary Etta Power (Mrs. Albert Smith) of Frankfort, KY has another list of the children. Her list is as follows: Joseph and Mary Ann Hancock's children were Bea, Seth, Rhoda, George Ann, Milkey who married a man named Glass, Adley, Albert and Joanna who was her ancestor.

At the time of their marriage, Joseph Franklin was 57 and America was 33. Their children were: Joseph, Henry, John W. Mary E., Edward, Samuel and Melinda.

Joanna Hawkins was b. Feb. 8, 1834. She married on Dec. 6, 1856 in Owen CO., KY William Washington Power b. Jan. 2, 1836 in Bath CO., KY. Joanna died on May 4, 1903 and William Washington died on Mar. 22, 1926.

It is thought that Joseph Franklin Hawkins and Mary Ann Hancock lived in Grotz, KY.

John Scott Hawkins, son of William Hawkins, Sr. and Ann Bohannon Smith was b. ca 1808 and d. Mar. 30, 1835. He married Virginia Ann Bryant.

Agnes, dau. of William Hawkins Sr. and Ann Bohannon Smith married Moses Hawkins, Jr. on Nov. 9, 1815 in Franklin CO.

Smith Hawkins, son of William Hawkins Sr. and Ann Bohannon Smith remains a mystery. There is no available information at this time.

Lucinda Hawkins, dau. of William Hawkins Sr. and Ann Bohannon Smith was b. ca 1791 and married Willis Bartlett on Oct. 9, 1816 in Franklin Co.

Elisha Commodore Hawkins, son of William Hawkins, Sr. and Ann Bohannon Smith was b. May 4, 1795 in Franklin CO. KY. He married Sarah Campbell Steele who was b. Mar. 12, 1800 in Greenbrier, CO. VA. Her father was Robert Steele and her mother was Jane Mc Clung. Robert Steele's mother was a Campbell. His father, Samuel Steele died in 1799 in Augusta CO. VA.

Elisha Commodore and Sarah had the following children: Robert S. was b. ca 1821, mar. Eliza Gault ca 1855.

Ann S. b. April 10, 1822, marr. William B. Onan on Oct. 16, 1849. She died on Mar. 29, 1891 and she and her husband are buried in the Steele, Hawkins, Onan Cemetery. Their great granddaughter is Anita Hanna of Raleigh, N. C. She is from Frankfort originally. She is married to Charles Hanna.

Elizabeth M. Hawkins, dau. of Elisha Commodore and Sarah Steele was b. ca 1824 and married Lawson F. Noel on Aug. 11, 1860. She was his second wife. He was the son of Rev. Silas Mercer Noel (1783-1839). Lawson Noel's first wife was Mary Long, the dau. of Moses and Eliza Green Long. Moses was the son of Azuba Hawkins and John Long. Azubah's father was William Hawkins, Sr.

Agnes Hawkins, dau. of Elisha Hawkins and Sarah Campbell Steele mar. Reuben Waites on Aug. 10, 1865. She was b. in 1826 and died in 1926.



Anita Hanna remembers her "Aunt Aggie" Waites when she was almost 100 years old. She remembers visiting her when she was very young and shortly before Agnes died. She was living with Willie Pope who was married to either her daughter or a granddaughter. He could also have been her grandson. They lived in a house located where the Trailer Camp is located now, on the Kentucky River, 7 miles north of Frankfort. Agnes is buried in the Steele, Hawkins, Onan Cemetery.

Mary J. Hawkins, dau. of Elisha C. and Sarah, was b. ca 1828. She married William B. Johnson on Dec. 23, 1875 and they lived in Franklin CO.

Samuel S., son of Elisha Commodore and Sarah Campbell Steele, was b. ca 1830 in Franklin County, KY.

John S. son of Elisha C. Hawkins and Sarah Steele was b. ca 1832 and mar. Susan Meany Johnson on Mar. 16, 1876.

Alice, dau. of Elisha C. Hawkins and Sarah was an Epileptic and was never married.

Charles, M., son of Elisha C. Hawkins and Sarah was b. ca 1836 in Franklin CO., KY.

Ellen C. dau. of Elisha C. Hawkins and Sarah Steele was b. ca 1838. She married A.G. Walthall on Dec. 20, 1859. Bk. 3, Pg 155 Franklin CO., KY. Another record shows that she married A. G. Walthall on Aug. 10. 1865 at the home of her mother Sarah Campbell Steele Hawkins. Wit: William Onan, John Downing and Robert Onan. A.G. was 21 years old and was from Paducah, Ky. He was b. at Mt. Vernon, Indiana. (Marriage Records, Franklin, CO., KY.) In 1860, the couple are living with her parents, Elisha C. and Sarah Hawkins. He is shown in the census as being 23 years old and Ellen as 21. In the 1870 census, Bettie B. Walthall is shown living with Ellen C. Walthall's mother. Elisha C. died Dec. 25, 1860. In 1860 Ellen is living with her mother but her husband and daughter are not shown. They had a son George who was b. Aug. 17, 1862 who died Jan. 14, 1863. He is buried in the Steele, Hawkins, Onan Cemetery.

Ellen was married again to J.O. Chambers, May 3, 1886 in Franklin CO. At the time of her marriage to J.C. Chambers, she was Ellen Sumners, a widow.

William C. Hawkins, son of Elisha Commodore and Sarah Steele Hawkins was b. ca 1842. He died in Mar. 1927. He was a "Captain of a Riverboat" and used to dock the boat near the Hawkins Property, and across the river at Onan's Landing. His sister was Ann Hawkins Onan.

Othello T. Hawkins, son of John Scott Hawkins and Virginia Ann Bryant was b. ca 1836. He had brothers, Lucian B. b. ca 1838, Walter Scott, b. ca 1843-44 and died on Oct. 17, 1855 of typhoid fever. Stephen B. Hawkins was another brother. He was b. ca 1847. There was a sister Sarah, b. ca 1842. Ann Bryant Hawkins died just 5 days after her son Walter. She also had typhoid fever.

What happened to Mary Hawkins, Watson, Markspile? She was the sister of William Hawkins, Sr. Elisha, Arculous, Reuben and John. A Hawkins family tradition says that "two sons (descendants) of Sir John Hawkins came to America in 17???. and settled in Orange, CO. VA. Their names were William and John. William lived to be 115 years of age. He died in 1789 on Dec. 31. He had sons, William, Reuben, Arculous, Elisha, John and a daughter Mary Fisher." Was Fisher Mary's middle name or did she marry a man named Fisher for her third husband?

FAMILY of MARY HAWKINS and DANIEL WINDLE

In our first issue, Christmas, 1986, the family group sheet for Joseph Hawkins and Sarah Marlin was published. Barbara Curry, a new subscriber, also descends from this line, through Mary Hawkins Windle, daughter of Joseph and Sarah.

Children on the following group sheet are not in birth order. Mary, #8, had daughter, Mary, mentioned in her mother's will in 1815. The line is carried back in N-Siegen Immigrants.

Andrew Moore Windle served two terms during the War of 1812, one from Cocke Co., TN., and one from Rockbridge Co., VA. Joseph Hawkins Windle served in the War of 1812 from Overton Co., TN.

Mary's will left Sally, #2, a house and land in Cocke Co., TN. There are none of these records in Cocke Co.

References: Swathmey (?) had Daniel taking his oath as Ensign of Militia, 28-5-1778. Daniel was still a tithable in Shenandoah Co., VA., in 1782, and was gone after that. He purchased 7 3/4 acres land in Feb., 1789, in Rockbridge Co., VA.; 2 acres in Oct. 1791; paid 5 pds. for 17 3/4 acres Jan. 18. Daniel sold 7 3/4 acres, Oct. 1799 for 5 pds. There is a grantee for 8 1/2 acres in 1805 for Mary Windle in Rockbridge Co., VA. Rockbridge Co. WB 2, pgs 429, 439; WB 4, pgs 135, 137.

PROOF THAT JOHN HAWKINS OF HANOVER CO., WAS SON OF JOSEPH  
HAWKINS OF SPOTSYLVANIA Co., VA. (John, h/o Mary Langford)  
by Joanna Neilson

John Hawkins is referred to as the son of Joseph in Cavaliers and Pioneers, Vol. III, p. 363. Two land patents are described:

"Joseph Hawkins - 670 acs (N. L.) Spot., County in St. George's Par. N. side of the N. Fork of the Northanna on the NE side of Hawkins' tract, & on E. side of a Beaverdam Run. 28 Sept. 1728. p. 421."

"John Hawkins, son of Joseph Hawkins - 620 acs. (N. L.), Spot. Co. in St. George's Par; N. side of N. Fork of North Anna (Riv) and on S. side the Riga, Adj. Capt. Jeremiah Clowder; 28 Sept. 1728. p. 425."

In the book, Orange County Land Patents, by Ulysses P. Joyner, Jr., Orange Co. Historical Society, Inc. 1985, Joyner places the location of these 2 patents issued in 1728. These were the only land patents in today's Orange Co. which were issued to Hawkinses, although Joseph also co-patented another one and let it lapse. Other Hawkins family members obtaining land in Orange Co., bought it from a previous owner.

In 1750, May 24, in Orange Co. Deed Bk. II, pp 196-197, "John Hawkins and Mary his wife of the Parish of St. Martin in the County of Hanover within the Colony of Virginia" sell to "Elijah Morton of the Parish of St. Thomas & the County of Orange" for one hundred and ten pounds Curr<sup>t</sup>. money of Virg<sup>a</sup>. -- "three hundred and fifty acres in the Parish of St. Thomas & County of Orange is part of a larger tract or parcel of land granted by Patent to the above said John Hawkins".

Two questions arise in my mind from the above information:  
1. How did Joseph Hawkins manage to get a land patent for his son John, when John was only 10 years old, if John was b. in 1718 as his family (descendants) say? 2. When was Joseph born in order to have a son born in 1718? Joseph is the Exr. of his father's will in King Wm. Co., but he has a son, John, b. about the same time that his father was still having children, i.e. Mary Craig, Philemon, Phoebe Smith & Eliz. Smith. Was Joseph s/o of Mary Long Hawkins or another wife? Were there other children b. between Joseph and the above 4 mentioned ones? The land settlements from the destroyed King William will don't show any distribution to other children, either in King Wm. or Spots. Cos.; but there was a John Hawkins who took the Pauper's Oath in King Wm. Co. in 1737 -- Not Joseph's father, as he was dead, prior to 1729/30. Even as late as 1784, there was a John Hawkins in Car. Co. On pg. 385 of Spot. Co. Records, by Crozier, "Augt. 3, 1784, John Mason of Spots. Co. and Anna, his wife of first part; John Hawkins of Caroline Co., Gent., & Anna Gabriela, his wife, of third part, to Thomas Towles of Spots. Co., of fourth part."

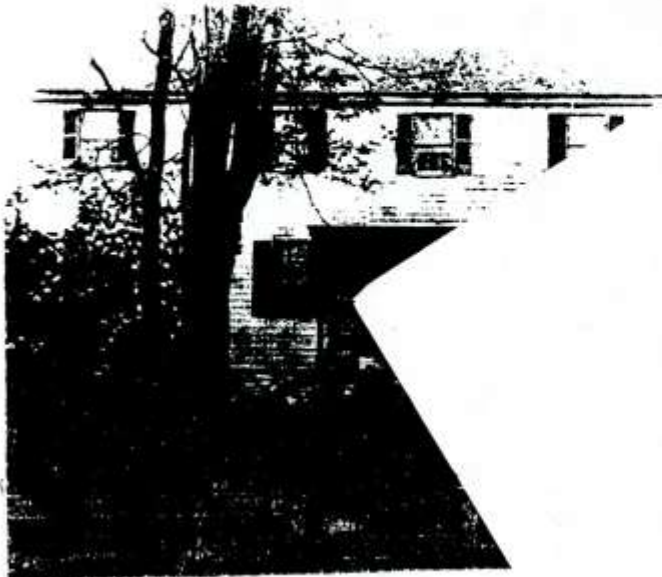

## HAWKINS and CROCKETT

In Notable Southern Families, Vol. 5, "The History of the Crockett Family", by Janie Preston Collup French and Zella Armstrong, there is a brief history of the Joseph Hawkins family. It states that Joseph, Benjamin, and Samuel Hawkins were three brothers who came to America in 1658 from England. They settled in Gloucester and Matthew Cos., Va., which was still a part of Maryland at that time. John and Phesa, two other brothers, arrived in 1691 and settled in Massachusetts. Phesa died soon afterwards.

The brother Joseph, b. 1712, m. Anneke Jane Edwards, in 1739. Their children were: Benjamin, Joseph, Richard, Samuel, Jr., Jane, w/o Col. Richard Campbell; Sarah, w/o Gov. John Sevier; Rebecca, w/o John Crockett; Susan, w/o Dr. Graham of Winchester, Va.; Mary, w/o John Byrd of VA.; and Caroline, w/o Mr. Wyndall of VA. John and Rebecca Hawkins Crockett were the parents of Davy Crockett.

MARY BATEMAN or MARY LONG  
Who was the wife of John Hawkins of King William Co.?  
.....An opinion by Joanna B. Neilson

In my opinion it is not Mary Bateman. Dorothy Wulfeck in her book, Hawkins of Virginia, 1962, tries to make a connection with Mary Bateman. One John Hawkins did marry a Mary Bateman in NC in 1701. Wulfeck states on p. 41, "In 1704 John Hawkins and wife Mary sold to Geo. Slade 150 acres in South Lancaster, N. C. The John whose will dated 8 Feb. 1716/1717 prob. 10 Apr. 1717 left a bequest, among others to 'Thomas, son of Joyce Hartshorne'. Our John Hawkins's dau. Mary named a daughter, 'Joyce'. The most noted Hawkins in N. C. in later years were Philemon Sr. and Philemon Jr. Our John Hawkins named a son Philemon and he lived in Spots. Co., Va."

This John whose will was prob. Apr. 10, 1717, can't be the same John as the one whose will was destroyed in King William Co., Va. Our John had a land grant of 510 a. in King Wm. Co. (today's Caroline Co.) in 1721. In 1725 he purchased 400 a. in Spots. Co. on both sides of Terry's Run from Harry Beverly. On June 30, 1726 our John of King Wm. Co. got a land grant of 400 a. on both sides of Terry's Run and on the N. side of the N. Fork of the N. Anna. He was dead prior to 1729 (1730).

There are several references in the Spots. Co. Court Order Books to a suit in which Mary Hawkins and Joseph Hawkins, Ex. of John Hawkins, sue Charles Goodall. The Court Orders are difficult to read, but Joseph and Mary finally won the suit. These COB records are not listed in Crozier's Spotsylvania County Records. The earliest record in this book, referring to "Mary Hawkins, widow of John Hawkins, late Decd., and Joseph Hawkins, George Smith and Elizabeth, his wife, and Phebe Hawkins to Philemon Hawkins, etc.", was on Oct. 7, 1740. p. 153 (Deed Book C, p. \_\_, 1734-1742). This is the date that several authors use as a reference when stating that John Hawkins died prior to October 7, 1740.

Mary Long Hawkins is listed in the Compendium of American Genealogy, Vol. VII p. 155, Ed. by Frederick Adams Virkus. Under the name FARNSWORTH it says, "6-Capt. Tolliver Craig (1704-95) posthumous son; b. enroute to America; of Spotsylvania Co. Va; Capt. Orange Co., VA. Militia, 1777; oldest defender of Bryan Station nr. Lexington, Ky.; m. 1730 Mary Hawkins (1716-1804; John<sup>7</sup>. of King William Co., Va. m. Mary Long; Sir John<sup>8</sup>; Wm.<sup>9</sup>, capt. R.N.):"

JOSEPH HAWKINS and REBECCA FUNK  
- submitted by Wanita Lucas

Joseph, son of Joseph and Sarah Hawkins, married Rebecca Funk. They had 9 sons, and probably daughters, although no record of them can be found in Shenandoah Co., VA. Joseph became the owner of his father's home (310 ac. grant) and the adjoining land on the east of the No. Shenandoah River. This land was purchased from Fairfax on May 5, 1753. The old home was just east of Hawkinstown on the farm which is now called "Beverly Farms".

Joseph lived in this old home with his first two wives. Around 1789, he is thought to have built a new house on his 562 acres across the river, east of Hawkinstown, and moved into this new home about 1799. This house is still in use and was owned and occupied by Thomas R. Fleming, in 1981.

The nine sons were: 1. JOSEPH - Mrd. Margaret Bird, his neighbor from Red Banks, 1 of the 5 daughters of Col. Abraham Bird and Rachel Ziegler Bird. Later Joseph and Margaret moved to Marion Co., MO.  
2. JOHN - Mrd. Mary Ann Pennywitt, and moved to Spring Valley, Green Co., OH. Had 6 CH: One son, Samuel, became a physician, and is mentioned in OH. histories. Samuel m. Mary A. Andrews, and had 8 CH., 6 of whom were Jennie, Permelia, Celia, Georgia, Addie, & John A. They were all born in Ohio.  
3. WILLIAM - Mrd. Lydia \_\_\_\_\_. They went west (where?)  
4. MOSES - Mrd. Betty Moore, d/o Lewis and Rosina Moore. They also moved west.  
5. MOUNCE - Mrd. Mary Allen, d/o Davis and Elizabeth (Antrim) Allen. They moved to Xenia, OH, in 1814, along with Mary's parents. CH: Reuben m. Lydia Fallis. Reuben d. 1870 and Lydia, 1894. Both buried in Woodlawn Cemetery, Xenia, Ohio. CH: Frank, b. 12-12-1841 at Xenia, and lived in the old home; Joseph G., killed in Civil War at age 20; Mary E. mrd. Preston Machael, d. 1901, leaving ch., Jessie and Harry; Hannah L., d. at 15; and James, d. in infancy.  
6. BENJAMIN - Mrd. Mary (Polly) Allen, d/o Lydia Moore Allen, who m. Joseph second. They remained in Shenandoah Co. Benjamin and Mary became large land owners. Had 2 daughters: Sarah Ann m. Wm. Keeran. Mary Cathy m. Daniel Peters.  
7. AARON - No record of a marriage, but he acknowledged sons, Aaron, Jr., s/o Jane Cully, & Joseph, s/o Rebecca Bird.  
8. JAMES - Mrd. Christina Roof, d/o Jacob & Anna Roof. No CH. Stayed in Shen. Co. Brd. in Hawkins Cem., Hawkinstown.  
9. SAMUEL - Mrd. Anna Allen, d/o Jos. & Eunice Rogers Walton Allen. Eunice was widow when she married Joseph. Joseph Allen had 8 or 9 children with his first wife, Ruth. He mrd. Eunice when he was about 60, and they had two children who lived to adulthood, and possibly two others who died in childhood (Rhesa and Anna).

## NGS CONFERENCE

RITA SOUTHER, a descendant of Isaac and Sarah Hawkins, spoke at the NGS Conference in Biloxi, MS., in April of 1988. Rita is patron services librarian for the Annandale, VA., LDS Branch Family History Library. She is also co-editor of "Lest We Forget: A Guide to Genealogical Research in the nation's Capital (6th edition)".

- - -

HELEN F. M. LEARY, past president of the NC Genealogical Society, also spoke at the NGS Conference. Her subject was "But How Do I Prove This Is The Same Man [Or Woman]". The outline of her speech was printed in the 1988 NGS Conference in the States, the publication presented at the Conference.

Mrs. Leary suggests that we try looking for a person, not a name. Our ancestors' backgrounds and surroundings help identify them - "friends, extended families, religious, social, and support groups".

Her comments draw attention to the fact that we may frequent-locate records, but hurriedly put them down on paper or into the computer, without taking time to really interpret what we have found. Finding the record is half of it, and "interpreting it" is the other half. She suggests that we "ALWAYS extend the search beyond the time frame of supposed marriage, death, or move [i.e, physical bodies cannot be in two places at once; dead men don't marry or sell land]."

Mrs. Leary says that "When all else fails: a. Reevaluate all sources (the compiled genealogy or great-grandmother's letter may be wrong); b. reexamine all assumptions.....(the man who 'died' in SC may be alive and well and begetting children in KY); c. Recheck all research notes; and patiently assemble the whole family and/or neighborhood." And finally, "the weight of evidence (not the number of records) may identify the ancestor. A preponderance of the evidence proof cannot be used unless the quality and extent of the research on which it is based justifies it."

## THE "R's" HAVE IT

JAMES HAWKINS was born ca. 1765 in VA., according to my gr grandparents' Hawkins Family Bible. James and Margaret had at least five sons: William R., John R., James R., Moses R., and Walter R. The middle initial?! No record of marriage, land, or will, lists a name - just an "R". Perhaps a surname from their mother's line? Perhaps for no name at all?

The Hawkins Bible lists James R.'s birth and death dates (1794-1834), but not a marriage for him. He lived in Clark Co., KY., during the 1820's, and although a James R. Hawkins and Caza Wilcockson were married there in 1822, this was not proof that he was the James R. of the family Bible.

In January, 1988, I heard from David Dye of Flemingsburg, KY., who is a descendant of Moses R. Hawkins. I have researched the War of 1812 only minimally, but military service records are of interest to David. The three older Hawkins brothers would have been of age to serve in the War of 1812. In continuing his search for possible service records, he found that James R. Hawkins died in Bourbon Co., KY. in December of 1834, the same date as in the Bible. He did indeed serve in the War of 1812 in the VA. Militia for a month in 1814, and was honorably discharged. His widow, Cusiah/Caza (Wilcockson), never remarried, and made the sworn statement in the Fayette Co. Court in 1856, that she once heard her husband say that he put the "R" in his name himself. He did not want to be confused with all the other James Hawkins, so he used the "R" for that purpose. She didn't know if the "R" was on the original Muster Roll. It was not. Caza rather thought that "James put the initial in his name after he moved to KY."

Is anyone wondering if ALL the brothers Hawkins decided the same thing? (.....You know, a rose is a rose is an R.)

Caza also mentioned in her statement, that she remembered James' saying that he was from Stafford, and/or Orange and Fauquier Cos., VA. This goes along with the KY vital stats that another brother, Walter R., was born in Stafford Co.

William R. Hawkins volunteered as a substitute for William M. Henderson in the War of 1812. He served as a private in Capt. James Dudley's Co., 17th Regiment of the KY. Volunteer Militia, commanded by Lt. Col. John Francisco; and was honorably discharged at Urbana, Ohio in March 1815. He served in Feb. and March of 1815. This information was registered by the Bath Co. Clerk on Nov. 12, 1853. On June 25, 1855, William R. appeared before the Fleming Co. Clerk, applying for Bounty Land. Robert and Andrew Nickell claimed upon oath that William Hawkins was who he claimed to be. Moses R. was about two years old when William R. and James R. served. He

was later to marry Melvina and Martha Jane Nickell, sisters of Robert and Andrew Nickell. This information already provides more clues for descendants of this Hawkins line.

There are those of us who have visited this quiet place, hoping that with one wish on a star, it could be a clear and lovely spot for our ancestors. On Christmas Eve, 1987, someone did more. Robert Hawkins and family were in Franklin Co., IN in April, 1851 when William Hawkins was born. They were not on the 1860 census for Franklin Co., IN, and were not found on the 1860 record for Paulding Co., OH (at least half of the census record for Paulding Co., OH in 1860 is illegible). The data on the 1850 census for Franklin Co., IN agree with the data shown above.

Robert Hawkins enlisted in the army 28 Dec 1863 at Antwerp, Paulding Co., OH. He mustered in 28 Feb 1864 at Columbus, OH, and was a Private in Co. C, 68th Regt., Ohio Volunteer Infantry. He was killed in the "Battle Before Atlanta", 22 Jul 1864 by being "shot through the head above the left eye and died instantly."

Mary Ann Jones Hawkins married Zephaniah Bell 26 Jan 1873 in Antwerp, OH.

DID YOU KNOW?: The 1787 Census of Virginia (WV and KY), compiled by Netti Schreiner-Yantis and Florene Speakman Love, is now available. It lists every tithable white male over 21 by name, not just heads of households. In many cases, perhaps a son between 16 & 21 whose name is listed, shows his tax to be charged to a person, who might show relationship of father to son. The 2,000 pages include all the taxation data of the period. Many libraries will have this set. ....Olyve

## A SPELLING BEE (...and a little more)

In looking for the name of your ancestor, be sure to look for the various spellings. H-a-w-k-i-n-s: Let us count the ways. Most of us have searched for a James, William, Moses, or Augustine, long enough to find them as Hawkings, Hockins, Haskins, Hankins, and many more variants. If the census-taker or clerk looped the "t" in Shults, and crossed the "l" as well, then in one wave of his pen, our ggg gf very easily became "Shutts". An ancestor married Amey Satterwhite in Tennessee. Not according to the marriage bond. She was Amey Lotta White!

Taxation records are invaluable, especially in burned out counties. Your ancestor may be found on this list when he was left out of the regular census records for 30 years! Beware of what the taxable age for males was in that particular county and time period. That is important, and can be found in SWEM, for the state of Virginia. (They could be as different as area sales taxes are today.) If a John Hawkins was taxed on 7 slaves one year, he was not on the list the next year; but Martha Jane Hawkins' name appeared with 7 slaves, consider that Martha was John's widow.

Deeds are often not given enough prominence in our research. It's a hope that we might find an ancestor's will that provides all the information that we need in identifying the family. If a will just isn't there, really search for a deed. Once you find it, the land might be divided among the listed "heirs" and not the hoped for term of "children", but even still, that's a plus.

Don't overlook the Masonic Lodge records in various areas. There were literally thousands of members from 1800-1850 in the state of Kentucky. Certainly if your ancestor had a masonic marker on his gravestone, further information might be found in the Lodge records. And finally, don't forget to stop by the area libraries in the little towns whose court houses you visit. You might ask the Librarian if there are any family files or church records that are not on the shelf, but that would be available to you. It's worth a try.

My ggg gf, George Hallmark, was the Clerk of the little Baptist Church in Grainger Co., TN. in 1794. Those church records, including all the minutes that he wrote over several years, are in the McClung Library - not in the Court House. The records included why an individual was not in his chair at the last meeting. Was his reason valid, and excuseable? Would they continue to remove their shoes for washing of feet? Whose turn was it to sit by the door with musket in hand, in case of an attack? Why not check into church records of your ancestors? .....Olyve H. Abbott

Following are brief outlines of some Hawkins wills made in Virginia, prior to 1800. The wills are outlines, but they do include all names mentioned, including witnesses. In Virginia Wills, by Torrence, the author lists the name of the person whose will, estate settlement, or inventory was made prior to 1800; and in which county said document is found. The sources for the documents themselves are the County Court Houses of Virginia, or the Virginia State Library.

Abbreviations: i: inventory; w: Will; Inv & App: Inventory & Appraisal; WB: Will Book; Rec: Recorded; Pro: Probated.
