

Message from the President

Dear Hawkins Cousins and Friends,

Once again we have Olyve Abbott to thank for putting together this fine issue. We now have 37 member/subscribers and while this issue is at the printers I will be preparing to send away our first newsletter donations.

A copy of all the issues to date will be donated t the largest microfilm library in the world which is The Family History Center of The Church of Jesus Christ of Latter-Day Saints. This will allow the widest possible circulation of our newsletter as all the hundreds of branch genealogical libraries around the world will carry "Hawkins Heritage" in their Surname Catalog and Author/Title Catalog. The public will be able to read our newsletter by ordering a microfilm or a subscription from us.

We will donate one issue to the Library of Congress. If they select our newsletter they will put it in the Library of Congress Catalog which is sent to thousands of libraries throughout the world. We may have to give them a complete subscription to do this; I will see what can be worked out. We will donate one copy each to the Virginia State Library, The Kentucky Historical Society, and the Dallas Public Library. Hopefully this will help more interested people to be able to find us and share information.

Health problems have continued to plague me and I have not been able to do hardly any research nor fulfill my position as president of the Hawkins Family Organization. I still hope to recover but don't know when. I am no longer able to work. December has been the most frustrating month of the year because I want to do the familiar fun Christmas activities but am too slow to do much. Our newsletter arrived for completion at this time, as did the current flu bug, so this issue has been delayed.

I have been disabled by health problems for a year and a half now and have seen local medical people of all sorts and gotton worse. Finally I got a diagnoses by going to a clinic in Tijuana Mexico. Four Hawkins cousisns I know of have been to clinics in Mexico and three of us went to American Biologics. I was very impressed with the hospital, the staff, and the diagnostic and treatment services. They offer much that is not available in the U.S. and Canada due to our restrictive regulations. They can completely turn around many people with degenerative diseases like cancer and arteriosclerosis or with difficult viruses like Epstein-Barr and AIDS. My root problem is an old head injury that reasserted itself during illness began depressing normal functioning. Although I have improved in some ways it is not known when my performance will return to normal. Now, however, with a proper diagnoses, the local medical people are able to work with it and I know to rest. For the new year I need to concentrate on regaining my energy and strength and hope to have time again for my favorite activity, family history.

Before anyone accepts his health problem as incurable or untreatable I want you to know that there are alternatives. He was buried in Harris Chapel Cemetery with wife, Elma Jane Freeman, b. 23-2-1846, d. 11-7-1934. Another daughter could have been Sarah Woods who married Benjamin Franklin Garrett. SURNAME RESEARCH INDEX

A Surname Index is an excellent method for contacting others who are researching the same lines. We are Hawkins "cousins" already, but other surnames might provide even more help. Many of our members descend from the same initial Hawkins branch, so I would like to present this project to you. Since the list is planned for the next issue, and not as a separate supplement, please write to me soon.

FORMAT:

- 1. Send a list of the surnames that you are researching.
- 2. Begin with your first two known Hawkins in America. Send these Hawkins, with their given names and spouses' names if known. By sending two Hawkins names, others may more easily identify the specific branch from which you descend. Add the county/counties and states in which the Hawkins ancestors were born or lived, and their birth and death years.
- 3. Continue with an <u>alphabetical</u> listing of other <u>surnames</u> that you are researching (if you are researching Smith, Jones, Johnson, Williams, or Brown, include given names).

EXAMPLE:

- James Hawkins 1765-1834; Stafford VA.; Clark/Fleming KY; Mrd. Margaret ?
- William R. Hawkins 1791-1879; Stafford VA; Clark/Rowan/ Fleming KY; Mrd. Judah Hawes
- Atchison Cassity DuVall Evans Fore Fossaker -Fowke - Hallmark - Johnson, Zacharia - McGuire - Nickell Pearce - Pickerill - Shults - Springston - Thorowgood.

Limit the total number of surnames to twenty, including Hawkins and their spouses. This Surname Index will also serve you as a Hawkins Heritage membership roster. We will publish the full membership, whether or not surname lists are sent, but I hope you will take a few minutes to participate.

A personal project of 1988 for the Ft. Worth Genealogical Society was a Surname Research Index. I began the request for names in Feb., and I have just now completed a 56 page publication of over 5,500 surnames, with counties & states, & researchers' names (Not soliciting, just reporting - \$4.75 including mailing) Since my tenure as President of the Genealogical Society is over this year, perhaps I can soon get to "serious" Hawkins research.

Much of the material for Hawkins Heritage is obtained from you who are generous in sharing. At present, there is a good supply, but do submit information that you would like to see printed in our issues. If you have sent material and it has not been published, drop me a note. It may be in line for next time, or it could have gone into one of those "important" folders that somehow got on the bottom of the stack! Bits and Pieces of the Hawkins Family Puzzle

by Mildred Showalter Farmer Cont'd from last issue

We have discovered the "William who lived to be 115" to be two William Hawkins in Orange CO., VA. There appeared on the scene in Orange County another William Hawkins, a colorful character who seems to appear and disappear without any family named Hawkins claiming him. This is his story: "Borrowed from THE HISTORY OF ORANGE COUNTY VIRGINIA by Scott pg. 28

A number of the justices were desired to view the Rapidan above and below Germanna for a convenient place to keep a ferry, and to wait on Col. Spotswood to know on what terms he would let such a place. Later he agreed that he would let his land for a ferry there for 630 pounds of tobacco, with sufficient land for two hands to work, but debarred the keeping of tippling houses and hogs running at large, and public notice was ordered of the letting of the ferry and plantation at a subsequent term, and that advertisements be set up at the churches."

Mrs. Miller of the Orange County Historical Society provided a copy of the original letter written by Colonel Spottswood complaining of of William Hawkins who was the above mentioned ferryman who had been selected to live at his plantation. This is the letter:

Germanna Aug. 17, 1736

I desire you to move the Court about the Ferry at Germanna -----Condition upon which William Hawkins was allowed to be Ferry-keeper there: which was that he could keep no Ordinary or Tippling House so near my dwelling; to the end my people might not be drawn away from their Business--that Condition is now so audaciously violated to openly bring thither great quantities of rum and sugar, -- to make my house at the Ferry, in spite of all I can say. -----a place of continual Report, for my servants----with other loose of Profligate perjury in so much that during a month past I have not got done ten days of work by----or shoemaker nor a weeks work by my ----.

Moreover, the said Hawkins is perpetually drunk he had carried his vulgar ---- towards me for such an unsufferable height as to come to insult me at the door of my own dwelling House before all my family, telling me that I had been Governor of Virginia as work not very valuable---for a drunken rascal.---- that I might drive the abusive sot from away from before my door, he repeatedly threatened that if I struck him it should be the last white man I should ever strike: and riding off some few paces further into what he called The King's Highway, he then dared, and dared me again, to come there to strike him; declaring that he did not value his life more than the dirt at his feet. Then after this rude treatment of me before my door, I went down to the Ferry and called over to him for me, if the fellow was more sober and found him in no less insult: a position of mind. and when I ordered him to remove with his family and goods from off my land--he refused to comply; and when I required him to--- with me (I had sent ---messenger to him before for the same purpose.) he very rudely stated that he would ---- Fountain with his acc--- provided that I came with a ---or if I had one; then he should then have another.

Now, no man can imagine that -----who say for above 130 Tithal es in these two parishes Cant be ----with m-----to correct such a -----abusive behavior I want the --- to force---Bloody minded wretch, as he----off my land but I have rather than give the last occasion of breaking The King's --- to apply first to the Court for redress of being persuaded that they----For Quarter Master General for Great Britain, of --- Post Master, General of all His Majisties Dominions and I proclaim that the Court will at least order----to remove the said Hawkins out of my house and give me --- of my property without it being put to a trial--- a desperate persons he threatens to prove of shooting any --- to run him out. for if the Court will not interfer to protect me by securing my safety in walking before the dwelling house; Self Preservation which is Nature's Law for me to make use of the Power that Providence had ----drive such a dangerous Brute; a Declared Ruffian for ---- Habitation; it being fresh in my memory how in one--- he not long ago pursued his wife with a loaded --- Resolution to shoot her, but wa then prevented by the poor woman in one of my Houses. That n---may his removal if he has any on the ground, readily----in reason be valued at. And as for the Ferry, I will ----removal take care that it be duly tended. This is what I desire you; to be before the Court this day from Your Most Humble

----- Spotswood

The Governor took action and Hawkins was fined. Showing his compassion, the Governor puid his fine.

From Orange County, Virginia Deed Books 3 and 4, abstracted and compiled by John Frederick Dorman, we find our friend, William again in trouble.

"Owen Grinnan VS. William Hocking Grinnun complains that the defendant in Orange County on March 6, 1732/3 made his promissory note to him for 1000 pounds of tobacco and on May 4, 1733 for 500 pounds of tobacco. He was obliged to lay out ----pounds of tobacco in prosecuting the defendant in Prince William County where the defendant removed and lived. He asks damages of 25000 pounds of tobacco.

Z. Lewis for the defendant says the plaintiff included in the note six pounds for the forebearance and usury of 150 pounds and 850 pounds for one year, against the form of the Act of Assembly and also says the defendant has apid the plaintiff 500 pounds of tobacco." Mar. 6, 1732/33.

"Promissory note of William Hocking to Owen Grinnan for 500 pounds of tobacco , 24, May 1733. Wit. John Willcocks, Ann (X) Hawkins."

"Summons to William Hocking, 20 May 1735 returned 10 June 1735 by Wm. Henderson, copy left."

Z, Lewis and J. Mercer render an opinion, 13, July, 1736 that there is due Owen Grinnan 15000 pounds of tobacco. The question was submitted to their award in February.

Court ordered an attachment, 16, Sept. 1736. I have found one Rasp of the value of ten pounds of Tobb. of the estate of the within named Wm . Hawkinses Estate which is all I can find at present of His Estate. Benjamin Cave S.O.C."

"Order for taking Hockings in Custody.

Bond of William Hawkins of Orange County, Blacksmith, Thomas Stanton George Wheetly and James Pollard of same, Gent., Our Soveringhn Lord the King, for 180 £ sterling.

18 Aug. 1736. On the motion of Alexander Spotswood, Esq., it is ordered that the Sheriff remove William Hockings from the ferry plantation belonging to Alexander Spotswood and that Spotswood take charge of the ferry and keep it according to law."

We do not know who this William Hawkins was for certain but we do know that he was a blacksmith. John Hawkins of Essex County left his son William "smith's tools, after he was of age." Pg. 34 Essex CO. Virginia by Dorman. Alexander Spottswood Esq. vs. WM Hawkins

"Account of William Hawkins the Hon. Alexander Spottswood, Esq., dated Germanna 28 Aug. 1736, for saw files, scissors, sugar, cotton, bacon, pepper, salt, shoemaker's thread, men's shoes, linen, paper, rum ect. and sundry medicines per Dr. Gibbs' account. Total 3.17.10 E between Jan. 1734/35 and 9 Nov. 1735. Received Oct. 1735 from Thomas Rutherford, 5 shillings; due 3.12.10 E. Dated at Germanna 28 Aug. 1736. (this is included in the preceding account)

Promissory note of Wm Hocking to Colo. Alexander Spotswood, dated Germanna 25, Oct. 1736. for 1.2.0£ current money.

Summons to Wm Hocking, 20 Aug. 1736 executed 1 Sept. 1736 by G. Marr, Deputy Sheriff. Judgement for 1.2.0 f."

Another William Hawkins b. Feb. 16, 1725 lived in Essex CO. VA in the parish of St. Ann. He left a neatly written will in 1769, in which he names his wife, Margaret, his daughters Sabrinah Boutwell, Elizabeth Moseley and Margaret Hawkins. His sons were: John, Thomas, Liven, Birkenhead and William, They were all left many slaves. His sons remained in Essex Co. and copies of their wills are available at the Virginia State Library in Richmond, VA. This William Hawkins was the son of John Hawkins, son of Thomas, an early settler of Virginia.

From Daughters Of The American Revolution we find records of a William Hawkins who was born in England and came to Fauquier CO., VA. At the age of 30, he enlisted at the Chesterfield Courthouse on Sept. 1, 1780. He was a butcher by trade and had brown hair, black eyes, and a dark complexion. After the war, ie went to Harrison CO. VA (now W. Virginia). He died there prior to Apr. 18, 1835.

William was married to Elizabeth---- and they had children: Thomas, b. ca 1770, John, Sarah who m. 1. John Chesher and 2. A. Hill, Hannah, Issac, William who m. Catherine Brumage, Oliver, who m. Nancy Ann Jones, Elijah ma. Drucilla Pearse, Jessee ma. 1. Polly Jones and 2. Cary Jones, Walter b. ca 1774 ma. Mary Yates Cross, Margaret m. John Yates, Nancy ma. John Williamson and James ma. Eleanor Pearce.

Walter, son of William and Elizabeth was b. ca 1779 at Fauquier CO. Her parents were William Yates and Nancy Gibson. She also was married to Joseph Cross. Walter and Mary were married in Harrison CO. Va on July 22, 1803. Their children were: Thomas, who ma. Nancy Wheeler, Elizabeth, who ma. Isaac Wiseman, Presley ma. Susanna Latham and Fanny ma. John Carden.

Presley and Susanna had a son David who married Martha A. Dunn from Marion, CO. VA. They had a daughter Maggie, who was b. at Pleasants CO., WV. Maggie married Charles P. Cottrill. He was b. in W. VA. Their daughter was Ester Cornell who is a member of the DAR.

Sarah Hawkins, dau. of William Hawkins Sr. and Ann Bohannon Smith ma. Thomas Haydon. Their daughter Almira Haydon mar. John J. Christopher and their daughter was Mary Ann. She ma. James Thomas Wilson. Callie Wilson, their daughter ma. Russell Perkins and they had a daughter, Ann. She was the mother of Jean D. Purvis who is Jean Purvis Abrams. Her husband is Darrell Abrams of Frankfort, KY. They have a son Brad. See pg. 74 for more genealogy on this family.

David H? Hawkins b. Oct. 4, 1796 married Elizabeth S. Driver ca 1818. Elizabeth Driver was b. Feb. 14, 1804 in North Carolina. She was a descendant of the Sumner family, a very influential family of North Carolina in the 1700's. Elizabeth died on Apr. 15, 1885 in Weakley CO. TN and is buried at the Mt. Vernon Cemetery there. Her husband, David Hawkins died ca 1840.

A descendant of this family contributed this interesting information:
"Elizabeth Sumner Driver Hawkins' father, Moses Driver died in 1815 in Lincoln CO. TN, and her mother Sarah Sumner Driver, died in Marshall CO. TN in 1853. This probably accounts for the fact that Elizabeth S. Driver Hawkins, her 7 children and slaves left Marshall CO., TN by horse drawn wagons for Weakley CO., TN, a distance of about 135 miles, or at least 6 days travel. I was told that one night when they stopped for overnight in a farmer's barn yard one of the women peeked through a crack in the door of one of the farmer's outbuildings and saw 3 skeletons hanging by the necks with ropes. This frightened them all and caused the men to harness up the teams and all to keep traveling all night down the wagon road. This story was told to me by a great granddaughter, Lura Ward Stancil, in her 80th year, who had lived in Weakley CO. TN all her life."

"Martha Elizabeth Hawkins and Samuel Benjamin Sanders were my great grand parents and I feel certain that the Hawkins and Sanders families were well acquainted before my Hawkins moved to Weakley CO., TN, for my great grand-father, Samuel B. Sanders, is said to have ridden a big black horse from Marshall CO. TN to Weakley CO. TN with the purpose of getting married to Rebecca Ann Hawkins. However, after arriving he changed his mind on the girls and married Martha Elizabeth Hawkins on Mar. 18, 1858. This couple later moved to the mountains north of Ozark, Franklin CO. Ark. on the advice of their doctor for the wife's health. I don't know what health problems she had."

David Hawkins and Elizabeth Driver had children: Sally Ann b. Nov. 20, 1819, Polly D. Hawkins, b. Apr. 1, 1821, Rebecca Ann, b. Aprl 1, 1824 in Tennessee. She never married and died on Nov. 11, 1912. She is buried in the Mt. Vernon Cemetery in Weakley, TN. Her sister, Lena Caroline Hawkins was b. Aug. 27, 1826. She never married and died on Dec. 27, 1910. She is buried in the Mt. Vernon Cemetery in Weakley, TN. Moses Henry Hawkins b, Nov 1, 1827 ma. Julia Amanda Surber in Lincoln CO. TN on Dec. 27, 1855. He died on Apr. 10, 1877 and is buried in the Mt. Vernon Cemetery. Martha Elizabeth Hawkins was b. Sept. 20, 1832 and married Samuel Benjamin Sanders in Weakley CO., TN on Mar. 18, 1858. She died on Mar. 16, 1906 and is buried in Mt. View Cemetery in Franklin, Arkansas. William Duke Hawkins, b. Dec. 29, 1833 was never married and was a Civil War Vet. He died on Mar. 28, 1903 and is buried at the Mt. Vernon Cemetery. Jacob John Pinkney Hawkins was b. Dec. 20, 1836 and James Driver Hawkins was b. Dec. 17, 1839. He died on Mar. 27, 1862 and is buried in the Mt. Vernon Cemetery in Weakley, TN.

Mr. Gervis Floyd is retired after many years in the Navy where he served on destroyers. He later retired from the Army Signal Corps after 13 years in Alaska.

Martha Rebecca Amanda Clement Floyd was the daughter of Simeon Erasmus Clement and Elizabeth Ann Caroline Sanders (Clement). Martha Rebecca was b. Mar. 6, 1881 in Weakley CO. TN and married Nolen Floyd on Oct 2, 1901 in Franklin CO. Ark. She died on Mar. 19, 1964 and is buried at Rose Hills Cemetery at Whittier CA, She was a great granddaughter of David Hawkins and Elizabeth Driver Hawkins. She was the mother of Gervis Floyd.

The Bourne family is closely connected with Hawkins and Morton. Thalia has shared Bourne family history, and while this information is extensive, the editor includes only the three daughters of Andrew Bourne and Jane Morton, who married into the Hawkins family.

The PERSONAL PROPERTY TAX LISTS For The YEAR 1787 copyrighted by Netti Schreiner-Yantis

"The 1787 tax list is a unique one. It is the result of a law passed by the Virginia Assembly on the 11th of October 1786 which mandated that the tax commissioner should 'on the tenth day of March annually, begin and continue proceeding without delay through their respective district, and call on every person subject to taxation or having property in his or her possession for a written list thereof"...."You will find that the lists often give information that was not required by law. The names were left in their original spellings, but in some cases, a cross reference of unusual spellings assist the researcher."

This project by Netti Schreiner-Yantis is published in a three volume set, found in larger libraries. Also offered are individual county books which give lists in the original order, and then the lists are rearranged by the date the commissioner visited each taxpayer. You can tell by the second list who the neighbors were, since the commissioner would conveniently visit the residents somewhat in order.

"White males between the ages of sixteen and twenty-one were subject to a county parish tithe, but not the state poll tax". If a William Hawkins was listed as having a tax charged to himself, next in the list might be a James Hawkins, and it is stated that his tax was charged to William Hawkins. If James was not William's son, it at least showed a connection, since William would be responsible for his tax.

I ordered several individual county books for my own book shelves. The booklets may be ordered from Genealogical Books In Print, 6818 Lois Drive, Springfield, VA, 22150. They range from about 2.50 to 8.00 each. If you do not have access to the books in a Library, you might consider writing for a price list for the counties in which you are interested. The entire set includes counties from Virginia, West Virginia, and Kentucky. The 1787 lists offer some personal property data as well.

Tax list "B". Edward Humston was this District's Commissioner, and he includes all males above 16. Those between 16 and 21 are indicated, and others are over the age of 21. If a person is not tithable, it so states.

Chancery Court Suits Involving Settlement of the Estate of Matthew Hawkins Who Died Testate 1820 Culpeper CO. Va.

There were suits filed in Orange Co. and a later one in the Circuit Court of Fredericksburg, Va. The information is from Margaret Brown of Culpeper Va., who found this information while doing research on her Hawkins line. Margaret shared the information with me in 1985, and now I am glad to pass it on to you.

Matthew Hawkins had two wives: "Betty" is mentioned in the will he wrote 27 May 1820--pro. 19 June 1820 Culpeper Co. VA. Betty was his 2nd wife. His first wife was named "Hannah", and this is proved in a deed Culpeper Co. Deed Book U, p 191. Matthew and his wife, Hannah, deeded land to their son Job on Sep 28, 1798 which was recorded 18 Feb. 1799. On pg. 196 of the same deed book, Matthew and wife Hannah deeded 79 & 1/4 acres to son James on 23 Jan 1798, recorded 18 Feb. 1799. (This was shortly after James got married.)

The chancery suit names Matthew's son John as having died in a "distant state" (really just neighboring state of N.C. - Rowan Co.) John's heirs are named in Culpeper Co. Deed Book SS on p. 528, Aug. 1826. "Heirs of John Hawkins, deceased, of Rowan County, N.C., namely William, Issaac Allen and wife, Sarah, Brice W. James and wife Polly, to heirs of John Hawkins, deceased, in Culpeper Co." I'm quoting this from Margaret's letter.

The information on the Fredericksburg Chancery suit shows the question on how to divide the estate arose because Matthew's youngest child, Rebecca (Betty's daughter), and married her 1/2 sister's son-her 1/2 nephew Hawkins Popham! And I quote from Margaret's letter on the notes she took at Fredericksburg. (The material was too fragile in Orange Co. and she wasn't allowed to see it but told it was on film in the Va. State Library.) The other suit dealt with the same question.

Chancery suit regarding the Estate of Matthew Hawkins of Culpeper who died testate, leaving 7 children by first wife & one child by second wife.

The question is raised--is this marriage legal & is Rebecca entitled to a distribution or is Hawkins Popham entitled to same as her husband?" (I think Margaret meant to say "same as his wife?")

The marriage of Rebecca and Hawkins Popham was annulled by the Fredericksburg court. Later on I received some more information on the "widow Popham" (or should they have called her the "grass widow Popham"?). In 1822 she married John Story (p. 25, A History of the "Red Oak" Johnson Family), and had eleven children. A note of interest is the DAR records do not have the information on Matthew's 2 wives and list only Betty as wife. Some members may want to check to see if Hannah is the mother they should have on their records.

I also have some information regarding Matthew Hawkins' children by first wife, Hannah (?). This is from a letter sent by Margaret Brown of Culpeper, VA. It concerns a chancery court suit in Orange Co which was to settle Matthew's estate. It lists children of both wives, D.A.R. records are in error in assigning all children to second wife, Betty. She was mother to just one daughter.

* Sarah Willis was the mother of Sarah (Willis) Hawkins. She was married at least four times. Her maiden name is uncertain. A researcher of the Hudson family has proposed that it may have been Hawksford, but this is speculation. This comes from Mrs. Dolores Hudson of Hazelwood, MO. She got some of the information from the Hudson Family Bulletin. A lot came from Dr. Newman Hall. John Hauxford/Hawksford (I've seen it also spelled Hoxford) 4 Jan. 1699 (will?) had as apprentice a John Plunkett (Sr. later on). This John Plunkett m. Frances Frank (d/o Robt. Frank). John Plunkett Jr. had a son John Plunkett III who md. Mildred Hawkins the dau. of Sarah Willis and Benjamin Hawkins. The John Hauxford who had the apprentice John Plunkett Sr. is very likely the father of Sarah Willis Wood Hudson Turberville, according to Dr. Hall's research.

Sarah's (Hawksford?) first husband was William WILLIS m. ca. 1709/10. This husband died 1716 and left her with the following children: Sarah, John, William.

Sarah (Hawksford?) m. 2nd Henry WOOD who was was dead by 1722 July 6. They had one son named Henry, after the father.

Sarah m. 3rd husband Rush HUDSON by the July 6 date above.

He was dead by 1735 in King Geo. Co. and left her with
the following sons: David, Joshua, and Rush Hudson.

Sarah m. 4th Edward TURBERVILLE by 7 Nov. 1735 in Richmond Co. (?) VA., and there were no children from this union.

Sarah (Hawksford?) Willis Wood Hudson Turberville (what a gal!) died leaving a will written 28 May 1761 Orange Co. VA. (Will Book 2 pg. 310-11.)

SARAH HAWKINS

S. G. Heiskell, author of Andrew Jackson and Early Tennessee History: Of the Sevier family.... "Sevier was born September 23, 1745 in Augusta (later Rockingham Co., Va.). His father, Valentine Sevier 1st, came from London ca. 1730/40. His mother was Joanna Goode, gd/o John Goode, who immigrated by way of the Barbados in 1650. Sevier himself was married in his seventeenth year to Miss Sarah Hawkins, the daughter of Mr. Joseph Hawkins and the granddaughter of Samuel Hawkins, one of four brothers who came over about 1685."

Bishop E. E. Hoss of Galbraith Springs, TN., writes to Mr. Heiskell in 1918: "Sarah Hawkins, the first wife of Governor Sevier, was daughter of Joseph Hawkins, of Frederick Co., Va. I have a copy of his will in my possession. He was the son of Samuel Hawkins, who came to Gloucester Co., Va. in 1680. Benjamin Hawkins U. S. Sen. from North Carolina...and William Hawkins, Gov. of North Carolina in 1812-15, were members of the same family. Colonel Richard Campbell who was killed at the battle of Eutaw Springs in the Revolutionary War, married another of Joseph Hawkins' daughters....."
Bishop Hoss, who died in 1919, and was buried at Muskogee, Okla., was the grandson of Major John Sevier, third son and namesake of Governor Sevier.

Thank you to Wanita Lucas, for sending this portion of Heiskell's book, from which the above excerpts come. Wanita also mentions that Shenandoah records show that Joseph and Sarah's daughter, Rebecca, married Col. Richard Campbell. Their daughter, Betsey, gave an affidavit that her <u>sister</u>, Rebecca, was the wife of Col. Richard Campbell, in order to help their sons get their father's war services benefit.

CONFLICTING "FACTS"

Sometimes we receive information from more than one person, on the same Hawkins family. There is always the chance of discrepancies, and each of us has probably run into that situation. Perhaps the husband would be listed with one wife in one book, and with another wife in the next publication; and he really married more than once. Knowing for sure which children belonged to whom, often presents the difficult question. Arriving at which Joseph or John belongs in what family, or who is the husband of which daughter, is not new.

In the early 1890's, James M. Bourne kept up a lengthy correspondence with various researchers and county officials, trying to obtain the signature of a specific John Hawkins of the early 1800's. If it matched that of his own John Hawkins ancestor, he would know that they were one and the same. When the second signature was finally located, even though similar to the first, it appeared that it had been either "traced" or signed by someone other than John Hawkins. It still left somewhat of a puzzle for James M. Bourne.

Joanna Neilson submitted much appreciated information for our last issue, including some quotes from Notable Southern Families, by French and Armstrong, concerning Joseph Hawkins. HH editor neglected to mention that the latter, sent by Joanna, was not accepted as all correct by her (nor by the editor), when you compare with documentations. Also, make note of the year of arrival in America, of the Hawkins brothers, Joseph, Benjamin, and Samuel, as "1658" (Notabl. South. Fam.). 1680 and 1685, as other records show, are more feasible.

JOSEPH HAWKINS, SR., (d. 1770) - Son of SAMUEL HAWKINS FROM ENGLAND Submitted by Harry E. Long

(Note: Since several of our HH members descend from different children of Joseph, a little more space is being devoted to him and his family. This entry from Mr. Long may add to your own records, or give comparison to previous material in Hawkins Heritage.)

"Joseph Hawkins, Sr., (son of Samuel from England) died 1770, at his home several hundred steps east of Hawkinstown, in formerly Frederrick, now Shenandoah Co., VA., leaving a will recorded in Frederick County Will Book 4, p 51. He is believed to have married Sarah Marlin, daughter of Richard Marlin. Marlin lived on Mill Creek just west of the present Town of Mt. Jackson, Shenandoah Co., Va., on 265 acres of land granted to Richard Merley (Marlin) by Thomas Lord Fairfax on 14 June 1754. By deed of gift written 21 Oct 1769: Richard Marlin gave to his son-in-law, Joseph Hawkins, Sr., his 265 acre Fairfax grant and all other of his worldy belongings.

Col. Samuel Hawkins (1776-1835); son of Joseph Hawkins, Jr., (ca. 1754-1831); grandson of Joseph and Sarah Marlin Hawkins; and great grandson of Samuel Hawkins from England; is buried in the Riverview Cemetery, at Strasburg, Shenandoah County, Va. On 17 May 1808, Samuel Hawkins was married to Anna Allen by the Reverend Paul Henkel. Anna Hawkins, who died 20 Sept 1842, was a Quaker and daughter of Quaker parents, Joseph Allen and his second wife, widow Eunice Rogers-Walton, of Mt. Jackson, Shenandoah Co., Va. Samuel and Anna Allen Hawkins had the following children: Eunice, Rhesa A., Sarah Ann, Joseph Allen, Samuel Walton, and Elizabeth Mary.

After Samuel died in 1835 his eldest son, Rhesa A. Hawkins, was appointed administrator. His appointment, recorded in Shenandoah Co. MINUTE BOOK 1835-43, page 24, reads:

At a court held for the County of Shenandoah on Monday the 11th day of Jan. 1836 -- "Administration on the estate of Samuel Hawkins dec granted to Rhesa A. H. Hawkins (Anna Hawkins widow relinguishes her right [in serving as administrator]) who was sworn & gave bond & security according to law".

Proof that Joseph Hawkins, Sr., who died 1770 at Hawkinstown was the son of Samuel Hawkins from England is inscribed on marble in the Riverview Cemetery at Strasburg, Va. There in a very small cemetery plot are the graves of Samuel Hawkins and five of his descendants.

The inscription read:

IN MEMORY OF COL. SAMUEL HAWKINS, BORN 1776--DIED 1835, A GREAT GRANDSON OF SAMUEL HAWKINS WHO WITH TWO BROTHERS CAME FROM ENGLAND IN 1685. HIS FATHER JOSEPH HAWKINS DIED 1815.

RHESU HAWKINS 23 DEC 1812 -- 15 JUN 1865, 52-5-22

ELIZA HAWKINS, WIFE OF RHESA HAWKINS, 12 APR 1812 31 JAN 1865, 47-9-9

SAMUEL D. HAWKINS 4 NOV 1839 -- 25 JUN 1905 (on same stone) EFFA A. HAWKINS 13 MAR 1867 -- 1 DEC 1940

ANNIE HAWKINS WIFE OF VERNON LYNN WILLS 4 NOV 1885 -- 10 MAY 1960

ELLEN VIRGINIA WILLS 1931 -- 1931

Two dates should be corrected on the above listed tombstones. Eliza born 1818--not 1812. And, on Samuel's stone it should read -- HIS FATHER JOSEPH HAWKINS DIED 1831. Date of death of Samuel's father, Joseph Hawkins, is taken from Shenandoah County MINUTE BOOK 1830-- 1855, pages 8 & 10, dated 30 May 1831:

At a special Superior Court of Law Appointed and held for the County of Shenandoah at the Court House thereof on Monday the 30th day of May 1831. . . "On the motion of Samuel Hawkins who made oath according to Law and entered into bond with Jo-H. Samuels his security in the penal sum of three hundred dollars Conditioned as the Law directs a Certificate for obtaining letters of Administration on the estate of Joseph Hawkins dec . in the form is granted him."

As five of Joseph, Jr's. sons, Joseph III, John, William, Moses, and Mounce had moved to other parts of the country only four sons, Samuel, Benjamin, Aaron and James remained in Shenandoah County. In 1831 Samuel Hawkins, the eldest son residing in the county, qualified administrator of the estate of his father, Joseph Hawkins dec.

It may be noted in this report there are two bearing the name Col. Samuel Hawkins. Although born in different generations both were born at Hawkinstown in the same house. The elder Co. Samuel Hawkins (1762--1814), a brother to Joseph Hawkins, Jr., was an uncle to Col. Samuel Hawkins (1776--1835). The younger Col. Samuel, his elder brother, John, and his younger brother, Moses, all three were officers in Shenandoah County Rifle Company, 2nd Battalion, 13th Regiment of Virginia Militia. Their uncle, Col. Samuel Hawkins, a soldier in both the Revolutionary War and War of 1812, attained the rank of Colonel in the Kentucky Militia Company that took part in the Indian Wars in Ohio, under the command of General Anthony Wayne.

Col. Samuel Hawkins; born Nov. 1762 Hawkinstown, Shenandoah County, Virginia; died 2 July 1814 at the Town of Eaton, Preble County, Ohio, the youngest son of Joseph and Sarah Marlin Hawkins; married around 1783, in Ohio Virginia (now W. Va.), Catherine "Christina" Worthington (1759--1813), daughter of Thomas and Ann Worthington of near Wheeling, Ohio County, West Virginia. See Shenandoah County, Virginia, Deed Book D, page 387, dated 20 Feb 1784; Ohio County, W. VA., Deed Book 7, page 461; and Thomas Wothington's will in Ohio County, W. Va., Will Book 1, page 3.

Newly married Samuel and Christina, from Wheeling W. Va., boated down the Ohio River to Kentucky and took up residence in Lincoln County, Virginia (now KY); returned home in the winter of 1784 and sold his inherited land to his sister, widow Rebecca Campbell; returned to Kentucky and took up land in Bourbon County joining with lands of brothers, Pvt. John Byrd and Capt. Abraham Byrd, who were Samuel's Virginia neighbors at Hawkinstown; his sons except the yuoungest, Byrd Hawkins, were born in Bourbon County; removed to north of Cincinnatti, on the Great Miami River, in Butler County, Ohio, where lived a number of Samuel's Quaker friends from the Hawkinstown, Virginia area; 1799 removed to Germantown, in Montgomery County, Ohio, where his son, Byrd Hawkins, was born in 1803; and in 1806 removed to Eaton, Preble County, Ohio, where he died on 2 July 1814. See HISTORY OF PREBLE COUNTY, OHIO, by Williams (or Collins) pages 100, 145, 146.

Bourbon County, Kentucky, Marriage Book 2, page 1, shows Lydia Hawkins married George Worthington in 1799. As she was married several years after Col. Sam had removed his family from that county and whereas Capt. Joseph Campbell Hawkins did not list her as his sister, Lydia was probably a relative but not a daughter of Col. Samuel Hawkins.

HAWKINS LETTERS

"Copies of Letters Written to General John P. Hawkins Concerning the Hawkins Family"

These original letters were xeroxed, and bound in 1913, and were not published for purchase. The originals are among the rare documents in Frankfort, KY. Hereafter they will be referred to as "General Hawkins' Letters".

The book from which these excerpts come is a collection of letters written to General John Parker Hawkins, U. S. Army, during the early 1890's. General Hawkins was interested in his family history and obviously had a great correspondence with many Hawkins, be they of his specific branch or not; as well as with other correspondents who had Hawkins information to share.

Throughout the letters, General Hawkins made notations, either verifying information given, or correcting it. Assuming that the information is correct, some of the letters may provide material that is unpublished elsewhere.

The first are excerpts from letters written by Gen. Hawkins' cousin, Sallie Hawkins Long, the "22nd day of June, A.D. 1892". It is a deposition concerning the ancestry of Sallie, and was sworn to in the Probate Court of Lafayette County, Missouri, before Judge William Young.

".....Sallie Hawkins Long, of Lexington, MO, born Boone County, Kentucky, January 4th, 1821, and now age 71 years, daughter of Gabriel Hawkins, Granddaughter of Jameson Hawkins and Great Grand daughter of John Hawkins, who died near Georgetown, Scott County, Kentucky about the year 1806, make this statement concerning said Great Grandfather John Hawkins - viz: My Grandfather Jameson Hawkins, was born in Culpeper County, Virginia, August 16th, 1768, died at Indianapolis Indiana, Sept. 16th, 1840, aged 72 years, he was therefore at the close of the Revolutionary War in 1783, 15 years old."

The letter continues to say that Jameson was of "fair" education for the times, and had a reputation for unusual intelligence. He was also an ordained preacher in the Baptist Church.

"....My grandfather's first wife was Margaret Jameson, of Culpeper County, Va., she was the sister of John and David Jameson
both of these were officers in the Revolutionary War". "....All
join me in love to you and Coz - (your wife) Lovingly yours
(sigd.) Sallie H. Long."

The following segments were written by Sallie H. Long on March 15th, 1892. "Dear John: Yours of February 29th came to hand an hour since and reply at once. Will first tell you I know Gabriella Jones H. is not the least related to us...she and her 'tribe'lived in Mercer, now Boyle County, Ky."

Sallie tells of a visit to Danville in 1841, where she sat by the fire in the home of her Aunt. Her Aunt remarked that she was sorry that "Mother called one of her children Gabriella", for fear that people might think that they were related. My uncle had known the family from his boyhood and took pains to trace the family 'on the sly' ...and ascertained they are none of ours. (Note: More personal opinions of Gabriella are given in Sallie's letter.)

"There was a family in Lexington, Ky (Gus Hawkins) some of them lived in Hannibal, Mo., they may belong to our family - the name is very common. The old stone house I know was built by our Great Grandfather there is no gainsaying it, my parents, my Grandparents all -- the old relatives and the neighbors have often told me it was. I was shown the 'girls room' where my own mother slept when a child, she boarded there and went to school with my father and yours too." She was Elizabeth (Betsy) Bradford as you were aware and your Mother was Elizabeth Waller but Uncle John preferred to call her Eliza. I have stood by the side of the graves of our Great Grandparents; when I was there, there was a stone wall around them and several cedar trees.... You will find their names on the old church book of the Great Crossing Church. I have handled the old book and seen their names on its brown pages.... I will direct a letter to the 'Clerk of the Great Crossing Church, Scott County, Ky', if there are any records, dates, unitings with the church, we can get them ... I do not think they were constituent members, if by letter we will find out their former church home and trace them."

"The place belonged to a man named Herndon, and it was 'The Lunceford Herndon Farm'....it is immediately on the Frankfort pike about a mile or so below the crossing on Elkhorn Creek."

Other information given in the letter indicates that Martin Hawkins was a Mason. Sallie felt that their great grandfather may have been a mason - at least some of that branch of the family was. Sallie and John Parker Hawkins' grandfather was Philemon, and his wife was Elizabeth ______.* She said that Philemon's family came to Missouri a very long time ago, and that their names included Margaret, Elizabeth, Alfred, Washington, and William, and others that she couldn't remember.

"They settled in Ralls or Marion Counties, but I do not believe they recognized each other (I mean Uncle Elijah's family) as relatives. There was another family in one of those counties, the old gentleman was called 'Honesty John H.' for his integrity, and by the by there was a Wm. Hawkins in the southern portion of Mo., who died from the effects of a dose of laudanum accidently taken". "....He was a politician and some of the extravagant members of the Legislature called him the 'Bull Dog of the Treasury' as he was so tenacious as to the safety of the public money."

^{*} General Hawkins wrote in the name of "Lewis".

"John and William Hawkins were full brothers but only half brothers of our grandfather. John the older, married Joanna Harrison of Mason County Ky., they had only four children, Sally (Mrs. Stevens), Nancy, (Mrs. Moore), Harrison and Jameson. Harrison died years ago. He never married and if John did I never knew it."

Sallie includes the following information sent to her by Mrs. William Hawkins, the mother-in-law of John D. Cason (son of Coz Ben Cason) and copied from the old Bible of her father-in-law, William Hawkins (Sallie's great uncle). "William Hawkins, son of John and Sarah Hawkins was born February 10, 1784. William Hawkins and Lydia Todd Francis, were married April 23, 1810, he died the 8th of July '45. His son Wm died a few years since and if there are any of the family living with the exception of this same John D., Cason's wife, I am not able to say."

"My father was born at Bryants Station December 4th, 1788, if such is the case you see that Uncle Wm. was four years older than my father and there were several children older than him... If our great grandfather ever lived anywhere in Kentucky with the exception of Fayette and Scott counties I never heard of it, am of the opinion that they (the Jessamine County Hawkins), were Martin Hawkins family and the family of Mrs. Rankins and Dr. Henry Craig of Georgetown, Ky, both dead. The Edmund Hawkins you mentioned must belong to that branch of the family, or to the family of Professor Wm. Waller Hawkins, he (Wm W.) was long ago one of the Professors of Georgetown College".

Sallie mentioned several of her grandfather's cousins, including Thomas, who never married. He had "only brains, money, and piety". All the Hawkins family were Baptists as well as politicians and soldiers. She says that the worst thing that they could say about the Hawkins was that very many of them "are not great money makers, but none extremely poor, all 'comfortable livers', and the 'soul of honor'."

One last comment in Sallie's very lengthy letter was that the whole state of Kentucky "seemed infested with Hawkins". (Her complete copied letter is eight pages, 8 1/2 x 14".)

In comments scattered throughout some of the letters concerning Jameson Hawkins, General John Parker Hawkins mentioned: "The proper spelling of my great grandmother's name is Margaret Jameson not Jamieson or Jameison. I believe it is usually pronounced in Scotland as if spelled Jimison, and that has been the custom in our family." "...Lt. Col. John Jameson was a brother of my grandmother." "....The Spotsylvania and the Stafford County Wallers have an emigrant ancestry -- I am descended from the Stafford Co. branch. John P. Hawkins."

X. HAWKINS (Hawkins Letters)

732 St. Louis Street Springfield, Missouri Friday, March 25th, 1892

General J. P. Hawkins, Dear Sir:

The name Hawkins is of Danish origin, signifying son of Haco - this is all born out by the character of Sir John Hawkins who was one of the three first Englishmen who sailed round the world and was knighted by Queen Elizabeth for services in the great sea fight between the English military and the Spanish Armada.....Later on, in Queen Ann's time we have Sir John Hawkins, said by Dr. Johnson to be an "inclubable man". We can only suppose that we are kin to these and though we have every reason to think that it is so - no on has ever taken the trouble to trace it up. Now we come to know facts:"

"John Hawkins of Norfolk, Va. married Mary Langford....There were many sons and daughters of this marriage. I fear we cannot form a complete record but will name all I remember. (born 1764 d. 1830) Martin, James, John, Edmund, Joseph -Langford; Jane, Lucy, Mildred, Frances. Of the daughters only Mildreds descendants are known to us, being the Butler family of Kentucky; one of her sons was General William O. Butler, of Carrollton, Ky (now deceased), Major General of U.S. Army, during Mexican War; one of her Grand-daughters is Mrs. Mildred Butler Carlisle, of Washington City - and her great Grandson Pierce Butler, of Louisville, Ky., of the sons Martin survives in the Turpin family of Corpus Christi, Texas -, in Winslow Dudley, Esqr. of Lexington Ky., and in Marie Prescott (an actress.)"

"Edmund is represented by the present Edmund Hawkins, of Russellville, Ky. Joseph Langford, my Grandfather certainly held a commission signed by General Washington as Major; it is religiously preserved in the house of his son Col. Pierce Butler Hawkins at Bowling Green, Ky."

The writer stated that his father, William Waller Hawkins, son of Joseph Langford, did not have an interest in family history, "being for his part a Professor of Greek, Latin and Mathematics, he cared very little for the annals of the Hawkins family as compared with those of the Trojans. I have five sons, so the family is not likely to become extinct soon......Yours sincerely, (signd.) X. Hawkins"

Editor's Note: At the bottom of this letter, there was, "was there not another son named Thomas? J.P.H."In Hawkins Heritage records, the group sheet for John and Mary Langford Hawkins show the children listed by the writer of the above letter, plus Thomas, Agnes, and Elizabeth.Olyve

 and Thomas were to be executors.

(Baltimore County Land Records, 1R #AM, fol. 12).

"The first cabin township was built by Jerry Gilmore on Section 2 near where the town of LaClede now stands; the second was built on Section 3 in in 1832 by a MR. HAWKINS and on the farm owned and occupied by Samuel C. Spencer, who moved and settled there soon after."OHA
