JOHN HAWKINS/EMILY CULLEM - John Hawkins b. 1822 in Ireland. Sometime before 1860, John and Emily settled in Burlington, IA, where John was a tailor on Jefferson St., downtown Burlington. At least seven children: Mary Jane, John, Ann, Frank, William, Edward, and James. Jeff Forsythe descends from Mary Jane who m. Joseph Robinson 27-June-1882. In 1890 they lived in Tombstone, AZ. Later lived in CO. Their children include Jennie Elizabeth, Richard, John, Emily, and Agnes Ann. After Joseph died, Mary Jane returned to Chicago where she died in 1933. . . . Pruitt); Mary (m. William West); John (m. Hackleman); Rebecca, from whom Kathleen Hill descends, m. 1796 in Abbeyville Dist., SC., d. 19-9-1868 in Bartholomew CO, IN, (m. EPHRAIM HAWKINS/SARAH FARMER - Ephraim Hawkins, b. 1761 Baltimore CO, MA., m. Nancy Ann Farmer, b. 1767, s/o John and Sarah (Green) Farmer. Their son, Thomas, b. 1790/1800, m. Mildred Norris. Thomas and Mildred's daughter was Malaeny Hawkins, b. 1817 in Person CO, NC, and m. Carter L. Jones in 1842. She d. in 1902 in Whitfield CO, GA. HAWKINS/WITHERS/FOSSAKER/FOWKE/THOROWGOOD/HAWES - Several of our members research Stafford CO, VA. Since it was a burned county, many valuable records are not available. Four years ago, in the VSL in Richmond, I found an index with many familiar names in it. The bad news was that the book for which it was an index had been destroyed. Judith H. Dixon, Tony Stump, and I descend from the Withers family of Stafford CO. Since my (and other members') James and Margaret Hawkins lived in Stafford CO from at least as early as 1791 until 1825, would you check your notes to see if you have notations on any Hawkins at all who connect with these surnames listed above? There were early Hawkins in Stafford, but there is also a lapse of time before James Hawkins showed up in my Stafford CO research. I would like to connect James to the earlier Stafford Hawkins families. - Olyve Abbott

HAWKINS/CASTLEMAN/TURPIN - Moses Hawkins, b. 1776 Orange CO VA. m. Sarah Castleman 25-7-1800. They both d. in Woodford CO KY. Their son, Lewis Castleman (d. 1867 Caton, Lewis MO) m. Mary (Beard) Hawkins, whose daughter Martha Octavia, b. 1834, m. Hezikah W. Turpin. Their son, Lewis H. Turpin, b. 1858, m. Anna Mae Wright.

PHILEMON HAWKINS - Does anyone have information on Barsheba Hawkins, d/o Philemon Hawkins, Sr. and Delia Martin? . . . James A. L. Miller, Jr., Georgetown 2810 K Carriage Dr., Winston Salem, NC. 27106-5328.

JOHN HAWKINS/ELIZABETH COIL - John Hawkins, probable s/o John, was married to Elizabeth Coil. Elizabeth Coil is the gr grandmother of Monica Kelly of Australia. She knows that John Hawkins was in CA during the gold rush days. He was actually a ship's captain and probably trained in America. Mrs. Kelly says that it has taken her years to trace them to the Cooma Church in Australia.

In hearing from the Parish Secretary of St. Patrick's Parish in Cooma, N.S.W., Mrs. Kelly learned that her gf, John Washington Hawkins, s/o John and Elizabeth, who lived in Kiandra, was b. 3-11-1862. His Godparents were James Martin and Mary Quinn. The Hawkins family was associated with the Methodist Church, although another Hawkins family member was Peter Hawkins (m. to Eliza Jane Elliott), who lived in Holt's Flat, Mount Cooper. After Peter's death, Eliza, at the age of 64, m. John Dunn. "Government Regulations requiring the compulsory civil registration of marriages in New South Wales did not come into force until 1856". Since marriage records were not available in N.S.W. prior to that time, it isn't known if John Hawkins and Elizabeth Coil were married there or in America.

The Parish Secretary also mentioned to Mrs. Kelly that John Hawkins, a bachelor, age 55, m. Catherine Grimes in St. Patrick's. He was born in Ireland, the s/o Edward Hawkins and Mary Duggan.

Thank you, Monica, for your interest and your informative letter. Although my files do not have connecting material at this time, perhaps a reader of Hawkins Heritage will contact you.

As per your suggestion, I am editing my previous questions in a form suitable for publication as queries. Please publish them at the earliest possible time.

- 1.) Thomas FAULCONER was the husband of Elizabeth "Betty" HAWKINS, daughter of Thomas HAWKINS and Ann COVINGTON. Note from the corresponding pedigree charts that both Thomas and Elizabeth were descended from people named MOSELEY. Is there a connection between these two MOSELEY families?
- 2.) Does anyone have information on the surname COVINGTON, ancestors of Elizabeth "Betty" HAWKINS?
- 3.) William MOSELEY, husband of Susannah BURNET, was born in the city of Rotterdam. Was his surname of Dutch origins, or was William MOSELEY simply embarking from the port of Rotterdam when he emigrated from Europe?
- 4.) In reading excerpts from Millie S. Farmer's book, I was confused as to her explanation of the ancestral progression which included Admiral HAWKINS, as well as the famous Captain William HAWKINS, and so forth. I tried unsuccessfully to add these names to the pedigree chart of Thomas HAWKINS, Sr. Will anyone share with me a pedigree chart that extends the lineage from Thomas HAWKINS, Sr. back to the so called famous Captain William HAWKINS? And, why was he so famous? I found an entry in another book made brief mentioned of "the famous Captain William HAWKINS, who captained the ship Griffin against the Spanish Armada in 1589." Were they one in the same?
- 5.) My wife, Karen, has a direct line ancestor named Beulah Ann HAWKINS, grand-daughter of a Nicholas HAWKINS, wife of Elizabeth JONES (see the enclosed pedigree chart). Is anyone able to help determine which Nicholas HAWKINS this was? Who were his ancestors? And, who were his wife's ancestors?

EDITOR'S note: Re #5's pedigree chart - Nicholas & Elizabeth Jones Hawkins were parents of Elijah Hawkins, who m. Elizabeth SCOTT, d/o Ruben Scott and Margaret COPE. Their dau., Beulah Ann, b. 14-Oct-1807 OR CO. VA; m. 22-Jun-1831 to Level PERRY. Beulah d. 1882 Cabell CO, WV. This is the information on the chart sent by Marty Cook.

Daniel Berry Kelley and Nellie Lee Hawkins had children: Robert Edward b. Apr. 4, 1906 and mar. Remere Hill. Edna Mae b. June 1, 1908 mar. M.G. Brown. Ruby b. Oct. 13,1910 was never married. Murzie b. Nov. 7, 1912 mar. Kyle Adams, Amy L. b. Apr. 6, 1915 mar. T.D. Hayes. J.D. b. Aug. 5,1917 was not married. Hazel b. Aug. 17, 1919 was not married. Nellie was not married.

Edna Mae Kelley was b. June 1, 1908. She mar. M.G.Brown who was b. July 23,1903. He died on Oct. 13,1985. Their children were James Dewey, Marion Eugene, Lois Geardine and Glenda Joyce.

James Dewey was b. Mar. 10, 1925. He married Gladys Smith and they have

Patricia Ann b. 1949 and James Floyd b. 1951.

Shirley Lonergan is the wife of Marion Eugene who was b. July 25,1933. Their children are Donna Jean b. 1953, Jerry Hugh b. 1955 and Marion Eugene b. 1968.

Lois Geardine was b. Dec. 12, 1938. She is mar. to Dal Caradine and their children are Ronald Franklin b. 1955, Donald Eugene b. 1957 and Dalwayne b. 1961.

Glenda Joyce was b. Dec. 25,1944 and mar. John Hazel. Their children are Michael Wayne b. 1962 and Glenda Renae b. 1964.

There was another Robert Hawkins b. in South Carolina ca 1820. He mar. Mary W. Gold on Jan. 21, 1847 in Wilson Tennessee. He died between 1870-1880 and is bur. in the Kious Cemetery in Saline, IL. Mary Gold was the dau. of Josiah Gold and Martha Averett. She was b. ca 1826 in Wilson, TN.and died between 1880 and 1890. Their children are Joel Samuel b. Oct. 16,1847 and d. Sep. 23,1899 in Saline, IL. He mar. Margaret Abney on Apr. 15,1875. Leroy b. Aug. 16,1849 in Saline IL died there in Sept. 1901. He was mar. to Laurinda Cook. They were mar. on Aug. 28,1870. John Henry b. ca 1851 died when he was a youth. Zacharis was b. ca 1852. He moved to Texas. Mary Jane was b. Apr. 7,1854 and d. Feb. 23,1928. She married Henry Hawkins on Dec. 11,1873. Carrie b. ca 1856 mar. Joseph Burks on Oct. 5 1879 in Saline, IL. Richmond b. Jan. 26,1858 mar. his third wife Alice Magill on Mar. 30,1902. He died on July 4,1941 in Newbern, Jersey CO., IL and is buried at Scenic Hill Cemetery there. Julia was b. Nov. 7,1862 and died on Oct. 14,1945. She mar. James Heathman. William and Minerva died in their youth. Edith Zimmerman of Grafton, IL is a descendant.

Elisha Hawkins b. ca 1800 in Union CO., S.C was a farmer and died after 1850. He is buried at Mountain Springs Methodist Church Hwy 178, off Hwy. 9 s. of Centre, AL in Cherokee CO. It is thought that his father was Isaac Hawkins of Union, SC.

Elisha mar. Elizabeth Guthery/ Guthrie b. ca 1806 in S. C. She died after 1860 and is also bur. in the Mountain Springs Methodist Churchyard. Their children were: John L. b. Jan. 9,1825 in SC and died Jan. 19,1901. He married Mary Emma Isham. 2. Amos was b. ca 1828-1832 in SC and died in Bell Texas. He mar. Sarah Jane Lewallen b. Jan. 3,1836 in Alabama and d. Dec. 31, 1890. She was the dau. of Wiley and Mary "Polly" Lewallen of NC,TN and AL. 3. Francis, a female was b. ca 1834 in SC. 4. Synthia was b. ca 1836 in SC and mar. Bedford Welch. 5. Elmira was b. ca 1838 in SC. 6. James was b. ca 1840 in SC and mar. Nancy----. 7. William Berry (catled Berry) was b. ca 1842 and mar. Mary E.:--b. ca 1844 and another source says that he mar. Martha White. Mary was b. ca 1843 in SC and mar. Jess Bedwell. Martha was b. ca 1844 and Dolly was b. ca 1845. Caroline (Calorina or Clorena was b. ca 1848. She mar. John Hansard. George Dallas b. .ov. 19,1846 d. Nov. 10,1919. His wife was Sarah Ann Hendrix.

Amos Hawkins b. 1828/32 in Union CO., SC was a farmer and mar. Sarah Jane Lewallen in Cherokee CO., AL. He died in Bell CO. TX after 1880. He was a Civil War Veteran on the side of the Confederacy and was in the Battle of the Wilderness amoung others. He was wounded and hospitalized three times. He moved from Alabama to Texas in the 1870s.

Sarah Jane Lowallen was b. Jan. 3,1836 in Alabama. She died on Dec. 31, 1890 in Bell CO , TX. Her father was Wiley Lewallen and her mother was

Mary "Polly".

Amos and Sarah Jane had children: Bartow Green b. Sept. 29, 1861 in Cherokee CO., AL. He mar. Miranda Eula Nixon and his death was in Bell CO. Van Buren Hawkins was b. in AL and d. in Bell Texas. He was b. in July,1867. Van Buren's wife was Halley---b. Jan 1870 in Texas. Margaret A. was b. in 1870 in Cherokee CO. Columbus was the twin brother of Mary. They were b. on Mar. 3, 1873 in Texas. Columbus d. on Nov. 3, 1892 and is bur. in the S.E. section of Hillcrest Cemetery in Temple Texas. Marcus was b. in 1876 in Texas. His wife was ----Cleary and they had several children incl. son Marcus (Mark) and dau. Gladys.

There were Hawkins families in early North Carolina and it was Philomon Hawkins' widow who moved her family there. Philomon Hawkins was born in England in 1590. He married Anne Eleanor Howard there and emigrated in 1619 to Charles River CO., VA. Two patents were granted to him in 1619 and two in 1625 for land near Todds Bridge which is now in King and Queen CO., VA. At the time that he lived there Todds Bridge was in King William County. The bridge spanned the Matapony River near where his relative possibly a brother, John Hawkins lived. Philomon died at the age of 35, leaving his widow and sons Philomon and John and a daughter Anne. In 1735, Anne Eleanor moved with her children to North Carolina.

Philomon Hawkins II, b. 1717 in VA, d. 1801 in Bute CO. (Now called Warren CO.) NC. He was the son of Philomon, the Immigrant and Anne Eleanor Howard. He married Delia Martin in 1743 and they had six children. Their sons were: Col. John Hawkins, Col. Philomon Jr., Col. Benjamin b. 1754 and Col. Joseph. Their daughters were: Delia who mar. L. Bullock and Ann who mar. Micaja Thomas. Both girls died young with no living children. Col. John mar. Mary and four of their five sons served for many years in the North Carolina legislature. John's daughter Mary mar. Aug. 12, 1760 in Granville, NC. Nathaniel Bullock son of Richard Bullock and Anne Henley. Mary died in Oglethorp, GA in 1833.

Col. Philomon Hawkins Jr. son of Philomon and Delia built Pleasant Hill, near Middleburg, N.C. and with his father he fought at Alamance but both became patriots and both fought in the American Revolution on the side of the Americans. His son William was the Governor of North Carolina in 1814 and Speaker of the House in 1810 and 1811.

Col. Philomon Jr. was a member of Provincial Congress and in 1789 the Convention that ratified the Federal Constitution. His Dau. Mary, mar. John Downey.

Col. Benjamin was a senator from Warner CO. N.C. and served in the War of Independence. He was b. Aug. 15,1754 and d. June 6, 1818.

Maryland had its Philomon Hawkins too. Philomon Lloyd Hawkins came with Edward Lloyd to Charles City CO., MD in 1650 from Wales. He had a brother Henry living in St. Marks CO., MD who d. in 1673 leaving a will in which he

mentioned his nephew Edward son of Philomon Lloyd, who was executor.

There was a Ralph Hawkins in Charles CO. in 1650 who died in Anne Arundel CO., in 1675. He was the ancestor of Capt. John Hawkins, 3rd Regiment, (VA) Continental Line. No connection has been established with Ralph and Philomon. The fact that he came to this country from Wales doe not necessarily mean that he was a native of that place. It indicates the place where his ship left for the New World.

Philomon Hawkins, Gent. son of John Hawkins and Mary Long of King WM, CO., VA was born in the early part of the 18 th Century. The Virginia Colonial Militia by Crozier show that he was a soldier in a Regiment commanded by Col. William Byrd in the French Colonial War. He was a Capt. of a company of Foot, taking his oath Feb. 5, 1750 in Spotsylvania Co. and was commissioned a Captain on July 21, 1755. Later, he became a Col. as did his son John.

Philomon owned various properties in Caroline, Spotsylvania, King William and Orange Counties. Some of his property was inherited from his father and

a part was purchased from his sister Mary Craig.

This Philomon Hawkins was the ancestor of Gen. John Hawkins who wrote a book Gen. JOHN P. HAWKINS REMINISCENCES written in the 19th Century.

Gen. Hawkins claims that John Hawkins of Hanover CO., VA who mar. Mary Langsford is related to him. His cousins, descendants of John of Hanover used to visit his home when they were children. They were children of Littlebury Hawkins who was in Texas at the time. His sister brought Littlebury's sons Antoine Domineuil and Ross Hawkins home with her.

Gen. Hawkins tells a story on pg. 74 of his book: "Capt. John Hawkins had a son, Martin, concerning whom the following adventure is related: That he was fishing in the James River and having caught a large sturgeon and having him near shore, he jumped into the water and thrust his hands into his gills to land him, but the fish closed his gills on his hands and made for the deep water, where for some time there was a lively struggle for the mastery. Finally Martin landed the fish on the opposite shore. I have heard this story all my life as the wonderful performance of a relative. It is known among all of the Hawkins name having relationship to him."

Gen. Hawkins also speaks of the relationship between Sir John Hawkins and John Hawkins of Hanover CO. He quotes from a part of Sir John's will this:

"To my servant, Roger Langford, an annuity of twenty pounds during such term as he shall be employed in going through my accounts with Her Majesty, which accounts I willed to follow by the direction of my wife and of my son, Richard Hawkins" In another part of the will he leaves his cousin, Sir Francis Drake, "whom he had educated" : "My Best jewel, which is a cross of emeralds."

Dr. James Russell Hawkins who gave information on his Hawkins ancestors, including Martin the fisherman his uncle was a native of Spotsylvania, CO., VA. He was b. Jan. 30, 1805 to Maj. Joseph L. Hawkins and Ann P. Robinson Hawkins. In Kentucky A History Of The State by Perrin, Battle and Kniffen we find that his grandfather John Hawkins of Hanover CO who married Mary Langford, died of smallpox while serving as a major in the Revolutionary War.

Dr. J. Russell was reared on a farm in Virginia where his father was prosperous and hired private teachers for him. He married Sarah A. Boles of Henrico CO. and they had eight children: Joseph, Betsey Ann, Mary Eliza, J.Russell Jr. Julia L., Mildred J., William B. and Hamilton Pope. His wife died in 1878.

The family moved to Kentucky in 1838 and settled in Franklin, CO.after practicing medicine in Boone CO. for eleven years. He was also active in politics and was secretary of the State Senate in 1851 and served for 25

years in that position. He was one of the three commissioners who selected Hopkinsville as the sight for the Western Lunatic Asylum in 1848. He received his education to become a physician at Transylvania College.

Another James Hawkins who lived in the same area in Kentucky is listed in Perrin, Battle and Kniffen's book is James S., the son of Senat A. and Mary Dodd Hawkins. He was born in Woodford, CO., KY on Feb. 19, 1810. He was a merchant, farmer, justice of the peace and constable.

During the Civil War he served under Gen. Morgan in Company E. Second KY Cavalry and was wounded in the shoulder at Cynthiana in 1863 and in the side and right hand at the Battle of Bull's Gap. After he surrendered with Gen. Taylor in Mississippi he opened a store, raised stock and was a farmer. He married Dolly Reed. They were Presbyterians.

The usual pattern of migration from the east to west is reversed in the case of the following family: Ambrose Lee Hawkins was b. on Oct. 18, 1841 in Gainsborough, Jackson County, Tennessee. He married Mildred Frances Faulkver in Blacksburg, Montgomery County, VA on Nov. 15, 1870. His parents were William K. Hawkins b. in 1798 in North Carolina and Elizabeth --- of NC in 1802. Mildred's parents were Fielding Jones and Sarah Jane Smith. She was b. Feb. 27, 1847 in Montgomery CO., VA.

Ambrose Lee and Mildred had the following children, all born in Blacksburg, Montgomery CO., VA. Sarah Elizabeth b. Sept. 26, 1871. She mar. Watson

Edwin Camper on Sept. 1, 1897. She d. Oct. 5, 195?.

Bertie Mildred b. Sept. 10, 1873 died on Feb. 5, 1902. She was never mar. Edgar Lee was b. Oct. 25, 1875 and mar. Hallie Kath. Price on May 30, 1900. He died on July 26, 1951.

Joseph Fielding was b. Jul. 16, 1877 and mar. Bessie Martin on Jan. 2, 1901.

He died on Oct. 21, 1962.

Hugh Lawrence was b. Dec. 20, 1879 and mar. Nannie Jane Price on May 30, 1900. He died on Apr. 19, 1968.

Olive Lucy was b. June 18, 1881 and d. June 22, 1945. She was not married. William Thomas was b. Aug. 25, 1883 and mar. Isobel G. Harrek on Dec. 20, 1911. He d. on Sept. 29, 1948.

Benjamin James was b. May 27, 1888 and mar. Bessie Keffer on June 1, 1910.

He died on Mar. 8, 1965.

Virginia M. Hawkins, dau. of Hugh Lawrence and Nannie Jane Price mar. David Paul James. They reside in Petersburg, VA.

Regarding the parentage of John Hawkins, I doubt that he was the son of John Hawkins and Mary Dewe. I am aware of the Mayos material in which he is identified as their son, but Judge Mayes gives his source as The Dictionary of National Biography, Volume 25, page 230, which portains to William Hawkins. I found the article about William Hawkins in Volume IX, page 230, of The Dictionary of National Biography, but it does not identify John Hawkins of Virginia as being a brother of William. That article, of which I have a Kerox copy, refers to Burke's Commoners, Volume II, page 215. I have a set of A Genealogical and Heraldic History of the Commoners of Great Britain and Ireland (John Burke, Esquire, London, 1834-1838, reprinted Genealogical Publishing Company, Baltimore, 1977), and the article on page 215 in Volume II refers to the family of John Hawkins and Mary Dewe. Among other things it states that their son John Hawkins married a Miss Wainwright and had a son William who married Sarah Grant, who had a son Samuel who married Sarah Collins, who had issue unidentified. There is no reference to emigration to Virginia, so this seems to eliminate John Hawkins of King William County as their son.

Since John Hawkins of King William County named his first son Philemon, I have assumed that he was a brother of his contemporary Virginia colonist Philemon Hawkins. According to a descendant, Philemon, who died young in Charles City County, Virginia, in 1725, was a son of John Hawkins and Mary Dewe, but no proof was given. Since Philemon is not mentioned in the Commoners article, he may not have been a son of John Hawkins and Mary Dewe either. Nevertheless, it still seems likely that Philemon and John hawkins of Virginia were brothers.

It also is doubtful that John Hawkins of Great Milton, who married Mary Dewe, was the son of John Hawkins of Slapton and his wife Hester Richards. I have Plymouth Armada Heroes, The Hawkins Family, (Mary W. S. Hawkins, William Brendon and Sons, Plymouth, 1888, authorized facsimile copy produced by University Microfilms International, Ann Arbor, MI, 1976) and it states that John Hawkins, son of John Hawkins and Hester Richards, was born on 21 September 1643, lived with his parents, died in 1670 and was buried at Slapton. His sister Hester Hawkins was granted administration of his small estate which consisted of his personal effects and the furnishings of his room. Judge Mayes did not comment on this contradiction in developing his lineage, but it surely bothers me.

I hate to rain on anybody's parade but I trust that all of us are seeking the truth. I was very disappointed to find that these sources contradict the long presumed ancestry of John Hawkins. I was looking for substantiation in them, rather than denial, and I will be delighted if someone can rebut these facts and prove that John Hawkins was who he has been claimed to be.

The parents of John Hawkins, who died in King William County, Virginia, about 1740, have not been determined. The maiden name of his wife Mary has been considered generally to have been Long and she was identified as the daughter of John Long (Hawkins Heritage, Hawkins Family Association, Fort Worth, TX, page 24, April 1990.), without source citation. She also has been identified in family records as Mary Hall and as Mary Bateman, without proof.

Traditionally, John Hawkins of King William County has been described as a greatgrandson of Admiral Sir Richard Hawkins (Hawkins), the British haval hero, but his descent from the famous Hawkins family of sailors from Devonshire, England, is

unsubstantiated. It has been claimed that he was a younger son of John Hawkins and Mary Dewe of Great Milton in Oxfordshire, England, and a brother of William Hawkins, the eminent serjeant-at-law. (Genealogy of Mayes, Rigg, Lamar, Longstreet and Related Families, Judge Edward Mayes, Hederman Brothers, Jackson, MS. 1929, citing The Dictionary of National Biography, Volume 25, page 230, see Hawkins, William, and Introduction to Hakluyt's Voyages, page 1.)

The biography of William Hawkins (1678-1748), serjeant-at-law, describes him as the second son of John Hawkins and Mary Dawe, who was a daughter of Edward Dawe of Islip, Oxfordshire, but it does not identify his siblings. (The Dictionary of National Biography, Volume IX, page 230, citing Burke's Commoners, Volume II, page 215.) John Hawkins and Mary Dawe did have a son John but he married a Miss Wainwright and had a son William who married Sarah Grant, who had a son Samuel who married Sarah Collins, who had issue unidentified. (A Genealogical and Heraldic History of the Commoners of Great Britain and Ireland, John Burke, London, 1834-1838, Volume II, page 215, reprinted Genealogical Publishing Company, Baltimore, 1977.) There is no reference to emigration to Virginia, so this seems to eliminate John Hawkins of King William County as their son.

William Hawkins, serjeant-at-law, was described as a descendant Sir John Hawkins (Hawkins) in his biography but the connection was not explained. The parentage of his father John Hawkins was not stated. (The Dictionary of National Biography.) The lineage that claimed that John Hawkins of King William County was a son of John Hawkins and Mary Dewe of Great Milton identified John Hawkins of Great Milton as the son of John Hawkins and Hester Richards of Slapton but that is disputable also. John Hawkins, son of John Hawkins and Hester Richards, was born on 21 September 1643, lived with his parents, died in 1670 and was buried at Slapton. His sister Hester Hawkins was granted administration of his small estate which consisted of his personal effects and the furnishings of his room. (Plymouth Armada Heroes, The Hawkins Family, Mary W. S. Hawkins, William Brendon and Sons, Plymouth, 1888, authorized facsimile copy produced by University Microfilms International, Ann Arbor, MI, 1976.) This suggests that John Hawkins, son of John Hawkins and Hester Richards, died unmarried and without issue.

JOHN HAWKINS - MARY DEWE

In 1991's December issue, Hawkins Heritage requested sources for the parentage of John Hawkins who married Mary Dewe, and of John Hawkins, husband of Mary Long. Several years ago I ordered a booklet, "Hawkins Family Records", by J. Montgomery Seaver, and printed in 1929 by the American Historical-Genealogical Society in Philadelphia. In 1971 it was republished by the American Genealogical Research Institute, 20 "E" Street, Northwest, Washington, DC 20001. This may be of interest to you, if only for comparison. Many sources are listed for the booklet information, but not specific sources for the following.

The first "Pedigree A" began with William Amadas Hawkins, Sergeantat-Arms to Henry VIII; m. Margaret Hawkins, d/o ?. Their daughter, Joan, m. John Hawkins, Esq, and lived in Travistock, ENG. He d. in 1490. Their son, Capt. Wm. Hawkins was a sea captain, b. probably at Plymouth, Devonshire; & m. Joan Towne Trelawney, an only child.

A son of Wm. and Joan was Capt. William, who commanded the "Griffin" against the Spanish Armada. (Seven Ch: Richard, Nicholas, b. 1582, Francis, William, Elizabeth, Frances (m. John Newton), and William. A 2nd son was Adm. Sir John, b. 1532, m. #1 Katherine Gonson, #2 Margaret Vaugh, d. at sea 12-Nov-1595. Adm. Sir Richard, s/o Sir John, m. Judith Hele. Richard & Judith's son, John, b. 1604, m. Hester Richards. Seaver further states that John & Hester's son, John, b. 1643, m. Mary Dewe. (Their ch: Wm., b. 1673, author of "Treatise of the Pleas of the Crown"; and John, b. 1680 who settled in St. Anne's Parish, Essex CO, VA, 1705; d, before 7-Oct-1740. John Hawkins & Mary Dewe's children listed as Joseph, b. ca 1707, living in Hanover CO, VA 1740; m. Jane ?; d. ca. 1770. #2 was John, b. ca 1735, living in Hanover and later In Guilford CO, NC; drowned in the Haw River after the Revolution. Richard Hawkins was another son listed for Admiral Sir Richard Hawkins and Judith Hele.

Pedigree "B" begins with Zacharia Hawkins, b. in Eng, and was one of the original proprietors of Brookhamen Town, Suffolk CO, L.I., NY, His children were Zacharia, Joseph, Eleazer, Martha and Hannah.

I believe that Wanita Lucas is the only member who has mentioned the Seaver source to me, so perhaps the 36 page booklet isn't readily available, nor still in print, so I listed excerpts from it.

Wanita Lucas, member from Pana, IL, likes to take Hawkins notes the way many of us do - take a lot of them, and figure it out later! In Seaver's notation, Wanita suggests that John, father of Joseph b 1708 Essex CO VA, and John who lived in Hanover CO, and later moved to Guilford CO, NC, does not seem to be the same John Hawkins who lived in King William CO, VA, and who Virkus says married Mary Long. She mentions that it is obvious that many researchers have confused the John Hawkins. Also, "'The Sevier Family History' has indicated that the Joseph Hawkins, b. 1708, s/o John was the father of Sarah Hawkins Sevier. However when I wrote to Mrs. Madden, the writer of the Sevier book, she replied that she had no documentary proof of that, but only assumed it, and felt it needed further study."... Wanita (Wanita's address is 100 W. Fourth, Pana, IL.)


