Bits and Pieces of the Hawkins Family Puzzle

Cont'd from last issue

Rita Souther of Alexandria, VA has an ancestor Isaac Hawkins b. 1790-1800 and mar. ca 1820 Sarah T---. He died in Bath CO., KY 1846-1849. He is possibly the Isaac Hawkins buried in a cemetery in Nicholas CO. 2½ miles from Sharpsburg, KY. (1799-1840) Sarah was b. ca 1793 and died after 1860 at which time she was living in Bath CO., KY. Isaac and Sarah had a son Levi Hawkins b. Nov. 7, 1826 in Nicholas CO., KY. He mar. Elizabeth Ann Coons and they had one daughter, Elizabeth Ann b. Dec. 11, 1853. She mar. Elias Ullery. Elizabeth Coons was the dau. of Thomas Coons and Lucinda Hon.

Levi mar. Elizabeth Edwards who was b. Jan. 25, 1838 in either Kentucky or Independence, MO. She died on July 23, 1929 and is bur. in Cass CO., MO. She was the dau. of James M. Edwards b. Jan. 28, 1812 in KY and mar. June 24, 1834 in Montgomery CO., and Sarah Coons (Coonce). Sarah was b. on Oct. 10 1814 in Kentucky and died in 1883 in Cass CO., MO. Her parents were John Coons

and Elizabeth Ellis. Agnes Brooks Carr was her mother and William Ellis was her father. John Coons was the son of Jacob Coons (Kuntze) and Elizabeth Handback.

James M. Edwards, the father of Elizabeth Edwards, was the son of Joseph Edwards b. ca 1780-85 in Virginia and Malinda Mc Ilhaney b. ca 1791 in S.C. Joseph Edwards is thought to be the son of Thomus Edwards and Grizelda Barnes. Malinda McIlhaney was the dau. of ----McIlhaney who. mar. May 12, 1792 1793, Grizella Graham who may have been his second wife.

A Hawkins couple who deserves recognition is William Hawkins and his wife, Mary who lived in Stephans CO., Texas. It is said that they have had nineteen children of their own and raised some of their grandchildren.

In the Stephans CO., TX 1880 census William is shown to have been b. in Tennessee and was 64 years of age. Mary was b. in Alabama. Their children at home at the time were Peter Thomas, 16, and Lewis McK. 10. Both were born in Texas. Also living with them were grandchildren, Delita Jane, 14, James 12, and Sarah C. 10.

Mary Ann Hawkins (b. Aug. 29, 1841 d. Dec. 21,1872 was the dau. of William and Mary. She mar. John W. Berry b. Mar.4, 1828 and d. July 6, 1873. Their children were: William Henry b. Jan. 27, 1860, d. Feb.2, 1860. Mary Suzanah b. April 23,1861 mar. William Griffin. Safronah Alabama b. Feb. 27,1863, d. July 1, 1951. Delita Jane b. Mar. 18,1866. James French b. Mar. 4,1868. Sarah Caroline was b. June 27, 1870 and d. April 13,1949.

Carolyn Sue writes, "Sarah Caroline was my Grandmother. When her mother and father died, she and her brother and sister went to live with her Grandpa and Grandma Hawkins."

"Sarah married 18. June 1891 Marion Wesley Martin at Vernon, TX. Their first two children were b. at Stephenville, TX. They moved to Floydada Floyd, Texas and this was the last time she saw her Grandpa and Grandma Hawkins. I don't know when they died."

George Hawkins a cooper, lived in Lower Norfolk CO., VA in 1647-1655.. In 1654 he was a debtor and in 1659 he was paid from the County levy. In 1653 he was a constable of Lower Norfolk and was also convicted of a theft the same year. For a crime unknown, he was arrested, 1655 and 1657. He was fined in 1653, 1655 and 1656. He was a plaintiff in 1655 and judgement is listed in 1650 and 1659. Payment was ordered to him in 1658. He was a defendant in 1656 and payment was ordered from him in 1656 and 1657 when he is listed as having petitioned the court. He was involved in a court case both years and probate of an estate was granted to him in 1660. His earlist known listing in a court case was in 1652.

Lucretia Hawkins b. 1810-15,1905 mar. Jerimiah Vardeman Munday (1808-1875) on Sept. 26, 1834 in Woodford CO.,KY. Their children were: Susan Mitilda,(sic) Aug. 16,1835 d. July 1913. She mar. Joseph T. Curd. She died in Fresno,CA. Thomas b. Dec. 23,1850, John b. 1844 and William b. 1849.

James S, Hawkins was b. Sept. 30,1840 in Woodford CO., KY was the son of Senate A. Hawkins and Mary Dodd. His grandfather James was b. in Virginia. James S. served under General John Hunt Morgan in CO. E. Second Kentucky Cavalry and was wounded in the shoulder at Cynthiana in 1863. He was

wounded in the side and right hand at Bull's Gap. He surrendered with Gen. Taylor in Mississippi on Apr. 15,1865. He returned to Woodford County and opened a general store and raised cattle. His wife was Dolly Reed of Jessa-Mine CO. He was a Presbyterian. Information from Biographical Sketches in Kentucky A History Of The State by Perrin, Battle and Kniffin.

John Hawkins b. 1750-60 mar. ca 1770 to Elizabeth----. Their children were: Delila, John, Elender, Joseph, Milly, Elizabeth, Nancy, all born in Kentucky. In 1790 he was in Nelson, CO. KY and in 1791 a daughter was born. In 1815, he deeded one and one third acre of his property for a Baptist Church meeting house and burial ground. It is now called Lincoln Memorial Cemetery on Fort Knox near Mill Creek. In 1820, he was in Harden CO. and died 1830-31.

Mrs. Willie Shearer wrote a family history on her Hawkins line in 1976. A copy was made for me at the Spotsylvania Historical Society in July, 1983. She wrote: "The foregoing family history was given to Mr. Mays or Judge Edward Mays by a--- in a letter bearing the date of Oct. 30, 1893, she being then 72 years old, and having gathered the same from family letters and family conversations." All attempts at contacting Mrs. Shearer were in vain and

the identity of "she" remains a mystery.

The "foregoing" information given to Mr. Mays is this: "John Hawkins left his wife, Mary (Waller) Hawkins the following children: 1. John Hawkins, 2. Hardress (Hardy) Hawkins, 3. Elizabeth Hawkins, married John Dick, who died in a year, leaving a daughter Mary Hawkins Dick, who subsequently became the mother of Mrs. Mary Hawkins Jackson of Nashville, TN. Elizabeth Hawkins Dick married Thomas Crowder and left several children, one of whom married a Mr. Nash. 4. Mary Hawkins, born Sept. 9, 1771, married Emsley Parke on Oct. 16, 1794. Children: 1. Pleasant S. Park, 2. Alfred W. Parke, 3. Frances Eliza Park. 5. Frances M. Hawkins married a Mr. Duggar, Children: 1. Elizabeth Duggar, married a Dr. Williams. 2. Caroline Duggar, married a Dr. Battle. Dr. Williams and Dr. Battle were from LaGrange, GA."

Who was this John Hawkins? The Tennessee D.A.R. State Records show that Captain John Hawkins born February 14, 1733, died on Dec. 19, 1786. He was married to Mary Waller and was in the 5th Maryland Battallion 1771-1781.

Ref. Heitman's Official Register Pg. 214.

Mrs. Shearer uses Marriages of North and South Carolina by Clemmons, Pg.120 as her reference for the following: "John Hawkins, oldest con of John and Mary Waller Hawkins went to Rowan County, North Carolina. John married Mary (Polly) Goodman, daughter of John Goodman, on December 27, 1796 in Rowan CO."

The Randolph CO. Deed Book 13, Pg. 354 shows John was married to Elizabeth Varner, dau. of Jacob Varner. Elizabeth Varner of Randolph CO., NC married Benjamin, son of John and Polly Goodman in April, 1831. It is not clear if this is his sister-in-law or another Elizabeth Varner.

Orange CO. NC Deed Bk. 8, Pg. 360 shows that John and Hardress Hawkins, brothers and heirs of John Hawkins came to an agreement on the division of land owned by their deceased father, John. " John agrees to: One tract whereon my father lived, adjoining John Lin, George Fogleman, and the Orange CO., line, 640 acres and one other tract adjoining Robert Fields, Jeremiah Fields, 641 acres, "and was witnessed by J.Scott and Isaac Holt. Pro. May, 1800.

Mrs. Shearer shows that a John Hawkins was a Sheriff and Hardrip Hawkins was a Deputy Sheriff in Orange CO., NC. In Sept. 1786, he had a license to keep a tavern or "Ordinary" at his dwelling home. In 1787, she shows that John Hawkins drowned accidently in the Haw River.

Benjamin Hawkins, son of John Hawkins and Polly Goodman was b. June 3, 1803 in Randolph CO.,NC. He purchased 250 acres from his father, John in 1825. His wife was Elizabeth Kindley whom he mar. on Feb. 28, 1825 in Randolph CO. They had children: John b. Nov. 25, 18--. He mar. Louisa Smith in Smith CO.,MS. Martha (Patsy) was b. May 1, 1827 in Randolph CO. and mar. Anguish Gunn in 1848 in Smith CO.,MS. Pleasant C. Hawkins was b. June 9, 1829 and mar. Polly Westbrooks.

After Elizabeth Kindley's death in January 1830, Benjamin mar. Elizabeth Varner on Apr. 3, 1831. Their children were: William b. Sept. 16, 1832 in Randolph CO., NC. William mar. Mary Quinn on Jan. 24, 1855 in Smith CO.MS. Anderson b. in Randolph CO. mar. Martha E. McQuinn, Sept. 20, 1855 in Smith CO. Jessee Dobson b. 1838 in Randolph CO. mar. Catherine Johnson on Apr. 16, 1867. Charles (Brim) b. 1840, Mary Ann b. Dec. 12, 1842 mar. Moses Lingle on Aug. 2,1861. Nancy b. 1844, probably in MS, Thomas b. 1847 mar. Lincy Shirley of Smith CO., MS. Before moving to Mississippi, Benjamin was a member of the Assembly (House of Representatives) from Randolph in 1833/34. He owned over 1,100 acres in Randolph County. He is said to be a descendant of Sir John Hawkins.

Another interesting fact that Mrs. Shearer discovered is that Elizabeth Kindly Hawkins was a descendant of John and Ursula Briles who came from Germany in 1717 to Gernanna, VA. Germanna was located on the Rapidan River in Orange, CO., VA. This was the location where Gov. Spotswood established his community of German workers. Remains of living area and place of worship is still there. The location is on the Orange County side of the Rapidan River to the left of the bridge to Culpeper CO. on Hiway 3. from Fredericksburg. The pictures below on this page were taken there. It is still a woodsy and beautiful place. Flat Run is near this area. William Hawkins of Orange CO. left property on Flat Run to his sons, Reuben and Elisha in 1799.

- 1668 Capt. Tho. HAWKINS and Coll. CATLETT witnessed a deed acknowledgement by Capt. Alex. FLEMING on "16th 9bris 1668". The deed was to Eliza. HOSKINS. [ob15-16. tb 9]
- 1668 same parties and date as above, except that HAWKINS and CATLETT were referred to as "Justices of the peace for Rappa. Co."[ob16-7, tb 10]
- 1668 Capt. THOMAS HAWKINS and Collo. Jno. CATLETT "two of his Maties Justices for Rappa County" on 16 Nov 1668 witnessed a deed acknowledgement by John BLACKDEN. The deed was from BLACKDEN to Robt. PAYNE(ob18-21,tb 11-12)
- 1668 Tho. and Elizabeth PAGE named "our loveing Freind" Thomas HAWKINS their attorney to acknowledge a deed from them to James and William BOWLER. 26 Oct 1668 [ob 26-8, tb 16-17]
- 1666 James COGHILL, planter purchased from Rorah MACRAH 2/3 of land which MACRAH bought and purchased of Wm. GIBSON. For 3300 lbs. tobacco. 1 Dec 1666. Witnesses: Abraham COOMBE and Ro. PAYNE.
 - On 14 Feb 1667, MACRAH and COGHILL acknowledged the deed before John CATLETT and Thos. HAWKINS.
 - On 18 Dec 1667, James COGHILL sold the MACRAH land to Archdall COMBE. Witnesses Robert GRIFFIN and Timothy PELL.
 - On 14 Feb 1667(sic) James COGHILL acknowledged the deed to COMBE before John CATLETT and Thos. HAWKINS.
 - On 9 April 1668, Archdall COMBE sold the land purchased from COGHILL to Francis TRIPLETT, witnesses: John EVENS and Tho. WRIGHT. On 28 Sept 1668 this deed was acknowledged before John CATLETT and Thos. HAWKINS.[ob28-31,tb 17-8]
- 1668 In 1668, Francis TRIPLETT and Abigal his wife acknowledged a deed to Francis STERNE in the presence of John CATLETT and Tho. HAWKINS. [ob 29-31, tb 19]

- 1667 A patent to James GAINES dated 11 Mar 1667 mentions that 386.25 acres of the patent had been initially patented to Thomas HAWKINS on 20 Sep 1661 but had been assigned by him to GAINES. [ob 192-3, tb 32]

A Samuel Hawkins owned 300 acres of "3rd rate" land (B. & L. Harrison survey) on the Licking in Nicholas county, Kentucky.

Samuel was listed on the tax list as 1 white male - and he owned 3 mares.

1807 On 370 (3rd rate) acres, we find Samuel's household consisted:

1 white male voter

1 white male 16-21

3 mares

In this period there were several other Hawkins in Nicholas County: Thomas, Gregory - and in 1814: James.

1808 Samuel was living on 300 acres (Owings survey) on the Licking - owning 4 mares.

1811 Samuel was taxed on 370 acres of 3rd rate land on the Licking (Owings survey) - with 4 mares.

1814 He is still there in 1814 listed as 1 white male over 21 with 5 mares. His land was valued at 3.50 per acre. The total value:

1435. His area was under the jurisdiction of Capt. Collins.

Samuel is taxed on 100 3rd rate acres on the Licking in Nicholas 1821 County (Martin survey). 1 white male and 3 mares valued at \$850.

He is in school district #16 with 3 mares on his 100 acres -1822 value: \$880.

Samuel's 100-2nd rate-acres on the Licking were listed as "Bell" 1836 survey. He had 1 mare. By this time, if still living, he would have been about 70 years old. Hannah had 93 3rd-rate acres on the Licking (also Bell) and 3 cattle.

Elijah was over 21 and had 1 horse and 1 cattle.

Squire, a white male, had 4 horses and 2 cattle.

1838 Samuel seems to have died in 1838. There was a division of land on June 19, 1839 conducted at the March term 1839 Court. ['38, '39?] 1839

Cassandra Blair inherited Lot 8:

Beginning at Water Beechat bank of Licking thence N 551° E 751 poles to 2 Poplars thence N 9° E 21 poles to stone thence

HAWKINS NOTES

by Wanita Lucas

In General John Parker Hawkins' books on his family, he refers to Maryland Hawkins families, which he believes are connected to his family because of the reference to the name Philemon. He says that the name has been carried down through his family -- descendants of John and Mary Hawkins of VA, and descendants of Philemon and Anne Howard Hawkins, who was an immigrant to VA. They then moved to NC.

In a book, Founders of Anne Arundel Co., MD, by Warwick, I find some references to these early Hawkins families, and to the Lloyds. He says that the Bennett, Lloyd, and Meers families were closely allied to the early Hawkins families who settled on the Magothy River, and in the Nansemond area.

We find Ralph Hawkins living on the Magotly River as early as 1657, with wife Margaret. In his will of 19-9-1668, he mentions wife, and sons, Ralph, Jr. and William.

The will of Thomas Meers, of Severn River, leaves personality to Eliza Hawkins, wife of William.

The will of Thomas Hawkins, probated 7-Apr-1677, names his brother John, wife Hannah, and eldest daughter, Eliza, and also Margaret, daughter of Edward Hall.

The will of John Hawkins, probated 17-Mar-1676, leaves his entire estate to wife Mary (or Martha?).

The will of Giles Cole, of Charles Co., MD, dated 7-10-1675, leaves personality to John Hawkins, Jr., and his brother, Henry, and their sister, Eliza Hawkins, and also a bequest to Thomas Hawkins. Henry Hawkins is the executor.

In the will of Henry Hawkins, probated 15-8-1673, leaves his property to Richard Woolman, Alis, his wife, and children; to his brother Philemon Lloyd, his wife; to Edward Lloyd, son of Philemon Lloyd, 4 patents of land; to Susanna Maria Bennett and Edward Lloyd, residue of estate. Ex: brother Philemon Lloyd. It is believed that Henry Hawkins was the stepbrother of Philemon Lloyd, and there were some references to the Lloyd family in England, connected with Hawkins.

Edward Lloyd was made commander of Prividence, a position similar to Lt. Gov. One of his commissioners was Mathew Hawkins, who also owned land on the Magothy River. Ralph Hawkins was a neighbor to Mathew Hawkins and Edward Lloyd.

It is believed all these Hawkins families were connected, but it is difficult to determine the exact relationships. In 1651, Col. Cornelius Lloyd was made guardian of Samuel Hawkins, an orphan, and he also acted as agent for Henry Hawkins.

(References to Hawkins wills from Maryland Calendar of Wills, by Jane Baldwin, 1901.)

RALPH HAWKINS

Ralph is a given name that hasn't come to my attention very much, via Hawkins correspondence. My first thought is that if you have a Ralph in your ancestry, he might connect with this family.

According to Baltimore County Families, 1659-1759, Ralph Hawkins died in A.A. CO cSept 1699. His wife's name was Margaret, who "may have m. as her 2nd husband James Kyle". Ralph had a son, William Hawkins, of Balt. CO. His will of 1688 listed sons Wm. and Ralph.

William Hawkins, probably son of Ralph, d. there by 1711. His wife was Ann, widow of Stephen White. The article states that John Rockhold of A.A. CO, in his will of 1698, "left property to his 'cousins' (i.e. nephews) Stephen White and William Hawkins, Jr. It was signed by Thomas Hawkins and Elizabeth Slade as kin. "Wm. and Ann had issue: Wm. Jr; possibly Thomas, Elizabeth, m.? Slade; dau. m.? White". The article states that there is a study of Hawkins family in William N. Wilkins Gen. Collection at MD Historical Society.

William Hawkins, s/o William and Ann, died in Balt. CO by 1722. He married Ann, who later m. Robert Emory.

To Quote Or Not To Quote

In the May 1991 issue of "Writer's Digest", Art Spikol has some interesting comments on the subject of quoting published material. After making the statement, "Okay. Now that we've established that using someone else's words is not necessarily plagiarism, how far can we go before it is?" He says that if we read a factual statement in a newspaper - "something about the latest census, for instance - you have no obligation to quote the author of the article."

. . . "Nobody owns facts. . . . but a collection can be copyrighted." We probably already know that some things are in public domain. The copyright might be outdated, not renewed, or the material was published before copyright laws.

Mr. Spikol says. . . . "you are not allowed to lift a body of information that would tend to devalue in any way, the work in question." That requires some thought. To me, whenever someone has submitted for publication, information concerning their ancestry, with the hope of hearing from an "unknown cousin", they surely wouldn't mind having it reprinted in another genealogical publication. SAMUEL HAWKINS

COL. SAMUEL HAWKINS, b. Nov 1762, just east of the present day Village of Hawkinstown, Shenandoah County, Virginia, d. 2 July 1814, in Preble County, Ohio (formerly Hardin Township, Hamilton Co., Ohio); son of Joseph Hawkins (d. 1770) and Sarah (Marlin) Hawkins, m. ca. 1783, Ohio County, Virginia, (now WV), Catharine "Christina" Worthington (1759-1813), dau. of Thomas and Ann Worthington, of near Wheeling, Ohio Co., WV. See will of Thomas Worthington (d. 1781) in Ohio Co., WV, Will Book 1, page 3, wherein he willed his plantation to daus. Catharine and Mary Ann Worthington, and Ohio Co., WV, Deed Book 7, page 461, wherein Samuel Hawkins and wife Catharine Worthington Hawkins of Preble, Co., Ohio, sold the land which Catharine had inherited from her father.

In 1770, when Samuel was but seven years of age, his father, Joseph, died. Five years later, upon the request of their mother, Sarah Hawkins, "Samuel and Elizabeth, youngest children of Sarah" were, on the 5th day of the 6th month 1775, received as members of the Quaker, Hopewell Monthly Meeting. They remained Quakers until 1783 in which year both were dismissed—he for having become a Revolutionary War soldier. See Encyclopedia of American Quaker Genealogy, by William Wade Hinshaw, pages 399 and 597.

Family tradition has it that Samuel Hawkins joined the army at age 16; served throughout the Revolution with the rank of private; was discharged in 1783 at Wheeling, West Virginia, and there married Christina Worthington; and without returning home, joined with a party of settlers and went to Kentucky.

In the winter of 1784, Samuel and his wife Catharine returned to Shenandoah County, Virginia, for the purpose of selling his land, it being his divided part of the 420 acre Joseph Denham tract, located west of the Town of Mt. Jackon, which had been devised to Benjamin and Samuel Hawkins by the terms of their father's will. By deed dated 20 Feb 1784 (D.B. D, p. 387), Samuel and Catharine Hawkins from Lincoln County in the Commonwealth of Virginia (now Kentucky), for the sum of 350 pounds, sold to his sister, Rebecca Campbell, widow of Lt. Col. Richard Campbell, 200 acres and 100 perches of land. This deed was also signed by Samuel's mother, Sarah Hawkins, as she was executrix of the estate of Joseph Hawkins, deceased

Then aged 22 and reasonably wealthy from the sale of his inherited land. Samuel and Catharine returned to Kentucky and took up land in Bourbon County joining John Byrd, Capt. William Byrd and not far from Capt. Abraham Byrd. See Bourbon Co., KY, Deed Book X, p. 313, dated 8 March 1830. There are some Bourbon County records that indicate Samuel's older

brother, Benjamin and his wife Magdalene (Byrd) Hawkins, may also have settled in that neighborhood.

Magdalene Byrd Hawkins, Pvt. John Byrd, Capt. Abraham Byrd and Capt William Byrd were all four children of Mounce and Clara (Ruddell) Byrd. From 1762 to 1772 Mounce and Clara Byrd lived at the Red Banks plantation just north of and joining the Hawkins plantation at Hawkinstown. The Hawkins and Byrd families were neighbors in Shenandoah County, VA, and Bourbon County, KY.

In the Bourbon Co, KY, Circuit Court File Box 23-26 is found two documents: The first, dated 18 March 1790, sets forth charges by James Hall and Daniel Workman against Benjamin Hawkins and Samuel Hawkins for non-payment of 10 pounds or a horse of equivalent value. The second, dated 19 Nov 1790, is an order to the Bourbon County sheriff to bring Benjamin and Samuel Hawkins before the court on the third Tuesday in February 1791, to answer charges brought by Hall and Workman. Apparently Benjamin Hawkins had died in 1790, before this suit was prosecuted, for his widow, Magdalene Byrd Hawkins, married John Taylor, in Shenandoah County, Virginia, in April 1791.

Also in Bourbon Co., KY, Circuit Court File Box 100-105 is Samuel Hawkins' bond with Abr. Byrd as security. Hawkins and Byrd agree to pay should Elizabeth Caril win her Judgment against Samuel Hawkins. This undated document is signed in their own handwriting by Samuel Hawkins and Abr. Byrd. In Shenandoah County, Virginia, Deed Book I, page 187, dated 22 June 1793, is a deed whereby "Abraham Bird & Mary his wife of the State of Caintucka", released unto his brothers, William Byrd and Mounce Byrd, "All Our Rights and Title of in and to the Personal or Moveable Estate of Mounce Bird deceased late of the County of Shenandoah in the State of Virginia." A comparison of Abr. Byrd's original signature on this Shenandoah County deed with his original signature on the Samuel Hawkins bond in Kentucky, shows that both signatures are identical, thus providing positive proof that Mounce Byrd's son, Abraham, was the same Abraham Byrd that signed Samuel Hawkins' Bourbon County, Kentucky bond.

Much of the information regarding the places Col. Hawkins lived and data on his children is recorded in the <u>History of Preble County</u>, Ohio, by Collins on pages 100, 145 and 146. Collins states his source for the facts (on pages 145-6) about Col. Samuel Hawkins as taken from a clear, concise manuscript written by Joseph C. Hawkins, when Mr. Hawkins was in his ninety-seventh year. His age being 97 is obviously incorrect as Joseph C. Hawkins (1785-1849) died at age 65 and is buried in Mound Hill Cemetery, Eaton, Ohio. In this manuscript Joseph C. Hawkins lists his brothers and sisters as John J., Benjamin W., Samuel, Byrd, Sarah, Rebecca and Eleanor. No mention was made of a sister Lydia.

In Bourbon County, Kentucky, Marriage Book 2, on page 1, is recorded the marriage, in 1799, of Lydia Hawkins to George Worthington Collins, on page 100 of his <u>History of Preble County</u>, Ohio, states that Colonel Samuel Hawkins, with his sons Joseph C, John J, Benjamin F, Samuel, and Bird Hawkins were, in 1806, among the first settlers at Eaton, Ohio. On the same page Collins states that a little after 1808, "George Worthington, whose wife was a daughter of Colonel Samuel Hawkins" came to Eaton, Ohio Possibly George Worthington was a relative of the wife of Colonel Hawkins, rather than son-in-law.

According to a note furnished by Mrs. Marion H. Gray of Columbus, Indiana, Mrs. Grey quotes the following from: Fountain Co. (Ind.)
Centennial Book--DAR, 1926--

"In 1824 came a boat load of settlers from Maysville, Ky, bringing with them materials for a community house which they built on the Wabash River bank, 1824. The Town of Maysville was later platted, grew to considerable prominence and disappeared. The men who came were Morrison, Henryman, Dunkin, Hemphill, George Worthington and his father-in-law, Hawkins and Isaac Coleman."

As Col. Samuel Hawkins had died on 2 July 1814, at Preble Co., Ohio, there are some doubts as to whether he was the father of Lydia Hawkins who married, in 1799, George Worthington, in Bourbon County, Kentucky. Col. Samuel Hawkins was living in Ohio, when Lydia married George Worthington. This, coupled with the fact that Joseph C. Hawkins did not name Lydia as his sister, makes it doubtful that George Worthington was a son-in-law of Col. Hawkins. Possibly George Worthington married Lydia, a daughter of some other Hawkins.

Col Hawkins, a soldier in the Revolutionary War and War of 1812, attained the rank of Colonel in the Kentucky Militia company that took part in the Indian Wars in Ohio under the command of General Wayne. After his victory at the Battle of Fallen Timbers, Gen. Anthony Wayne, in 1795, signed the Treaty of Greenville, thus making a large portion of Ohio safe for settlers. Shortly after the Treaty was signed, Col. Hawkins removed from Kentucky and settled north of Cincinnati on the Great Miami River, in Butler County, Ohio. In 1799 he removed from that locality and became a resident of the spot on which the Town of Germantown, in Montgomery County, Ohio, was later built. There his son, Byrd Hawkins, was born in 1802. In 1806 he sold out and moved to and was among the first settlers at Eaton, Preble County, Ohio. He built a home and tavern and it was in the Hawkins Tavern that the first Court for Preble County was held.

Children of Samuel and Catharine "Christina" Worthington Hawkins (probably not in correct order of birth) were

(1) CAPT JOSEPH CAMPBELL HAWKINS, b. 1 May 1785, in Bourbon Co., Ky, d. 12 March 1849; buried in Mound Hill Cemetery, Eaton, Ohio; son of Samuel and Catharine, m. 13 Aug 1805, Esther Pogue. Her tombstone erected by her daughter, Mary Gray, in Mound Hill Cemetery reads "Isabel, wife of J. C. Hawkins, b. 6 Nov 1785, d. 22 Jan 1818. Reference: "Miami Valley, Ohio, Pioneers," by Lindsay M. Brien (1980), page 78. Capt. Joseph C. Hawkins was Clerk of Preble Co., Ohio, Court in 1824.

Some sources list Lydia Hawkins; who m. in 1799, George Worthington, in Bourbon Co., Ky; as a daughter of Samuel and Catharine "Christina" Worthington Hawkins.

Much of the information regarding the descendants of Col. Samuel Hawkins is from a handwritten genealogy compiled in 1932, by Jane S. Hawkins Watkins, when she was age 75. Her father was Joseph Campbell Hawkins, son of John Jones Hawkins, son of Col. Samuel. With a letter written from Portland, Indiana, dated 21 Feb 1932, addressed to Mrs. Marion H. Gray of Terre Haute, Indiana, Jane Hawkins Watkins enclosed her genealogy of the Hawkins family. In her letter she wrote—"I have been a long time sending you this genealogy but I know you will forgive my delay when I tell you that I am 75 years old and have to work every day for my living. It is restaurant work and hard for me. So I only have about 2 1/2 hours a day to do other things."

HAWKINS FAMILY REPORT

To Rudelle Davis

Peggy did an excellent job of collecting what little that has been published pertaining to my Hawkins family and their relationship to Davy Crockett. Although much of what has been published in Notable Southern Families is incorrect, it does provide some helpful information. What is basically correct in these reports is that Joseph Hawkins (d. 1770) and wife Sarah Marlin of Hawkinstown did have three sons—Joseph, Jr., Benjamin, Samuel and a daughter Sarah, wife of Tennessee Governor John Sevier. It is also correct that Joseph's youngest son was Col. Samuel Hawkins, who had married Catharine "Christina" Worthington and they were the parents of Joseph Campbell, John Jones, Benjamin Worthington, Samuel, Byrd, Sarah and Eleanor Hawkins. Although Lydia is also reported as a daughter of Col. Samuel there are some reasons to believe she was not.

About four years after Col. Hawkins had removed from Bourbon County, Ky, in Bourbon County, Ky, in the year 1799, a Lydia Hawkins was married to George Worthington. A correspondent writes that in 1824-twelve years after Col. Hawkins had died--"George Worthington and his father-in-law Hawkins," from Maysville, Ky., moved up the Wabash River and established a new town called Maysville. She gave her source: Fountain Co. (Ind.) Centennial Book--DAR 1926.

The following is proof that Samuel Hawkins, b. 1762 at Hawkinstown, Shenandoah Co., Va.; son of Joseph Hawkins (d. 1770) and wife Sarah Marlin; was the same person as Col. Samuel Hawkins, b. 1762 in Va.; d 1814 in the Town of Eaton, Preble Co., Ohio.

- 1-By Deed dated 20 Feb 1784, Samuel Hawkins and Catharine his wife of Lincoln County, Virginia (now Ky.) signed in Shenandoah Co., Va., a deed whereby they sold to his sister, Rebecca Campbell, 200 acres of land west of Mt. Jackson, it being the same land devised to Samuel by will from his father Joseph Hawkins (d. 1770). Ref: Shen. Co. Deed Book D, p. 387.
- 2--Joseph Campbell Hawkins (1785-1849), son of Col. Samuel Hawkins, provided the information on his family which is recorded on page 146 of Willims, <u>History of Preble County</u>, Ohio. Joseph C. reported he was born in Bourbon County, Kentucky, in 1785 and came with his father's family to Eaton, Ohio. He does not mention having a sister Lydia.
- 3--In his will recorded in Ohio County, West Virginia, Will Book 1, page 3, Thomas Worthington (d. 1781) devised his land located along the Ohio River near Wheeling, Ohio County, Virginia, jointly to his daughters, Catharine and Mary Ann Worthington.

4--The second daughter, Mary Ann Worthington, applied for and in 1784 obtained from the Commonwealth of Virginia, two patents, one for 400 acres and the other for 320 acres of land, it being land along the Ohio River near Wheeling that Thomas Worthington had made settlement upon in 1773. These two patents, made out in the name of Mary Ann and Catharine Worthington (Legatees of Thomas Worthington), are recorded in the Virginia State Library, Richmond, Virginia, in Grants L, p 445 and Grants 10, p. 100.

5--The University of West Virginia Library at Morgantown, West Virginia, has the original suit documents pertaining to the Court division in 1808 of Thomas Worthington's 320 acre tract along the Ohio River that had been patented to his daughters Catharine and Mary Ann Worthington. Among the suit papers is a plat and survey description whereby on 4 Nov 1808, Court appointed Commissioners divided Mary Ann and Catharine Worthington's 320 acres into two separate tracts, one containing 168 acres and the other containing 132 acres.

6--By a Deed dated 13 April 1813, recorded in Ohio County, West Virginia, Deed Book 7, p. 461, "in compliance with a partition made by the Court of Ohio County," Samuel Hawkins and wife Catharine (also referred to in the deed as Christain) of the Town of Eaton, Preble Co., Ohio, for the sum of 225 pounds sold the same identical 132 acre tract of land partitioned by the Court, on 4 Nov 1808, from a larger tract of 320 acres jointly owned by Mary Ann and Catharine Worthington.

Assistance in identifying Col. Samuel Hawkins as the son of Joseph Hawkins of Hawkinstown, Virginia, was provided in the many old letters and documents zeroxed and sent to me by Mrs. Marion H. Gray of Columbus, Indiana. Mrs. Gray, now in her 80's and partially blind, began research on her ancestor Samuel Hawkins back in 1922. After her 51 year search, it has been my pleasure to have recently located and provided her with the above data on her Hawkins ancestors.

John William Hawkins, b. Greenville, S.C. Feb 14, 1799 to March 7,

William E., b. Dec 28, 1841 d. Jan 27, 1849.

I no longer have an address for Mr. Smith. I doubt he is still alive. The last time I wrote him I had no reply. He wasn't well. A lot of his data was speculation I guess, he told me.

I have,

Joshua Hawkins b. July 25 - 1725 a son of Michael and Agness (Eaton?) Hawkins. He had brothers and sisters.

The above Mr. Smith told me was documented in Bristol parish, Prince George Co., VA. (We know our Hawkins came from VA to So. Carolina)
Michael and Agness son Joshua md. Sarah Cook. Sarah b. 25 July 1725.
Sarah, dau. of Richard and Elizabeth Cook. Sarah b. 18 Dec 1729 and had cousins Richard, Henry, Fredrick, John, Nicholas and Elizabeth.

Richard Cook had brothers Robert, Winfred, John and Dinah. Joshua Hawkins will probated 1801, Greenville, S.C.. His son Eaton Hawkins will probated 1812.

Joshua immigrated from VA about 1780. By 1801 at least they lived near Greenville, S.C.. Joshua had a son Joshua who was a Rev. War hero b. 1750 - d. 1812. This Joshua was probably a brother of W.E. Hawkins? Mine Eaton had at least 16 children & probably more than one wife! He married Catherine _____ Hawkins.

Isham Smith m. a cousin Sally Hawkins (1st cousin) and moved to Barren Co., KY.

Ichabod also m. a 1st cousin, Haley Hawkins and they had several deaf and dumb children.

May have lived to 90-91 yrs..... Ezekiel md. a 1st cousin, Polly Hawkins (Mary).

Mine...... Berryman Hawkins, who was my GG/GF md. Martha Salmon, after she died about 1849 - later listed 1860 census a second wife, Fanny Bridges age 49 - Berryman age 55.

Martha Salmon was a dau. of Walker & Polly (Young) Salmon of VA. Luther Preston Hawkins 1835 - a son of Berryman was 14 or 15 when his mother died. A son of uncle Luther told me his dad never talked about his family, so he knew very little, but probably didn't like his stepmother.

I have no idea who you are decended from? I don't know how much history you have. But I havn't worked on it for so long I've forgotten

Son of Berryman..... Richard Hawkins m. DeShago she was French. He died during the C.W. of pneumonia, bro. of Luther Preston DeShago she was Hawkins. Son of Berryman. Richard suffered wounds was a prisoner C.W.

Uncle Luther apparently had a young brother (b. 12 Sept. 1838 in the Bible). No one knew anything about him, but on the 1860 census is (Franklin Salmon.) found a Franklin Salmon Hawkins with Henry & Hannah Hawkins. I don't know who this Henry & Hannah were. Uncle Luther had an uncle Henry who m. Lucy Salmon, an aunt of Martha Salmon.

These Hawkins had so many kids and so many of the same name it's hard to seperate them. Like looking for Smiths and Wilsons by the dozen.

From Mrs. FOrrester of Greenville, S.C., photo copy 1972 in dept. N.C. archives & history. Rutherford, a N.C. tax list 1782 p. 3a:

" Eaton Hawkins - same tax list living near Eaton is Fredrick Hawkins indicating our Eaton & Catherine Hawkins lived in Rutherford Co., N.C. sometime before coming to S.C.. Could also indicate that Levina Hawkins Martin, b. in N.C. & data found in our Hawkins bible, may have been a G/ niece of Eaton - a grandchild - daughter of one of Eaton's sons, of

whom we last trace - to name - Henry Hawkins. Uncle Luther had a sister Elizabeth who m. Jesse Poole who died in C.W. in Alabama. Jesse & Elizabeth had three children who never married. (Nephew of Luther P. above)

1. Jefferson Davis Poole

Jesse P. Poole (had a hardware store in S.C.)(Maybe Travelers Rest)

3. Mattei E. Poole

The wife of Richard received a nice letter about her husband saying he was a fine man & honest. I'm wrong, Uncle Luther received the letter from Richard's brother-in-law & was signed _ DeShazo.

As for the data you sent - Joshua Hawkins & Sarah Cook Hawkins, will 1801, Greenville, S.C. was father of my Eaton Hawkins & GF of my Berryman! You will also note the Joshua Hawkins you mention, Rev W. hero, was apparently a son of the above Joshua & Sarah.

There is Jesse Hawkins buried Bushy Creek cem, S.C.

b. 25 Dec 1774 d. 1853. He was 79.

1775 - 1814 1st wife P. Hawkins

He outlived 2 wives. 1775 - 1848 2nd wife E. Hawkins

There were several Berryman Hawkins (Berry for short) also lots of Eatons. Jesse above will 26 June 1848/ probated 10 May 1853, 2 acre set aside for cemetery & rock wall to be built around it.

Catherine, wife of Eaton d. ca 1829. We had no trace of Henry then. On page 317 RMC office, Greenville, S.C. 8 Nov 1816 Henry Hawkins was moving in 1816 or earlier (where?)

We lost tract of Henry after 1816. So Henry might have moved to N.C.? Levina Hawkins Martin b. in N.C., could have been dau. of Henry. All her kids b. in Missouri, 1846 or later. Levina b. Aug 1827 and in the census in N.C.. Her and Georges children were:

Isabelle, b. 1846. Elizabeth, b. 1848. Polly, b. 1849. John, b. 1851. William, b. 1853. Sealy, b. 1854. James H., b. 1856. George A., b. 1859.

Phillip, b. 1861. All in Missouri.

Riley B. Hawkins, bro. of my GM Elizabeth Jane Hawkins Wells, b. 1856 and d. 1940. I guess he m. 1877 to Mary C. _____, b. 1858. Children of this family: Alfred Lenoard, b. 1878 and d. at age 20 of pneumonia. Fana W., b. 1881. Nancy E., b. 1884. I think this one md. an old man - had twins and died from it according to a story my aunt told me many years ago. John J., b. 1888.

He md. 2nd a part Indian woman, Elizabeth Ellen Denton in 1891.

2nd family: 1. William Riley md. Effie Jones of MO.

2. Elizabeth Jane md. Otto Evans. Otto served in WW 1 and had one leg shot away. Took his knife and finnished cutting it off.

There were Pinkneys (Pink) in the Hawkins, too. Ezekiel Hawkins md. Mary Hawkins, a cousin (1st) and from a story a decendant of mine sent me; a wagon train came and camped in the Reedy River Church (Greenville, S.C.) ground. They were md. (I guess she came with the train) and spent their first night in the church. Mary lived to be 90 yrs. old.

I have a copy of an old letter dated Sept 3, 1837 written by Ichabod Hawkins to bro. "Fredric". Fredric may have been a bro. in law , brother of Mahalia his wife. Parents of Mahalia were William and Sarah Hawkins.

Ichabod speaks of his daughter " Mary can't hear or speak." Neither

could Jerry. He speaks of Uncle Pink.

In Sept. 1838, he mentions "Street" that was Salomon. Ichabod speaks of moving to wherever Fredric lived. In April 1837, he mentions brother Bayliss and sister Martha and Henry.

Jerry Hawkins talked with his hands . I had letters from a woman in Charlotte, N.C. in the 60's. Ichabod came to Hendersonville, N.C. to see his dad, William Henry Hawkins. He brought his brother Jerry and she saw him "talk".

Alford Hawkins was killed in the church house by a son of a woman he had stepped out with in Hendersonville, N.C.. Katie Hawkins (Ezekial) md. James Gudger. He was a congressman from Ashville, N.C.. Katie wrote that Alvin Hawkins, Gov. of Tennessee, was related to our Hawkins. But I never learned how. She wrote this in about 1916.

Katie Gudger's dau. Katie md. a Senator Langley, congressman from KY.

Katie Langley had a dau. Katie Hinton.

A sister of Henry, Ichabod, Berryman married John Ragland of KY and her name was Polly (Mary). Sarah, the eldest m. Alexander West.

 Matthew Hawkins Jr's. purchases are found on page 445 of WB H, November 14, 1820 and November 15th 1820. He purchased a wheat fan and other

items amounting to \$19.62.

There has been no proof so far of a relationship between the two Matthews of Culpeper County, but many feel that Matthew Sr. was Matthew Jr.'s uncle, a brother of his father, Benjamin Hawkins. There's been much speculation by some that this family's progenitor is the famous Sir John Hawkins; but convincing proof is lacking. Although much of the evidence is only circumstantial, it's more likely the Culpeper County Hawkins were related to the MD Hawkins family many of whom bore the same given names as the Culpeper Co. family: Benjamin, Matthew, and Augustin. There were frequent moves between the two states in the 1600's and 1700's for economic as well as religious reasons. Records exist for Hawkins named Matthew, Benjamin, and Augustin in Virginia (Essex and York) and Maryland. Although it IS possible the sea captain was Matthew's ancestor, it SEEMS more likely the Maryland Hawkins were the progenitors. So far the first Culpeper Co. record for Matthew is in the county Court Order Book 1763-4, page 333: Matthew Hawkins vs. James Hawkins. Judgement for plaintiff. It concerned a horse in the possession of James Gaines Jr. and Daniel Dulaney.

The birth order and years of her children are estimated from their marriage dates when known. They may be older or younger. Hannah's birth year is also a guess based on the approximate marriage date of her parents. The year she died is estimated by using the approximate year of Matthew's second marriage to Betty Pitcher and the birth of their child Rebecca.

Proof that there were two wives is established by the Fredericksburg City Chancery Court Suit, File \$124, initiated to settle Job's estate and divide land Matthew left to Job and James. This suit proves the correct relationships

and shows that all but the youngest child (Rebecca) were born of his marriage to Hannah Maxwell. The documents name the wives and the children born to each. They belonged to the Raggedy Mountain Baptist Church, which was later known as the F. T. Baptist Church. Today it is located on the road between the towns of Madison and Sperryville in Rappahannock County.
