  Hawkins, b. c1765 and 1768 in VA. Vital Statistics show that they lived in Stafford County, VA from 1793 until 1825, when they emigrated to Clark County, KY. One son, John R., married into the Hawkins/Bourne line, which may be a connecting Hawkins branch of the above James. Because of an apparent need for "group" research, our publication is now open to descendants of all Hawkins lines.

Individual Membership and subscription is \$12 per year. Contributing Membership and subscription is \$20 per year (may vote).

Subscriptions begin with the <u>April</u> issue. ### OUERY

Who were the parents of THOMAS P. HAWKINS who was born ca 1770, place unknown, and married LUCY COLBERT ca 1796? He was in Hancock County, Georgia in 1797 when he was Executor of the Will of his father-in-law, WILLIAM COLBERT. He died in Talladega County, Alabama in 1837. Was MATTHEW HAWKINS, who sold land to THOMAS in Jones County, Georgia 20 June 1809 his brother? Was the trader, STEPHEN HAWKINS, who witnessed a Deed in Shelby County, Alabama 16 September 1822 between THOMAS P. HAWKINS' son and son-in-law, THOMAS M. HAWKINS and THOMAS BRASHER, also a brother? Were they related to AZIMALECK HAWKINS, who died in Richmond County, Georgia in

When you see the name THCMAS P. HAMKINS, you immediately think the P has to stand for PHILEMON, but I have not been able to make a connection with PHILEMON HAMKINS. THCMAS named his first son THCMAS M. HAMKINS, making me wonder if the MATTHEM HAMKINS in Jones County, Georgia in 1809 could have been named after their father. THCMAS' oldest daughter, ELIZABETH, named her first child ABIMALECK HAMKINS ERASHER, raising the possibility that ABIMALECK, who died in Augusta Georgia in 1798, was THCMAS' father. I read his obituary in the "Augusta Chronicle", and he was apparently a respected and well-to-do man. Unfortunately, the obituary did not name his survivors. When I wrote to Augusta for a Will, I received an Administration Bond for SARAH FACKINS, EZEKIAL HARRIS, and COLLIN REED, naming SARAH Administratrix. ABIMALIX (sic) HAMKINS married SARAH RAGLIN 8 March 1795, only three years before his death. I have no record of his previous wife or wives. If any one has, or has access to, the records of the distribution of his estate, I'll gladly reimburse you for the expense of copying and sending them to me.

In "Historical Sketches of Shelby County, Alabama" by REV. E. B. TEAGUE, the author states that THOMAS had an older brother named STEPHEN. The records show they were in Shelby County at the same time, and even though REV. TEAGUE got some names wrong. I believe he was correct in this statement. STEPHEN and his sons. SAMMEL and BENJAMIN, are pretty well documented, but unfortunately, I haven't seen anything that tells who his parents were. In SCOTT's "MC INTOSH FAMILY" he says that the SAMMEL HAMKINS who married the daughter of CHIEF WILLIAM MC INTOSH was the son of COL. BENJAMIN HAWKINS, the Agent. That is not true. In U. S. House of Representatives Report #98, 1825, STEPHEN HAWKINS states that he is the father of this SAMMEL and his brother, BENJAMIN. COL. BENJAMIN HAWKINS named his only son, JAMES MADISON, in his Will.

I will certainly appreciate hearing from any one who has an answer to any of my questions or even a suggestion of where I might look for answers, and I will gladly reimburse you for any expenses you may incur on my behalf.

### WHAT A FIND!

My husband Clarence and I made the most wonderful discovery ever, during our many years of researching my various lines in Kentucky. Our annual trip to Kentucky was made in October this year, and one of our goals during our visit was to locate and visit the "Old Republican Cemetery" in Bath County.

Our first full day in Kentucky, October 14th, we planned on visiting the Court House and library in Fleming County, only to find both were closed because of what we assumed to be "Court Day" or a fall festival of some kind. Needless to say we were disappointed, but determined to come back another day to pursue our research on my Hawkins line in Fleming County.

We then drove to the public library in Owingsville (Bath County) to review their old precinct maps with the purpose of locating the Hendrix Cemetery where many Hawkins are buried, and the "Old Republican Cemetery" where several of my Hawkins line are listed as being buried. After locating the two cemeteries on the precinct maps, we then could determine approximately where they were located.

After arriving in the general area of the Hendrix Cemetery, we were able to locate it with the help of a local resident who advised us to "go back the way we came to three cattle guards" and we would find the cemetery on the left and up the hill. The "hill" was at a 40 degree angle and the cemetery was approximately 1/4 mile off the road. After reaching the graveyard, we found it to be terribly overgrown with weeds and thorn bushes. Needless to say we received a number of scratches and quite a few snags in our clothing. The reward for such an effort was finding quite a few Hawkins stones, fairly intact with the engravings readable. At the time, after carefully studying them, I couldn't determine if any of these Hawkins are from my line, but I have reason to believe they are. Attached is a list of Hawkins and related burials in the Hendrix Cemetery as copied at the Owingsville Public Library in October 1990. For a complete list of burials, please write me and I will mail them to you.

Our next stop was in the area of the "Old Republican Cemetery" on Flat Creek, also in Bath County. Again, after inquiring about the location from a local resident, he informed us it was about 1/3 mile back the way we had come in. The reason we passed it was because several large bales of hay obscured our vision. If they hadn't been where they were, fairly close to the road, we could easily have spotted the stones, because most of the graves were obviously outlined by stones from Flat Creek. These have the appearance of being above the ground burials, but doubt that they were.

I knew several of my ancestors were buried in the "Old Republican Cemetery", thanks to the dedication and efforts of Mildred and Cliff Wonn in compiling a list of identifiable burials in that particular cemetery. (See attached list of burials as copied at the Owingsville Public Library in October 1990.)

The Elizabeth Hawkins as listed 21 Apr. 1739 - 18 Oct. 1805 was my g-g-g-g-grandmother; John Hawkins, 20 Jan. 1760 - 18 Oct. 1823, the son of Elizabeth, my g-g-g-g-grandfather and Cassias (Cassandra Roberts) Hawkins, John's wife, my g-g-g-g-grandmother. Who Martha Hawkins was and who is listed as buried in the "Old Republican Cemetery" I don't know - perhaps a daughter of Elizabeth Hawkins or a daughter-in-law.

We easily found the stones of Elizabeth, John and Cassias Hawkins and saw a grave stone to the immediate right of Elizabeth, which was not readable. It was covered with dirt and moss and had sunk into the ground. We took pictures of all the graves, but had to leave because it was jetting dark by that time.

This same evening, Mrs. Hazel Boyd, a researcher and local historian in Montgomery County, Kentucky, suggested contacting a Mrs. Perkins in Mt. Sterling regarding information on another line I am researching; which I did. The next day while reading deeds at the court house in Mt. Sterling, (Montgomery County), Mrs. Perkins came in to meet us in order to put a face to my telephone voice. Mrs. Perkins husband was a descendant of the famous William Calk of Montgomery County who along with Joel Berry acquired 5,000 acres of land in 1786 on the waters of Howards Upper Creek and Lulbergud Creek in Clark and Montgomery Counties, Kentucky. After talking for a time with Mrs. Perkins, we told her about our returning to Bath County and the "Old Republican Cemetery" to try to read more of the stones there. She was kind enough to tell us of a method of "making out" the engravings on the tomb stones, as told to her by a friend. She suggested we spray the stones with shaving cream (not gel) and scrape the excess off with a flat object.

We returned to the cemetery our last full day in the area, October 18th, after visiting the court house and library in Flemingsburg. As luck would have it, it turned out to be the hottest day of the week! We tried the shaving cream process with not too much success because the stones were so dirty. About that time, another local resident (what would we do without them) came by and asked what we were doing. After telling him, he said he had a stiff brush in his truck, because he was a painter and we could try brushing the dirt and moss off the stones before spraying them with shaving cream. The brush worked beautifully and after spraying the already readable stones of my ancestors, we took Polaroid and Disc camera pictures and discovered the engravings on the Polaroid pictures really showed up well. (We found later when we had the other pictures developed at home, the relief stood out on those too!). We at last tackled the large buried stone that was next to Elizabeth Hawkins. Clarence had to dig out some of the medium sized stones that were partially covering the stone that we

thought was the one that should have engraving on it. clearing the medium stones and dirt away, I then used the stiff brush to clean the dirt and moss off the large stone. I then sprayed it with the shaving cream and wiped off the excess with some old gloves we had in the trunk of the car. This worked better for us; then we sprayed it again with shaving cream, wiped it off and discovered what was the stone of G. F. Hawkins, my g-g-g-g-ggrandfather, buried right next to Elizabeth, his wife. Farmer Hawkins was b. 18 June 1733 and d. 1810; and as far as we know, his grave and burial has not been documented anywhere. WHAT A FIND! I have thought it strange that he wasn't buried in the same cemetery as Elizabeth, because his death occurred only five years after hers. Gregory Farmer Hawkins did remarry after the death of Elizabeth, who died in 1805, to a Mary Jones in 1807 in Montgomery (now Bath County) County, Kentucky. By his second marriage, he had two children; Thomas Fletcher Hawkins, b. ca. 1808 and David Sorrency Hawkins, b. ca 1810. Mary Jones Hawkins probably remarried after the death of Gregory; she would have been young enough.

The "Old Republican Cemetery" on Flat Creek in Bath County is very unique. Most of the graves had stone walls on the long sides, piled 20 to 24 inches high and each end had a large single stone. The stone at the foot of the grave was smaller than the head stone; the one that had the engraving on it. All the stones evidently had come out of Flat Creek. We estimated there had to be at least twenty graves in the cemetery, if not more. Most all of the walls have toppled and the area is in a deplorable condition. There were some graves with no walls, with a single engraved stone, but it was difficult to determine how many. Several graves along with their stone walls were toppled because of some dead trees falling on them. Clarence determined two of these headstones identified the "Workman" name.

We also found what must have been part of the walls and foundation forming the "Old Republican Meeting House". We took pictures and weren't sure how they would copy, but a "xerox" sets out the detail of what remains of the foundation and walls.

I would just like to add that if anyone feels strongly about information concerning their ancestors, it probably will turn out to be true. Keep trying, the results may be just what you're searching for!

### Bits and Pieces of the Hawkins Family Puzzle

I have tried to write and leave with our very brief history of the lawkins family, also my Mother's Family as best I could; Joseph Brown, his first and second wives and their children.

With much love for you all I am Your Father. Warnes Authors

Philip Hawkins was your Great Grandfather. He was born Feb. I4 1801-departed this life Sept. 24, 1863. He was born in Virginia, immigrated to Chic
in 1812 when he was eleven years old. He was married to Elizaboth Martin;
daughter of Samuel and Elizabeth Martin on May 18, 1826. Philip Hawkins had

three brothers and two sisters whose names are not known.

He and his wife emigrated from Ohio to Howard County in central Indiana in the fall of 1847. At this time my Father, Thomas J. Hawkins was only six years old. This part of the country was then a wilderness with plenty of Indians and wild game. Philip Hawkins wife was born in Ohio in I803. To this union was born two daughters, Hary Ann and Rebecca, and seven sons; Ephric William, Martin, Samuel, Thomas Jefforson, Frank and Moses, Moses died in infancy. I do not remember my Grandfather Hawkins but do remember my Grand-Mother Hawkins fairly well as she lived with Father and I was thirteen years old when she died. Of Fathers brothers I remember Uncle Ephriam (Ellis) father of Elza and Dora. Uncle Frank who married my Mother's sister Tillic and who lived only a few years after his marriage. All of his children died in Aunt Tillie was later married to John Uncle Frank died of T.B. Knote and to this union were born four children, Ed, Alton, Blanche, who marrie a lir Lee, and William. Alton's have a son Raymond Warner Knote and a daughter Ruth who married Floyd Miller in 1929. The Knote family live in Indiana mostly at this time. Uncle William Hawkins was the Father of Thosdore and Cameron, thete were also two daughters I only remember the name of one Allie. The other was married to John Knote ( this was before he married my Aunt Tillie. I do not remember Uncle Samuel very well and only remember one of his children, Clint Hawkins who in later years married my half Brother "Otto's" wife and widow.

Thomas Jefferson Hawkins, your grandfather was born in Ohio, June I, I841 His Father moved to Indiana in the fall of 1847 when Father was six years old. He was brought up on a Homestead in Howard County Indiana, which was at this time a wilderness of heavy timber and swamps, no place for crops until the land was cleared of its natural growth of timber. Then before it would frow much the land had to be underdrained by ditches. This was done by cutting tree and splitting them something like sawed planks, nailing them together and putting them in ditches about two feet deep, with proper draining that the water would soak through the ground into these ditches and be carried away by natural fall of drainage. The trees grew very large, thick and tall walnut, oak, poplar and maple from which we made maple syrup. I have helped my father make maple syrup, "Sure Good". There were also beech, hickory and the sycamore, made famous by song, and many other kind of species. These trees grew three to four feet in diameter and were forty to fifty feet to the first limb. Father's work was to help clear this land and make a home with the rest of his brothers and sisters. There was only about two menths school each year. Travel was very difficult and there were but few laid out roads. Father enlisted in the Union Army Sept. 10, 1961. He was then twenty years old, three menths and nine days, Tejoined the Indiana Volunteer Infantry.

Regiment 34. Co. K. No was wounded it Champion Mills, Miss. May 16, 1863. In the Rospital at ! cmphis Tenn and from there to Indianapoli Indiana . thense to Cincinatti, ChioDec 25, 1863 and was ther until 1864. At this battle of Champion Tills lies, he with many others was severely wounded. His wound being the loss of his big toe of the left foot being shot away. He was left a cripple for life. He made the best of it during the years of a useful life In later years he lost a toe from his right foot which happened while he was cutting wood. He used to go barefoot and I could always tell Father's tracks Father served his country just a little more than three years, recieving his Honerable Discharge Sept. 27, 1864 at Columbus Ohio. He was mattied to Mary Margaret Brown, daughter of Joseph and Tempa Brown, on April, 9 1865. To this union on March .30,1866 WARNER HAWKINS was born. This union was only for a short time for on April 13, 1867 Mother was taken. She was less than twenty and her baby less than one year old. I did not realize that I had lost my Mother until I was perhaps twelve or fourteen years old and of course never thought of her. But after I was eighteen years old I thought of her often, and the older I get the more I think of the Mother I never knew. I have often dreamed of her and many, many cried myself to sleep and until my heart was almost broken when alone thinking of her. Father in later years told me that she was very beautiful and good and how it grieved her to know she had to leave him and her baby boy. "MY DEAR GOOD MOTHER". To you my children I know you will always love and honor your Mother. This has been hard for me to put in writing.

On March 12, 1868 Father married Virginia Allen daughter of Vanmeter and Hannah Allenof Jerome Ind: To this union were born seven children; etto, who died when he was about 30, Zelia who married Art McKenna, Rolla who married Minnie Hamburger, Bryant, who marriedDella Holland and who now lives at Duluth Minn. Lida who married Don Baird and who now lives at Mounds, Oklahoma Clora who married William Schoolcraft now living at Shelbyville Ind. and George whose wife died in 1926. George died at Miami, Florida in Jan. 1930. Fathers second wife died in Sept. 1905 and on Nov. 12, 1907 he was again united in marriage to Mrs. Awilda Carr who was the widow of John Carr of Greentown Indiana. Father was a hard worker, good provider and good to his children. He was a harness marer for two or three years, then a farmer until 1892 when he left the farm and moved to Greentown Indiana. Here he sold Insurance and real estate, until his failing health cause him to give it up. He was never very successful financially but he raised a large family none of which are very bad-he always gave us good wholesome advice. He departed this life on the 29th of

June 1918, his age being 77 years and 28 days.

WARNER HAWKINS, your Father, son of Thomas J. and Mary Margaret Brown, born at Jerome. Ind. in a log cabin March 30,1866. As mentioned before my Mother died before I was a year old. So I with my half brothers and sisters put most of our time in on the farm where Father worked. I left home when I was sixteen years old, and worked on farmes near home until I was nineteen. In the fall of 1885 I went West arriving at Hamelin, Brown County, Kunsas at 2:30 PMM. Nov.5, 1886. My Diary explains that I had only six dollars at this time. I got a job picking corn at One dollal per day, worked for Mr. John Ingels who was from Indiana. I might say that I had never been on a train until I started for Kansas and I was plenty green. I staid with Me Ingles through the winters of 85,86 doing chorès for my board. Began work for him March I, 1886 and worked nine months for \$160. and when the time was up I had \$140 due me. In the fall of 1886 I went with Mr. Horner in a covered wagon out to Norton County Kansas. I bought a Homestead Right for \$300. I was not old enough to filr on it so got Theodore Carr, an Indiana chum to file on it for me.

This homestead was seven miles north of Norton, Kansas, one mile south of Prairie Dog Creek. On Tuesday Sept. 7, 1886 Theodore and I arrived in Norton. Theodore went to the land office at Kirvin Kansas to file on the land. On the morning of the eighth I walked out to the Homestead and back to Norton about a teen mile walk. I was very hungry and I had no dinner. On the ninth we went to the homestead and took up our abode in a little old one room shanty. (sod) with about three dollars worth of home made furniture. We staid ther until Wed. Feb. 9 1887. We had a very nice time the two months we were there. We dug a well on our homestead and helped Fred Campbell our neighbor dig a well also. We played lots of Euchre and wenr to Literary Societies. Hunting was our main passtime. We left this place Feb. 9, 1887. Being short of money Theodore bought a ticket for Randall Kansas so he could take our things. On this day I was up early. First I walked to Orinoque and back to the homestead to get a letter from Father. Then I walked across the prarie to Edmund as I was going to burn my way on a freight as I was short of money. They told me the freight did not stop so I walked to Dansmore and on to Logan Walking this way about thirty seven miles. A lady gave me my dinner out on the prairie about four miles north of Edmund. I was very hungry and tired too. After resting a short time in the depot at Logan I was so stiff I could hardly get up town, did without supper but got a bed at the hotel and left orders to call me for the freight which was to come about four in the morning. Any way I was there and made good getting aboard. NO PAY. I finished the trip on the blind baggage and got into Randall at the same time that my pal Theodore did. Only he paid his way and I took the hard bumps. WAS GOOD FOR ME--- This was Feb 10, 1887. Wesley and Ollie Reed, my second cousins lived at Randall at the time. I worked for a man by the name of John Burger on his farm four miles southwest of Randall until July 3, 1887 at \$10 per month. At this time it was evident that the hot dry weather had ruined the crop. The Rock Island R.R. Company was now building a lien through northern Kansas. On July 4 I began work helping build the grade at Mount Roger Jewell County Kansas at \$15 \$1.50 per day and board myself. I continued this work until the ground was frozen at which time we were as far west as Norton. It was while I was working on the R.R. grade north of Randall that my Father visited me. I quit work for a few days while he was there and I was surely glad to see him. We visited my cousins Ollie and Wesley Reed who lived at Randall and went over to Concordia Kansas one day. We also visited Uncle Will Allen who lived at Washington Kansas. This was in 1\_\_\_, 44 years ago. I do not remember this visit of Fathers as well as I would like to. I could have but very little money and times were plenty tough. On Monday Nov. 10 I headed again out on the Homestead all alone. . The following is taken from my Diary of Nov. 15, 1887. "I was up early and worked hard all day. Fred Campbell helped me on my sod dugout." Again on Dec. 6, 1887 "I got up early and got breakfast, after which Mr. Ramsey and I went out and looked over my homestead as he was thinking of trading for it. We then went to Norton and finally made the trade. "and I perhaps gave up the only home I can ever call my own." but the future will tell. Written under this you will find. Jan 2 1951 "didn't end so badly. Five good children, one good wife and enough money that we need not worry. I traded my homestead for a large black team of horses, one old wagon and a fairly good set of harness. In all worth about \$350. I had worked this team and knew they were good. I later farmed with them for four years. On Dec. 7, 87 I went to work on the R.R. grade at \$3.00 per day man and team. Taken from my diary Dec. 8, 87 "Shorty and I slept on the ground in a tent with but two covers under us. Pretty cold - up early and put in ten hours."

(Note: This original page was extremely dim, so it is re-typed.)

This work o ly lasted a few days until the ground froze. I put in the winter living with my good friend Fred Campbell helping for my board. I had my team to feed and lbok out for.

On March 14, 1888 I began work again on the R.R. grade in Cheridan Co. Kansas about 30 miles south of Oberlin, Kansas. Rocd \$3.00 per day. I worked here until about the middle of June. We then shipped to Caldwell Tunsas just a few miles north of the Oklahoma line. We unloaded here and started work again on the Rock Island R.R. which was being built south through the Indian territory .. We worked where the cities of Pond Creek and Enid now are. that time there were no roads, sences or houses. We crossed the Kansas line into Indian Territory. I worked here until about the twentieth of July 1088 when I got disgusted with this work and the life that went with it. Itook my team and covered wagon and started North travelling about 25 miles per day. In about twelve days I had again got back to my friends John J Ingles whose place I had left on Dec.6, 1886.

At this time I wish to say to you my son, my daughter that your Dad was aure in the making during these two years of roaming. All whom I met were strangers to me. Ibecame of age on the thirtieth day of Parch, I887. I took some pretty tough breaks, but usually most people I met were kind to me. I truthfully think that these two years were good for me and well spent for After getting to Mr. Ingles I got a job at forming my life for the future. once going with his threshing machine, hauling water etc. I think I got \$2.50 per day and board and feed for my team. Could save some at this rate. After threshing was over I shucked corn for Mr. Ingles and staid with him until about MarchI 1889. Tt was in the fall of 1888 that I met a beautiful. wonderful girl, your Mother.

During the last two years of I887.88 I lost but very little time but could save but little money. Wages were small and the expence when not at

work soon took all I could save.

On March, I. 1889 I began farming with Mr. George Dean. We were on the Poutz farm just two miles south of Hamlin, Brown County Kansas. He and his wife were very good to me and treater me as a fid brother. George died in Cuthrie several years ago. His widow is still living there. Ivisited them twic after they went to Oklahoma. Durin - these two years we raised pretty good crops. I remember at one time we sake ISOO bu, of corn at ISO per bu. During these two years I saved about . 200. As montioned before I met your lether in the fall of 1888. She was also working for Mr. Ingles. Do not remember many hap enings at this time. But do call to mind I was takin her home one Sunday Afternoon. Our form of canveyance was a two wheeled cart with no top. Mother enjoyed her trip so much that she lost her fan, and did not say anythin; about it until we had driven about a mile / This of course prolonged the trip as we had to drive back for the fan. ( The copyist, Clare Swett wonders if Galanad did t throw it out intentionally.) I have just read this paragraph to Mother and she says she remembers looking back and seeing the fan in the road one mile away. From this time we corresponded (No doubt ardent Fan Mail) We seldom met each other. Mother taught the home school, Carson School the spring term of 1889 at \$27.50 per month. She gave a nice little entertainment at the end of the term which I attended, and of course thought she was more wonderful than ever. We continued to correspond not often though and seldom met each other. In the winter of IESP ->O also the torm of 90-91 she taught at Robinson, Kansas, had 44 Jupils enrolled and drew 35, per month. late summer of I890 we began going togother and became engaged at about Christmas time. I bought the ring paying \$17.50 for it. She still has the ring. We continued going together. Somtimes to Literaries at Carson and at Dist. Two south east of Hamelin. Tur courtship was of short duration for it was in March 1891 that I with my big team of black horses and dog Jack started out in the covered wagon for Friend Nebraska. This dog Jack was some fighter and it was just too bad for the dogs he met on this trip.

I, Elijah Hawkins of the county of Madison and state of Kentucky, being at the present under the afflicting hand of Providence and weak in body but sound and perfect mind and memory, blessed be all mighty God for the same and at the same time considering the uncertainty of this mortal life do make and publish this my last will and testament in manner and form, following that is to say first it is my will and desire that as much of my property be sold as will pay my just debts and the balance, if any, to remain in the hands of my beloved wife, Nancy Hawkins.

It is further my will and desire that my wife have the sole use and benifit of my plantation during her natural life. Or, her remaining my widow and then the whole of land and what property remains, to be sold and the money arising there from, to be didvided as follows, to wit: my sons Weden and John Hawkins to have eighty dollars

each and the balance to be equally divided among all my children.

Nevertheless, it is my desire that if the money can be raised to let my son Weden have his eighty dollars when he becomes of age and I do appoint my son James B. Hawkins and my beloved wife, my whole and sole executors of this my last will and testament in testimony whereof I have here unto set my hand and seal this fifth day of June, 1815". .

Malinda was an aunt to Paschal Walker HAWKINS and also the grandmother of his wife Lucretia Kilby. On the day her sister Lucy Thornhill died of pneumonia in Rappahannock Co. (see death record for Lucy Thornhill), Malinda and her newly widowed brother-inlaw, Bluford Thornhill, went over to Culpeper Co. and filled out an application for a wedding license (Dec. 28, 1864). The following week in Culpeper Co. on Jan. 3, 1865, Rev. A. Grimsley (Baptist) married them. Malinda was forced to bring suit against her brother Augustine Hawkins a few years after her father James and first husband Thomas died in order to collect money he owed her from their father's estate. This suit which is titled "Kilby vs. Hawkins' (Malinda Kilby vs. Augustine Hawkins and others) can be found in the Culpeper Co. clerk's office with the Chancery Court suits and contains all papers pertaining to the settlement of James Hawkins' estate which was a large one. Records of the sale of perishable goods and those who purchased them are also among these papers as well as being in the other books (Wills and Deeds for example). This suit may furnish the reason why in a later generation the family of Lucretia Kilby (Malinda's grandaughter) were not too happy with her choice of Paschal Walker Hawkins (Augustine's son) for a husband!

He purchased many items from his father-inlaw James Hawkins' estate, but he himself died shortly afterward and before he and his wife could collect the difference between their share of James' estate and their purchases from it. In the Chancery suit filed by Malinda (see notes for \$46) she stated that her husband, Thomas, had died "early in the year" after her father James Hawkins.

He had also died without leaving a will.

His estate contained two small tracts of land. One of these parcels of land was assigned to his wife Malinda and son James F. (Frank) about 1841 as their share of the real estate. The other tract of 139 3/4 acres was divided among the seven remaining children as their share of their father's estate. This is from the deposition given by son Joseph M. Kilby in the Culpeper Co. Chancery suit "Kilby vs. Kilby" to settle Albert Kilby's estate. At the time of Thomas Kilby's death all nine of his children were alive. The order to inventory and appraise his estate was made 19 May 1834, completed 2 Aug 1834, and returned to the Culpeper Co. court on 20 Oct. 1834. His estate excluding the land and real estate was appraised at \$1090 which was a rather average amount for that time and area. He had Negros Henry, Sarah, and Sarah's child Juliett Ann valued at \$700 total. (This is on file in the Culpeper Co. Clerk's office.) Note: In the 1830 Culpeper Co. Virginia Census his name appears as Thomas "J" Kilby.

He was a clerk for the F. T. Baptist Church Sperryville, VA. for many years. and was the Madison County surveyor. Sources: THE HISTORY OF MADISON COUNTY VA., family records, US Census for 1850 and 1870, F.T. BAPTIST CHURCH 1778 to 1978 (Creel), pg 45 of the Membership Roster of the Baptist Church of Jesus Christ at F. I. Culpeper Co. Va. 1805-1855 Minutes Book. Bessie Bell Hawkins Evans, his grandaughter, said he had also been a schoolteacher.

Many thought well of Augustine, well enough to make him the clerk of F. T. church and elect him as the county surveyor. However, his own sister Malinda, widow of Thomas Kilby, saw him in another light since she had such a difficult time trying to collect money he owed her from their father's estate. Being a young widow with nine children, she no doubt needed all the money she could get! She tried in vain and finally had no recourse but to file suit to claim what was owed her. This suit was complicated and it may even be the cause for Augustine later borrowing money from his wife's rich kin, "Pack" Finks, so he could pay his sister the money owed her. Augustine admitted owing her the same amount she presented to the court in the papers. Her claims lead one to think Augustine lost no time in getting himself appointed the executor/administrator of his deceased father's estate. James had died without a will and Augustine may have been the only son still living in the area although his sisters all resided in the vicinity. He posted the necessary bond and handled the details of disposing of his father's perishable estate items, slaves, etc. Accounts of the sale of this estate show James to have been a 'man of substance' who had a larger than average estate. Malinda and her sisters may've been justified in feeling their brother "railroaded" the whole proceedings taking the bulk of it for himself!
