NEWSLETTERS: HAWKINS HERITAGE is published three times a year in April, August, and December. All members are encouraged to contribute letters and material to the editor. It is preferable if you type your material, but if not covenient, please share it anyway.

QUERIES: Members are also encouraged to send queries to the editor.

MEMBERS AND SUBSCRIPTIONS: HAWKINS HERITAGE was begun with the hope of identifying the parents of James and Margaret? Hawkins, b. c1765 and 1768, probably in Virginia. Taxation records show that they lived in Stafford CO Virginia from 1793 until 1825, when they migrated to Clark CO Kentucky. One son, John R., married into the Hawkins/Bourne line, which may be a connecting branch of the above James. Because of an apparent need for "group" research, our publication is now open to descendants of all Hawkins lines.

Individual membership and subscription is \$12 per year. Contributing Membership and subscription is \$20 per year (may vote).

Subscriptions begin with the April issue. Subscribers during the membership year may receive back issues of the <u>current</u> year or begin with the next year and pay for any single back issues, which are \$4 each. The 1st issue was December 1986; 2nd, April 1987; 3rd, 1988; continuing with August and December from then on.

PEDIGREE SERVICE: You are welcome to send your Hawkins pedigree chart to be checked with our collection. You will be given any additional information which we might have on file, that would match up with your own. Your chart will be filed for possible future contact. 1. Alexander H. Rennick, Clerk of the County Court for Franklin County in the State of Kentucky do hereby Certify that the foregoing contains the original proceedings in the matter of the application of Elisha Hawkins for a pension and I do further certify that Henry Wingate Esqr. who hath his name to the certificate purporting to have qualified Jehudia Hawkins proving the Service of said Elisha Hawkins Senr. and which is hereto attached was at the time of doing the same Justice of the Peace in and for the County and State aforesaid duly commissioned & qualified and by law author zed to administer oaths

In testimony whereof I have hereto set my name as Clerk as aforesaid and affixed the Seal of Said County this 19th day of October 1832.

WILL OF ELISHA HAWKINS

I, Elisha Hawkins, being of the County of Franklin and State of Kentucky, being at this time of perfect mind and memory, but calling to mind the mortality of all living, do hereby ordain and establish this instrument of writing as my last will and testament.

In the first place, I commend my soul into the hand of Almighty God, and my body to be decently buried by the executors to be hereinafter names.

- 2. It is my will that the plantation and tract of land on which I now live, as well as all and any other of my real estate, as well as all my slaves and their increase also, all my personal estate of every kind, including money I note and due me, shall belong to William Hawkins (black head) who I raised, and his heirs fore er, and all the property I received, by my present wife at the time I married her shall return to her again.
- 3rd I Hereby appoint the said William Hawkins the executor of this, my last will and testament, revoking all former wills, witness my hand and seal this 2nd day of November 1824.

Personally appeared before me Henry Wingate a Justice of the peace for said County, Jehudiah Hawkins, aged from appearance Seventy-five or six years, who being by me solemanly charged and sworn in due form of law to testify the truth touching the Revolutionary Services of Elisha Hawkins, Senr. deposeth & says that he was 76 years of age on the 25th day of August last past- That he is well acquainted with the Said Elisha Hawkins Senr. now a resident of Franklin County, Kentucky, and that he knew him in Orange County in the state of Virginia in the year 1776 when he enlisted as a regular Soldier under Capt. Francis Taylor and marched under him to Williamsburg, Virginia where a number of troops lay all that summer, and on the next winter they were summoned to the north and the said Elisha Hawkins Senr. returned home in April 1778 having remained in the service under said enlistment two years.

This deponant further states that he always understood and so believes the fact to be that the said Elisha Hawkins Senr. Served several tours of Militia duty in the war of the Revolution, but knows nothing of said Services

Jehudiah X Hawkins

State of Kentucky Franklin County

on the 20th day of August 1832, personally appeared in open Court before the Franklin County Court now setting Elisha Hawkins a resident of Franklin Co. and state aforesaid aged 77 years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

I enlisted in Orange county Virginia under Capt. Francis Taylor, 1st Lieutenant William Taylor, 2nd Lieutenant Benjamin Porter, Ensign Francis Coward. I enlisted on the 2nd day of March 1776 according to the best of my recollection and served two years under the same officers and was then discharged at Valley Forge. I belonged to the second Virginia Continental Regiment. I had at one time a regular discharge but, now have nothing to show the same having been lost, nor have I any documentary evidence to show the fact of my service. And I know of but one person now living by whom I can prove my service a Mr. Jehu Hawkins I was once on a furlough to my relation being sick & permitted to return home & he went back to the army with me on private business. I never was in any regular engagement but in several skermishes. I have been living in Kentucky about thirty six year and the last thirty in the County of Franklin. I hereby relinquish every claim whatever to a pension or annunity except the present and declare that my name is not on the pension roll of the agency of any State.

Sworn to: Elisha Hawkins

We William Hickman Jr & John Brown Ministers of the Gospel belonging to the Baptist denomination of the County of Franklin in the State aforesaid do certify, that we are well acquainted with Elisha Hawkins who has Subsribed & Sworn to the above declaration, that we believe him to be Seventy Seven years of age, that he is reputed & believed in the neighborhood where he resides to have been a Soldier of the revolution & that we concur to that opinion.

Sworn to and subscribed this 12th day of September 1832. (signed) John McKee, J.P.of C. Note: Out August issue will continue with a declaration by Rebecca Hawkins widow of Reuben Hawkins

REBECCA EDWARDS, daughter of Uriah Edwards, Sr. and Mildred Head, born 21/28 May 1762 in Spotsylvania County, Crown Colony of /irginia, North America, she died 27 July 1840 in Franklin County, Kentucky, her place of burial is unknown. She married in August 1778, by Farson James Marye, Jr. at St. John's Episcopal Church, Berkeley Parish (vicinity the present town of Lewiston, Virginia), Spotsylvania County, Crown Colony of /irginia, North America, Mr. REUBEN HAWKINS, his date of birth is unknown, he died in August 1812 in Orange County, Virginia, his place of burial unknown. He was the son of William Hawkins and Elizabeth Wall. They were the parents of twelve children:

Elizabeth Hawkins - William Benton Hawkins born 26 February 1781 probably in Orange County, Virginia - Elisha Hawkins - Roddy Hawkins - Arculus Hawkins - Reuben Hawkins, Jr. - Lucy Hawkins - Moses Hawkins - Uriah E. Hawkins - Willy Hawkins - Benjamin S. Hawkins - Sally Hawkins.

Her husband, Reuben Hawkins died in Orange County, /irginia intestate, however, the following inventory of his personal property was found.

Agreeable to an order of the County of Orange made 24th May 1813 we the undersigned being first sworn for that purpose proceeded to appraise the possessions and chattels of Reuben Hawkins, deceased, viz:

MARTHA "PATSY" HAWKINS - RAYMOND BEDFORD

Martha "Patsy" Hawkins, was born c1762. She married Raymond Bedford, Rutherford CO, NC, in 1781. Martha died after 1830 in Rutherford CO.

(The following extracted by your editor from printed material sent by Mrs. Schartman.)

Raymond Bedford was born 1758, probably born in Essex CO, NJ., his family moving to Cumberland CO PA, and then to Mecklenburg, NC. He died 15 May 1820 in Rutherford CO.

Martha and Raymond had six children: James, b1786; Nancy c1788; Massa (f) c1790; Noah Peter c1794; Joseph Hawkins c1800 and Jonas c1804.

A source for some of the above taken from <u>The Ancestors of Glen Johnson of Texas</u>. According to this book, parents of Raymond Bedford were Jonas Bedford, Sr., 1735-1823, and Mercy Travis, 1740-1822.

According to Colonial Granville County And Its People, edited by Worth S. Ray: "Grant to Philemon Hawkins, 70 A on N side Main Broad River, adj. William Hawkins land that he bought of Jonas Bedford & below on Peter Dills, on Richardsons Creek . . . 20 Oct 1784. Alex Martin."

Frances Schartman would like to know if William Hawkins born c1742 in Halifax CO VA was "Patsy's" father, and did Patsy have a brother named Philemon? Since we have members who descend from the same line as General John Parker Hawkins (with "Philemons" in his line,) perhaps someone can add to Frances' family history.

Frances also sent a generation descent chart of her surname of "Killian." (The first was Andreas Killiam 1702-1788, born in Germany, and died in Catawba CO NC.)

THE STORY OF THE BRASS CANDLESTICK

Submitted by Gail Hawkins, 11615 Sagevale Lane, Houston, TX 77089

On Oct. 12, 1812, three young couples were married in the same church ceremony in Culpeper Co., Va. One of these couples was John B. Hawkins, my Gr-Grandfather and his bride, Ann Foard. (A copy of their marriage contract is in the documented data in the Family Lineage Book.) Since Ann was an orphan, her uncle, William Foard signed for her. her own father's name was James Foard.

(Note: Gail corrects the father's name to "William," and mother was Ann Moore.)

Outside the church waited six riding horses, and after saying farewells to their families and friends, the six young people mounted and left on a long and hazardous honeymoon. They were bound for "Kentucky Territory," where there was land offered for homesteading. The brides' saddle-bags held their wedding gifts, linens, bed clothes, and other homemaking items. The men carried tools to build the cabins' farm implements, and seeds for planting. One of Ann's gifts from home, was this pair of candlesticks, which had been in her family, probably for several generations, since they were made in England. (Authority-Curator of Wichita Art Museum, where this one was displayed in 1965.)

Several evenings later as they approached the "Cumberland Gap" in what is now central Tennessee--a deep narrow valley between the mountains, Ann's horse lost a shoe, and John and Ann had to stop while the shoe was replaced. The two other couples rode ahead to make camp, but by the time John and Ann were ready to travel, it was too dark to see the narrow road, and they decided to wait until the next morning.

When they reached the campsite of their friends, they found that Indians had attacked, stolen the horses, and saddlebags and left only the scalped bodies of the four young people lying beside the road.

After burying the bodies of their friends, John and Ann had the courage to continue their journey and came into what is new Mason Co., Ky., where they built their cabin, and reared their family. The fourth child, James Foard Hawkins was my grandfather, born in 1823.

The pair of candlesticks was divided when one was given to my mother and the other to her brother, and each gave them to their daughters. This one came to Kansas with me in 1921 and the other is, I suppose, still in Daviess Co., Ind., where James and his wife, Hannah Ann Hixson lived at the time of their deaths.

Seeking information on Dr. J.W. Hawkins from IL. Married first ?? and had a daughter, Margaret E., born November 20, 1860 in IL. Moved to Guadalupe County, Seguin, TX. and married Mary Elizabeth Springs March 25, 1872. They had a son, William Ashbury (or Asbury) born July 7, 1872, who married Cynthia L. Scott, May 8, 1901. Hawkins died between 1874 and early 1880. Mary Hawkins died November 23,1911.

BARNETT HAWKINS

Barnett Hawkins settled in Newton County, Indiana, his family having previously lived in New York for generations.

Barnett Hawkins died in Kentland on July 9, 1903. He was born in Poughkeepsie, NY in 1834. His parents were Edgar and Lydia Ward Hawkins. Lydia belonged to an old Quaker family. This couple had six children, two of whom were George and Frank. The family settled first in Michigan City, IN, then moved to Laporte. Edgar settled on a farm, of 230 acres. His death occurred through an accident at a mill which he owned in Brook.

They were active in the Methodist Episcopal Church. Barnett attended a log schoolhouse, later teaching school and attending college at Greencastle. He was also a carpenter and served as county surveyor.

In 1857, Barnett married Anna V. Jones, daughter of Cornelia and Mathilda Minchell Jones. Her parents came to Brook, remaining there until their deaths. They had eleven children.

Barnett and Anna had six children: Florence, b1858; Homer E., b1861; Frederick G., b1866; Arthur E., b1868; Edgar C., b1870; and Clyde B., b1876.

WILLIAM D. HAWKINS - JULIA BLACKWELL

WILLIAM D. HAWKINS, my gr-gf, was born in North Carolina. I think his father may have been Robert of Rhode Island, but I'm not certain. His wife was AMY ALDRICH. He and his wife had three sons, John, born 1821, Stephen born 1827, and William, 1829. My gr-gf married JULIA BLACKWELL, maybe his 2nd wife, but she was my gr-gm.

William D. was a Confederate soldier. He was b1829. He was in Company D, 65th Infantry. Enlisted May 6, 1862 and was promoted to 2nd Sgt. Aug. 15, 1864. In his application for a pension filed in June,1910, he stated he was at the Battle of Nashville; separated from his command in the retreat and did not reunite with the Army until after Hood's surrender. I found him living in what is now Rome, GA, at 1022 Watters in 1860.

This could have been Cherokee County which extended from NC through a part of AL. I went there last year and they are very close along the northern area of these three states. He probably had a brother named James, who was lists as a private in the Cherokee Rangers on Aug. 17, 1861. They all lived in the same area of Rome, GA at this time. I think he also had a brother named J. N. B. Hawkins, since he and his wife, Sarah Melton, are buried in Van Zandt County, TX.

I will be happy to share my information with anyone who is interested and will also research records available to me in this area. Thanks again,

A WORD OF WARNING

Gail Hawkins of Houston sent me a copy of an article from The Virginia Genealogist, Sept-Oct, 1995. We have all heard of publications of various surnames, when in reality, they ar nothing but a little information concerning the history of the surname, plus those surnames listed in telephone books throughout the country. We can to our own libraries and get the same listings for ourselves.

I am not saying they are frauds. Just think about it. The informative article by Helen Hinchcliff, National Genealogical Society Ethics Committee is helpful.

The name involved is HALBERT. They issue six book titles leading possible customers to believe they contain information about their own family name. Apparently not so! Should you receive advertising mail from HALBERT'S, you can ignore it! Even their "clan reunion tours" of Scotland seem to be standard tours and not a route where you can see where your own Scottish ancestors lived.

HALBERT'S has been investigated by the Postal Service before. Helen Hinchcliff suggests if you have comments and complaints about HALBERT'S, write to Jennifer Angelo, Chief Counsel, Office of Consumer Protection, U.S. Postal Service, 475 L'Enfant Plaza, Washington, DC 20260-1100.

Also, for years various companies have solicited business through the mails, concerning surnames. They all lead you to believe their publications give you much material on your ancestry. And WE will even have our names in their books! Yep, so does our telephone book. As soon as the Postal Service fines them, they seem to change their business name and start over.

He married Johanna Harrison 18-Dec-1803 in Mason CO KY. John died February 1840 in KY. Johanna was also born in North Carolina, and died 5-Mar-1835.

Jamerson, son of John and Johanna Harrison Hawkins, was born 23-Sept-1819. On 26-May-1871, he married Matilda Klutte in KY.

PERMELIA NICKELL HAWKINS - LETTER

(From the letter collection passed down to her great-granddaughter, Olyve H. Abbott.)

From Permelia:

George's Creek, Texas March 19, 1889

My dear children,

Mr. Hix just came over from Granbury and told us you were ailing, John. We are so sorry to hear that. I am uneasy about you. Now Willie, be sure to write often so we will know and won't have to worry. Take care of each other.

We enjoyed the visit so much, and we got home all right, even though it had been raining hard. I thought it would let up and stop, but it had already been pouring. We crossed at Rock Crossing. We met a man that said the water would run over the wagon bed at the Marline Crossing, and indeed it did. I was not scared at all, and we got home before night. Later when I thought on it, the water was a bit fierce.

When I came home Rosa Atchison and her baby Annie Ester were sick and I had to go there. The babe is only five months old and real sweet. Then my friend Mrs. Hodges sent for me and I was up with her all night. She had a big boy, weighing thirteen pounds and they are both well.

I got a letter from Ella Story and got the nicest present Sunday evening. And yesterday a brown flowered dress came in the mail. We can't think where it came from. I am going up to Uncle Wright's and cut out and make him a pair of pants.

Now I hope all the sick there is better. We are all well. I fear you will not have enough money. Do you have? Be sure to let me know.

From mama to her dear children,

Permelia's Journal:

John and Willie have taken work in Granbury, over in Hood Country. I just left from there and now John is sick. Andrew could sure use their help, but our friends there need them more, and the boys can use some extra money too. Poor Mr. Scarbro passed away and his wife couldn't get the work done. We'll just have to ride back over and take some things, and of course, see our boys again. -- Permelia.

From John Robert:

Hood County, Tex. March 28, 1889

Dear folks at home,

Your letter just came to us and we are glad you didn't have real trouble in getting back. I am feeling well now and have been eating all the time to make up for what I missed when I was sick. It's hard to know when I have had enough.

Now sit down since this is going to be a long story if I can get it all told. Up in Colorado there were these two physicians that had been wanting to do some kind of experiment with hanged criminals, to see if they could bring them back to life. Well, they made arrangements with the vigilante committee to get this man sent over to the hotel after he was hung. So after the hanging, a boy came over to the doc's office to fetch them to this hotel.

They went right to the hotel room where the clerk sent them, and sure enough there he was laying out still as could be. One of the doctors put a piece of metal in each of the man's hands. This metal was on wires somehow on a battery and then they turned on the switch. Well, that man jumped out of bed and was screaming and hollering so much to the hotel clerk that they thought they'd brought him back to life. The clerk said, "You brought him back to life nothin'. He sent for you to lance a boil!"

So you know Ma, the doctors went to the wrong room. I tell you Ma, that man grabbed his gun and chased those

doctors until they couldn't run any more. Can't you just see it happening?

You probably think I'm joking you for an April fool's joke Ma, but that's what was told to me.

We're about getting this work done. It's been a real wet week though, more than usual so it's just get as much done in the mud as possible.



LETTER FROM JAMES M. BOURNE

The following are letters from the collection of General John Parker Hawkins, who researched his family history in the late 19th century and into the 20th. The original letters are in the Kentucky Historical Society Library in Frankfort, KY. Copies are available for patrons' viewing.

Louisville, June 10, 1892

M. Paxton, Esq. Platte City, MO

Dear Sir:

I am just in receipt of the information that in your history of "The Marshall Family" you claim that "Maria Love Hawkins, who married John A. Washington Smith was a daughter of Capt. John Hawkins, Adjutant of Col. Thomas Marshall's Third Virginia Regiment. - and that the Adjutant was descended from Ralph Hawkins who settled in Charles County, MD about 1650."

Will you please inform me upon what records or other evidence you base the statement?

The descendants of two other John Hawkins claim descent from the Adjutant of that Regiment. Please give me as complete a history of the one mentioned by you as you canhis residence, brothers and sisters and parents.

Mr. Bourne:

I cannot now mention with certainty my authority for the passage to which you refer, but am convinced that it was either, Hon. Marshall J. Smith of New Orleans (No. 492 of my Chart) or Miss Margaret V. Smith (1202 of my Chart) of Alexandria, Va. I think the former was my informant, but both are well informed in genealogical matters, and will courteously reply to your letter.

On page 147 I find "Anna G. Strother=John Hawkins. So that I have a note."

J.R. Darnall of Wichita Falls, Texas, writes his lineage as follows:

Anna G. Strother = John Hawkins - Their son Wm. Strother Hawkins = _____ Keith

Isham Keith Hawkins = ____ Darnall

J.R. Darnall of Wichita Falls, Texas - He will answer your letter.

You will find a good deal on the Hawkins family in the "Historic families of Kentucky and Virginia" by Col. Thomas M. Green of Danville, Ky.

WILL OF JOHN HAWKINS - SCOTT CO, KENTUCKY

At some time a fire occurred in the County Office at Georgetown, Scott County, burning many records. The following is all that remains of a partially burned paper.

— John P. Hawkins

In the name of God, Amen: I John Hawkins, of Scott County and State of Kentucky, being in health, of a sound memory, knowing the uncertainty of human life, do make this my last Will and Testament, and all other Wills by me made before, void of course.

First. I recommend my soul to God who gave it, my body to be buried at the discretion of my Executrix hereinafter named, and as to what worldly estate the Lord has blessed me with both real and personal I give among my children in manner and form following.

Item. In the first place I lend unto my beloved wife Sarah Hawkins, during her natural life, the lands and improvements whereon I now live and Sall, Ceazer, Joe, Betty, Winny and James, and the choice of my horse creatures, and two of my choice Oxen, a sixth part of my other cattle, Hogs, Sheep &c, two and furniture and as much household and kitchen and plantation utensils as she may think necessary, which is to be returned to my children and equally divided among them after my death

It is my Will and desire after the death of my wife Sarah Hawkins, that what I have lent her be equally divided among my eleven children before named

Sally Smith Hawkins - Thomas P. Thomas

Fanny Hawkins - Philemon Thomas

The latter moved to Louisiana was distinguished in the early History of that State. M.C. & etc. See Appletons Encyclopedia of Philemon Thomas. He married Fanny, a daughter of John and Sarah Hawkins.

Lastly I appoint my beloved wife Sarah Hawkins, Executrix and Philemon Thomas, Jameson Hawkins, John Hawkins, Georgetown, and John Payne, Executors of this my last Will and Testament to which I have willingly and deliberately set my hand and seal this 30th day of October, 1804.

Lewis Hawkins,

Sept 13th 1806.

Jameson and Philemon were the only children left by Margaret Jameson. The others here mentioned were the children of Sarah Johnson.

I relinquish my right as Executrix to the Will, Given under &c. this 22 September 1806.

Sarah Hawkins

Scott County, September Court, 1806.

This is the last Will and Testament of John Hawkins, Decd. was this day produced in Court by John Payne, Jameson Hawkins, John Hawkins, three of the Executors therein named and proved to be the act and deed of the said John Hawkins, dec'd. by the oaths of Toliver Craig, and Andrew Johnson, two of the subscribing Witnesses thereto, and ordered to be recorded & the said Executors having taken the oath and acknowledged their bond agreeably to law
